AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in reimbursements by Commonwealth and 5 between school districts, providing for emergency supplemental payment for basic education funding for 2015-6 7 2016 school year; and making an appropriation. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 12 as the Public School Code of 1949, is amended by adding a 13 section to read: 14 Section 2502.55. Emergency Supplemental Payment for Basic Education Funding for 2015-2016 School Year. -- (a) For the 2015-15 16 2016 school year, an eligible school district as provided in 17 subsection (b) shall receive an emergency supplemental payment 18 for basic education funding as calculated in subsection (c). 19 (b) A school district that meets the following criteria 20 shall be an eligible school district:

(1) An average daily membership for the 2014-2015 school

- 1 year that is equal to or greater than seven thousand (7,000) and
- 2 less than twenty thousand (20,000).
- 3 (2) A total expenditure per average daily membership for the
- 4 2013-2014 school year that is less than fifteen thousand ninety-
- 5 one dollars (\$15,091).
- 6 (3) The difference between the following amounts is greater
- 7 than ten percent (10%):
- 8 (i) the allocation received by the school district for basic
- 9 <u>education funding for the 2014-2015 school year under section</u>
- 10 <u>1722-L(17.1)</u> of the act of April 9, 1929 (P.L.343, No.176),
- 11 known as "The Fiscal Code"; and
- 12 (ii) the amount that the school district would qualify to
- 13 receive for the 2015-2016 school year by the application of
- 14 section 2502.53 to the entire basic education funding
- 15 appropriation for fiscal year 2016-2017.
- 16 (c) An eligible school district shall receive an emergency
- 17 supplemental payment for basic education funding for the 2015-
- 18 2016 school year that shall be calculated as follows:
- 19 (1) Divide the amount of the difference calculated under
- 20 subsection (b) (3) for the eligible school district by the total
- 21 amount of the differences calculated for all eligible school
- 22 districts.
- 23 (2) Multiply the quotient in paragraph (1) by one hundred
- 24 fifty million dollars (\$150,000,000).
- 25 Section 2. The sum of \$150,000,000 is hereby appropriated to
- 26 the Department of Education for the purpose of emergency
- 27 supplemental payments for basic education funding for the 2015-
- 28 2016 school year in accordance with section 2502.55 of the act.
- 29 Section 3. This act shall take effect July 1, 2016, or
- 30 immediately, whichever is later.
