A RESOLUTION

- Designating April 13, 2016, as "Industrial Resource Center Appreciation Day" in Pennsylvania.
- 3 WHEREAS, Manufacturing is among this Commonwealth's leading
- 4 industries, contributing \$82 billion to the gross State product
- 5 each year, making this Commonwealth the eighth-largest
- 6 manufacturing state in the nation; and
- 7 WHEREAS, Manufacturing provides a family-sustaining average
- 8 wage of more than \$57,000 to more than 570,000 direct employees
- 9 each year, infusing more than \$32 billion in employee earnings
- 10 into this Commonwealth's economy each year; and
- 11 WHEREAS, More than 14,000 manufacturers Statewide helped to
- 12 fuel this Commonwealth's economy by contributing more than \$959
- 13 million in wage taxes and \$445 million in sales taxes to the
- 14 Pennsylvania Treasury last year; and
- 15 WHEREAS, Under the act of June 22, 2001 (P.L.400, No.31),
- 16 known as the Industrial Resources Center Partnership Act, the
- 17 General Assembly established the Industrial Resource Centers to

- 1 serve the manufacturing industries in this Commonwealth; and
- 2 WHEREAS, The Industrial Resource Centers diligently provide
- 3 technical services and much-needed expertise to our small and
- 4 mid-sized manufacturing community Statewide in areas of
- 5 innovation, process improvement, reshoring and technology
- 6 acceleration; and
- 7 WHEREAS, Over the past 10 years, the work of the Industrial
- 8 Resource Centers has had positive impacts upon, and has created
- 9 or retained critical manufacturing jobs within, more than 3,200
- 10 manufacturing businesses in this Commonwealth; and
- 11 WHEREAS, The United States Department of Commerce recently
- 12 verified that over the past 10 years Pennsylvania manufacturers
- 13 have realized sales impacts of more than \$7.4 trillion and
- 14 bottom-line cost savings of more than \$636 billion as direct
- 15 results of Industrial Resource Center services; and
- 16 WHEREAS, The United States Department of Commerce recently
- 17 verified that over the past 10 years Industrial Resource Center
- 18 activities have facilitated more than \$1.6 billion of
- 19 manufacturer investment in this Commonwealth and have positively
- 20 impacted more than 57,000 created or retained manufacturing
- 21 jobs; and
- 22 WHEREAS, The Industrial Resource Centers throughout this
- 23 Commonwealth represent a public-private partnership that looks
- 24 forward to continuing to leverage Federal, State and industrial
- 25 resources to further advance our manufacturing economy and
- 26 create manufacturing jobs well into the future; therefore be it
- 27 RESOLVED, That the Senate designate April 13, 2016, as
- 28 "Industrial Resource Center Appreciation Day" in Pennsylvania
- 29 and urge its observance throughout this Commonwealth to show
- 30 appreciation for the work of the Industrial Resource Centers and
