AN ACT

- Amending the act of April 14, 1972 (P.L.221, No.63), entitled, as amended, "An act establishing the Pennsylvania Advisory Council on Drug and Alcohol Abuse; imposing duties on the 3 Department of Health to develop and coordinate the 4 implementation of a comprehensive health, education and 5 rehabilitation program for the prevention and treatment of 7 drug and alcohol abuse and drug and alcohol dependence; providing for emergency medical treatment; providing for 8 treatment and rehabilitation alternatives to the criminal 9 process for drug and alcohol dependence; and making repeals," 10 further providing for consent of minor. 11 The General Assembly of the Commonwealth of Pennsylvania 12 13 hereby enacts as follows: 14 Section 1. Section 12 of the act of April 14, 1972 (P.L.221, No.63), known as the Pennsylvania Drug and Alcohol Abuse Control 15
- 17 Section 12. Consent [of Minor] <u>for Minors.--(a)</u>

Act, is amended to read:

- 18 Notwithstanding any other provisions of law, a minor who suffers
- 19 from the use of a controlled or harmful substance may give
- 20 consent to furnishing of medical care or counseling related to

- 1 diagnosis or treatment. The consent of the parents or legal
- 2 quardian of the minor shall not be necessary to authorize
- 3 medical care or counseling related to such diagnosis or
- 4 treatment. The consent of the minor shall be valid and binding
- 5 as if the minor had achieved his majority. Such consent shall
- 6 not be voidable nor subject to later disaffirmance because of
- 7 minority. Any physician or any agency or organization operating
- 8 a drug abuse program, who provides counseling to a minor who
- 9 uses any controlled or harmful substance may, but shall not be
- 10 obligated to inform the parents or legal guardian of any such
- 11 minor as to the treatment given or needed.
- 12 (b) Notwithstanding a minor's refusal to provide consent, a
- 13 parent or legal quardian may give consent for the minor.
- 14 Section 2. This act shall take effect in 60 days.
