AN ACT

1 Amending the act of April 9, 1929 (P.L.177, No.175), entitled
2 "An act providing for and reorganizing the conduct of the
3 executive and administrative work of the Commonwealth by the
4 Executive Department thereof and the administrative
5 departments, boards, commissions, and officers thereof,
6 including the boards of trustees of State Normal Schools, or
7 Teachers Colleges; abolishing, creating, reorganizing or
8 authorizing the reorganization of certain administrative
9 departments, boards, and commissions; defining the powers and
10 duties of the Governor and other executive and administrative
11 officers, and of the several administrative departments,
12 boards, commissions, and officers; fixing the salaries of the
13 Governor, Lieutenant Governor, and certain other executive
14 and administrative officers; providing for the appointment of
15 certain administrative officers, and of all deputies and
16 other assistants and employes in certain departments, boards,
17 and commissions; providing for the regulation of pari-mutuel
18 thoroughbred horse racing and harness horse racing
19 activities, imposing certain taxes and providing for the
20 disposition of funds from pari-mutuel tickets; and
21 prescribing the manner in which the number and compensation
22 of the deputies and all other assistants and employes of
23 certain departments, boards and commissions shall be
24 determined," in powers and duties of Department of Labor and
25 Industry, its departmental administrative and advisory boards
26 and departmental administrative officers, further providing
27 for fair share fee and payroll deduction.

28 The General Assembly of the Commonwealth of Pennsylvania

29 hereby enacts as follows:

1 Section 1. The definitions of "public employer" and "school
2 entity" in section 2215(a) of the act of April 9, 1929 (P.L.177,
3 No.175), known as The Administrative Code of 1929, are amended
4 to read:

5 Section 2215. Fair Share Fee; Payroll Deduction.--(a) As
6 used in this section, the following words and phrases shall have
7 the meanings given to them in this subsection:

8 * * *

9 "Public employer" shall mean the Commonwealth of
10 Pennsylvania. [or a school entity.

11 "School entity" shall mean any school district, intermediate
12 unit or vocational-technical school.]

13 * * *

14 Section 2. No collective bargaining agreement made by a
15 school district, intermediate unit or vocational-technical
16 school after the effective date of this section nor any
17 extension of an existing collective bargaining agreement made by
18 a school district, intermediate unit or vocational-technical
19 school after the effective date of this section may require
20 payment of a fair share fee to the exclusive representative by a
21 nonmember of the exclusive representative.

22 Section 3. This act shall take effect immediately.
