## AN ACT

- Relieving certain employee organizations of certain duties and obligations; and making a related repeal.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Collective
- 7 Bargaining Agreement Limitation Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Exclusive representative." The employee organization
- 13 selected by the employees of a public employer to represent them
- 14 for purposes of collective bargaining pursuant to the act of
- 15 July 23, 1970 (P.L.563, No.195), known as the Public Employe
- 16 Relations Act.
- 17 "Fair share fee." The regular membership dues required of

- 1 members of the exclusive representative, less the cost for the
- 2 previous fiscal year of its activities or undertakings which
- 3 were not reasonably employed to implement or effectuate the
- 4 duties of the employee organization as exclusive representative.
- 5 "Political subdivision." A county, city, borough,
- 6 incorporated town, township and county institution district.
- 7 Section 3. Limitation on collective bargaining agreements.
- 8 No collective bargaining agreement made after the effective
- 9 date of this section by any political subdivision nor any
- 10 extension of an existing collective bargaining agreement made
- 11 after the effective date of this section by any political
- 12 subdivision may require payment of a fair share fee to the
- 13 exclusive representative by a nonmember of the exclusive
- 14 representative.
- 15 Section 4. Repeals.
- 16 Repeals are as follows:
- 17 (1) The General Assembly declares that the repeal under
- paragraph (2) is necessary to effectuate this act.
- 19 (2) The act of June 2, 1993 (P.L.45, No.15), known as
- the Public Employee Fair Share Fee Law, is repealed.
- 21 Section 5. Effective date.
- This act shall take effect immediately.
