AN ACT

- Amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in intergovernmental cooperation, further providing for ordinance, for content of ordinance,
- for joint purchases with private educational establishments, for required review of specified agreements and for effect of
- joint cooperation agreements.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Sections 2305, 2307, 2310, 2314(a) and 2315 of
- 10 Title 53 of the Pennsylvania Consolidated Statutes are amended
- 11 to read:
- 12 § 2305. [Ordinance] Adoption of ordinance or resolution.
- 13 (a) Ordinances. -- A local government may enter into
- 14 intergovernmental cooperation with or delegate any functions,
- 15 powers or responsibilities to another governmental unit [or],
- 16 local government or authority as defined in section 5602
- 17 <u>(relating to definitions)</u> upon the passage of an ordinance <u>or</u>
- 18 resolution by its governing body. If mandated by initiative and
- 19 referendum in the area affected, the local government shall

- 1 adopt such an ordinance or resolution.
- 2 (b) Compliance by authorities. -- An authority as defined in
- 3 section 5602 may not share or be delegated any function, power
- 4 or responsibility through an agreement under this subchapter
- 5 unless the function, power or responsibility is consistent with
- 6 both the law under which the authority was created and the
- 7 powers or purposes of the authority contained within its
- 8 <u>articles of incorporation.</u>
- 9 (c) Council of governing bodies. -- A council or consortium of
- 10 governing bodies or similar entity may not be entered into
- 11 unless by ordinance.
- 12 § 2307. Content of ordinance or resolution.
- 13 The ordinance or resolution adopted by the governing body of
- 14 a local government entering into intergovernmental cooperation
- 15 or delegating or transferring any functions, powers or
- 16 responsibilities to another local government, an authority as
- 17 defined in section 5602 (relating to definitions) or to a
- 18 council of governments, consortium or any other similar entity
- 19 shall specify:
- 20 (1) The conditions of agreement in the case of
- 21 cooperation with or delegation to other local governments,
- 22 the Commonwealth, other states or the Federal Government.
- 23 (2) The duration of the term of the agreement.
- 24 (3) The purpose and objectives of the agreement,
- including the powers and scope of authority delegated in the
- 26 agreement.
- 27 (4) The manner and extent of financing the agreement.
- 28 (5) The organizational structure necessary to implement
- the agreement.
- 30 (6) The manner in which real or personal property shall

- 1 be acquired, managed, licensed or disposed of.
- 2 (7) That the entity created under this section shall be
- 3 empowered to enter into contracts for policies of group
- 4 insurance and employee benefits, including Social Security,
- 5 for its employees.
- 6 § 2310. Joint purchases with private educational
- 7 establishments.
- 8 Any local government may, by ordinance or resolution,
- 9 authorize joint purchases of materials, supplies and equipment
- 10 with any private school, parochial school, private college or
- 11 university or nonprofit human services agency within the local
- 12 government. The ordinance or resolution shall require that the
- 13 school, college or agency shall be bound by the terms and
- 14 conditions of purchasing agreements which the local government
- 15 prescribes and that the school, college or agency shall be
- 16 responsible for payment directly to the vendor under each
- 17 purchase contract. Schools, colleges and agencies shall be
- 18 exempt from any existing statutory requirements governing
- 19 competitive bidding and execution of contracts with respect to
- 20 purchases under this section.
- 21 § 2314. Required review of specified agreements.
- 22 (a) General rule. -- An agreement between a local government
- 23 and the Federal Government, the Commonwealth, any other state or
- 24 government of another state under the provisions of this
- 25 subchapter shall, prior to and as a condition precedent to
- 26 enactment of an ordinance or resolution, be submitted to the
- 27 Local Government Commission for review and recommendation. An_
- 28 <u>agreement exclusively between a local government and an</u>
- 29 authority as defined in section 5602 (relating to definitions)
- 30 shall not be subject to the requirements under this section.

- 2 § 2315. Effect of joint cooperation agreements.
- 3 Any joint cooperation agreement shall be deemed in force as
- 4 to any local government when the agreement has been adopted by
- 5 ordinance or resolution by all cooperating local governments.
- 6 After adoption by all cooperating local governments, the
- 7 agreement shall be binding upon the local government, and its
- 8 covenants may be enforced by appropriate remedy by any one or
- 9 more of the local governments against any other local government
- 10 which is a party to the agreement.
- 11 Section 2. This act shall take effect in 60 days.
