AN ACT

1 Amending Title 4 (Amusements) of the Pennsylvania Consolidated  
2 Statutes, in table games, further providing for local share  
3 assessment; and, in revenues, further providing for  
4 establishment of State Gaming Fund and net slot machine  
5 revenue distribution.

6 The General Assembly of the Commonwealth of Pennsylvania  
7 hereby enacts as follows:

8 Section 1. Sections 13A63(b)(2)(ii) and 1403(c)(2)(ii)(D) of  
9 Title 4 of the Pennsylvania Consolidated Statutes are amended to  
10 read:

11 § 13A63. Local share assessment.

13 (b) Distributions to counties.--The department shall make  
14 quarterly distributions from the local share assessments  
15 deposited into the fund under subsection (a) to counties,  
16 including home rule counties, hosting a licensed facility  
17 authorized to conduct table games under this chapter in  
18 accordance with the following:

20 (2) If the facility is a Category 1 licensed facility

1 that is located at a thoroughbred racetrack and the county in  
2 which the licensed facility is located is:

4 (ii) Except as set forth in subparagraph (iii), a  
5 county of the third class: 50% of the licensed  
6 facility's local share assessment shall be distributed as  
7 follows:

8 (A) Fifty percent to the county to be used  
9 solely to fund the establishment of a county violent  
10 crime task force to reduce gang violence, gun  
11 trafficking and violence and drug-related crimes in  
12 the county. The district attorney shall appoint,  
13 direct and coordinate the operations and personnel of  
14 the task force.

15 (B) Fifty percent to a contiguous county  
16 containing a township that receives a portion of the  
17 licensed facility's local share assessment under  
18 subsection (c) (5) (iii).

20 § 1403. Establishment of State Gaming Fund and net slot machine  
21 revenue distribution.

23 (c) Transfers and distributions.--The department shall:

25 (2) From the local share assessment established in  
26 subsection (b), make quarterly distributions among the  
27 counties hosting a licensed facility in accordance with the  
28 following schedule:

30 (ii) If the licensed facility is a Category 1

1 licensed facility and is located at a thoroughbred  
2 racetrack and the county in which the licensed facility  
3 is located is:

5 (D) A county of the third class: [1% of the  
6 gross terminal revenue to the county hosting the  
7 licensed facility from each such licensed facility.  
8 An additional 1% of the gross terminal revenue to the  
9 county hosting the licensed facility from each such  
10 licensed facility for the purpose of municipal grants  
11 within the county in which the licensee is located.]  
12 2% of the gross terminal revenue from each such  
13 licensed facility shall be deposited and distributed  
14 as follows:

15 (I) 1% of the gross terminal revenue to the  
16 county hosting the licensed facility from each  
17 such licensed facility.

18 (II) 1% of the gross terminal revenue to a  
19 contiguous county containing a township that  
20 receives a portion of the licensed facility's  
21 local share assessment under paragraph (3)(v).
