1 2 3 4 5 6 7 8 9 10 11	Amending the act of December 20, 1985 (P.L.457, No.112), entitled "An act relating to the right to practice medicine and surgery and the right to practice medically related acts; reestablishing the State Board of Medical Education and Licensure as the State Board of Medicine and providing for its composition, powers and duties; providing for the issuance of licenses and certificates and the suspension and revocation of licenses and certificates; provided penalties; and making repeals," further providing for definitions and for State Board of Medicine; and providing for recreational therapists.
12	The General Assembly of the Commonwealth of Pennsylvania
13	hereby enacts as follows:
14	Section 1. Section 2 of the act of December 20, 1985
15	(P.L.457, No.112), known as the Medical Practice Act of 1985, is
16	amended by adding definitions to read:
17	Section 2. Definitions.
18	The following words and phrases when used in this act shall
19	have the meanings given to them in this section unless the
20	context clearly indicates otherwise:

22	"Recreational therapist." An individual licensed to practice

1 recreational therapy or therapeutic recreation. "Recreational therapy." A service designed to treat an 2 3 individual affected by an illness or disabling condition in order to accomplish any of the following: 4 5 (1) Restore, remediate or rehabilitate the individual's level of functioning and independence in play, leisure, 6 7 recreation and community activities. 8 (2) Promote health and wellness through engagement in play, leisure, recreation and community activities. 9 10 (3) Reduce or eliminate limitations and restrictions to participation in play, leisure, recreation and community 11 12 activities. * * * 13 Section 2. Section 3(a), (b) and (f) of the act are amended 14 to read: 15 State Board of Medicine. 16 Section 3. 17 Establishment.--The State Board of Medicine shall (a) 18 consist of the commissioner or his designee, the Secretary of 19 Health or his designee, two members appointed by the Governor 20 who shall be persons representing the public at large and seven members appointed by the Governor, six of whom shall be medical 21 doctors with unrestricted licenses to practice medicine and 22 23 surgery in this Commonwealth for five years immediately 24 preceding their appointment and one who shall be a nurse 25 midwife, physician assistant, certified registered nurse 26 practitioner, respiratory therapist, licensed athletic trainer [or], perfusionist or recreational therapist licensed or 27 28 certified under the laws of this Commonwealth. All professional 29 and public members of the board shall be appointed by the 30 Governor, with the advice and consent of a majority of the 20170HB0843PN0925

1 members elected to the Senate.

2 Terms of office. -- The term of each professional and (b) 3 public member of the board shall be four years or until his or her successor has been appointed and qualified, but not longer 4 than six months beyond the four-year period. In the event that 5 any of said members shall die or resign or otherwise become 6 disqualified during his or her term, a successor shall be 7 8 appointed in the same way and with the same qualifications and shall hold office for the unexpired term. No member shall be 9 10 eligible for appointment to serve more than two consecutive 11 terms. The Governor shall assure that nurse midwives, physician assistants, certified registered nurse practitioners, 12 13 perfusionists [and], respiratory therapists, athletic trainers 14 and recreational therapists are appointed to four-year terms on a rotating basis so that, of every four appointments to a four-15 16 year term, one is a nurse midwife, one is a physician assistant, one is a certified registered nurse practitioner and one is a 17 18 respiratory therapist.

[(f) Sunset.--The board is subject to evaluation, review and termination in the manner provided in the act of December 22, 1981 (P.L.508, No.142), known as the Sunset Act.]

25 <u>Section 13.7. Recreational therapist.</u>

26 (a) Licensure qualifications.--To be eligible to apply for
 27 licensure as a recreational therapist, an applicant must fulfill_

28 the following requirements:

29 (1) Be at least 18 years of age.

30 (2) Be of good moral character.

1	(3) Complete a bachelor level program or higher in
2	recreational therapy or therapeutic recreation, or a bachelor
3	level program or higher in a related field which includes
4	courses pertaining to recreational therapy or therapeutic
5	recreation as required for certification by the National
6	Council for Therapeutic Recreation Certification.
7	(4) Submit a completed application and fee as required
8	by the board by regulation.
9	(5) Complete all certification requirements for and
10	maintain certification by the National Council for
11	Therapeutic Recreation Certification.
12	(6) Not be addicted to alcohol, narcotics or other
13	habit-forming drugs.
14	(7) Have not been convicted of a felony under the act of
15	April 14, 1972 (P.L.233, No.64), known as The Controlled
16	Substance, Drug, Device and Cosmetic Act, or of an offense
17	under the laws of another jurisdiction which, if committed in
18	this Commonwealth, would be a felony under The Controlled
19	Substance, Drug, Device and Cosmetic Act, unless the
20	following apply:
21	(i) Ten years have elapsed from the date of
22	conviction.
23	(ii) The applicant satisfactorily demonstrates to
24	the board that the applicant has made significant
25	progress in personal rehabilitation since the conviction
26	and the licensure of the applicant is not expected to
27	create a substantial risk of harm to the health and
28	safety of the applicant's clients or the public or a
29	substantial risk of further criminal violations.
30	(iii) The applicant otherwise satisfies the

2	(b) Current professionalsIt shall be unlawful four years	
3	after the effective date of this section for any person to	
4	practice or indicate an ability to practice recreational therapy	
5	unless licensed under this act.	
6	(c) Duration of licenseA recreational therapist license	
7	issued under this section shall be valid for a period of two	
8	years and shall be nontransferable.	
9	(d) Title and practice protectionNo person may practice	
10	or hold himself out as being able to practice recreational	
11	therapy, use the term "recreational therapist," "licensed	
12	recreational therapist," the initials "CTRS/L" or other similar	
13	terms or provide recreational therapy services in this	
14	Commonwealth without being licensed under this act to do so.	
15	(e) Recreational therapy servicesThe techniques used by	
16	recreational therapists to treat individuals include all of the	
17	following:	
18	(1) Conducting an individualized assessment for the	
19	purpose of collecting systematic, comprehensive and accurate	
20	data necessary to determine the course of action and	
21	subsequent individualized treatment plan.	
22	(2) Planning and developing an individualized	
23	recreational therapy treatment plan that identifies an	
24	individual's goals, objectives and potential treatment	
25	intervention strategies for play, recreation, leisure and	
26	community activities.	
27	(3) Implementing an individualized recreational therapy	
28	treatment plan that is consistent with the overall treatment	
29	plan.	
30	(4) Systematically evaluating and comparing the

1	individual's response to the individualized recreational
2	therapy treatment plan and making modifications as
3	appropriate.
4	(5) Developing a discharge plan in collaboration with
5	the individual and the individual's family, treatment team
6	and other identified support networks where appropriate.
7	(6) Identifying and training in the use of adaptive
8	play, recreation and leisure equipment.
9	(7) Identifying, providing and educating individuals to
10	use play, recreation, leisure and community resources that
11	support a healthy, active and engaged life.
12	(8) Providing leisure education and counseling to
13	address issues that hinder health and engagement in play,
14	recreation, leisure and community activities.
15	(9) Providing community integration, reintegration,
16	inclusion and transitioning services to maximize health and
17	participation in play, recreation, leisure and community
18	activities.
19	(10) Addressing functional skill recovery, development
20	or maintenance related to health and participation in play,
21	recreation, leisure and community activities and utilizing
22	play, recreation, leisure and community activities as
23	modalities to advance health and functioning.
24	(11) Assisting individuals in constructing a healthy
25	leisure lifestyle that supports continued recovery, health
26	promotion and quality of life.
27	(12) Providing play, recreation, leisure and community
28	opportunities for individuals with illness, disability or
29	challenges for therapeutic purposes.
30	(13) Minimizing personal and environmental contextual

1	barriers and maximizing personal and environmental contextual
2	facilitators to enhance health and participation in play,
3	recreation, leisure and community activities.
4	(14) Collaborating with and educating the individual,
5	family, caregiver and others to foster an environment that is
6	responsive to the health, play, recreation, leisure and
7	community engagement needs of the individual.
8	(15) Consulting with groups, programs, organizations or
9	communities to improve physical, social and programmatic
10	accessibility in play, recreation, leisure and community
11	activities.
12	(f) License renewalA licensee is eligible for biennial
13	renewal of a recreational therapist license if the following
14	requirements are met:
15	(1) A completed application and fee as established by
16	regulation of the board are submitted to the board.
17	(2) Continuing education requirements as established by
18	the board have been completed.
19	(3) The applicant holds current certification as a
20	therapeutic recreational specialist by the National Council
21	for Therapeutic Recreation Certification.
22	(4) Any other requirements are met as established by the
23	board.
24	<u>(g)</u> Referrals
25	(1) Consultation and evaluation by a recreational
26	therapist may be performed without a referral.
27	(2) Recreational therapy services provided to
28	individuals with medically related conditions shall be based
29	on a referral from a qualified health care professional who,
30	within the scope of the professional's licensure, is

1	authorized to make referrals for health care services.
2	(3) A referral shall not be required for recreational
3	therapy services related to prevention, wellness, education,
4	adaptive sports and recreation.
5	(h) ConstructionNothing in this section shall be
6	construed to:
7	(1) Prohibit an individual currently holding a
8	professional license from practicing within the applicable
9	scope of practice for that individual's professional license.
10	(2) Prohibit students enrolled in a recreational therapy
11	related course of study from performing recreational therapy
12	that is incidental to their course of study or required
13	supervised work relating to their course of study.
14	(3) Prohibit an individual practicing as a music
15	therapist from providing music therapy services.
16	(4) Prohibit an individual employed by the Federal
17	Government to provide recreational therapy service while in
18	the discharge of the person's official duties.
19	Section 4. This act shall take effect in 60 days.
