AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the 3 Executive Department thereof and the administrative 4 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 6 Teachers Colleges; abolishing, creating, reorganizing or 7 authorizing the reorganization of certain administrative 8 departments, boards, and commissions; defining the powers and 9 duties of the Governor and other executive and administrative 10 11 officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 certain administrative officers, and of all deputies and 15 16 other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the 17 number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," in powers and duties of the 18 19 20 Governor and other constitutional officers and of the 21 Executive Board and of the Pennsylvania State Police, 22 providing for State trooper services contractual program. 23 24 The General Assembly of the Commonwealth of Pennsylvania 25 hereby enacts as follows: 26 The act of April 9, 1929 (P.L.177, No.175), known Section 1.
- 27 as The Administrative Code of 1929, is amended by adding a
- 28 section to read:

- 1 <u>Section 714. State Trooper Services Contractual Program.--</u>
- 2 (a) This section shall apply to a municipality and adjacent
- 3 municipalities that:
- 4 (1) currently have or, prior to January 1, 2013, had an
- 5 organized police force or contracted police coverage through a
- 6 regional or municipal police department; and
- 7 (2) disband their organized police force or eliminate their
- 8 contracted police services.
- 9 (b) If subsection (a) applies, the municipality or adjacent
- 10 <u>municipalities shall:</u>
- 11 (1) enter into an agreement with the Pennsylvania State
- 12 Police for State trooper services; and
- (2) agree to pay for the State trooper services.
- 14 (c) In order to implement this section, the Commissioner of
- 15 the Pennsylvania State Police shall enter into agreements with
- 16 boroughs and townships for the furnishing of police protection
- 17 by one or more State troopers on a contractual basis at agreed-
- 18 upon hours and locations.
- 19 (d) Moneys paid for the services under this section shall be
- 20 credited to a restricted account and used for the express
- 21 purpose of financing the services for which the contract price
- 22 was paid.
- (e) For every two thousand hours annually contracted under
- 24 this section, one full-time State trooper shall not be counted
- 25 <u>in determining the total number of officers and enlisted members</u>
- 26 in the Pennsylvania State Police.
- 27 (f) A municipality with an agreement with the Pennsylvania
- 28 State Police for State trooper services before the effective
- 29 <u>date of this section shall not be required to enter into a new</u>
- 30 agreement in accordance with this section until one year after

- 1 the effective date of this section.
- 2 (g) An agreement entered into prior to the effective date of
- 3 this section shall expire within one year of the effective date
- 4 of this section. Upon the expiration of an agreement under this
- 5 section, the following shall apply:
- 6 (1) The Pennsylvania State Police shall maintain its level
- 7 of State trooper services under the expired agreement if the
- 8 <u>municipality fails to enter into a new agreement under this</u>
- 9 section with the Pennsylvania State Police for State trooper
- 10 services or a regional or municipal police department for police
- 11 <u>services.</u>
- 12 (2) If the Pennsylvania State Police provides State trooper
- 13 services under paragraph (1), the municipality shall finance the
- 14 State trooper services by the highest amount as specified in an
- 15 <u>agreement with a municipality of similar population size as</u>
- 16 determined by the Commissioner of the Pennsylvania State Police.
- 17 If the Pennsylvania State Police has not entered into a contract
- 18 with a municipality of similar population size, the municipality
- 19 shall finance the State trooper services by the highest amount
- 20 as specified in an agreement between a municipality of similar
- 21 population size and a regional or municipal police department
- 22 for police services in the same county.
- 23 (h) If the municipality fails to enter into a new agreement
- 24 under this section with the Pennsylvania State Police for State
- 25 trooper services or a regional or municipal police department
- 26 for police services after three months from the date of the
- 27 <u>expiration of an agreement under this section</u>, the Commissioner
- 28 of the Pennsylvania State Police may assess additional fees on
- 29 the municipality as necessary to maintain current State trooper
- 30 services until the municipality enters into a new agreement

- 1 under this section with the Pennsylvania State Police for State
- 2 trooper services or a regional or municipal police department
- 3 for police services.
- 4 (i) The Pennsylvania State Police shall promulgate rules and
- 5 regulations as may be necessary to implement this section and
- 6 the contractual agreements authorized by this section. The rules
- 7 and regulations shall:
- 8 (1) Require that, as a prerequisite to contracting for the
- 9 <u>services of a State trooper, a municipality or adjacent</u>
- 10 municipalities shall adopt a resolution or ordinance authorizing
- 11 the contractual arrangement with the Pennsylvania State Police
- 12 for the payment by the municipality or adjacent municipalities
- 13 of the costs incurred in connection with the provision of the
- 14 services under this section.
- 15 (2) Require State troopers to remain under the direct
- 16 control of the Pennsylvania State Police with supervision to be
- 17 provided by the commanding officer of the field installation
- 18 having jurisdiction over the municipality or adjacent
- 19 <u>municipalities contracting for the State trooper services.</u>
- 20 (3) Require that all organizational orders, regulations and
- 21 directives by the Pennsylvania State Police apply with full
- 22 force to the assigned State troopers.
- 23 (4) Prohibit the commanding officer of the field
- 24 installation from removing a State trooper assigned under this
- 25 section from the officer's area of jurisdiction during assigned
- 26 hours except in cases of emergency, in which case the governing
- 27 body of the contracting municipality or adjacent municipalities
- 28 shall be notified.
- 29 (5) Require State troopers to enforce 75 Pa.C.S. (relating
- 30 to vehicles), criminal laws of this Commonwealth and local

- 1 ordinances regarding public safety pursuant to the agreement
- 2 with the municipality or adjacent municipalities.
- 3 Section 2. This act shall take effect immediately.
