AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, in burglary and other criminal
- intrusion, further providing for definitions, for the offense
- of burglary and for the offense of criminal trespass.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 3501 of Title 18 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding a definition to read:
- 9 § 3501. Definitions.
- 10 Subject to additional definitions contained in subsequent
- 11 provisions of this chapter which are applicable to specific
- 12 provisions of this chapter, the following words or phrases when
- 13 used in this chapter shall have, unless the context clearly
- 14 indicates otherwise, the meanings given to them in this section:
- 15 "Domestic animal." As defined in section 5511 (relating to
- 16 cruelty to animals).

- 4 (d.1) Sentencing enhancement. -- The Pennsylvania Commission
- 5 on Sentencing, in accordance with 42 Pa.C.S. § 2154 (relating to
- 6 <u>adoption of guidelines for sentencing</u>), shall provide for a
- 7 <u>sentencing enhancement for courts to consider in cases involving</u>
- 8 burglary where a domestic animal is harmed or killed in the
- 9 course of the burglary.

- 13 (c.1) Sentencing enhancement. -- The Pennsylvania Commission
- 14 on Sentencing, in accordance with 42 Pa.C.S. § 2154 (relating to
- 15 <u>adoption of guidelines for sentencing</u>), shall provide for a
- 16 <u>sentencing enhancement for courts to consider in cases involving</u>
- 17 <u>criminal trespass where a domestic animal is harmed or killed in </u>
- 18 the course of the criminal trespass.
