AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- Pennsylvania Consolidated Statutes, in juries and jurors,
- further providing for compensation of and travel allowance
- for jurors.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 4561 of Title 42 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 4561. Compensation of and travel allowance for jurors.
- 10 (a) Compensation. -- [A person summoned to serve as a juror
- 11 shall receive compensation at the rate of \$9 a day for the first
- 12 three days in any calendar year he shall be required to report
- 13 for service and \$25 a day for each day thereafter in such
- 14 calendar year that such person is required to report. In
- 15 addition, persons so summoned shall be paid a travel allowance
- 16 at the rate of 17¢ per mile circular except that no travel
- 17 allowance shall be paid in the first judicial district.
- 18 Employers shall pay a person summoned to serve as a juror at the
- 19 person's ordinary wage or salary each day the person is required

- 1 to report for service. The Commonwealth shall grant a tax credit
- 2 to the employer for the amount expended in the same calendar
- 3 <u>year.</u>
- 4 <u>(a.1) Unemployed persons.--Unemployed persons shall be</u>
- 5 compensated using the appropriate rate of unemployment
- 6 <u>compensation</u>.
- 7 (a.2) Self-employed persons. -- The Commonwealth shall grant a
- 8 self-employed person or a person whose sole means of income is
- 9 <u>commission a tax credit equal to the juror's monthly income in</u>
- 10 the previous year.
- 11 (a.3) Parking.--A person summoned to serve as a juror shall
- 12 be given a parking voucher for a nearby parking facility.
- 13 (b) State reimbursement.--[The Commonwealth shall reimburse
- 14 each county 80% of the amount expended by the county for such
- 15 compensation and travel allowance beyond the first three days of
- 16 service if the juror is participating in a trial or in grand
- 17 jury proceedings.] <u>Persons summoned to serve as jurors shall be</u>
- 18 paid a travel allowance at the rate provided by current Internal
- 19 Revenue Service regulations, except that no travel allowance
- 20 <u>shall be paid in the first judicial district.</u> Application for
- 21 reimbursement shall be made by the county to the State Treasurer
- 22 through the Administrative Office pursuant to procedures
- 23 prescribed by said office. As used in this section, trial
- 24 participation shall include voir dire examination only if such
- 25 examination shall have commenced prior to the juror's fourth day
- 26 of service.
- 27 (c) Definition.--As used in this section, the term "jurors"
- 28 does not apply to those persons summoned to serve on a
- 29 multicounty investigating grand jury who are reimbursed under
- 30 section 4553(b) (relating to expenses of investigating grand

- 1 juries and trials resulting therefrom).
- 2 Section 2. This act shall take effect in 60 days.
