AN ACT

- 1 Amending Title 3 (Agriculture) of the Pennsylvania Consolidated
- Statutes, in food protection, further providing for retail
- food facility and employee cleanliness.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 5710 of Title 3 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 5710. Retail food facility and employee cleanliness.
- 9 (a) General.--All retail food facilities, kitchens, dining
- 10 rooms and all places where foods are prepared, kept or stored
- 11 shall be kept in a clean and sanitary condition and be protected
- 12 from dust, dirt, insects and vermin in the manner prescribed by
- 13 the regulations of the department. The clothing and hands of
- 14 employees shall at all times be clean and sanitary. Except when
- 15 washing fruits and vegetables or when approved by the
- 16 department, food employees may not contact exposed, ready-to-eat
- 17 food with their bare hands and shall use suitable utensils such
- 18 as deli tissue, spatulas, tongs, single-use gloves or dispensing

- 1 equipment. No domestic pets or other animals shall be permitted
- 2 where food or drink is prepared, handled or stored unless
- 3 specifically permitted or required under the Americans with
- 4 Disabilities Act of 1990 (Public Law 101-336, 104 Stat. 327) or
- 5 other Federal or State law. No person shall be permitted to use
- 6 for living or sleeping purposes any room or place in any retail
- 7 food facility which is regularly and customarily used for the
- 8 preparation, handling, storing or serving of food.
- 9 (b) Required notice. -- The following notice shall be posted
- 10 conspicuously in all areas where food is prepared, including
- 11 where beverages are served with cut fruits or vegetables:
- 12 REMINDER ABSOLUTELY NO BARE-HAND CONTACT WITH READY-TO-EAT
- 13 FOOD, INCLUDING THE CUTTING AND SERVING OF FRUITS AND
- 14 <u>VEGETABLES FOR SALADS, DRINKS, AND GARNISHES AND ALL ITEMS</u>
- 15 SERVED IN EDIBLE CONTAINERS. USE APPROPRIATE UTENSILS, GLOVES
- OR DELI TISSUE. FOOD SERVERS SHALL NOT HANDLE MONEY WHILE
- 17 USING GLOVES.
- 18 Section 2. This act shall take effect in 60 days.
