1 2 3 4 5 6 7 8	Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in falsification and intimidation, providing for the offense of failure to comply with animal abuse registration requirements; in other offenses, providing for the offense of illegal use of animal abuse registry information; and, in sentencing, providing for registration of animal abuse offenders.

11	Section 1. Title 18 of the Pennsylvania Consolidated

2	(2) provide accurate information when registering under
3	<u>42 Pa.C.S. § 9799.54.</u>
4	(b) Grading
5	(1) Except as set forth in paragraph (2), an individual
6	<u>subject to registration under 42 Pa.C.S. § 9799.54 who</u>
7	commits a violation of subsection (a) or a similar offense
8	commits a felony of the third degree.
9	(2) An individual subject to registration under 42
10	Pa.C.S. § 9799.54 who commits a violation of subsection (a)
11	and who has previously been convicted of an offense under
12	subsection (a) or a similar offense commits a felony of the
13	second degree.

- 29 safety of animals that are at risk of abuse will be enhanced by

1	available to the public through the Internet, by telephone,
2	through written access and in person. Knowledge of the identity
3	of offenders or repeat offenders can be a significant factor in
4	protecting pets and animals from recidivist acts. The technology
5	afforded by the Internet would make this information readily
6	accessible to the public, enabling them to undertake appropriate
7	remedial precautions. Public access to information about
8	offenders and repeat offenders is intended solely as a means of
9	protection for the pets and animals of the public that are at
10	risk of abuse and shall not be construed as punitive. An
11	individual is authorized to use the information contained in the
12	central animal abuse registry and the local animal abuse
13	registry for protecting animals at risk of abuse.
14	<u>§ 9799.53. Animal abuse registries.</u>
15	The following apply:
16	(1) The county sheriff shall establish and maintain a
17	local registry of offenders and repeat offenders in the
18	sheriff's jurisdiction to be known as the local animal abuse
19	registry. The county sheriff shall:
20	(i) Forward all registration information obtained
21	under section 9799.54(c) (relating to registration
22	requirements) to the Pennsylvania State Police.
23	(ii) Within 10 days of receipt of an initial
24	registration from an offender or repeat offender, contact
25	and provide all county residences, schools, humane
26	societies, animal shelters and any other business within
27	<u>a half-mile radius of the offender's or repeat offender's</u>
28	residence or location with the registration information
29	of the offender or repeat offender, except for the
30	offender's or repeat offender's Social Security number.

1	(2) The Pennsylvania State Police shall establish and
2	maintain a central registry of offenders and repeat offenders
3	to be known as the central animal abuse registry. Information
4	contained in the central animal abuse registry of offenders
5	and repeat offenders shall be made available to the public
6	through a publicly accessible Internet website, by telephone,
7	through written access and in person. All of the information
8	contained in an offender's or repeat offender's registration,
9	with the exception of the Social Security number or any other
10	information protected by law, shall be made available to the
11	public. Records of each registration shall be maintained for
12	the seven-year period that an offender is required to be
13	registered. Records of each registration shall be maintained
14	during the periods that a repeat offender is required to be
15	registered.

14	(1) An offender or repeat offender shall provide the
15	county sheriff with the following information for entry in
16	the animal abuse registry:
17	(i) Legal name and any other names or aliases that
18	the offender or repeat offender uses or has used.
19	(ii) Date of birth.
20	(iii) Social Security number.
21	(iv) Current address or location.
22	(v) Place of employment.
23	(vi) The offense the offender or repeat offender was
24	convicted of and the date and location of the offense.
25	(vii) The county or counties in this Commonwealth
26	where the offender or repeat offender is registered under
27	this section.
28	(2) (i) The county sheriff shall obtain the following:
29	(A) A photograph of the offender or repeat
30	offender.

1	(B) A description of any tattoos, scars or other
2	distinguishing features on the offender's or repeat
3	offender's body that would assist in identifying the
4	offender or repeat offender.
5	(C) A full set of fingerprints of the offender
6	<u>or repeat offender.</u>
7	(ii) Fingerprints and photographs obtained under
8	this paragraph may be maintained for use under this
9	subchapter and for general law enforcement purposes.
10	(d) Sentencing court informationThe sentencing court
11	shall inform offenders and repeat offenders at the time of
12	sentencing of the provisions of this subchapter. The court
13	shall:
14	(1) Inform the offender or repeat offender of the duty
15	to register and provide the information required for
16	registration.
17	(2) Inform the offender or repeat offender of the duty
18	to inform the county sheriff within 10 days if the offender
19	or repeat offender does the following:
20	(i) changes residence or establishes an additional
21	residence or residences;
22	(ii) changes employer or employment location for a
23	period of time that exceeds 14 days or for an aggregate
24	period of time that will exceed 30 days during any
25	<u>calendar year or terminates employment; or</u>
26	(iii) changes institution or location at which the
27	offender or repeat offender is enrolled as a student or
28	terminates enrollment.
29	(3) Inform the offender or repeat offender of the duty
30	to register with a new law enforcement agency if the offender

1	or repeat offender moves to another state no later than 10
2	days after establishing residence in another state and if the
3	state requires such registration.
4	(4) Inform the offender or repeat offender of the duty
5	to register with the appropriate authorities in any state in
6	which the offender or repeat offender is employed, carries on
7	<u>a vocation or is a student if the state requires such</u>
8	registration.
9	(5) Require the offender or repeat offender to read and
10	sign a form stating that the duty to register under this
11	section has been provided in writing and has been explained.
12	If the offender or repeat offender is incapable of reading,
13	the court shall certify the duty to register was explained to
14	the offender or repeat offender and the offender or repeat
15	offender indicated an understanding of the duty.

17	The following entities shall be immune from liability for
18	good faith conduct under this subchapter:
19	(1) The Pennsylvania State Police and local law
20	enforcement agencies and employees of law enforcement
21	agencies.

23	office of sheriff of a county.
24	(3) District attorneys and their agents and employees.
25	(4) The Pennsylvania Department of Corrections and its
26	agents and employees.
27	(5) County correctional facilities and their agents and
28	employees.
