AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 2 3 primary and election expenses and election contests; creating 4 and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, 6 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 7 8 revising and consolidating the laws relating thereto; and 9 repealing certain acts and parts of acts relating to 10 elections," in dates of elections and primaries and special elections, further providing for nominations for special 11 12 election for Representative in Congress, Senator and 13 Representative in the General Assembly and member of council 14 or legislative body of cities, boroughs, towns and townships, 15 providing for special election for Senator or Representative 16 in General Assembly, creating the Special Election Fund and 17 imposing duties on the Department of State. 18 19 The General Assembly of the Commonwealth of Pennsylvania 20 hereby enacts as follows: 21 Section 1. Section 629 of the act of June 3, 1937 (P.L.1333, 22 No.320), known as the Pennsylvania Election Code, is amended to 23 read: 24 Section 629. Nominations for Special Election for Representative in Congress, Senator and Representative in the 25

General Assembly and Member of Council or Legislative Body of

- 1 Cities, Boroughs, Towns and Townships. -- [Candidates] Subject to
- 2 section 629.1 of this act, candidates to fill vacancies in the
- 3 offices of Representative in Congress, Senator and
- 4 Representative in the General Assembly and member of the council
- 5 or legislative body of any city, borough, town or township shall
- 6 be nominated by political parties, in accordance with the party
- 7 rules relating to the filling of vacancies, by means of
- 8 nomination certificates, in the form prescribed in section 630
- 9 of this act; and by political bodies, by means of nomination
- 10 papers, in accordance with the provisions of sections 951, 952
- 11 and 954 of this act. Said nomination certificates and nomination
- 12 papers for the office of Representative in Congress, Senator and
- 13 Representative in the General Assembly shall be filed in the
- 14 office of the Secretary of the Commonwealth not later than fifty
- 15 (50) days prior to the date of the special election, and for the
- 16 office of member of the council or legislative body of a city,
- 17 borough, town or township, in the office of the county board of
- 18 elections wherein such city, borough, town or township is
- 19 situate, not later than fifteen (15) days after the issuance of
- 20 the writ of election.
- 21 Section 2. The act is amended by adding a section to read:
- 22 Section 629.1. Special Election for Senator or
- 23 Representative in General Assembly. -- (a) Notwithstanding any
- 24 other provision of law, an individual who seeks consideration as
- 25 <u>a candidate in a special election for Senator or Representative</u>
- 26 in the General Assembly shall do all of the following:
- 27 (1) File with the chairperson of the political party with
- 28 whom the individual is affiliated within each county in which
- 29 the legislative district is located, on a form prescribed by the
- 30 <u>department</u>, the following information:

- 1 (i) The name of the individual.
- 2 (ii) The residence and contact information of the
- 3 individual, including, as applicable, street address, telephone
- 4 number and e-mail address.
- 5 (iii) The name of the office for which the individual seeks
- 6 to become a candidate in the special election.
- 7 <u>(iv) Other information required by the department.</u>
- 8 (2) Pay a filing fee in the amount of two hundred fifty
- 9 dollars (\$250) to the fund, which the department shall
- 10 distribute on a pro rata basis to the political party of each
- 11 county in which the legislative district is located.
- 12 <u>(3) Either of the following:</u>
- (i) Prepare a short video announcing the individual's
- 14 <u>interest in becoming a candidate in the special election. The</u>
- 15 <u>following shall apply:</u>
- 16 (A) The video shall be made available to be posted on the
- 17 department's publicly accessible Internet website and made
- 18 available for public broadcast on the Pennsylvania Cable Network
- 19 <u>or its assigns or successors.</u>
- 20 (B) The department shall determine whether it would be
- 21 appropriate to have the video posted or broadcast on another
- 22 form of media, including social media.
- 23 (C) The individual shall be responsible for all costs
- 24 associated with the preparation of the video and any costs
- 25 <u>associated with the posting or broadcast of the video.</u>
- 26 (D) For the purpose of enabling the general public to be
- 27 <u>better informed regarding prospective candidates for the special</u>
- 28 election, the video shall be available no fewer than ten (10)
- 29 days prior to the nomination of the candidate for the special
- 30 election and shall remain online or otherwise available to the

- 1 general public until the date of the certification of the
- 2 <u>candidate for the special election</u>.
- 3 (ii) File with the chairperson of the political party with
- 4 whom the individual is affiliated within each county in which
- 5 the legislative district is located, on a form prescribed by the
- 6 <u>department</u>, a statement that the individual wishes to opt out of
- 7 preparing the video and having the video posted or broadcast
- 8 <u>under subparagraph (i).</u>
- 9 (b) Each chairperson of the political party described under
- 10 subsection (a) (1) shall schedule a public meeting of elected
- 11 party committee members from the legislative district to
- 12 <u>consider each individual who seeks consideration as a candidate</u>
- 13 in the special election. The following shall apply:
- 14 (1) The chairperson shall ensure that each voting district
- 15 <u>in the county's legislative district which shall hold the</u>
- 16 <u>special election is fairly represented at the public meeting.</u>
- 17 (2) For the purpose of conducting the public meeting, no
- 18 fewer than a majority of the elected committee members from each
- 19 voting district must be present at the public meeting.
- 20 (3) The public meeting shall be advertised in at least one
- 21 <u>local newspaper of general circulation or on another local media</u>
- 22 outlet no fewer than fourteen (14) days before the public
- 23 meeting and the nomination of the candidate for the special
- 24 election.
- 25 (c) The Special Election Fund is established as a separate
- 26 restricted account within the General Fund to distribute money
- 27 to county political parties as described in subsection (a)(2).
- 28 (d) The department shall develop forms and promulgate rules
- 29 and regulations necessary to implement the provisions of this
- 30 section.

- 1 (e) As used in this section, the following words and phrases
- 2 <u>shall have the meanings given to them in this subsection unless</u>
- 3 the context clearly indicates otherwise:
- 4 <u>"Department." The Department of State of the Commonwealth.</u>
- 5 <u>"Fund." The Special Election Fund established under</u>
- 6 <u>subsection (c).</u>
- 7 Section 3. This act shall take effect in 60 days.
