AN ACT

Amending the act of April 14, 1972 (P.L.233, No.64), entitled "An act relating to the manufacture, sale and possession of controlled substances, other drugs, devices and cosmetics; conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, Device and Cosmetic Board; establishing schedules of 5 6 controlled substances; providing penalties; requiring 7 registration of persons engaged in the drug trade and for the revocation or suspension of certain licenses and 9 registrations; and repealing an act," providing for 10 dispensing of fentanyl. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. The act of April 14, 1972 (P.L.233, No.64), known 15 as The Controlled Substance, Drug, Device and Cosmetic Act, is amended by adding a section to read: 16 Section 4.1. Dispensing of Fentanyl. -- (a) Fentanyl and 17 fentanyl derivatives, as used in section 4(1)(ii)23, shall only 19 be dispensed: 20 (1) To a patient who is being treated on an in-patient basis

or remains in observation status, or during a surgery that takes

- 2 act of July 19, 1979 (P.L.130, No.48), known as the "Health Care
- 3 Facilities Act."
- 4 (2) For use in palliative or hospice care.
- 5 (3) For use in the management of pain associated with
- 6 cancer.
- 7 (4) FOR USE IN THE MANAGEMENT OF CHRONIC PAIN NOT ASSOCIATED <--
- 8 WITH CANCER. IN ORDER FOR THIS PARAGRAPH TO APPLY, THE
- 9 PRESCRIBER MUST:
- 10 (I) DOCUMENT THE CHRONIC MEDICAL CONDITION IN THE
- 11 INDIVIDUAL'S MEDICAL RECORD MAINTAINED BY THE PRESCRIBER.
- 12 (II) STATE THE REASON WHY ANOTHER MEDICATION IS NOT
- 13 APPROPRIATE TO ADDRESS THE CHRONIC MEDICAL CONDITION.
- 14 (5) To a patient whose treatment is associated with a <--
- 15 medical emergency as documented in the individual's medical
- 16 record.
- 17 (b) In instances where, in the professional medical judgment
- 18 of the prescriber, fentanyl is required to stabilize an
- 19 individual's acute medical condition, the prescriber may
- 20 prescribe no more than a seven-day supply of fentanyl. In order
- 21 for this subsection to apply, the prescriber must:
- 22 (1) document the acute medical condition in the individual's
- 23 medical record with the prescriber; and
- 24 (2) state the reason why another medication is not
- 25 appropriate to address the acute medical condition.
- 26 (c) The department, in consultation with the Pennsylvania
- 27 State Police, shall issue an annual report to the General
- 28 Assembly. The report shall contain the following:
- 29 (1) Information on the number of overdoses related to
- 30 fentanyl and the number of overdoses where fentanyl and opioids

- 1 were present.
- 2 (2) Any reduction in the dispensing of fentanyl.
- 3 (d) This section shall expire two years after the effective
- 4 <u>date of this section</u>.
- 5 (e) As used in this section, the term "prescriber" shall
- 6 have the meaning given to it in section 3 of the act of October
- 7 <u>27, 2014 (P.L.2911, No.191), known as the "Achieving Better Care</u>
- 8 by Monitoring All Prescriptions Program (ABC-MAP) Act."
- 9 Section 2. This act shall take effect in 60 days.
