AN ACT

1 Amending Title 72 (Taxation and Fiscal Affairs) of the
2 Pennsylvania Consolidated Statutes, providing for preliminary
3 provisions, for taxation, for fiscal affairs and for
4 Commonwealth agency employees.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Title 72 of the Pennsylvania Consolidated

12 10001. Short title of chapter.

14 § 10001. Short title of chapter.

15 This chapter shall be known and may be cited as the Truth in
16 Hiring Act.

17 § 10002. Definitions.

18 The following words and phrases when used in this chapter
19 shall have the meanings given to them in this section unless the
20 context clearly indicates otherwise:

21 "Commonwealth agency." Any department, board, commission or
22 office of the executive branch under the policy supervision and
23 control of the Governor.

24 "Independent agency." Any department, board, commission or
25 office of the executive branch which is not under the policy
26 supervision or control of the Governor. The term includes:

27 (1) The Treasury Department.

28 (2) The Department of the Auditor General.

29 (3) The Office of Attorney General.

30 "Secretary." The Secretary of the Commonwealth.

10 Governor's office.

11 The Governor's office may not impose a fee, charge or other
12 assessment on a Commonwealth agency or an independent agency to
13 pay the salary or costs associated with an employee of the
14 Governor's office for services rendered by the Governor's office
15 on behalf of a Commonwealth agency or independent agency.

16 § 10012. Salaries or costs associated with employees of
17 Commonwealth agencies.

18 A Commonwealth agency may not impose a fee, charge or other
19 assessment on another Commonwealth agency or an independent
20 agency to pay the salary or costs associated with an employee of
21 the Commonwealth agency for services rendered on behalf of the
22 other Commonwealth agency or independent agency.

23 § 10013. Duties of secretary.

24 No later than 30 days after the effective date of this
25 section, the secretary shall provide the following information
26 to the President pro tempore of the Senate and the Speaker of
27 the House of Representatives:

28 (1) The total number of employees of each Commonwealth
29 agency, including the costs associated with the employees.

30 (2) The total amount of funds from augmentation

1 appropriations received by Commonwealth agencies from other
2 Commonwealth agencies to pay for the costs associated with
3 employees of the Commonwealth agencies.

4 (3) The current funding for general government
5 operations funding for each Commonwealth agency.

6 Section 2. This act shall take effect in 60 days.
