## AN ACT

- 1 Authorizing the Department of Conservation and Natural
- 2 Resources, with the approval of the Governor, to grant and
- 3 convey to Robbie S. Cohen-Millstein certain lands situate in
- Nockamixon Township, Bucks County, in exchange for Robbie S.
- 5 Cohen-Millstein granting and conveying certain lands to the
- 6 Commonwealth of Pennsylvania, Department of Conservation and
- Natural Resources, to be added to those existing lands at
- 8 Delaware Canal State Park.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. Conveyance in Nockamixon Township, Bucks County.
- 12 (a) Authorization. -- The Department of Conservation and
- 13 Natural Resources, with the approval of the Governor, is hereby
- 14 authorized on behalf of the Commonwealth of Pennsylvania to
- 15 grant and convey to Robbie S. Cohen-Millstein certain lands
- 16 situate in Nockamixon Township, Bucks County, in exchange for
- 17 that certain property to be conveyed to the Commonwealth of
- 18 Pennsylvania, acting by and through the Department of
- 19 Conservation and Natural Resources, in accordance with
- 20 subsection (c).
- 21 (b) Conveyance of lands to Robbie S. Cohen-Millstein.--The

- 1 property to be conveyed in accordance with this act consists of
- 2 approximately 0.10 acres, located in Nockamixon Township, Bucks
- 3 County, Commonwealth of Pennsylvania, bounded and described as
- 4 follows: BEGINNING at an iron pipe on the line between the
- 5 property formerly of Margaret Cowperthwaite and the property now
- 6 or late of Robert and Rebecca Ranieri, said iron pipe being on
- 7 the north side, 13.6 feet perpendicular from the centerline of
- 8 State Route 32, thence N  $28^{\circ}5'$  W, 62.35 feet to a point in
- 9 Gallows Run, thence in and along Gallows Run, N 58°15' E, 56.64
- 10 feet to a point 8 feet southwestwardly from the edge of the
- 11 Delaware Canal, thence along the bank of the Canal, S 62°53' E,
- 12 19.88 feet to a point 8 feet southwestwardly from the edge of
- 13 the Delaware Canal, thence parallel to the bank of the Canal, S
- 14 44°08' E, 26.95 feet to a point, thence along land of Robbie S.
- 15 Cohen-Millstein, S 45°52' W, 31.45 feet to a point on the west
- 16 edge of a stone wall, thence along land of said Cohen-Millstein,
- 17 along the edge of the said stone wall, S 27°30' E, 33.3 feet to
- 18 a point along the edge of State Route 32, thence along the edge
- 19 of State Route 32, S 84°5' W, 48.33 feet to place of beginning.
- 20 BEING the same premises conveyed to the Commonwealth of
- 21 Pennsylvania from Margaret Cowperthwaite, by deed dated October
- 22 12th, 1967 and recorded November 16th, 1967 in the Bucks County
- 23 Recorder of Deeds Office at Book 1882, Page 904.
- 24 (c) Conveyance of lands to Commonwealth. -- The property to be
- 25 conveyed in accordance with this act consists of approximately
- 26 0.25 acres, located in Nockamixon Township, Bucks County,
- 27 Commonwealth of Pennsylvania, bounded and described as follows:
- 28 BOUNDED on the West by lands of Gregory and Jane Wuerstle, on
- 29 the North by the Delaware River, on the East by Gallows Run, and
- 30 on the South by the towpath of the Delaware Canal. BEING known

- 1 as Bucks County, Pennsylvania tax map number 30-008-045. BEING
- 2 part of the same premises conveyed to Robbie S. Millstein by
- 3 deed dated December 30th, 2013 and recorded December 31st, 2013
- 4 in the Bucks County Recorder of Deeds Office as Instrument
- 5 Number 2013101582.
- 6 (d) Conditions of conveyance. -- The conveyances described in
- 7 this section shall be made concurrently and under and subject to
- 8 all lawful and enforceable easements, servitudes and rights of
- 9 others, including, but not limited to, streets, roadways and
- 10 rights of any telephone, telegraph, water, electric, gas or
- 11 pipeline companies, as well as under and subject to any lawful
- 12 and enforceable estates or tenancies vested in third persons
- 13 appearing of record, for any portion of the land or improvements
- 14 erected thereon.
- 15 (e) Deeds.--The deed of conveyance of the property described
- 16 in subsection (b) shall be by special warranty deed and shall be
- 17 executed by the Secretary of Conservation and Natural Resources
- 18 in the name of the Commonwealth of Pennsylvania.
- 19 (f) Costs and fees. -- All costs and fees incidental to the
- 20 conveyances contained in this section shall be borne by their
- 21 respective parties. This provision shall not apply to any taxes
- 22 to which the Commonwealth is immune.
- 23 (g) Time period for conveyances. -- In the event that these
- 24 conveyances are not executed by December 31, 2019, the
- 25 authorization contained in this section shall become null and
- 26 void.
- 27 Section 2. Effective date.
- This act shall take effect immediately.
