AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled, as amended, "An act relating to the finances of the State 2 government; providing for cancer control, prevention and 3 research, for ambulatory surgical center data collection and for the Joint Underwriting Association, providing for the settlement, assessment, collection, and lien of taxes, bonus, 6 and all other accounts due the Commonwealth, the collection and recovery of fees and other money or property due or 8 9 belonging to the Commonwealth, or any agency thereof, 10 including escheated property and the proceeds of its sale, the custody and disbursement or other disposition of funds 11 and securities belonging to or in the possession of the 12 Commonwealth, and the settlement of claims against the 13 Commonwealth, the resettlement of accounts and appeals to the 14 courts, refunds of moneys erroneously paid to the 15 Commonwealth, auditing the accounts of the Commonwealth and 16 all agencies thereof, of all public officers collecting 17 moneys payable to the Commonwealth, or any agency thereof, 18 and all receipts of appropriations from the Commonwealth, 19 20 authorizing the Commonwealth to issue tax anticipation notes to defray current expenses, implementing the provisions of 21 section 7(a) of Article VIII of the Constitution of 22 Pennsylvania authorizing and restricting the incurring of 23 certain debt and imposing penalties; affecting every 24 department, board, commission, and officer of the State 25 government, every political subdivision of the State, and 26 certain officers of such subdivisions, every person, 27 association, and corporation required to pay, assess, or 28 29 collect taxes, or to make returns or reports under the laws imposing taxes for State purposes, or to pay license fees or 30 31 other moneys to the Commonwealth, or any agency thereof, every State depository and every debtor or creditor of the 32 Commonwealth," in Treasury Department, further providing for 33 34 investment of moneys.

- 1 The General Assembly of the Commonwealth of Pennsylvania
- 2 hereby enacts as follows:
- 3 Section 1. Section 301.1(i)(2) of the act of April 9, 1929
- 4 (P.L.343, No.176), known as The Fiscal Code, is amended to read:
- 5 Section 301.1. Investment of Moneys.--* * *
- 6 (i) * * *
- 7 (2) The authority to invest or reinvest the moneys of any
- 8 fund pursuant to this subsection shall expire December 31,
- 9 [2019] <u>2021</u>. The Treasury Department may maintain investments
- 10 pursuant to this subsection which are in existence on the
- 11 expiration date in this paragraph for not more than two years
- 12 following such expiration date.
- 13 Section 2. This act shall take effect immediately.
