A RESOLUTION

1 Designating February 8, 2017, as "Peripartum Cardiomyopathy  
2 Awareness Day" in Pennsylvania and urging the National  
3 Institutes of Health to recognize "Peripartum Cardiomyopathy  
4 Awareness Day" and to advance research relating to peripartum  
5 cardiomyopathy.

6 WHEREAS, Peripartum cardiomyopathy is a rare disorder in  
7 which a pregnant woman's heart becomes weakened and enlarged  
8 during the final stages of pregnancy or within five months of  
9 giving birth; and

10 WHEREAS, The cause is unknown and patients often have no  
11 history of heart disease; and

12 WHEREAS, Peripartum cardiomyopathy may occur in childbearing  
13 women of any age but is most common after age 30; and

14 WHEREAS, Symptoms include breathing difficulty when lying  
15 flat, shortness of breath on exertion, swelling, frequent  
16 nighttime urination, cough, excessive weight gain in the final  
17 month of pregnancy, heart palpitations, chest pain and enlarged

1 left heart ventricle; and

2 WHEREAS, The breathing difficulty, often ignored as a normal  
3 symptom in the late stages of pregnancy, increases the risk of  
4 potentially fatal complications; and

5 WHEREAS, While some women remain stable for long periods,  
6 others experience a rapid deterioration in health and show no  
7 improvement with medical therapy; and

8 WHEREAS, These women may require cardiac transplantation or,  
9 in severe cases, may die of heart failure, thromboembolic events  
10 or cardiac arrhythmias; and

11 WHEREAS, For a woman whose heart returns to normal size after  
12 the baby is born, the outcome is positive; and

13 WHEREAS, For a woman whose heart remains enlarged, future  
14 pregnancies may result in heart failure; and

15 WHEREAS, Women should understand the importance of contacting  
16 their health care provider if they are pregnant or have recently  
17 delivered a baby and are experiencing signs of peripartum  
18 cardiomyopathy; and

19 WHEREAS, Awareness is the key to successful outcomes in  
20 peripartum cardiomyopathy; therefore be it

21 RESOLVED, That the House of Representatives of the  
22 Commonwealth of Pennsylvania designate February 8, 2017, as  
23 "Peripartum Cardiomyopathy Awareness Day" in Pennsylvania and  
24 urge all residents to recognize that peripartum cardiomyopathy  
25 is a serious threat to women's health; and be it further

26 RESOLVED, That the House of Representatives of the  
27 Commonwealth of Pennsylvania urge the National Institutes of  
28 Health to recognize "Peripartum Cardiomyopathy Awareness Day"  
29 and continue research aimed at obtaining a better understanding  
30 of this condition; and be it further

1       RESOLVED, That the House of Representatives of the  
2 Commonwealth of Pennsylvania encourage all women to take charge  
3 of their cardiovascular health; and be it further

4       RESOLVED, That a copy of this resolution be transmitted to
