A RESOLUTION

1 2 3	Recognizing October 29, 2017, as "Psoriasis Day" in Pennsylvania on behalf of the many individuals who suffer from psoriasis and psoriatic arthritis.
4	WHEREAS, Psoriasis is a common autoimmune disease that
5	appears on the skin as red, itchy and scaly patches, affecting
6	7.5 million Americans and 125 million individuals worldwide; and
7	WHEREAS, Numerous studies have concluded that psoriasis is
8	linked to many other serious medical conditions, including
9	psoriatic arthritis, cardiovascular disease, cancer and
10	lymphoma, chronic obstructive pulmonary disease, obesity and
11	metabolic syndrome, diabetes, depression, sexual dysfunction and
12	sleep apnea; and
13	WHEREAS, An observational study conducted by the American
14	Medical Association found that patients with psoriasis have an
15	increased risk of peripheral vascular disease, cerebrovascular
16	disease and ischemic heart disease; and

1 WHEREAS, The Department of Dermatology at the University of 2 Pennsylvania established a link between severe psoriasis and an 3 approximately 50% increased risk for cardiovascular disease and 4 that the risk of death from major adverse cardiovascular events 5 increases by 57% for individuals living with severe psoriasis; 6 and

7 WHEREAS, The International Federation of Psoriasis 8 Associations (IFPA) is a nonprofit organization of psoriasis 9 support organizations around the world advocating for improved 10 medical care and increased research programs, and educating the 11 public about this disease; and

12 WHEREAS, The IFPA has celebrated "World Psoriasis Day" 13 annually since 2004 to rally support for psoriasis sufferers and 14 discuss significant issues affecting the world's psoriasis 15 community; and

16 WHEREAS, By establishing "World Psoriasis Day," IFPA hopes to 17 raise awareness, improve access to treatment, increase 18 understanding and build unity among the general public and 19 individuals afflicted with psoriasis; and

20 WHEREAS, The National Psoriasis Foundation (NPF) is the 21 leading organization in the nation advocating on behalf of 22 individuals suffering from psoriasis and raising funds for 23 research programs focused on finding a cure for this condition; 24 and

25 WHEREAS, The NPF also represents the United States in the 26 IFPA; and

27 WHEREAS, October 29, 2017, marks the 13th anniversary of 28 "World Psoriasis Day" designated by the IFPA in order to 29 increase public awareness of psoriasis and psoriatic arthritis; 30 therefore be it
