- Designating the month of October 2017 as "Community Planning Month" in Pennsylvania.

- 4 suburbs, counties, boroughs, townships, rural areas and other

- 6 WHEREAS, Community planning and plans can help manage this
- 7 change in a way that provides better choices for how people work
- 8 and live; and
- 9 WHEREAS, The full benefits of planning requires public
- 10 officials and residents who understand, support and demand
- 11 excellence in planning and plan implementation; and
- 12 WHEREAS, Community planning provides an opportunity for all
- 13 residents to be meaningfully involved in making choices that
- 14 determine the future of their community; and
- 15 WHEREAS, Community planning has a long history in this
- 16 Commonwealth and dates back to William Penn's plan for

- 1 Philadelphia; and
- 2 WHEREAS, More than 10,000 residents serve on municipal
- 3 planning commissions in this Commonwealth, working with public
- 4 and private sector professional planners to enhance the quality
- 5 of life in our communities; and
- 6 WHEREAS, The Pennsylvania Chapter of the American Planning
- 7 Association is holding its annual Statewide conference in the
- 8 State College region October 22 through 24, 2017; and
- 9 WHEREAS, The month of October is designated as "National
- 10 Community Planning Month" throughout the United States and its
- 11 territories; and
- 12 WHEREAS, The American Planning Association and its
- 13 professional institute, the American Institute of Certified
- 14 Planners, endorse "National Community Planning Month" in order
- 15 to highlight the contributions that planning and plan
- 16 implementation make to the quality of our communities and our
- 17 environment; and
- 18 WHEREAS, The celebration of "National Community Planning
- 19 Month" gives us the opportunity to publicly recognize the
- 20 participation and dedication of the members of planning
- 21 commissioners and other resident planners; and
- 22 WHEREAS, We recognize the many valuable contributions made by
- 23 professional community planners and professional regional
- 24 planners, working in the public and private sectors in this
- 25 Commonwealth and extend our heartfelt thanks for the continued
- 26 commitment to public service by these professionals; therefore
