## AN ACT

- Amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in support matters generally, further 2 providing for information to consumer reporting agency, for 3 general administration of support matters and for expedited 4 procedure. 5 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 4303 of Title 23 of the Pennsylvania 8 Consolidated Statutes is amended to read: 10 § 4303. Information to consumer reporting agency. 11 (a) Overdue support. -- Information regarding the name and the 12 amount of arrearages owed by an obligor shall be provided 13 periodically to consumer reporting agencies whenever the obligor owes overdue support, subject to the following: 14 15 (1)The information shall be available only after the 16 obligor owing the arrearages has been notified of the 17 proposed action and given a period not to exceed 20 days to

- 13 support to the domestic relations section under section 4325

- 18 (a) Powers and duties. -- Subject to any inconsistent general
- 19 rules and to the supervision and direction of the court, the
- 20 domestic relations section shall have the power and duty to:

- an obligor, provide monthly reporting to a credit reporting
- 24 <u>agency concerning the timely payments of support under</u>

- 1 (g) Payment record. -- A copy of the record of support
- 2 payments prepared by the domestic relations section and
- 3 certified as a true copy of the original by the custodian of the
- 4 record is evidence of facts asserted in it and is admissible to
- 5 show whether payments were made[.] in any civil proceeding,
- 6 <u>including an action under Title 13 (relating to commercial code)</u>
- 7 and for purposes of any consumer credit reporting.
