## AN ACT

- 1 Providing for academic excellence scholarships for individuals
- entering a college or university within this Commonwealth;
- and conferring powers and imposing duties on the Pennsylvania
- 4 Higher Education Assistance Agency.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Academic
- 9 Excellence Scholarship Program Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Agency." The Pennsylvania Higher Education Assistance
- 15 Agency.
- 16 "Approved educational institution." A postsecondary
- 17 educational institution located in this Commonwealth that is
- 18 authorized to provide approved courses of study and grant
- 19 degrees and has been approved by the Pennsylvania Higher

- 1 Education Assistance Agency as an institution in which students
- 2 may enroll to participate in the Academic Excellence Scholarship
- 3 Program.
- 4 "Program." The Academic Excellence Scholarship Program
- 5 established by this act.
- 6 "Student." An individual domiciled in this Commonwealth who
- 7 attends or is about to attend a secondary school or
- 8 postsecondary educational institution located in this
- 9 Commonwealth and whose annual family income does not exceed
- 10 \$250,000.
- "Work requirement." Postgraduate, full-time employment with
- 12 an employer located in this Commonwealth. The term does not
- 13 include a paid student internship, a paid fellowship, volunteer
- 14 service or employment before graduation.
- 15 Section 3. Academic Excellence Scholarship Program.
- The Academic Excellence Scholarship Program is established
- 17 within the agency to reward academic excellence and provide an
- 18 incentive for Pennsylvania students to pursue higher education
- 19 and professional opportunities within this Commonwealth.
- 20 Section 4. Scholarship grants.
- 21 (a) Issuance. -- The agency may provide scholarship grants
- 22 annually to eligible students who are residents of this
- 23 Commonwealth. A scholarship grant may be issued to a student
- 24 only upon confirmation from an approved educational institution
- 25 that the student has enrolled full time no later than the fall
- 26 semester immediately following high school graduation.
- 27 (b) Amount. -- Scholarship grants shall be for the amount set
- 28 forth in section 5(a) and may only be used for tuition and
- 29 mandatory fees.
- 30 (c) Award.--A scholarship program grant shall be awarded

- 1 solely on the basis of merit.
- 2 (d) Eligibility. -- To receive a scholarship grant under this
- 3 act, a student must meet all of the following requirements:
- 4 (1) Maintenance of Pennsylvania domicile during the term
- 5 of the scholarship grant.
- 6 (2) Graduation within the top 5% of students from a high
- 7 school in this Commonwealth. The student must have attended a
- 8 public or private high school within this Commonwealth during
- 9 the junior and senior years.
- 10 (3) High school cumulative grade point average of 3.0 or
- 11 higher, on a scale of 4.0, or its equivalent.
- 12 (4) A score of no less than 1400 on the SAT or an ACT
- 13 score of no less than 32.
- 14 (5) Maintenance of a grade point average of 3.0 or
- higher, on a scale of 4.0, or its equivalent.
- 16 (6) Entrance into a written agreement with the agency
- 17 to:
- 18 (i) Satisfy all degree requirements for graduation.
- 19 (ii) Commence employment in this Commonwealth within
- one year after completion of an undergraduate degree for
- 21 a period of one year for each academic year the student
- received a scholarship grant under this act unless the
- agency determines that there are extenuating
- 24 circumstances.
- 25 (iii) Reimburse the Commonwealth all amounts
- 26 received under this act and interest thereon, as
- 27 determined by the agency, if the student fails to comply
- with subparagraph (i) or (ii).
- 29 (e) Application. -- A student shall apply to the agency for a
- 30 scholarship grant as prescribed by the agency and provide all

- 1 information and documentation required by the agency. The
- 2 application of a student under 18 years of age shall include the
- 3 signature of a parent or guardian. The application shall include
- 4 a verified statement of grade point average from the appropriate
- 5 educational institution.
- 6 (f) Work requirement. -- The work requirement under subsection
- 7 (d)(6)(ii) shall begin after receipt of a bachelor's degree from
- 8 an approved educational institution.
- 9 (g) Termination.--If a student who has received a
- 10 scholarship grant terminates enrollment in the approved
- 11 educational institution during the academic year or prior to
- 12 completion, the approved educational institution shall notify
- 13 the agency in writing and shall return all unused portions of
- 14 the scholarship grant. Returned amounts shall be used to fund
- 15 other scholarship grants under this act.
- 16 (h) Transfer.--A scholarship grant may only be transferrable
- 17 to another approved educational institution if approved by the
- 18 agency.
- 19 (i) Limitation. -- A scholarship grant shall be paid from
- 20 funds appropriated for that purpose. First priority for awarding
- 21 scholarship grants shall be given to renewal applicants.
- 22 Thereafter, the scholarship grants shall be awarded on a first-
- 23 come, first-served basis.
- 24 (j) Exception. -- The agency shall postpone the work
- 25 requirement under subsection (f) for extenuating circumstances
- 26 or because of the student's enrollment on a full-time basis in a
- 27 graduate degree program within one year of the receipt of a
- 28 bachelor's degree from an approved educational institution. The
- 29 agency shall require documentation of the person's continual
- 30 status as a full-time student as defined by the agency. The work

- 1 requirement under subsection (d)(6)(ii) shall begin within one
- 2 year after termination of enrollment on a full-time basis in a
- 3 graduate degree program.
- 4 Section 5. Academic Excellence Scholarships.
- 5 (a) Amount of scholarship grants. -- The agency shall issue
- 6 scholarship grants under the program, which grants may be
- 7 referred to as Academic Excellence Scholarships, in the amount
- 8 of \$5,000 per academic year to a student enrolled full time in
- 9 an approved educational institution pursuing a bachelor's
- 10 degree. The student must be enrolled for a minimum of 12
- 11 semester hours each semester or its equivalent.
- 12 (b) Term of grant. -- The scholarship grant shall be for a
- 13 maximum of four academic years.
- 14 (c) Exception.--If the student fails to meet the cumulative
- 15 grade point average requirements during a semester and is denied
- 16 a scholarship grant, the student may reapply the following year
- 17 for a scholarship grant but must continue at the student's
- 18 expense for the next year. If the student earns a cumulative
- 19 grade point average of 3.0 or higher at the end of that year,
- 20 the student may reapply for the remaining years. If the student
- 21 does not obtain a cumulative grade point average of 3.0 or
- 22 higher within the year following dismissal from the program, the
- 23 student may not reapply.
- 24 Section 6. Administration.
- 25 (a) Verification. -- The agency shall monitor and verify a
- 26 student's fulfillment of all the work requirements under this
- 27 act.
- 28 (b) Enforcement. -- The agency shall enforce repayment of all
- 29 scholarship grants for a student who does not comply with the
- 30 provisions of this act, including use of all lawful collection

- 1 procedures and the use of private collection agencies.
- 2 (c) Exclusion from taxation. -- A scholarship grant received
- 3 by a student shall not be considered taxable income for purposes
- 4 of Article III of the act of March 4, 1971 (P.L.6, No.2), known
- 5 as the Tax Reform Code of 1971.
- 6 (d) Financial assistance. -- A scholarship grant received by a
- 7 student shall be considered financial assistance or an
- 8 appropriation to the approved educational institution.
- 9 (e) Appeals.--The provisions of this act shall be subject to
- 10 2 Pa.C.S. Ch. 5 Subch. A (relating to practice and procedure of
- 11 Commonwealth agencies).
- 12 (f) Regulations. -- The agency shall adopt regulations and
- 13 procedures necessary to carry out the purposes of this act.
- 14 Section 7. Annual report.
- 15 (a) Development of report. -- The agency shall publish a
- 16 report each year containing information regarding the operation
- 17 of the scholarship program. The initial report shall be
- 18 submitted by September 1 in the year following the first full
- 19 academic year in which scholarship grants have been awarded and
- 20 by September 1 of each year thereafter. The report shall
- 21 include:
- 22 (1) Total number of students receiving scholarship
- grants, with a breakdown of whether the scholarship is an
- initial scholarship grant or a renewal of a scholarship
- 25 grant.
- 26 (2) Total number of students who withdraw from the
- 27 program or work requirements.
- 28 (b) Submission. -- The annual report shall be submitted to the
- 29 Governor and the chairperson and minority chairperson of the
- 30 Appropriations Committee of the Senate, the chairperson and

- 1 minority chairperson of the Appropriations Committee of the
- 2 House of Representatives, the chairperson and minority
- 3 chairperson of the Education Committee of the Senate and the
- 4 chairperson and minority chairperson of the Education Committee
- 5 of the House of Representatives.
- 6 Section 8. Effective date.
- 7 This act shall take effect July 1, 2017, or immediately,
- 8 whichever is later.
