AN ACT

1 Amending Title 42 (Judiciary and Judicial Procedure) of the
2 Pennsylvania Consolidated Statutes, in organization and
3 jurisdiction of courts of common pleas, further providing for
4 courts of common pleas.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Section 911(a) of Title 42 of the Pennsylvania
8 Consolidated Statutes is amended to read:

9 § 911. Courts of common pleas.

10 (a) General rule.--There shall be one court of common pleas
11 for each judicial district of this Commonwealth consisting of
12 the following number of judges:

28 Section 2. The following shall apply:

29 (1) The provisions of 42 Pa.C.S. § 3135 shall not apply
30 to the selection of judges for the judgeships created by the

1 amendment of 42 Pa.C.S. § 911(a).

2 (2) The new judgeships added by the amendment of 42
3 Pa.C.S. § 911(a) shall be established on January 2, 2020, and
4 shall be initially filled by election at the 2019 municipal
5 election.

6 Section 3. This act shall take effect immediately.
