AN ACT

Amending the act of June 27, 2006 (1st Sp.Sess., P.L.1873, No.1), entitled "An act providing for taxation by school 2 districts, for the State funds formula, for tax relief in 3 first class cities, for school district choice and voter participation, for other school district options and for a task force on school cost reduction; making an appropriation; 6 prohibiting prior authorized taxation; providing for installment payment of taxes; restricting the power of 7 8 certain school districts to levy, assess and collect taxes; 9 and making related repeals," in senior citizens property tax 10 and rent rebate assistance, adding a prohibition relating to 11 adding rent rebates. 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. The act of June 27, 2006 (1st Sp.Sess., P.L. 16 1873, No.1), known as the Taxpayer Relief Act, is amended by 17 adding a section to read: 18 Section 1314. Unlawful uses of rebates. 19 (a) Rebates used as part of lease or agreement prohibited .--20 It shall be unlawful for a landlord and tenant to enter into a 21 lease or agreement to assign or pay any portion of any rebate 22 payable under this chapter, to which a tenant may be entitled, to the landlord or to the landlord's assignee or representative. 23

- 1 (b) Penalties.--A landlord that violates this section shall
- 2 <u>be ordered to fully reimburse the tenant of any portion of a</u>
- 3 payment that was assigned or otherwise used as payment by the
- 4 tenant to the landlord. Additionally, a penalty of 25% of the
- 5 total amount of the payment to which the tenant was entitled
- 6 shall be imposed on the landlord and paid to the department. The
- 7 penalty shall bear interest at the rate of 1.5% per month from
- 8 the date of imposition until paid in full to the department.
- 9 (c) Enforcement. -- The Attorney General shall enforce the
- 10 provisions of this section.
- 11 (d) Definitions. -- The following words and phrases when used
- 12 in this section shall have the meanings given to them in this
- 13 subsection unless the context clearly indicates otherwise:
- 14 "Landlord." An owner of real property that leases property
- 15 to a tenant under a lease agreement. The term includes a person
- 16 acting on behalf of the owner in the operation or management of
- 17 the real property.
- 18 "Tenant." A person who occupies a dwelling by reason of a
- 19 possessory interest in the real property on which the dwelling
- 20 is located under a lease agreement.
- 21 Section 2. This act shall take effect in 60 days.
