AN ACT

- 1 Establishing the Lead Remediation and Abatement Superfund.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Lead
- 6 Remediation and Abatement Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Authority." The Commonwealth Financing Authority.
- 12 "Eligible entity." Any of the following, for which tests
- 13 have shown elevated lead contamination levels:
- 14 (1) A school district.
- 15 (2) A charter school.
- 16 (3) A child day care center that is licensed by the

- 1 Department of Human Services under Article X of the act of
- June 13, 1967 (P.L.31, No.21), known as the Human Services
- 3 Code.
- 4 (4) A public housing authority.
- 5 (5) A municipality.
- 6 (6) An owner of a hazardous site.
- 7 "Lead remediation or abatement." The term includes, but is
- 8 not limited to, the following:
- 9 (1) Replacing lead or copper lead-solder pipes.
- 10 (2) Removing lead paint.
- 11 (3) Painting over lead paint.
- 12 (4) Burying lead-positive soil.
- 13 (5) Removing lead-positive soil.
- 14 (6) Any other method that the Department of
- 15 Environmental Protection determines is generally accepted as
- 16 a method to remediate or abate lead.
- "Superfund." The Lead Remediation and Abatement Superfund
- 18 established under section 5.
- 19 Section 3. Bonds.
- 20 (a) Limit. -- The authority may incur indebtedness under this
- 21 section in an amount up to \$500,000,000 plus the payment of
- 22 reasonable costs and expenses related to the issuance of
- 23 indebtedness in accordance with 64 Pa.C.S. Ch. 15 (relating to
- 24 Commonwealth Financing Authority) for not more than 30 years.
- 25 (b) Use.--Proceeds of bonds issued under this section shall
- 26 be used for the purposes of this act.
- 27 (c) Final maturity. -- Bonds may not have a final maturity in
- 28 excess of 30 years from the date of issuance.
- 29 (d) Deposit of bond proceeds. -- Funds received from the
- 30 issuance of bonds shall be deposited into the superfund.

- 1 Section 4. Debt service.
- 2 Payments on the principal of bond funds received by the
- 3 authority shall be paid from the general revenues of the
- 4 Commonwealth collected under Article II of the act of March 4,
- 5 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971.
- 6 Section 5. Lead Remediation and Abatement Superfund.
- 7 (a) Establishment. -- The Lead Remediation and Abatement
- 8 Superfund is established as a restricted account within the
- 9 State Treasury.
- 10 (b) Additional funding. -- The fund may:
- 11 (1) Accept Federal funds granted by an act of Congress
- or by executive order for any of the purposes of this act.
- 13 (2) Accept an appropriation from the Commonwealth.
- 14 (3) Accept a gift donation or bequest for any purpose of
- 15 this act.
- 16 Section 6. Applications, review and use of funds.
- 17 (a) Use. -- Money in the superfund shall be awarded by the
- 18 authority to an eligible entity for the remediation or abatement
- 19 of lead in public buildings or at hazardous sites.
- 20 (b) Application. -- The authority shall develop an application
- 21 process.
- 22 (c) Contents of application. -- The authority shall determine
- 23 the application requirements. The application shall require the
- 24 eligible entity to submit estimates of the cost to remediate or
- 25 abate lead.
- 26 (d) Review and approval. -- The authority shall accept
- 27 applications for funding from eligible entities. The authority
- 28 shall review the purpose for which the eligible entity plans to
- 29 use the funding and determine whether or not the purpose is in
- 30 the public interest or reduces the risk to children of exposure

- 1 to lead. If the authority determines an eligible entity does not
- 2 meet the requirements for funding, the authority shall not
- 3 approve funding for the eligible entity. An eligible entity who
- 4 is denied funding by the authority may reapply.
- 5 (e) Use of funds. -- Funds may be used by an eligible entity
- 6 to remediate or abate lead in any of the following:
- 7 (1) A school building.
- 8 (2) A day care.
- 9 (3) A public housing building or unit.
- 10 (4) A building or structure owned by a municipality that
- is open to the public and where children may be located.
- 12 (5) A private home, if the municipality has a program
- designed to assist residents with lead remediation or
- abatement. Funding may not be given by the authority directly
- 15 to a private homeowner.
- 16 (6) A hazardous site.
- 17 (7) Any other building or structure the authority deems
- in the public interest or reduces the risk to children of
- 19 exposure to lead.
- 20 Section 7. Awards.
- 21 (a) Grant awards. -- If an application submitted to the
- 22 authority under section 6 is approved, the authority shall award
- 23 a grant to the eligible entity. Grants shall be awarded on a
- 24 first-come, first-served basis.
- 25 (b) Limitation. -- The following limitations shall apply:
- 26 (1) The authority may not award grants in excess of the
- amount available in the superfund.
- 28 (2) The authority may not award a grant in excess of the
- 29 amount detailed in an eligible entity's application for
- 30 funding.

- 1 (3) The authority may not award one eligible entity more
- than 10% of the amount available in the superfund.
- 3 (4) An eligible entity may not use more than 2% of the
- 4 funding the eligible entity receives under this act for
- 5 administrative costs.
- 6 (c) Reporting. -- An eligible entity that receives funding
- 7 shall provide a full accounting of the use of the funds to the
- 8 authority within 90 days of completion of the lead remediation
- 9 or abatement. The authority may specify information required to
- 10 fulfill the full accounting requirements under this subsection.
- 11 If an eligible entity fails to provide a full accounting, the
- 12 eligible entity shall not be eligible for additional funding
- 13 until the required full accounting is completed.
- 14 Section 8. Effective date.
- This act shall take effect July 1, 2017, or immediately,
- 16 whichever is later.
