AN ACT

- 1 Providing for the preservation and maintenance of the
- 2 Pennsylvania State area portion of the Medal of Honor Grove
- in Schuylkill Township, Chester County.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Medal of
- 8 Honor Grove Act.
- 9 Section 2. Findings.
- 10 The General Assembly finds and declares as follows:
- 11 (1) The 52-acre Freedom Foundation's Medal of Honor
- 12 Grove in Schuylkill Township, Chester County, is the nation's
- oldest memorial site dedicated to Medal of Honor recipients.
- 14 The site was dedicated October 1, 1964, through the work of
- 15 President Dwight D. Eisenhower and General Omar Bradley,
- 16 among others. It honors our nation's Medal of Honor
- 17 recipients.
- 18 (2) The Medal of Honor is our nation's highest military

- 1 honor. Since its inception in 1862, it has been bestowed upon
- 2 346 Pennsylvanians and 3,498 individuals who attained
- distinction through "conspicuous gallantry and intrepidity at
- 4 the risk of his life above and beyond the call of duty while
- 5 engaged in the action against an enemy of the United States."
- 6 (3) The 52-acre grove is divided into one-acre plots
- 7 dedicated to each state in addition to the District of
- 8 Columbia and the Commonwealth of Puerto Rico.
- 9 (4) It is essential that the Commonwealth recognize and
- 10 preserve the Pennsylvania State area of the Medal of Honor
- 11 Grove and the individuals it represents so that their heroism
- 12 and service are never forgotten.
- 13 Section 3. Duties of the Department of General Services <--

- 16 AFFAIRS shall provide for the maintenance of the Pennsylvania
- 17 State area portion of the Medal of Honor Grove in Schuylkill
- 18 Township, Chester County.
- 19 Section 4. Contract for services.
- The Department of General Services MILITARY AND VETERANS
- 21 AFFAIRS may contract with an organization that maintains any
- 22 portion of the grounds of the Medal of Honor Grove to provide
- 23 the following services for the Pennsylvania State area portion
- 24 of the Medal of Honor Grove:
- 25 (1) Arranging for the fabrication and installation of
- new ground plaques for new Medal of Honor recipients.
- 27 (2) Engraving new Medal of Honor recipient names on the
- 28 State obelisk.
- 29 (3) Restoring or replacing any American, Commonwealth or
- 30 military flags.

- 1 (4) Maintaining the landscape, trees, ground plaques,
- 2 State obelisk and flag poles.
- 3 Section 5. Effective date.
- 4 This act shall take effect in 60 days.
