AN ACT

- Amending Title 25 (Elections) of the Pennsylvania Consolidated Statutes, in uniform military and overseas voters, further
- providing for definitions, for duties and responsibilities of
- secretary and for registering to vote.

- 7 Section 1. The definition of "military-overseas ballot" in

12	(c) Electronic transmission system The secretary shall
13	ensure that the electronic transmission system described in
14	section 3503(c) (relating to duties and responsibilities of
15	secretary) is capable of accepting a Federal postcard
16	application, military-overseas ballot and any other approved
17	electronic registration application sent to the appropriate
18	county election board. The voter may use the electronic
19	transmission system or any other approved method to register to
20	vote.
