15	(a) Requirements A person who engages in defense-initiated
16	victim or witness outreach shall:
17	(1) Communicate in an honest manner without deception or

- 8 <u>victim or witness on behalf of the criminal defendant or the</u>
- 9 criminal defendant's counsel through any of the following:
- 10 (1) A victim liaison.
- 11 (2) A victim outreach specialist.
- 12 <u>(3) A social worker.</u>
- 13 <u>(4) An investigator.</u>
- 14 (5) Any other individual designated by the criminal
- defendant or the criminal defendant's counsel.
- 16 Section 2. Sections 9543(a)(1) and 9545(b)(2) and (d)(1) of
- 17 Title 42 are amended to read:
- 18 § 9543. Eligibility for relief.
- 19 (a) General rule. -- To be eligible for relief under this
- 20 subchapter, the petitioner must plead and prove by a
- 21 preponderance of the evidence all of the following:
- 22 (1) That the petitioner has been convicted of a crime
- 23 under the laws of this Commonwealth and is at the time relief
- 24 is granted:
- (i) currently serving a sentence of imprisonment,
- 26 probation or parole for the crime;
- 27 (ii) awaiting execution of a sentence of death for
