AN ACT

1 Amending the act of August 9, 1955 (P.L.323, No.130), entitled,
2 "An act relating to counties of the first, third, fourth,
3 fifth, sixth, seventh and eighth classes; amending, revising,
4 consolidating and changing the laws relating thereto;
5 relating to imposition of excise taxes by counties, including
6 authorizing imposition of an excise tax on the rental of
7 motor vehicles by counties of the first class; and providing
8 for regional renaissance initiatives," making extensive
9 revisions relating to preliminary provisions; names and
10 corporate powers, classification of counties; fixing and
11 relocating lines and boundaries; county officers; county
12 commissioners and chief clerks; controller; auditors;
13 treasurer; county solicitor; engineer; sheriff and coroner;
14 prothonotary, clerks of court, clerk of orphan's court,
15 register of wills, recorder of deeds; district attorney,
16 assistants and detectives; salaries of county officers; fees
17 of salaried county officers, salary boards, payment of
18 solicitors appointed by county officers; fiscal affairs;
19 contracts and special powers and duties of counties; public
20 health; aeronautics; grounds and buildings; eminent domain
21 and injury to property; recreation places; bridges, viaducts
22 and culverts and roads; providing for military and veterans
23 affairs; and making editorial changes.

24 The General Assembly of the Commonwealth of Pennsylvania
25 hereby enacts as follows:

26 Section 1. The title of the act of August 9, 1955 (P.L.323,
27 No.130), known as The County Code, is amended to read:

28 AN ACT

1 Relating to counties of the first, second class A, third,
2 fourth, fifth, sixth, seventh and eighth classes; amending,
3 revising, consolidating and changing the laws relating
4 thereto; relating to imposition of excise taxes by counties,
5 including authorizing imposition of an excise tax on the
6 rental of motor vehicles by counties of the first class; and
7 providing for regional renaissance initiatives.

8 Section 2. Section 102 of the act, amended April 20, 2016
9 (P.L.134, No.18), is amended to read:

10 Section 102. Applicability.--(a) Except incidentally, as in
11 sections 108, 201, 210, 211, 401 and 1401 or as provided in
12 section 1770.12, Article XII-B and Article XXX, this act does
13 not apply to counties of the first[, second A,] or second
14 classes.

15 (b) Except where otherwise specifically limited, this act
16 applies to all counties of the second A, third, fourth, fifth,
17 sixth, seventh and eighth classes.

18 Section 3. The act is amended by adding a section to read:

19 Section 102.1. Definitions.--The following words and phrases
20 when used in this act shall have the meanings given to them in
21 this section unless the context clearly indicates otherwise:

22 "Municipal corporation." A city, borough, incorporated town,
23 township of the first or second class or a home rule or optional
24 charter municipality other than a county.

25 "Municipality." A municipal corporation or county.

26 "Recreation places." The term includes public parks,
27 parkways, bridle paths, horse show rings, foot paths,
28 playgrounds, playfields, gymnasiums, public baths, swimming
29 pools, agricultural fairgrounds or other indoor or outdoor
30 recreation centers.

1 "Street." A street, road, lane, court, cul-de-sac, alley,
2 public way or public square.

3 Section 4. Sections 103, 104, 105, 106, 107 and 108 of the
4 act are amended to read:

5 Section 103. Excluded Provisions.--This act does not include
6 any provisions of, and shall not be construed to repeal:

7 (1) [The Municipal Borrowing Law, approved June twenty-five,
8 one thousand nine hundred forty-one (Pamphlet Laws 159)] 53
9 Pa.C.S. Pt. VII Subpt. B (relating to indebtedness and
10 borrowing).

11 (2) [The Pennsylvania Election Code,] Except as otherwise
12 provided in section 3903, the act of June 3, 1937 (P.L.1333,
13 No.320), known as the "Pennsylvania Election Code," approved
14 June three, one thousand nine hundred thirty-seven (Pamphlet
15 Laws 1333).

16 (4) The Local Health Administration Law, approved August
17 twenty-four, one thousand nine hundred fifty-one (Pamphlet Laws
18 1304).

19 (5) [The Municipal Unclaimed Moneys Act, approved May
20 seventeen, one thousand nine hundred forty-nine (Pamphlet Laws
21 1403).] Article XIII.1 of the act of April 9, 1929 (P.L.343,
22 No.176), known as "The Fiscal Code."

23 (6) [Any] Except where otherwise expressly provided, any law
24 relating to the collection of municipal and tax claims.

25 (7) [Except as provided under subdivision (e) of Article
26 XVII, any] Any law relating to the assessment and valuation of
27 property and persons for taxation.

28 (8) Any law relating to the giving of county consent to
29 public [utility corporations] utilities.

30 (9) Any law relating to State highways.

1 (10) Any law relating to the validation of elections, bonds,
2 resolutions and accounts of corporate officers.

3 (11) Any law relating to collections by county officers of
4 moneys for the Commonwealth, and the issuance of State licenses.

5 (12) Any law relating to the government and regulation of
6 jails, prisons and other correctional institutions and the
7 commitment thereto, and maintenance and care of prisoners or
8 inmates therein.

9 (13) Any law relating to civil and criminal procedure,
10 except special provisions concerning action.

11 (14) Any law relating to joint county and municipal
12 buildings and works.

13 (15) Any law relating to county libraries, except law
14 libraries.

15 (16) Any law relating to the recording of deeds, mortgages
16 or other instruments in writing.

17 (17) Any law relating to the re-binding, re-indexing and
18 transcribing of records in county offices.

19 (18) Any law relating to the fees of county officers, except
20 as any such acts are repealed by [section two thousand nine
21 hundred one] Article XXXIX of this act.

22 (19) Any temporary law.

23 (20) Any amendment or supplement of any of the laws referred
24 to in this section.

25 (21) [The Public Utility Law, approved May twenty-eight, one
26 thousand nine hundred thirty-seven (Pamphlet Laws 1053)] 66
27 Pa.C.S. Pt. I (relating to public utility code).

28 Section 104. Saving Clause.--(a) The provisions of this
29 act, as far as they are the same as those of existing laws,
30 shall be construed as a continuation of such laws, and not as

1 new enactments. The repeal by this act of any provisions of law,
2 shall not revive any law [heretofore] previously repealed or
3 superseded, nor affect the existence or class of any county
4 [heretofore] previously created. The provisions of this act
5 shall not affect any act done, liability incurred, or right
6 accrued or vested, nor affect any suit or prosecution, pending
7 or to be instituted, to enforce any right or penalty, or punish
8 any offense under the authority of [such] the repealed laws.

9 (b) All ordinances, resolutions, regulations and rules, made
10 pursuant to any act [of Assembly] repealed by this act, shall
11 continue with the same force and effect as if [such] the act had
12 not been repealed. All local acts [of Assembly] applying to
13 particular counties, not specifically repealed, shall continue
14 in force, and any provisions of this act inconsistent
15 [therewith] with local laws shall not apply to the counties
16 affected by [such] the local laws, unless [such] the application
17 is clearly indicated.

18 (c) All acts and parts of acts [of Assembly] relating to
19 counties, or to particular classes of counties, in force [at the
20 time of the adoption of this act] as of January 1, 1956, and not
21 repealed [hereby] by this act, shall remain in force in the same
22 manner and with the same effect as prior to the adoption of this
23 act.

24 (d) This act shall be considered a continuation of the act
25 of July 28, 1953 (P.L.723, No.230), known as the "Second Class
26 County Code," as it pertains to second class A counties except
27 where otherwise expressly provided. The repeal of the "Second
28 Class County Code," as it relates to second class A counties by
29 section 3901 of this act shall not be construed as modifying or
30 repealing any term of office, power, ordinance, rule or

1 regulation of home rule counties or counties of the second class
2 A existing on the effective date of this subsection.

3 Section 105. Holding of Office.--Any person holding elective
4 office under any act [of Assembly] repealed by this act shall
5 continue to hold [such] the office until the expiration of the
6 person's term [thereof], subject to the conditions and salary
7 attached to [such] the office prior to the passage of this act.

8 Section 106. Construction of References.--Whenever in this
9 act reference is made to any act [by title, or name, such], the
10 reference shall also apply to and include any codifications
11 wherein the provisions of the act referred to are substantially
12 reenacted or to reenactments, revisions or amendments of the
13 act.

14 Section 107. Constitutional Construction.--The provisions of
15 this act shall be severable, and, if any of its provisions are
16 held to be unconstitutional, the decision of the court shall not
17 affect the validity of the remaining provisions of this act. It
18 is hereby declared as a legislative intent that this act would
19 have been adopted by the General Assembly had [such] the
20 unconstitutional provisions not been included [therein] within
21 this act.

22 Section 108. Legislation According to Class.--The affairs of
23 counties [are herein and shall hereafter] shall be legislated
24 for and regulated by general laws, applicable to all counties,
25 or to particular classes, as [herein] fixed and appointed by
26 this act. All laws adopted by the General Assembly for one or
27 more of the classes [herein] fixed and appointed by this act
28 shall be deemed to be general laws.

29 Section 5. The act is amended by adding a section to read:

30 Section 108.1. Collection of Tax on Real Property from Rent

1 Paid to Owner in County of the Second Class A.--(a) Where the
2 owner of any residential or commercial real property that is
3 located in a county of the second class A and subject to a claim
4 pursuant to the act of May 16, 1923 (P.L.207, No.153), referred
5 to as the Municipal Claim and Tax Lien Law, derives any rental
6 income from that property, the county treasurer shall notify the
7 property owner in writing of the property owner's duty to remit
8 that rental income to the office of the county treasurer. The
9 rent remitted shall be applied to the amount of tax owed, along
10 with any interest or penalties due, until the claim is paid in
11 full.

12 (b) The notice of the county treasurer shall include the
13 amount of the claim on the property, including interest and
14 penalties, and the date or dates the rental income is to be
15 remitted. If, after fifteen days of the date or dates specified
16 in the notice, the property owner fails to remit the rental
17 income, the county may immediately begin the judicial sale
18 process provided for in the Municipal Claim and Tax Lien Law.

19 Section 6. Section 109 of the act is amended to read:

20 Section 109. Proceedings for Recovery of Penalties.--Unless
21 [herein] otherwise specifically provided[, in every case in
22 which] in this act, when any pecuniary penalty or forfeiture is
23 imposed by this act, the proceeding for the recovery of the same
24 shall be by indictment in the court of [quarter sessions] common
25 pleas, or by civil action as debts of equivalent amount are by
26 law recoverable. [Aldermen or justices of the peace] Magisterial
27 district judges shall not have jurisdiction of any suit or
28 action for the recovery of any penalty imposed by this act for
29 official misconduct. Such suit or action, when brought in the
30 court of common pleas, shall have preference for trial over all

1 other actions.

2 Section 7. The act is amended by adding a section to read:

3 Section 109.1. Collection of Tax and Municipal Claims by

4 Suit; Limitations.--(a) In addition to the remedies provided by

5 law for the collection of tax and municipal claims, a county may

6 proceed for the recovery and collection of any tax or municipal

7 claim against any owner or owners of the property owing the tax

8 or municipal claim by a civil action or other appropriate

9 remedy. To each judgment obtained for the taxes or municipal

10 claim, there shall be added a penalty of ten per centum,

11 interest at the prevailing legal rate and costs of suit. Upon

12 judgment, execution may be issued without any stay or benefit of

13 any exemption law.

14 (b) The right of a county to collect unpaid taxes or

15 municipal claims under the provisions of this section shall not

16 be affected by the fact that the tax or municipal claims have or

17 have not been entered as liens in the office of the

18 prothonotary.

19 (c) A civil action brought to recover unpaid taxes or

20 municipal claims shall be commenced within twenty years of the

21 following:

22 (1) The date a tax is due.

23 (2) The date of completion of an improvement from which the

24 claim arises.

25 (3) The date that the property owner first became liable for

26 payment of any claim other than that for taxes or improvements.

27 (d) The remedy granted under this section shall be applied

28 retroactively.

29 Section 8. Sections 110, 202, 210, 211, 301, 302, 303, 304,

30 305, 306, 401, 402 and 403 of the act are amended to read:

1 Section 110. Publication of Legal Notices.--(a) Whenever,
2 under the provisions of this act, advertisement, notice or
3 publication is required to be published in one newspaper, [such]
4 the publication shall be made in a newspaper of general
5 circulation as defined [by the act, approved May sixteen, one
6 thousand nine hundred twenty-nine (Pamphlet Laws 1784), known as
7 the "Newspaper Advertising Act,"] in 45 Pa.C.S. § 101 (relating
8 to definitions), printed in the county, unless the matter in
9 connection with which the advertising is being done affects only
10 a political subdivision, in which case [such] the advertisement
11 shall be published in a newspaper printed in [such] the
12 political subdivision, if there is such a newspaper and, if not,
13 then in a newspaper circulating generally in [such] the
14 political subdivision. If [such] notice is required to be
15 published in more than one newspaper, it shall be published in
16 at least one newspaper of general circulation[, defined as
17 aforesaid], printed, if there [be] is such a newspaper, or
18 circulating generally in the county, as [above] provided [in the
19 county] above.

20 (b) When [such] the notice relates to any proceeding or
21 matter in any court, or the holding of an election for the
22 increase of indebtedness, or the issue and sale of bonds to be
23 paid by taxation, [such] the notice shall also be published in
24 the legal newspaper, if any, designated by the rules of court of
25 the proper county for the publication of legal notices and
26 advertisement, unless [such] the publication [be] is dispensed
27 with by special order of court. All ordinances, auditors'
28 reports, controllers' reports, or advertisements, inviting
29 proposals for public contracts and for bids for materials and
30 supplies, shall be published only in newspapers of general

1 circulation[, as hereinbefore defined].

2 (c) Nothing in this act shall preclude the publication of
3 notices by means other than in a newspaper to the extent
4 authorized by law.

5 Section 202. General Powers.--Each county shall have
6 capacity as a body corporate to:

7 (1) Have succession perpetually by its corporate name.

8 (2) Sue and be sued and complain and defend in all proper
9 courts by the name of the county of

10 (3) Purchase, acquire by gift or otherwise, hold, lease, let
11 and convey [such] real and personal property as shall be deemed
12 to be for the best interests of the county.

13 (4) Make contracts for carrying into execution the laws
14 relating to counties and for all lawful purposes.

15 (5) Have and use a seal which shall be in the custody of the
16 commissioners [thereof]. The official acts of the commissioners
17 shall be authenticated [therewith] with the seal. The
18 commissioners may prescribe the form of [such] the seal.

19 (6) To make appropriations for any purpose authorized by
20 this or any other act of the General Assembly.

21 Section 210. Counties Divided Into Nine Classes.--For the
22 purposes of legislation and the regulation of their affairs,
23 counties of this Commonwealth, now in existence and those
24 hereafter created, shall be divided into nine classes as
25 follows:

26 (1) First Class Counties, those having a population of
27 1,500,000 inhabitants and over.

28 (2) Second Class Counties, those having a population of
29 [800,000] 1,000,000 and more but less than 1,500,000
30 inhabitants.

1 (2.1) Second Class A Counties, those having a population of
2 500,000 and more but less than [800,000] 1,000,000 inhabitants.

3 (3) (i) Third Class Counties, those having a population of
4 210,000 and more but less than 500,000 inhabitants.

5 (ii) After the results of any Federal Decennial Census are
6 published, any county of the third class having a population of
7 500,000 inhabitants and over may elect not to become a county of
8 the second class A by enacting an ordinance or adopting a
9 resolution of the [Board of County Commissioners] commissioners
10 not later than February 15 of the year following the year in
11 which the figures from the Federal Decennial Census are
12 certified by the United States Department of Commerce and
13 available.

14 (4) Fourth Class Counties, those having a population of
15 145,000 and more but less than 210,000 inhabitants.

16 (5) Fifth Class Counties, those having a population of
17 90,000 and more but less than 145,000 inhabitants.

18 (6) Sixth Class Counties, those having a population of
19 45,000 and more but less than 90,000 inhabitants and those
20 having a population of 35,000 and more but less than 45,000
21 inhabitants which by ordinance or resolution of the [Board of
22 County Commissioners] commissioners elect to be a county of the
23 sixth class.

24 (7) Seventh Class Counties, those having a population of
25 20,000 or more but less than 45,000 inhabitants and those having
26 a population of 35,000 and more but less than 45,000 inhabitants
27 which have not elected to be a county of the sixth class.

28 (8) Eighth Class Counties, those having a population of less
29 than 20,000 inhabitants.

30 Section 211. Ascertainment, Certification and Effect of

1 Change of Class.--(a) The classification of counties shall be
2 ascertained and fixed according to their population by reference
3 from time to time to the decennial United States census as
4 [hereinafter provided, deducting therefrom] provided in this
5 section, less the number of persons residing on any lands that
6 have been ceded to the United States.

7 (b) Whenever it shall appear by any [such] decennial census
8 that [any] a county has attained a population entitling it to an
9 advance in classification, or whenever it shall appear by the
10 last two preceding censuses that a county has [heretofore or
11 hereafter] decreased in population so as to recede in
12 classification, as [herein prescribed] provided in this section,
13 it shall be the duty of the Governor, under the great seal of
14 this Commonwealth, to certify that fact accordingly, to the
15 [board of county] commissioners on or before the first day of
16 October of the year succeeding [that] the year in which the
17 census was taken [or as soon thereafter as may be], which
18 certificate shall be forwarded by the commissioners to the
19 recorder of deeds and be recorded in [his] the recorder's
20 office.

21 It is the intent of this section that the classification of
22 any county shall not be changed because its population has
23 decreased at the time of one United States decennial census,
24 because it is recognized that a change in the form of local
25 government is attended by certain expense and hardship, and
26 [such] the change should not be occasioned by a temporary
27 fluctuation in population, but rather only after it is
28 demonstrated by two censuses that the population of a county has
29 remained below the minimum figure of its class for at least a
30 decade.

1 (c) Changes of class ascertained and certified [as
2 aforesaid] shall become effective on the first day of January
3 next following the year in which the change was [so] certified
4 by the Governor to the county commissioners but the salaries of
5 county officers shall not [thereby] be increased or decreased
6 during the term for which they shall have been elected. In the
7 municipal election following [such] the certification of change
8 of class and preceding the effective date of [such] the change,
9 the proper number of persons shall be elected to fill any
10 elective office which will exist in the county by the change of
11 classification certified. No election shall be held for any
12 office which will be abolished as a result of [such] a change of
13 classification.

14 Section 301. Petition to [Superior] Commonwealth Court.--(a)
15 The boundary line between any two or more adjoining counties may
16 be determined, surveyed, [relocated] established or marked in
17 the manner provided by this article.

18 (b) Such a proceeding shall be instituted on petition of any
19 taxpayer, the [county] commissioners or the [corporate
20 authorities] governing body of any political subdivision of any
21 of the counties involved.

22 Section 302. [Superior] Commonwealth Court to Designate
23 Neutral Court; Appointment of Commission.--(a) The court, upon
24 the filing of such petition, shall designate a court of a county
25 not affected by the question and not adjoining any of the
26 counties involved to act in the proceeding. The designated court
27 [so designated] shall sit in its home county.

28 (b) If it appears to the [court so] designated court that
29 the county line, or any part thereof, shall be surveyed or
30 marked, it shall appoint a boundary commission, composed of

1 three surveyors or professional engineers [in civil
2 engineering,] licensed or registered in accordance with the act
3 of May 23, 1945 (P.L.913, No.367), known as the "Engineer, Land
4 Surveyor and Geologist Registration Law," to act for the court
5 as hereinafter provided.

6 Section 303. Compensation, Assistants and Expenses.--(a)
7 The surveyors or professional engineers [in civil engineering]
8 composing [such] the boundary commission shall each receive such
9 compensation as the court shall fix for the time necessarily
10 spent in the discharge of their duties and[, in addition
11 thereto,] shall also be reimbursed the necessary expenses
12 incurred by them respectively while engaged upon the work of
13 [such] the commission.

14 (b) The boundary commission may employ such assistants as
15 the court shall allow, at a compensation to be fixed by the
16 court[, and such assistants shall be reimbursed the actual
17 necessary expenses incurred by them respectively while employed
18 by such commission]. Assistants shall also be reimbursed for
19 actual necessary expenses incurred while employed by the
20 commission.

21 (c) All costs, including the necessary expenses of
22 advertising the meeting of the boundary commissioners as
23 hereinafter provided, and in procuring and setting the permanent
24 monuments [needful] necessary to mark [in a permanent manner
25 such] the county line, the expenses of the boundary commission
26 and its assistants and all other expenses necessarily incurred,
27 shall be paid by the interested counties jointly, in equal
28 parts, or by any party or parties to the proceeding as the court
29 may direct, upon presentation of properly itemized bills, duly
30 verified by affidavit of the person claiming payment or [some

1 one on his] someone on the person's behalf.

2 Section 304. Oath; Organization and Duties.--(a) The
3 members of the boundary commission shall take and subscribe [an
4 oath to perform their duties impartially and with fidelity] the
5 oath as provided in 53 Pa.C.S. § 1141 (relating to form of oaths
6 of office) prior to assuming duties with the commission.

7 (b) The boundary commission shall meet and organize within
8 two weeks of its appointment. It shall select from its
9 membership a chairman and also a secretary who shall keep a full
10 record of the proceedings and work of the commission. [Before
11 entering upon its duties, it shall designate, by advertisement]
12 The commission shall advertise in not more than two newspapers
13 published in each of the counties concerned, a time and place of
14 meeting, when and where parties interested shall be heard. After
15 [such] the hearing, it shall, without unreasonable delay,
16 ascertain the location, and survey and mark with [suitable]
17 permanent monuments [of a permanent character] the existing
18 county line between such counties[, if it shall consider such
19 old county line a proper one].

20 Section 305. Authority to Fix [New] Undetermined County
21 Line.--(a) When the boundary commission [has ascertained,
22 located and determined said line, if it appears to it that the
23 existing county line, from any cause whatever, has become
24 inconvenient for any purpose, or improper, difficult to
25 ascertain, or not related to the natural or other land marks,
26 the commission] cannot determine, ascertain or locate the
27 existing county line, it shall so report [these facts, or any of
28 them,] to the court of [quarter sessions having appointed the
29 commission] common pleas, with a recommendation that a new
30 county line be established in whole or in part.

1 (b) [Thereupon, if said] If the court shall be of opinion
2 that it is [to the interest and advantage of the respective
3 counties] necessary that a new county line be established, [they
4 may] it shall direct [said] the boundary commission to fix and
5 determine a new county line [and], to mark the same with
6 [suitable] permanent monuments [of a permanent character] and to
7 prepare the report as provided in section 306.

8 [(c) Notice shall be given to the counties interested, and
9 to the owners of all lands which will be affected by the
10 proposed change, of the time when the recommendation of the
11 commission for a new county line will be considered by the
12 court.]

13 Section 306. Report of Boundary Commission; Approval by
14 Court; Certification of Line.--(a) The boundary commission[, or
15 a majority thereof, shall make a report, in writing, and attach
16 thereto] shall prepare a written report containing a map or
17 draft showing the courses and distances of the line ascertained
18 and designated by them as the existing county line, or where
19 they may have been directed to fix and determine a new county
20 line, such map or draft[, in lieu thereof,] shall instead show
21 the courses and distances of new county line. In either case,
22 the map or draft shall also show the lands through which said
23 line passes and the buildings in close proximity thereto,
24 together with the roads and streams crossed by or near to such
25 line.

26 (b) The report and map, signed by a majority of the members
27 of the commission [or a majority of them], shall be filed in the
28 court of [quarter sessions] common pleas having been given
29 jurisdiction, and if approved by such court, shall be ordered
30 recorded in the records thereof.

1 (b.1) Written notice shall be given by the boundary
2 commission to the counties interested, and to the owners of all
3 lands which will be affected by the proposed change, of the time
4 when the report containing the recommendation of the boundary
5 commission will be considered by the court.

6 (b.2) A copy of the report and approval shall be certified
7 by the [clerk of the court] prothonotary to the [clerk of the
8 court of quarter sessions] prothonotary of each county affected,
9 where it shall be recorded in the records. The line so
10 ascertained, surveyed and fixed and so marked shall
11 [thenceforth], as of the date of the certification, be the
12 boundary line between the counties.

13 (c) The [clerk of the court of quarter sessions]
14 prothonotary, having determined the matter, shall certify the
15 approval of the court on two copies of the report and map filed
16 in [this] the prothonotary's office and, within thirty days,
17 transmit a copy by mail to the Secretary of [Internal Affairs,
18 to be by him deposited in his department, and another to the
19 Department of Highways] Community and Economic Development, the
20 Department of Transportation and the Department of Conservation
21 and Natural Resources.

22 Section 401. Enumeration of Elected Officers.--(a) In each
23 county, there shall be the following officers elected by the
24 qualified electors of the county:

25 (1) Three county commissioners.

26 (2) Three auditors or, in counties of the second class A and
27 in all counties where the office of auditor has heretofore been
28 or shall hereafter be abolished, one controller.

29 (3) One treasurer.

30 (4) One coroner.

1 (5) One recorder of deeds.

2 (6) One prothonotary.

3 (7) One clerk of the court of [quarter sessions and of the
4 court of oyer and terminer] common pleas.

5 (8) [One] Except in counties of the second class A, one
6 clerk of the orphans' court.

7 (9) One register of wills, who, in counties of the second
8 class A, shall serve as clerk of the orphan's court.

9 (10) One sheriff.

10 (11) One district attorney.

11 (12) Two jury commissioners, except in counties where the
12 office of jury commissioner has been abolished.

13 (b) [All] Except as provided in subsection (b.1), all such
14 officers shall be elected at the municipal election next
15 preceding the expiration of the terms of the officers now in
16 office, and quadrennially thereafter, and shall hold their
17 offices for a term of four years from the first Monday of
18 January next after their election and until their successors
19 shall be duly qualified, but in the event that any [such]
20 officer so elected, excepting a county commissioner or auditor,
21 shall fail to qualify, or if no successor shall be elected, then
22 the chief deputy, first assistant, first deputy or principal
23 deputy in office at the time the vacancy occurred shall assume
24 the office until a successor has been appointed pursuant to
25 section 409 or until the first Monday in January following the
26 next municipal election, whichever period is shorter. In the
27 case of a county commissioner or auditor, there shall be a
28 vacancy which shall be filled as provided in this act.

29 (b.1) In the event that any officer in a county of the
30 second class A, other than a county commissioner, shall fail to

1 qualify, or if no successor is elected, the officer then in
2 office shall continue in office only until the first Monday in
3 January following the next municipal election, at which time a
4 successor shall be elected for a term of four years.

5 (c) All the county officers enumerated in this section shall
6 remain as now constituted. This section does not create any
7 office in any county where such office does not now exist.

8 (d) The office of jury commissioner may be abolished by
9 referendum at the option of each county which on the effective
10 date of this subsection is a county of the third class having a
11 population under the 1990 Federal decennial census in excess of
12 237,000 residents, but less than 240,000 residents, or a
13 population under the 1990 Federal decennial census in excess of
14 337,000 residents, but less than 341,000 residents, whenever
15 electors equal to at least five per centum of the highest vote
16 cast for any office in the county at the last preceding general
17 election shall file a petition with the county board of
18 elections, or the governing body of the county adopts, by a
19 majority vote, a resolution to place such a question on the
20 ballot and a copy of the resolution is filed with the county
21 board of elections for a referendum on the question of
22 abolishing the office of jury commissioner. Proceedings under
23 this subsection shall be in accordance with the provisions of
24 the act of June 3, 1937 (P.L.1333, No.320), known as the
25 "Pennsylvania Election Code." Upon approval of the referendum
26 the office of jury commissioner shall expire at the completion
27 of the current jury commissioners' terms of office. The
28 referendum shall not take place in any year in which the office
29 of jury commissioners is on the ballot.

30 (e) The office of jury commissioner may be abolished in a

1 county of the third class having a population during the 2000
2 decennial census of not less than 371,000 and not more than
3 380,000 if the governing body of the county adopts, by a
4 majority vote, a resolution abolishing the office of jury
5 commissioner. Upon approval of the resolution, the office of
6 jury commissioner shall expire at the completion of the current
7 jury commissioners' terms of office.

8 (f) After review of the procedures in effect within the
9 county to ensure that lists of potential jurors are a
10 representative cross section of the community, the governing
11 body of a county of the second class A or third through eighth
12 class may adopt, by a majority vote, a resolution abolishing the
13 office of jury commissioner. Upon approval of the resolution,
14 the office of jury commissioner shall expire at the completion
15 of the current jury commissioners' terms of office.

16 Section 402. Incompatible Offices.--(a) No elected county
17 officer or, in counties of the third through eighth class,
18 county solicitor, shall, at the same time, serve as a member of
19 the legislative body of any [city, borough, town or township of
20 any class, nor as treasurer or tax collector of any city,
21 borough, incorporated town or township,] municipal corporation
22 nor as school director of any school district, nor as a member
23 of any board of health.

24 (a.1) Except as otherwise authorized by law, no elected
25 county officer or county solicitor of a county of the third
26 through eighth class shall, at the same time, serve as treasurer
27 or tax collector of any municipal corporation.

28 (b) No member of Congress from this State, nor any person
29 holding or exercising any office or appointment of trust or
30 profit under the United States, shall, at the same time, hold or

1 exercise any county office in this State to which a salary, fee
2 or perquisites are attached. This section shall not apply to
3 [United States Reserve Officers or enlisted personnel] members
4 of the National Guard or other reserve component of the armed
5 forces not called into active duty.

6 Section 403. Oath of Office.--(a) In addition to any oath
7 or affirmation required by any other act of Assembly, all county
8 officers, their deputies, assistants and clerks, shall, before
9 entering on the duties of their respective offices or
10 employments, take and subscribe the [following oath or
11 affirmation: "I do solemnly swear (or affirm) that I will
12 support, obey and defend the Constitution of the United States,
13 and the Constitution of this Commonwealth; and that I will
14 discharge the duties of my office (or employment) with fidelity;
15 that I have not paid or contributed, or promised to pay or
16 contribute, either directly or indirectly, any money or other
17 valuable thing to procure my nomination or election (or
18 appointment), except for necessary and proper expenses expressly
19 authorized by law; that I have not knowingly violated any
20 election law of this Commonwealth, or procured it to be done by
21 others in my behalf; that I will not knowingly receive, directly
22 or indirectly, any money or other valuable thing for the
23 performance or non-performance of any act or duty pertaining to
24 my office (or employment) other than the compensation allowed by
25 law".] oath as provided in 53 Pa.C.S. § 1141 (relating to form
26 of oaths of office).

27 (b) The foregoing oath shall be administered by some person
28 authorized to administer oaths, and shall be filed in the office
29 of the prothonotary of the county in which the same is taken.
30 Any person refusing to take said oath or affirmation shall

1 forfeit his office. Any person who shall be convicted of having
2 sworn or affirmed falsely, or of having violated said oath or
3 affirmation, shall be guilty of perjury. [, and shall be subject
4 to such penalties as are provided therefor in the act, approved
5 June twenty-four, one thousand nine hundred thirty-nine
6 (Pamphlet Laws 872), known as The Penal Code, and be forever
7 disqualified from holding any office of trust or profit within
8 this Commonwealth.]

9 Section 9. Section 403.1 of the act is repealed:

10 [Section 403.1. Compensation When Salary Not Fixed by Law.--
11 In counties where no annual salary is fixed by law for the
12 county treasurer, he shall receive in full compensation for his
13 services on behalf of the county a certain amount per centum on
14 all moneys received and paid by him, which rate shall be
15 settled, from to time, by the county commissioners with the
16 approbation of the county auditors.]

17 Section 10. Sections 404, 405, 406, 407, 408, 409, 410 and
18 411 of the act are amended to read:

19 Section 404. Officers to Have Commissions Recorded.--Every
20 county officer receiving a commission from the Governor shall,
21 immediately, deliver the same to the recorder of deeds for
22 recordation [at the expense of such officer]. No [such] officer
23 shall execute any of the duties of [his] office until [he has so
24 delivered the said commission] the commission has been
25 delivered.

26 Section 405. Location of Offices, Records and Papers.--(a)
27 The commissioners, auditors, controller, treasurer, sheriff,
28 recorder of deeds, prothonotary, clerk of courts [of quarter
29 sessions and oyer and terminer], clerk of orphans' court,
30 register of wills[, recorder of deeds] and district attorney

1 shall keep their respective offices, and all public records and
2 papers [belonging thereto] of those offices, at the county seat,
3 and in such buildings as may be erected or appropriated for such
4 purpose.

5 (a.1) The [county] commissioners shall have the power to
6 keep and maintain records and to contract with persons, for
7 storage, retrieval, and transmission of county records within or
8 outside the county except that no records shall be stored
9 outside the county seat without the approval of the [president
10 judge and the] officer in charge of the office to which the
11 records belong. The approval of the president judge shall be
12 required if records are in the custody of agencies of the court
13 of common pleas, the clerk of courts, the prothonotary, the
14 register of wills and the clerk of the orphans' court. Public
15 records stored outside of the county seat shall be made
16 accessible to the general public at the county seat by [means of
17 an electronic telecopying system] any electronic means or
18 facility which will permit the retrieval of the records or exact
19 copies thereof within [three] five business days.

20 County records used on a regular or frequent basis shall
21 remain in the county seat.

22 (a.2) The commissioners of counties of the second class A
23 shall have the power to impose a fee on recorded instruments
24 required to be kept permanently that are filed with the county,
25 and, with the approval of the president judge, shall have the
26 power to impose a fee on civil or criminal cases filed in the
27 court of common pleas. The fees will be collected by the
28 appropriate row officer and deposited in a special records
29 management fund, administered by the county's records management
30 program in the Office of Management and Productivity or, in the

1 absence of such an office, an office that handles the same or
2 similar functions. The fund shall be solely used to help defray
3 the cost of maintaining, administering, preserving and caring
4 for the records of the county.

5 (b) The [county] commissioners shall, after consultation
6 with the officer, furnish each [of such officers] officer with
7 an office and additional space in the county building, court
8 house or other building at the county seat sufficient to perform
9 the duties of the office.

10 (c) Any [person] officer failing or refusing to maintain
11 [his] the office and to keep all public records and papers
12 [belonging thereto] of the office in the buildings appropriated
13 for such purpose in accordance with the provisions of this
14 section, shall be guilty of a misdemeanor, and, upon conviction
15 thereof, shall be sentenced to undergo imprisonment until [he]
16 the officer complies with the provisions of this section, or
17 until sooner discharged by order of the court, and to pay a fine
18 not exceeding five hundred dollars (\$500), to be paid to the use
19 of the county.

20 Section 406. Records Open to Inspection.--[(a) The minute
21 book and other fiscal records and documents of every county may
22 be open to the inspection of any taxpayer thereof, but the
23 proper officers may make reasonable rules and regulations
24 respecting the time of such inspection.

25 (b) In case any officer shall refuse to permit the
26 inspection of any fiscal record or document the taxpayer may, by
27 petition to the court of common pleas of the county, set forth
28 his reasons for desiring to make such inspection, and, if the
29 court deems such reasons proper, it shall order the officer to
30 permit the inspection to be made.] Except as otherwise provided

1 by this act, records of county offices shall be open for
2 inspection subject to the rules and regulations provided in the
3 act of February 14, 2008 (P.L.6, No.3), known as the "Right-to-
4 Know Law."

5 Section 407. Officers to Secure Funds, Records, Books, Et
6 Cetera, from Predecessors.--(a) Any person, elected or
7 appointed, and duly commissioned to any county office, shall
8 demand and receive all records, books, drafts, plans, papers,
9 seals or other official things, including all public funds held
10 in [such] the office, and not otherwise provided for by Article
11 XIII.1 of the [act, approved May seventeen, one thousand nine
12 hundred forty-nine (Pamphlet Laws 1403), known as the Municipal
13 Unclaimed Moneys Act,] act of April 9, 1929 (P.L.343, No.176),
14 known as "The Fiscal Code," belonging to [such] the office from
15 the person or persons who held the office immediately before
16 [his] the officer's election or appointment, or from any other
17 person or persons holding or possessing them.

18 (b) Any person detaining from such a county office any
19 records, books, drafts, plans, papers, seals or other official
20 things, including public funds, as herein provided, belonging to
21 [such] an office after reasonable demand [therefor] has been
22 made, shall be guilty of a misdemeanor, and, upon conviction
23 thereof, shall be sentenced to undergo imprisonment until the
24 delivery of any such official things found to be in [his] the
25 person's possession or control to the proper officer, or until
26 sooner discharged by order of the court, and to pay a fine not
27 exceeding five hundred dollars (\$500), to be paid to the use of
28 the county.

29 Section 408. Deputies to Act in Certain Cases.--(a)
30 Whenever any county officer is authorized or required to appoint

1 a deputy or deputies, such deputy or principal deputy, where
2 there are more than one, shall, during the necessary or
3 temporary absence of [his] the deputy's principal, perform all
4 duties of such principal, and also, in case of a vacancy or as
5 provided in section 401(b), until a successor is qualified.
6 While fulfilling these duties, in the case of a vacancy, in
7 counties of the third through eighth classes, the deputy shall
8 receive the salary provided by law for the principal or the
9 salary provided for the deputy, whichever is greater.

10 (b) No person temporarily succeeding to any county office by
11 reason of the death, resignation or removal of the duly elected
12 or appointed officer, shall execute any of the duties of such
13 office until [he] that person has first taken oath and filed the
14 bond required of the principal officer.

15 Section 409. Vacancies Not Otherwise Provided For.--[In] (a)
16 Except as otherwise provided in subsection (b), in case of a
17 vacancy, happening by death, resignation or otherwise, in any
18 county office created by the Constitution or laws of this
19 Commonwealth, and where no other provision is made by the
20 Constitution, or by [the provisions of] this act, to fill the
21 vacancy, it shall be the duty of the Governor to appoint a
22 suitable person to fill such office, who shall continue
23 [therein] to hold and discharge the duties [thereof] of the
24 office until the first Monday in January following the next
25 municipal election occurring not less than ninety days after the
26 occurrence of the vacancy, or for the balance of the unexpired
27 term, whichever period is shorter. If there is a municipal
28 election occurring not less than ninety days after the
29 occurrence of the vacancy, other than the one at which the
30 office ordinarily is filled, then the office shall be filled at

1 that election for the balance of the unexpired term. Such
2 appointee shall be confirmed by the Senate if in session.

3 (b) In counties of the second class A, the appointed person
4 shall continue in office and discharge the duties of the office
5 for the balance of the unexpired term.

6 (c) The Governor shall discharge the duties set forth in
7 this section in accordance with section 207.1(d)(5.1) of the act
8 of April 9, 1929 (P.L.177, No.175), known as "The Administrative
9 Code of 1929."

10 Section 410. County Officials to Furnish Information to
11 Heads of the Governmental Departments.--(a) It shall be the
12 duty of all county officers to furnish, on application
13 [therefor,] to the head of any department of the State
14 government [such] information and copies of [such] records or
15 documents contained in their respective offices, as in the
16 opinion of [such] the head of department may be necessary or
17 pertinent to the work of [his respective] the department. The
18 county so furnishing information shall receive for copying and
19 forwarding the same such reasonable compensation as the Auditor
20 General may determine. Such compensation shall be paid to the
21 county by the State Treasurer, out of moneys not otherwise
22 appropriated, upon warrant from the Auditor General.

23 (b) All county officers shall also furnish to the Department
24 of Community [Affairs] and Economic Development such information
25 as may be requested by it.

26 Section 411. Penalty for Neglect or Refusal to Perform
27 Duties.--If any county officer neglects or refuses to perform
28 any duty imposed on [him] the officer by the provisions of this
29 or any other act, [or by the provisions of any other act of
30 Assembly,] or by any rule of court, [or other provision of law,

1 he] the officer shall, for each [such] neglect or refusal, be
2 guilty of a misdemeanor, and, on conviction thereof, shall be
3 sentenced to pay a fine not exceeding five hundred dollars
4 (\$500).

5 Section 11. Section 412 of the act is repealed:

6 [Section 412. Absconding Officers.--The office of any county
7 officer absconding from the county shall be vacant to all
8 intents and purposes.]

9 Section 12. Sections 413 and 414 of the act are amended to
10 read:

11 Section 413. Qualifications of Elected County Officers.--(a)
12 No person shall be elected to any county office, except the
13 office of district attorney otherwise provided for by this act,
14 unless [he] the person shall be at least eighteen years of age,
15 a citizen of the United States and a resident of the county, and
16 shall have resided within the county for one year next preceding
17 [his] election.

18 (b) In addition to the qualifications in subsection (a), a
19 person shall not be eligible for the office of sheriff except in
20 accordance with the act of February 9, 1984 (P.L.3, No.2), known

23 county officials and employes may, when authorized by the county

27 unless provisions of law require the payment of a higher rate]

6 Commissioners.--(a) Each of the following officers may
7 designate and appoint a person who shall be licensed to practice
8 law in this Commonwealth to act as solicitor to that officer:

9 (1) The county treasurer.

13 (5) The coroner.

14 (6) The controller or auditors, as the case may be.

15 (b) The solicitor shall advise upon all legal matters, and

28 Section 440. State Associations Authorized.--County officers
29 of each county may organize for themselves a State association

1 (1) The county commissioners, together with the county

19 Section 442. Deputies and Solicitors May Attend Annual
20 Meetings.--[The deputy controller, the deputy sheriff, the
21 deputy register of wills, the deputy clerk of orphans' court,
22 the deputy treasurer, the deputy prothonotary, the deputy clerk
23 of the courts of quarter sessions, the first assistant district
24 attorney, one assistant public defender and the deputy recorder
25 of deeds and the chief deputy coroner, with the approval of his
26 principal, and the solicitor for each officer, may attend the
27 annual meetings of his respective associations either together
28 with the controller, sheriff, register of wills, treasurer,
29 prothonotary, clerk of the courts of quarter sessions, district
30 attorney, public defender, recorder of deeds or coroner as the

17 Section 443. County Payment for Expenses of Attending
18 Members [to be Paid by County]; Time Limit on Meetings.--(a)
19 The actual expenses of all authorized elected county officers
20 attending the annual meetings of their associations shall be
21 paid by the [several counties] county out of the general county
22 fund. Each of [these] the officers, except the county
23 commissioners, shall be reimbursed for actual expenses not to
24 exceed [one hundred seventy-five dollars (\$175)] two hundred
25 twenty dollars (\$220) per day for the number of days specified
26 in subsection (b) of this section, together with mileage going
27 to and returning from such meeting and the registration fee. The
28 sum of [one hundred seventy-five dollars (\$175)] two hundred
29 twenty dollars (\$220) per day as set forth in this subsection
30 shall be adjusted annually by the annual increase in the cost of

1 living as determined annually by the United States Department of

3 (a.1) The actual expenses of all authorized nonelected
4 county officers and employes attending the annual meetings of
5 their associations may be paid by the [several counties] county
6 out of the county general fund. Each of these officers may be
7 reimbursed for actual expenses in an amount not to exceed [one
8 hundred seventy-five dollars (\$175)] two hundred twenty dollars
9 (\$220) per day for the number of days specified in subsection
10 (b) of this section, together with mileage going to and
11 returning from such meetings and the registration fee. The sum
12 of [one hundred seventy-five dollars (\$175)] two hundred twenty
13 dollars (\$220) per day shall be adjusted annually as set forth
14 in subsection (a) of this section.

15 (a.2) Every delegate attending the annual meeting shall
16 submit to the county original receipts along with an itemized
17 account of expenses incurred at the meeting. The county may
18 authorize employes to be compensated at their regular employe
19 rate during their attendance at the annual meeting. The actual
20 expenses for elected officers shall, and for nonelected officers
21 may, be paid for the number of days specified in subsection (b).
22 In addition, elected county officers shall receive, and
23 nonelected county officers and employes may receive, actual
24 expenses not to exceed [one hundred seventy-five dollars (\$175)]
25 two hundred twenty dollars (\$220) per day for each day not in

6 Section 444. Other Meeting Expenses Paid by Counties.--(a)
7 In addition to the expenses [hereinbefore] authorized in this
8 subdivision, the necessary expenses of the annual meetings of
9 the associations hereinafter named, including annual association
10 dues, printing, committee expenses and stenographical expense,
11 shall be paid in equal parts by the [several] counties whose

28 (2) For each county of the third and fourth class, seven
29 hundred fifty dollars (\$750).

30 (3) For each county of the fifth and sixth class, six

1 hundred twenty-five dollars (\$625).

2 (4) For each county of the seventh and eighth class, five
3 hundred dollars (\$500).

4 (c) In the case of the directors of veterans' affairs for
5 counties other than those of the second class A, the portion
6 charged to each county shall not exceed four hundred dollars
7 (\$400), and in the case of the probation officers an annual
8 membership subscription not exceeding [ten dollars (\$10)] twelve
9 dollars and fifty cents (\$12.50) per member shall be paid by the
10 county, and shall be in lieu of the expenses hereinbefore in
11 this section provided for other county officers.

12 (d) The amounts set forth in subsections (b) and (c) shall
13 be adjusted annually by the annual increase in the cost of
14 living as determined annually by the United States Department of
15 Labor.

16 Section 445. Annual Assessments for County Commissioners,
17 Etc.--(a) In addition to the expenses hereinbefore authorized,
18 the necessary expenses of the association of county
19 commissioners, county solicitors and chief clerks shall be
20 apportioned among the counties holding membership in the
21 association in amounts provided for by the rules and regulations
22 of the association.

23 (a.1) In addition to the expenses hereinbefore authorized,
24 the necessary expenses of the association of district attorneys
25 shall be apportioned among the counties holding membership in
26 the association in amounts provided for by the rules and
27 regulations of the association.

28 (b) Such annual apportionments of expenses shall be as
29 approved at each annual [convention] conference of the said
30 association by a majority vote of the members present and, when

1 so approved, shall be paid by the several counties from general
2 county funds.

3 Section 446. Associations and Organizations Concerned with
4 Governmental Affairs.--The [county] commissioners of any county
5 may[, by resolution,] join associations and organizations
6 concerned with county or governmental affairs, other than the
7 [Pennsylvania State Association of County Commissioners] County
8 Commissioners Association of Pennsylvania, may pay dues to such
9 associations and organizations and may send delegates to
10 meetings or [conventions] conferences of such associations and
11 organizations and pay the necessary expenses incident to their
12 attendance at such meetings or [conventions] conferences.

13 The county commissioners of any county may [by resolution]
14 authorize any county official and [his] employes of the official
15 to attend meetings of professional associations and
16 organizations, or study or training sessions for persons holding
17 the same or similar office or employment, and may pay all or any
18 specified portion of the necessary expenses incident to their
19 attendance at such meetings or sessions.

20 Every person attending any [convention] conference, meeting
21 or study or training session referred to in this act shall
22 submit to the controller, or to the county commissioners in
23 counties having no controller, an itemized account of [his]
24 expenses [thereat] related to the event, including traveling
25 expenses or mileage, which the county commissioners may have
26 agreed to pay.

27 Section 460. Meetings Open to Public.--[(a)] All meetings,
28 regular and special, of the board of county commissioners and of
29 all boards, commissions and authorities, created by or operating
30 as agencies of a county, are hereby declared to be public

1 meetings [open to the public at all times.

2 (b) Nothing contained in this section shall prevent the
3 county commissioners or any such board, commission or authority
4 from holding executive sessions from which the public is
5 excluded, but no final official action shall be taken as to any
6 proposed or existing resolution, ordinance, rule or regulation,
7 or part thereof, at such an executive session.] subject to the
8 provisions of 65 Pa.C.S. Ch. 7 (relating to open meetings).

9 Section 502. Organization.--The [county] commissioners shall
10 meet on the first Monday of January, in the year one thousand
11 nine hundred and fifty-six, and on the first Monday of January
12 every fourth year thereafter, in the office provided for them at
13 the county seat for the purpose of organization. If the first
14 Monday is a legal holiday, the meeting shall be held the first
15 day following.

16 Section 503. Meetings, Regular and Special; Conduct of
17 Meetings; Notices.--(a) The [county] commissioners shall adopt
18 rules for the conduct and order of business[, establishing also]
19 and establish regular times and places of meeting. A copy of
20 [such] the rules shall be posted at all times in a conspicuous
21 place in the county court house for the benefit of the public.

22 (b) Each commissioner shall have at least twenty hours
23 notice of any special meeting and of the nature of business to
24 be conducted [thereat] at the meeting, unless [such] the notice
25 [be] is waived by [him] the commissioner in writing or by
26 attendance at [such] the special meeting.

27 Section 504. Quorum; Execution of Official Instruments.--(a)
28 The commissioners shall constitute a board, two members of which
29 shall be a quorum for the transaction of business, and, when
30 convened [in pursuance of notice or according to adjournment]

1 after notice, shall be competent to perform all the duties
2 appertaining to the office of county commissioners.

3 (b) Where any official document, instrument or official
4 paper is to be executed by the [county] commissioners, it shall
5 be done by at least two of the commissioners and attested by the
6 chief clerk who shall affix the county seal thereto.

7 Section 507. Expenses.--The [county] commissioners shall be
8 allowed their expenses, necessarily incurred and actually paid,
9 in the discharge of their official duties, or in the performance
10 of any service, office, or duty imposed upon county
11 commissioners.

12 Section 508. Office Furniture, Stationery, Etc.--(a) The
13 [county] commissioners, at the cost of the county, shall
14 purchase and provide the office furniture, equipment and
15 supplies, blank books, [blanks,] blank dockets, books for
16 records, stationery, postage, [fuel, light and janitor and
17 telephone service,] utilities, cleaning and maintenance required
18 for each of the county officers whose offices are located in the
19 county buildings or at such other places at the county seat as
20 may be designated by the commissioners, and all supplies used by
21 the public in connection with such offices.

22 (b) The [county] commissioners, at the cost of the county,
23 shall purchase and provide all of the same items as needed for
24 each of the county officers whose offices are not required by
25 law to be kept and maintained in county buildings or at the
26 county seat.

27 (c) Before purchasing office furniture, equipment or
28 supplies, blank books, blank dockets, books for records or
29 stationery, the county officers who are to be furnished with any
30 of [such] the items shall have an opportunity to state in

1 writing [his] preferences as to the type and make of [such
2 articles or any of them] the items. The commissioners shall,
3 when feasible, purchase and supply to each officer [his
4 preference in such articles] the preferred item when such
5 preference has been given.

6 Section 509. Ordinances and Resolutions.--(a) The [board
7 of] commissioners may adopt resolutions and ordinances
8 prescribing the manner in which powers of the county shall be
9 carried out and generally regulating the affairs of the county.
10 The commissioners may formulate and adopt ordinances,
11 resolutions, and rules and regulations, pertaining to the use of
12 any property owned or used by the county and the conduct of
13 persons in, on or about such county property, in order to
14 preserve such property and to promote and preserve the public
15 health, safety and welfare.

16 (b) All [such] proposed ordinances, unless otherwise
17 provided by law, shall be published at least once in one
18 newspaper of general circulation in the county not more than
19 sixty days nor less than seven days prior to passage. Public
20 notices of any proposed ordinance shall include either the full
21 text [thereof] or the title and a brief summary of the proposed
22 ordinance prepared by the county solicitor setting forth all the
23 provisions in reasonable detail and a reference to a place
24 within the county where copies of the proposed ordinance may be
25 examined. If the full text is not included a copy thereof shall
26 be supplied to [a] the same newspaper of general circulation in
27 [the county at the time] which the public notice is published.
28 If the full text is not included, an attested copy thereof shall
29 be filed in the county law library[.] within thirty days after
30 enactment. The date of such filing shall not affect the validity

1 of the process of the enactment or adoption of the ordinance;
2 and a failure to record within the time provided shall not be
3 deemed a defect in the process of the enactment or adoption of
4 the ordinance. In the event substantial amendments are made in
5 the proposed ordinance or resolution, [upon enactment,] the
6 commissioners shall [within ten days], at least ten days prior
7 to enactment, re-advertise in one newspaper of general
8 circulation in the county, a brief summary setting forth all the
9 provisions in reasonable detail together with a summary of the
10 amendments. [Such ordinances] Ordinances shall not become
11 effective until recorded in the ordinance book of the county. In
12 any case in which maps, plans or drawings of any kind are
13 adopted as part of an ordinance, the commissioners may, instead
14 of publishing the same as part of the ordinance, refer in
15 publishing the ordinance to the place where such maps, plans or
16 drawings are on file and may be examined.

17 (c) The [board of county] commissioners may also prescribe
18 fines and penalties not exceeding one thousand dollars (\$1,000)
19 for a violation of a building, housing, property maintenance,
20 health, fire or public safety code or ordinance and for water,
21 air and noise pollution violations, and not exceeding six
22 hundred dollars (\$600) for a violation of any other county
23 ordinance, which fines and penalties may be collected by suit,
24 brought in the name of the county, in like manner as debts of
25 like amount may be sued for.

26 (d) Any person violating any of the ordinances adopted by
27 the [board of county] commissioners pursuant to this section
28 shall, upon conviction thereof at a summary proceeding, be
29 sentenced to pay such fine as may be prescribed in such
30 ordinances by the [county] commissioners but not in excess of

1 one thousand dollars (\$1,000), to be paid to the use of the
2 county, with costs of prosecution, or to be imprisoned for not
3 more than ten days, or both.

4 Section 521. Duties and Powers of Chief Clerk.--(a) The
5 chief clerk shall keep the books and accounts of the board of
6 county commissioners, record and file their proceedings and
7 papers, attest all orders and voucher checks issued by them and
8 perform all other duties pertaining to [his office as] the
9 office of chief clerk.

10 (b) [He] The chief clerk shall have general power to
11 administer oaths and affirmations[,] pertaining to the business
12 of the office of the county commissioners.

13 Section 601. Election and Term; Seal.--(a) At the municipal
14 election immediately preceding the expiration of the term of the
15 controller [now] in office on January 1, 1956, and quadrennially
16 thereafter, the qualified electors of each county of the third,
17 fourth and fifth classes, and of every other county where the
18 office of controller has been or may hereafter be established,
19 including counties in which the office was established by
20 general law, or otherwise, while such counties were in a higher
21 classification, shall elect one citizen of the county, who shall
22 serve as controller for the term of four years from the first
23 Monday of January following [his] the controller's election, or
24 until [his] a successor shall be qualified[, if he so long shall
25 behave himself well].

26 (a.1) In counties of the second class A, a controller shall
27 be elected at the municipal election immediately preceding the
28 expiration of the term of the controller in office on the
29 effective date of this subsection and quadrennially thereafter.

30 (b) Each county controller shall be provided with an

1 official seal of [his] the office by the county commissioners of
2 the county, which shall be used for the attestation of all
3 official papers.

4 Section 602. Eligibility.--(a) No person holding office
5 under the United States shall be eligible to the office of
6 county controller during [his] continuance in such office, nor
7 until one year thereafter.

8 (b) The county commissioners, county treasurer,
9 prothonotary, register of wills, clerk of the courts, recorder
10 of deeds, sheriff and district attorney, and their chief clerks
11 or deputies, shall be ineligible, during their continuance in
12 such office and for two years thereafter, to the office of
13 county controller.

14 (c) The controller shall always be eligible to reelection or
15 appointment.

16 Section 603. Deputy Controller and Clerks.--(a) The
17 controller in counties of the second class A, third, fourth and
18 fifth classes shall appoint a deputy controller and clerks, and
19 in counties of the sixth, seventh and eighth classes may appoint
20 a deputy controller and clerks, and each controller may
21 authorize one or more of the clerks employed in [his] the
22 controller's office to administer to all persons oaths and
23 affirmations, pertaining to the business of the office, with the
24 same force and effect as if administered by the controller or
25 deputy controller.

26 (b) The controller may appoint a second deputy controller,
27 who shall possess and discharge all the rights, powers and
28 duties of the principal deputy controller during [his necessary
29 or] the principal deputy controller's and the controller's
30 temporary absence.

1 Section 15. Section 604 of the act is repealed:

2 [Section 604. Solicitor to the Controller.--The county
3 controller may designate and appoint one person, learned in the
4 law, to act as his solicitor. Such solicitor shall advise upon
5 all such legal matters as may be submitted to him, and shall
6 conduct any litigation desired by the county controller. He
7 shall hold office at the pleasure of the controller.]

8 Section 16. Sections 605, 606, 607, 701, 702 and 703 of the
9 act are amended to read:

10 Section 605. Establishment of Office of Controller in
11 Counties of the Sixth, Seventh and Eighth Classes.--(a) The
12 office of controller may be established in any county of the
13 sixth, seventh or eighth class by the affirmative vote of a
14 majority of the electors of the county voting on the question
15 submitted, as herein provided, at the general election in which
16 the auditors are in the third year of their term.

17 (b) The question shall be submitted to the electors of the
18 county whenever county electors file a petition containing
19 signatures equal to at least five per centum of the highest vote
20 cast for any office in the county at the last preceding general
21 election. [Such] The petition shall be filed with the county
22 commissioners at least sixty days before the day of the general
23 election at which the question is to be submitted. If the
24 petition is sufficiently signed the county commissioners shall
25 cause the question to be submitted in the manner provided by the
26 Pennsylvania Election Code.

27 (c) If the majority of electors voting on the question shall
28 vote in favor of establishing the office of county controller,
29 [such] the office shall thereby be established, and, at the next
30 municipal election, and quadrennially thereafter, the electors

1 of the county shall choose a citizen of the county for the
2 office of controller in place of the county auditors.

3 Section 606. Appointment by Governor; Duties of Auditors;
4 Abolition of Office of Auditor.--(a) Whenever the office of
5 controller is established in any county, under the provisions of
6 section 605 of this act, or by a change in class of such county
7 not otherwise provided for by law, the Governor shall appoint a
8 suitable person to act as controller of said county until [his]
9 a successor in office is duly elected and installed.

10 (b) Upon the appointment of a controller, as provided in
11 this section, the county auditors then in office shall proceed
12 to audit all accounts as required by law, and shall file a
13 report of such audit with the controller so appointed, not later
14 than three months after the controller assumes [his] office,
15 whereupon the office of county auditor shall be abolished and
16 cease to exist in said county.

17 Section 607. Expenses.--The county controller and [his] the
18 county controller's deputy, clerks, and auditors shall be
19 allowed their expenses necessarily incurred and actually paid in
20 the discharge of their official duties, or in the performance of
21 any service or duty imposed upon them.

22 Section 701. Election and Vacancies.--(a) In each county
23 where the office of controller has not been established, three
24 county auditors shall be elected in the year one thousand nine
25 hundred fifty-five, and every fourth year thereafter. In the
26 election of auditors, each qualified elector shall vote for no
27 more than two persons. The three persons having the highest
28 number of votes shall be elected.

29 (b) Any casual vacancy in the office of county auditors
30 shall be filled, for the balance of the unexpired term, by the

1 court of common pleas of the county, [by the appointment of an
2 elector who voted for the auditor whose place is to be filled.]
3 sitting en banc, appointing a successor who shall be a
4 registered elector of the county and shall be a member of the
5 same political party as was the auditor whose place is to be
6 filled at the time the auditor assumed office.

7 Section 702. Eligibility.--(a) No person shall be eligible
8 to the office of county auditor who, within two years, shall
9 have been treasurer of the county.

10 (b) [No person holding the office of county auditor shall at
11 the same time hold or be employed in any office of the county,
12 the county institution district, any school district, any board
13 of health or any municipality authority of which the county is a
14 member.] No person holding the office of county auditor shall at
15 the same time hold any office or employment for the county or
16 for any municipal authority of which the county is a member. A
17 county auditor may not be employed in an administrative position
18 by any school district or any organization or entity that may be
19 audited by the board of auditors. A county auditor may not hold
20 an elected or appointed office or serve as a manager for any
21 municipal corporation in the county.

22 Section 703. Meetings; Quorum.--(a) The auditors shall
23 [assemble] meet at the county seat on the first Monday of
24 January in each year[, and begin] for the purpose of organizing
25 and to begin their audit of the fiscal affairs of the county for
26 the fiscal year immediately preceding.[, and thereafter, at such
27 times as they may find necessary for the completion of their
28 audit before the first day of the following July. They may, upon
29 petition to the court of common pleas, have such additional time
30 for the completion of their report as the court shall allow.]

1 If the first Monday in January is a legal holiday, the meeting
2 shall be held the first day following.

3 (b) The auditors shall meet as necessary for the completion
4 of their audit by the first day of the following July. The
5 auditors may petition the court of common pleas for additional
6 time for the completion of the audit and the filing of the
7 report. The court, upon a showing of due cause, shall grant such
8 additional time as it deems necessary for completion of the
9 audit and report.

10 (c) The auditors shall receive such compensation as
11 determined by the county commissioners in accordance with the
12 act of November 1, 1971 (P.L.495, No.113), entitled, as amended,
13 "An act providing for the compensation of county officers in
14 counties of the second through eighth classes, for compensation
15 of district attorneys in cities and counties of the first class,
16 for compensation of district election officers in all counties,
17 for the disposition of fees, for filing of bonds in certain
18 cases and for duties of certain officers," provided that any
19 daily or hourly compensation set for the auditors shall be
20 applicable for any period of extension granted in accordance
21 with this section.

22 (d) Any two auditors when duly convened shall be a quorum
23 for the purpose of transacting any business.

24 Section 17. Section 704 of the act is repealed:

25 [Section 704. Counsel.--The auditors may employ a competent
26 attorney-at-law to act as their counsel and attorney.]

27 Section 18. Sections 805, 806 and 806.1 of the act are
28 amended to read:

29 Section 805. Misapplication of Funds Collected for Specific
30 Purposes.--Whenever any moneys are collected by law in any

1 county [for any special purpose, and paid into the hands] and
2 are in the possession or control of the treasurer of [such] the
3 county, it shall be unlawful for [such] the treasurer to apply
4 such moneys, or any part thereof, to any other purpose than that
5 for which [such] the moneys were collected unless otherwise
6 authorized by law. Every such misapplication shall [be a
7 misdemeanor, upon conviction thereof such treasurer shall be
8 punished by a fine of not less than the amount so misapplied, or
9 by imprisonment for not less than three months nor more than one
10 year, or both.] constitute a violation of 18 Pa.C.S. § 3927
11 (relating to theft by failure to make required disposition of
12 funds received).

13 Section 806. Deputy Treasurer.--The county treasurer is
14 [hereby] authorized to appoint a deputy county treasurer who
15 shall perform such duties as shall be prescribed by the county
16 treasurer.

17 Section 806.1. Second Deputy Treasurer.--The county
18 treasurer may appoint a second deputy treasurer, who shall
19 possess and discharge all the rights, powers and duties of the
20 principal deputy treasurer during [his necessary or] the
21 principal deputy treasurer's and treasurer's temporary absence.

22 Section 19. Section 807 of the act is repealed:

23 [Section 807. Solicitor to County Treasurer in Third,
24 Fourth, Fifth, Sixth, Seventh and Eighth Class Counties.--In
25 counties of the third, fourth, fifth, sixth, seventh and eighth
26 classes, the county treasurer is authorized to appoint one
27 person, learned in the law, as his solicitor. The solicitor
28 shall advise upon all legal matters that may be submitted to him
29 and shall conduct any litigation when requested so to do by the
30 treasurer.]

1 Section 20. Sections 901, 902, 903, 904, 1001 and 1002 of
2 the act are amended to read:

3 Section 901. Appointment; Qualifications.--The county
4 commissioners shall appoint a county solicitor, who shall be an
5 attorney-at-law admitted to practice in the courts of this
6 Commonwealth. [He shall, before] Before entering upon the duties
7 of [his] office, the solicitor shall file with the county
8 commissioners an agreement to pay all fees, attorney's fees, and
9 commissions received from every source as county solicitor into
10 the county treasury.

11 Section 902. Duties.--[He] The solicitor shall commence and
12 prosecute all suits brought, or to be brought, by the county,
13 wherein or whereby any rights, privileges, properties, claims or
14 demands of the county are involved, as well as defend all
15 actions or suits brought against the county, and shall perform
16 all duties now enjoined by law upon county solicitors, and shall
17 do all and every professional act and render legal advice
18 incident to the office which may be required of [him] the
19 solicitor by the commissioners.

20 Section 903. Employees in [Third Class] Certain Counties.--In
21 counties of the second class A and third class, the county
22 solicitor may, with the consent of the county commissioners,
23 employ [a stenographer as an assistant in his office] clerks or
24 assistants as may be necessary in the discharge of the
25 solicitor's duties.

26 Section 904. Assistant County Solicitors.--[The] (a) Except
27 as provided in subsection (b), the county commissioners may
28 appoint one or more assistant county solicitors, and special
29 counsel who shall be attorneys at law admitted to practice in
30 the courts of this Commonwealth. Each assistant and special

1 counsel shall perform such duties in connection with the legal
2 affairs of the county as may be assigned [to him] by the county
3 commissioners or the county solicitor.

4 (b) In counties of the second class A, the power to appoint
5 assistant county solicitors and special counsel as provided in
6 this section shall lie with the county solicitor, subject to the
7 approval of the county commissioners.

8 Section 1001. County Engineer; Appointment; Term.--The
9 [county] commissioners of any county may appoint a professional
10 engineer in civil engineering[, who shall be styled] or an
11 engineering firm as the county engineer. [Such] The engineer
12 shall serve at the pleasure of the commissioners.

13 Section 1002. Duties.--The county engineer shall:

14 (1) prepare plans, specifications, and estimates of all
15 engineering work undertaken by the county, and, whenever
16 required, shall furnish the commissioners with reports,
17 information, or estimates on any such work and, in general,
18 shall perform all [such] duties with reference to any county
19 engineering work as the county commissioners may from time to
20 time prescribe.

21 (2) perform all duties relating to surveying as may be

25 Section 21. Article XII of the act is repealed:

26 [ARTICLE XII

27 SHERIFF AND CORONER

28 (a) Sheriff

29 Section 1201. Unfinished Business of Outgoing Sheriff.--(a)
30 It shall be the duty of every outgoing sheriff, to deliver all

1 unfinished and unexecuted writs and process whatsoever to his
2 successor whose duty it shall be to receive and execute the same
3 as if said writs and process had been originally issued and
4 directed to him, and to carry out and complete all other
5 official duties of his predecessor.

6 (b) Whenever any real estate shall be sold under any
7 execution by a sheriff who shall, in any lawful manner, be
8 succeeded in office before any deed shall be executed and
9 acknowledged by him in due form of law for such real estate, his
10 successor in office shall have the same power and be under the
11 same duty to execute and acknowledge a deed for such real estate
12 to the purchaser thereof as the sheriff selling such real estate
13 under execution if he were still in office, which deed so
14 executed shall be as effectual in law as if the title had been
15 completed by the former sheriff.

16 (c) No court order shall be necessary in any event to
17 authorize an incoming sheriff to carry out his duties as
18 prescribed by this act.

19 Section 1202. Sheriff May Act by Deputy.--Whenever the
20 sheriff is or shall be required by law to act in person under or
21 by virtue of any writ or process whatsoever issued by the courts
22 of this Commonwealth, he may act either in person or by a
23 regularly appointed deputy sheriff.

24 Section 1203. Chief Deputy; Compensation.--The sheriff of
25 each county shall appoint, by commission duly recorded in the
26 office for recording deeds, a chief deputy, whose appointment
27 shall be revocable by the sheriff at pleasure on recording in
28 said office a signed revocation thereof. The chief deputy,
29 during his continuance in office, shall have full power and
30 authority to perform any duty incumbent upon such sheriff, with

1 like effect in law as if such official act had been done by the
2 sheriff in person, regardless of the ability or temporary
3 disability of such sheriff to act, while such sheriff continues
4 in office. Nothing in this section shall operate to relieve such
5 sheriff or his sureties from liability upon their official bond.

6 Section 1204. Real Estate Deputies in Counties of the Third
7 and Fourth Classes.--In counties of the third and fourth
8 classes, the sheriff may have a real estate deputy to take
9 charge of all matters relating to sheriff's sales of real estate
10 and distributions of the proceeds thereof, whose appointment
11 shall be made and be revocable as hereinbefore provided for the
12 chief deputy. Such deputy shall have full power to perform all
13 duties incumbent upon the sheriff in like manner as his chief
14 deputy with like effect in law as if such official acts had been
15 done by the sheriff in person. Such duties shall include the
16 execution and acknowledgment of sheriff's deeds for real estate
17 upon receipt of the purchase price thereof. Nothing in this act
18 shall operate to relieve the sheriff or his sureties from
19 liability upon their official bonds but such liability shall
20 continue as heretofore.

21 Section 1205. Deputies and Clerks.--The sheriff of each
22 county may appoint such deputies and clerks as may be necessary
23 to properly transact the business of his office. He may revoke
24 the appointment of deputies in the same manner as his chief
25 deputy. The sheriff may also appoint necessary special deputies,
26 when any emergency arises, to assist him in executing any civil
27 or criminal process or court order or in preserving the peace,
28 who shall serve only so long as they are absolutely needed.

29 Section 1206. Deputy Sheriff's Qualifications.--A sheriff
30 shall not appoint any person a chief deputy or any other deputy

1 sheriff unless the sheriff files with the prothonotary, prior to
2 the appointment of such person, the name and photograph of such
3 person, together with an affidavit of such person setting forth
4 the following:

5 (1) His full name, age, and residence address.

6 (2) That he is a citizen of the United States, and eighteen
7 years of age or over.

8 (4) That he has never been convicted of a crime involving
9 moral turpitude under the laws of this Commonwealth, or of any
10 other state, or of the United States.

11 (5) That he has not, for a period of two years immediately
12 preceding the filing of such affidavit, acted either for himself
13 or as the agent or employe of another, in any labor dispute, or
14 hired himself out or performed any service as a private
15 detective, private policeman or private guard in any labor
16 dispute, or received any fee or compensation whatsoever for
17 acting as a private detective, private policeman or private
18 guard in any labor dispute, or conducted the business of a
19 private detective agency, or of any agency supplying private
20 detectives, private policemen or private guards, or advertised
21 or solicited any such business in this Commonwealth in
22 connection with any labor dispute.

23 Section 1207. False Statements in Deputy's Affidavit.--Any
24 false statement contained in any such affidavit shall constitute
25 perjury, and shall be punishable as such.

26 Section 1208. Filed Items, Public Records.--The name,
27 photograph, and affidavit of any such person so filed with the
28 prothonotary, shall constitute a public record.

29 Section 1209. Public List of Applicants for Deputy
30 Sheriff.--The sheriff shall, from time to time, prepare a list

1 of the names of all persons who have applied for appointment as
2 deputy sheriff and who meet the qualifications hereinbefore
3 prescribed. Such list shall be posted in a public place for a
4 period of not less than ten days, and thereafter shall be filed
5 in the office of the prothonotary. No deputies shall be
6 appointed by the sheriff whose names do not appear on said list.

7 Section 1210. Private Services, Gifts and Payments,
8 Contracts, Prohibited.--(a) No sheriff, deputy sheriff,
9 detective or other county police officer whatsoever, shall
10 perform, directly or indirectly, any official services or
11 official duties for any person, association or corporation, or
12 receive, directly or indirectly, any compensation, gifts or
13 gratuities from any person, association or corporation during
14 the period of his official services. Nothing herein contained
15 shall prohibit such officers from serving writs and other legal
16 process as authorized by law. Any compensation payable to any
17 such officer for official duties and services shall be paid only
18 out of the proper county, or other public funds, to the amount
19 and in the manner prescribed by law. Gifts, donations, and
20 gratuities of any nature whatsoever made by any person,
21 association or corporation to the county or to any official or
22 agent thereof, shall not constitute public funds within the
23 meaning of this section.

24 (b) No county, or any official or agent thereof, shall
25 accept as a gratuity, gift or donation any arms, ammunition,
26 military supplies, tear gas or equipment, or supplies or
27 articles of a similar character from, nor shall any such
28 gratuity, gift or donation be made by any person, association or
29 corporation.

30 (c) Any contract or agreement, whatsoever, made in violation

1 of the provisions of this section, shall be utterly void and of
2 no effect, in law or in equity, and is hereby declared to be
3 contrary to public policy.

4 (d) Notwithstanding any other provision of this section,
5 unless otherwise prohibited by resolution or ordinance of the
6 county, an individual who is employed as a sheriff, deputy
7 sheriff, detective or other county police officer may engage in
8 outside employment, including employment in security, during a
9 period in which the individual is not scheduled to perform nor
10 performing duty as a county employe. The county is not liable
11 for any damage resulting from an act of an individual acting
12 under this subsection.

13 Section 1211. Penalties.--Any sheriff, deputy sheriff or any
14 other county police officer, whatsoever, or any other official
15 of the county or any person, association or corporation,
16 violating any of the provisions of sections 1206, 1209 or 1210
17 of this act, shall be guilty of a misdemeanor, and, upon
18 conviction, shall be sentenced to pay a fine of not less than
19 one hundred dollars (\$100) nor more than five hundred dollars
20 (\$500), or to undergo imprisonment for not less than ninety days
21 nor more than two years, or both.

22 Section 1212. Construction.--Nothing contained in sections
23 1206 or 1210 of this act, shall be construed to prohibit the
24 appointment, employment or compensation by any county in the
25 manner expressly provided by law of--(1) night watchmen, (2)
26 railroad police, (3) bank police, (4) payroll police, (5)
27 special policemen to police and protect cemeteries and grounds
28 and buildings open to the public, or to enforce laws for the
29 prevention of cruelty to persons or animals, (6) fire police
30 whose only duty shall be to direct traffic and maintain order

1 to, at or from fires, (7) police or guards employed by nonprofit
2 corporations or organizations.

3 Section 1213. Solicitor in Third, Fourth, Fifth, Sixth,
4 Seventh and Eighth Class Counties.--In all counties of the
5 third, fourth, fifth, sixth, seventh and eighth classes, the
6 sheriff may appoint one person, learned in the law, as his
7 solicitor. Said solicitor shall advise the sheriff upon all
8 legal matters that may be submitted to him, and shall conduct
9 any litigation in connection with the sheriff's office when
10 requested so to do by the sheriff.

11 Section 1214. Chief Deputy Coroner to Act as Coroner in Case
12 of a Vacancy.--If any coroner shall be legally removed from his
13 office or shall die or resign before the expiration of the term
14 for which he was commissioned, the chief deputy coroner shall
15 execute the office of coroner and perform all things thereunto
16 appertaining and receive and retain for his own use the
17 compensation provided by law for coroners until another coroner
18 is commissioned and notice thereof is given to such chief deputy
19 coroner.

20 Section 1215. Sheriff to Keep Docket.--Every sheriff and
21 every coroner, acting as sheriff, shall provide and keep in his
22 office a book or books in which he shall enter all writs that
23 may come to him and the proceedings thereon, and, at the
24 expiration of his term of office, such book or books shall be
25 deposited in the office of the prothonotary for the inspection
26 of all persons interested therein.

27 (b) Coroner

28 Section 1231. Deputies.--The coroner may appoint one or more
29 deputies to act in his place and stead, as he may deem proper
30 and necessary. Such deputy or deputies shall have the same

1 powers as the coroner.

2 Section 1232. Duties with Respect to County Morgues.--The
3 coroner of each county in which a county morgue is established,
4 shall make general rules and regulations for its government and
5 control, and shall appoint suitable persons for each morgue so
6 established to have charge of the same, and who shall be
7 removable at the pleasure of the coroner. The number of such
8 persons and the salary of each shall be fixed by the salary
9 board.

10 Section 1233. Removal of Bodies to Morgue.--Whenever the
11 body of any deceased person who is unidentified or which body is
12 unclaimed by proper persons has been found within the county, it
13 shall be removed to the county morgue or to a private morgue
14 serving in lieu thereof. The coroner shall, if he deems it
15 necessary, cause any such body to be properly embalmed or
16 prepared for preservation for such length of time as he may
17 think proper. Any such body shall be examined or inspected only
18 by such persons as the coroner authorizes in writing, or who are
19 admitted in his presence. No such body shall be removed from any
20 such morgue except upon the certificate of the coroner.

21 Section 1234. Ambulance.--In each county, the county
22 commissioners may furnish and maintain, from the general funds
23 of the county, an ambulance for the removal of bodies of
24 deceased persons to and from the morgue, and for the burial of
25 unclaimed bodies. The coroner may provide rules and regulations
26 for the use and maintenance of the ambulance.

27 Section 1235. Unclaimed Property of Deceased; Sales.--(a)
28 The coroner shall safely keep in his charge all personal effects
29 and property which appear to have been on or about the person at
30 the time of his death, or being found on any decedent whose body

1 is received at the county morgue or at any other morgue serving
2 in lieu thereof, and all such effects and property which are
3 delivered to him according to law. The coroner shall hold such
4 property for one year, unless sooner claimed by legal
5 representatives of the deceased, or otherwise duly and lawfully
6 claimed or disposed of.

7 (b) After one year, the coroner shall cause such property
8 remaining unclaimed, or so much thereof as remains undisposed of
9 according to law, except moneys and such properties as
10 securities which may not be subject to such a sale, which shall
11 be turned over to the commissioners for proper disposition or
12 use, to be sold at public sale.

13 (c) Notice of any such public sale shall be published in at
14 least one newspaper of general circulation in the county once a
15 week for three successive weeks. The proceeds of all such sales
16 shall be paid immediately into the county treasury, and the
17 coroner shall make a written report thereof to the county
18 commissioners, under oath, at the same time. If the body has
19 been buried at the expense of the institution district, the
20 county shall pay the proceeds of sale, or such property as was
21 not subject to sale, as hereinbefore provided, less costs, over
22 to the institution district. The foregoing provisions shall be
23 in lieu of escheat to the Commonwealth.

24 Section 1236. Private Morgue May be Used.--In any county
25 where a county morgue is not maintained, the coroner may cause
26 any body which he is authorized to admit to a county morgue to
27 be removed to a private morgue within the county, and, for the
28 use thereof, the owner shall be paid a sum to be established by
29 the salary board, to be paid in the same manner as fees of
30 coroner's jurors are paid.

1 Section 1236.1. Requests for Examinations and Reports.--(a)
2 Requests for examinations or other professional services by
3 other counties or persons may be complied with at the discretion
4 of the coroner pursuant to guidelines established by the county
5 commissioners.

6 (b) A set of fees and charges for such examinations or
7 professional services shall be established by the coroner,
8 subject to approval by the county commissioners, and shall be
9 accounted for and paid to the county treasurer pursuant to
10 section 1760. Payment for examinations or professional services
11 shall be the responsibility of the county or person requesting
12 such services.

13 (c) The coroner may charge and collect a fee of up to one
14 hundred dollars (\$100) for each autopsy report, up to fifty
15 dollars (\$50) for each toxicology report, up to fifty dollars
16 (\$50) for each inquisition or coroner's report and such other
17 fees as may be established from time to time for other reports
18 and documents requested by nongovernmental agencies. The fees
19 collected shall be accounted for and paid to the county
20 treasurer pursuant to section 1760 and shall be used to defray
21 the expenses involved in the county complying with the
22 provisions of the act of March 2, 1988 (P.L.108, No.22),
23 referred to as the Coroners' Education Board Law.

24 Section 1237. Coroner's Investigations.--(a) The coroner
25 having a view of the body shall investigate the facts and
26 circumstances concerning deaths which appear to have happened
27 within the county, regardless where the cause thereof may have
28 occurred, for the purpose of determining whether or not an
29 autopsy should be conducted or an inquest thereof should be had,
30 in the following cases:

1 (1) sudden deaths not caused by readily recognizable
2 disease, or wherein the cause of death cannot be properly
3 certified by a physician on the basis of prior (recent) medical
4 attendance;

5 (2) deaths occurring under suspicious circumstances,
6 including those where alcohol, drugs or other toxic substances
7 may have had a direct bearing on the outcome;

8 (3) deaths occurring as a result of violence or trauma,
9 whether apparently homicidal, suicidal or accidental (including,
10 but not limited to, those due to mechanical, thermal, chemical,
11 electrical or radiational injury, drowning, cave-ins and
12 subsidences);

13 (4) any death in which trauma, chemical injury, drug
14 overdose or reaction to drugs or medication or medical treatment
15 was a primary or secondary, direct or indirect, contributory,
16 aggravating or precipitating cause of death;

17 (5) operative and peri-operative deaths in which the death
18 is not readily explainable on the basis of prior disease;

19 (6) any death wherein the body is unidentified or unclaimed;

20 (7) deaths known or suspected as due to contagious disease
21 and constituting a public hazard;

22 (8) deaths occurring in prison or a penal institution or
23 while in the custody of the police;

24 (9) deaths of persons whose bodies are to be cremated,
25 buried at sea or otherwise disposed of so as to be thereafter
26 unavailable for examination;

27 (10) sudden infant death syndrome; and

28 (11) stillbirths.

29 (b) The purpose of the investigation shall be to determine
30 the cause of any such death and to determine whether or not

1 there is sufficient reason for the coroner to believe that any
2 such death may have resulted from criminal acts or criminal
3 neglect of persons other than the deceased.

4 (c) As part of this investigation, the coroner shall
5 determine the identity of the deceased and notify the next of
6 kin of the deceased.

7 Section 1238. Autopsy; Inquest; Records.--(a) If, upon
8 investigation, the coroner shall be unable to determine the
9 cause and manner of death, he shall perform or order an autopsy
10 on the body.

11 (b) If the coroner is unable to determine the cause and
12 manner of death following the autopsy, he may conduct an inquest
13 upon a view of the body, as provided by law. At the inquest, the
14 coroner's duty shall be to ascertain the cause of death, to
15 determine whether any person other than the deceased was
16 criminally responsible therefor by act or neglect, and if so,
17 the identity of the person, and to examine any further evidence
18 and witnesses regarding the cause of death.

19 (c) The proceedings at the inquest shall be recorded, at the
20 expense of the county, in a manner to be provided by the county
21 commissioners.

22 Section 1239. Sudden Deaths Defined.--The coroner shall
23 regard any death as sudden if it occurs without prior medical
24 attendance by a person who may lawfully execute a certificate of
25 death in this Commonwealth, or if, within twenty-four hours of
26 death, the decedent was discharged from such medical attendance
27 or a change of such medical attendance had occurred, or if any
28 such medical attendance began within twenty-four hours of death
29 and the medical attendant refuses or is unable to certify the
30 cause of death. Medical attendance includes hospitalization.

1 The provisions of this section shall not be construed to
2 affect the coroner's discretion as to whether or not any death
3 was suspicious, nor shall they be construed to authorize a
4 coroner to investigate a sudden death any further than necessary
5 to determine the cause and manner of death.

6 Section 1240. Bodies not to be Moved.--In all cases where
7 the coroner has jurisdiction to investigate the facts and
8 circumstances of death, the body and its surroundings shall be
9 left untouched until the coroner has had a view thereof or until
10 he shall otherwise direct or authorize, except as may be
11 otherwise provided by law, or as circumstances may require.
12 Bodies upon a public thoroughfare or in other places may be
13 removed so much as is necessary for precaution against traffic
14 accidents or other serious consequences which might reasonably
15 be anticipated if they were left intact.

16 Section 1241. Release of Coroner's Jurisdiction.--Whenever
17 the coroner assumes jurisdiction of a body pursuant to the
18 provisions of this subdivision or of any other law, the body
19 shall not be released or removed from his jurisdiction except
20 upon his directions and consent, in accordance with law.

21 Section 1242. Cooperation with District Attorney.--In the
22 exercise of his duties as contained in this subdivision, the
23 coroner shall, so far as may be practicable, consult and advise
24 with the district attorney. The district attorney shall act as
25 counsel to the coroner in matters relating to inquests.

26 Section 1243. Justices of the Peace not Affected.--The
27 provisions of this subdivision shall not be construed to affect
28 any provisions of law requiring or authorizing justices of the
29 peace in certain cases to act in place of the coroner.

30 Section 1244. Certificate of Cause of Death.--The coroner

1 shall issue a certificate of cause of death in all cases
2 referred to him by the local registrar of vital statistics,
3 pursuant to the provisions of the act, approved June twenty-
4 nine, one thousand nine hundred fifty-three (Pamphlet Laws 304),
5 known as the "Vital Statistics Law of 1953," and in all other
6 cases of which he has jurisdiction, if no person duly authorized
7 by the said act certifies the cause of death.

8 Section 1245. Power of Subpoena and Attachment.--The coroner
9 shall have power to issue subpoenas to obtain the attendance of
10 any person whom it may be necessary to examine as a witness at
11 any inquest, and to compel attendance by attachment in like
12 manner and to the same extent as any court of common pleas of
13 this Commonwealth may or can do in cases pending before them,
14 and also to compel in like manner the production of all papers
15 and other things relative to such inquest. Such subpoena and
16 attachment shall be served and executed by the sheriff or by the
17 coroner himself or his deputy, as the case may require.

18 Section 1245.1. Inquests; Juries.--(a) The coroner may at
19 his discretion summon a jury of six to be selected from the jury
20 panels of the court of common pleas.

21 (b) The function of such jury shall be to determine the
22 manner of death and whether any criminal act or neglect of
23 persons known or unknown caused such death. Such jury shall be
24 paid as provided by law as if they were serving the court of
25 common pleas.

26 Section 1246. Power to Administer Oaths.--The coroner shall
27 have power to administer oaths and affirmations to all persons
28 brought or appearing before him, and any person swearing or
29 affirming falsely on such examination shall be guilty of
30 perjury.

1 Section 1247. Commitment to County Prison.--If any person
2 appearing before the coroner for examination shall refuse to
3 take oath or affirmation, or after having been sworn or affirmed
4 shall refuse to make answer to such questions as shall be put to
5 him by the coroner touching the matters of the inquest, such
6 persons so refusing may be committed by the coroner to the
7 county jail by warrant, under his hand and seal, directed to the
8 sheriff or any constable of the county, setting forth
9 particularly the causes of such commitment, until he shall
10 submit to be sworn or affirmed or to make answers to such
11 questions or be otherwise legally discharged.

12 Section 1248. Inquests Not Public.--The coroner may, in his
13 discretion, admit or exclude members of the public from any
14 inquest or part thereof, and admit or exclude any person
15 interested or suspected from such inquest or any part thereof,
16 but this provision shall not apply to representatives of the
17 press. No person excluded may appear by attorney, but any person
18 required to attend may have benefit of counsel at such
19 attendance.

20 Section 1249. Chief Deputy Sheriff to Act as Sheriff in Case
21 of Vacancy.--If any sheriff shall be legally removed from his
22 office or shall die or resign before expiration of the term for
23 which he was commissioned, the chief deputy sheriff shall
24 execute the office of sheriff and perform all things thereunto
25 appertaining, and receive and retain for his own use the
26 compensation provided by law for sheriffs, until another sheriff
27 is commissioned and notice thereof is given to such chief deputy
28 sheriff.

29 Section 1250. Vacancies; No Fees upon Commissions.--If any
30 person elected to the office of coroner shall neglect or refuse,

1 for the space of two months next after such election, to assume
2 the duties of said office and to comply with the requirements of
3 the acts of Assembly in such cases, the office shall be vacant,
4 and it shall be the duty of the Governor, upon the notification
5 of the recorder of deeds, to appoint and commission some
6 suitable person to fill such vacancy during the remainder of the
7 term. No fees shall hereafter be charged on commissions issued
8 to the coroner.

9 Section 1251. Official Records of Coroner.--Every coroner,
10 within thirty (30) days after the end of each year, shall
11 deposit all of his official records and papers for the preceding
12 year in the office of the prothonotary for the inspection of all
13 persons interested therein.

14 Section 1252. Solicitor to Coroner.--The coroner may appoint
15 one person learned in the law, as his solicitor. Said solicitor
16 shall advise the coroner upon all legal matters that may be
17 submitted to him and shall conduct any litigation in connection
18 with the coroner's office when requested so to do by the
19 coroner.

20 Section 1253. Anatomical Gifts.--The coroner may order the
21 removal of parts of a decedent's body for donation purposes in
22 accordance with 20 Pa.C.S. Ch. 86 (relating to anatomical
23 gifts).

24 (c) Provisions Relating to Sheriffs and Coroners

25 Section 1260. Not to Exercise Office Until Commission
26 Granted and Recorded; Penalty.--No person elected or appointed
27 to the office of sheriff or coroner shall execute any of the
28 duties of such office before a commission shall have been duly
29 granted to him by the Governor and left for record, under a
30 penalty of imprisonment for a term not exceeding six months, at

1 the discretion of the court of quarter sessions. Such person
2 shall nevertheless be liable to any person injured by any acts
3 done by him under color of such office.]

4 Section 22. The act is amended by adding articles to read:

5 ARTICLE XII-A

6 SHERIFF

7 Section 1201-A. Unfinished business of outgoing sheriff.

8 (a) General rule.--It shall be the duty of every outgoing
9 sheriff to deliver all unfinished and unexecuted writs and
10 process whatsoever to the sheriff's successor whose duty it
11 shall be to receive and execute the same as if the writs and
12 process had been originally issued and directed to the
13 successor, and to carry out and complete all other official
14 duties of the predecessor.

15 (b) Successor powers and duties.--Whenever any real estate
16 shall be sold under any execution by a sheriff who shall, in any
17 lawful manner, be succeeded in office before any deed shall be
18 executed and acknowledged by the sheriff in due form of law for
19 such real estate, the sheriff's successor in office shall have
20 the same power and be under the same duty to execute and
21 acknowledge a deed for such real estate to the purchaser as the
22 sheriff selling such real estate under execution if the sheriff
23 were still in office, which deed so executed shall be as
24 effectual in law as if the title had been completed by the
25 former sheriff.

26 (c) No court order necessary.--No court order shall be
27 necessary in any event to authorize an incoming sheriff to carry
28 out the duties as prescribed by this act.

29 Section 1202-A. Sheriff may act by deputy.

30 Whenever the sheriff is or shall be required by law to act in

1 person under or by virtue of any writ or process issued by the
2 courts of this Commonwealth, the sheriff may act either in
3 person or by a regularly appointed deputy sheriff.

4 Section 1203-A. Chief deputy and ~~second deputy~~ PETITION. <--

5 (a) Appointment.--The sheriff of each county shall appoint,
6 by commission duly recorded in the office for recording deeds, a
7 chief deputy and ~~second deputy~~, whose appointments WHOSE <--
8 APPOINTMENT shall be revocable by the sheriff on recording in
9 the office for recording deeds a signed revocation. The chief
10 deputy, during continuance in office, shall have full power and
11 authority to perform any duty incumbent upon the sheriff, with
12 like effect in law as if such official act had been done by the
13 sheriff in person, regardless of the ability or temporary

15 office. Nothing in this section shall operate to relieve such

22 (b) ~~Vacancy.~~ In the event of a vacancy in the office of

24 ~~duties under subsection (a) due to the deputy's death,~~
25 ~~resignation or otherwise, the second deputy shall have full~~
26 ~~power and authority to perform any duty incumbent upon the~~
27 ~~sheriff with like effect in law as if such official act had been~~

29 (c) ~~Delegation.~~ The powers and duties of sheriff that may
30 be exercised by a chief deputy or second deputy in accordance

1 ~~with this section shall include those under 18 Pa.C.S. Ch. 61,~~
2 ~~Subch. A (relating to Uniform Firearms Act).~~

3 (B) PETITION.--IF DURING A VACANCY IN THE OFFICE OF SHERIFF <--
4 THE DUTIES OF THE OFFICE CANNOT BE DISCHARGED IN ACCORDANCE WITH
5 SECTION 1213-A OR ANY OTHER LAW, THE RANKING DEPUTY OF THE
6 OFFICE SHALL PETITION THE COURT OF COMMON PLEAS TO AUTHORIZE A
7 DEPUTY TO PERFORM ANY DUTY INCUMBENT UPON THE SHERIFF. UPON A
8 FINDING THAT NO OTHER INDIVIDUAL HAS THE LEGAL CAPACITY TO

12 Section 1204-A. Real estate deputies.

13 The sheriff may have a real estate deputy to take charge of
14 all matters relating to sheriff's sales of real estate and
15 distributions of the proceeds thereof, whose appointment shall
16 be made and be revocable as provided for the chief deputy and <--
17 second deputy. The deputy shall have full power to perform all
18 duties incumbent upon the sheriff in like manner as the chief
19 deputy with like effect in law as if such official acts had been
20 done by the sheriff in person. The duties shall include the
21 execution and acknowledgment of sheriff's deeds for real estate
22 upon receipt of the purchase price thereof. Nothing in this act
23 shall operate to relieve the sheriff or the sheriff's sureties
24 from liability upon their official bonds. A chief deputy or <--
25 second deputy may be appointed real estate deputy in the same or
26 by separate commission. The exercise of the powers and duties of
27 the sheriff relating to sales of real estate and the
28 distribution of proceeds thereof, as authorized in section 1203-
29 A, shall be reserved to those occasions where a real estate
30 deputy has not been appointed or where a real estate deputy is

1 ~~temporarily or permanently incapable of acting.~~

2 Section 1205-A. Deputies and clerks.

3 The sheriff of each county may appoint deputies and clerks to
4 positions established in accordance with section 1623 for the
5 transaction of the business of the sheriff's office, and may
6 revoke the appointment of deputies in the same manner as the
7 chief deputy. In counties of the third through eighth classes,
8 the sheriff may also appoint necessary special deputies, when
9 any emergency arises, to assist the sheriff in executing any
10 civil or criminal process or court order or in preserving the
11 peace, who shall serve only so long as they are absolutely
12 needed.

13 Section 1206-A. Deputy sheriff's qualifications.

14 (a) Requirements.--A sheriff shall not appoint any person a
15 chief deputy or any other deputy sheriff unless the sheriff
16 files with the prothonotary, prior to the appointment of the
17 person, the name and photograph of the person, together with an
18 affidavit of the person setting forth the following:

19 (1) The person's full name, age and residence address.

20 (2) That the person is a citizen of the United States,
21 and 18 years of age or older.

22 (3) That the person has never been convicted of a crime
23 involving moral turpitude under the laws of this
24 Commonwealth, or of any other state, or of the United States.

25 (4) That the person has not, for a period of two years
26 immediately preceding the filing of the affidavit, acted
27 either individually or as the agent or employee of another,
28 in any labor dispute, or provided any service as a private
29 detective, private police officer or private guard in any
30 labor dispute, or received any fee or compensation whatsoever

1 for acting as a private detective, private police officer or
2 private guard in any labor dispute, or conducted the business
3 of a private detective agency, or of any agency supplying
4 private detectives, private police officers or private
5 guards, or advertised or solicited any such business in this
6 Commonwealth in connection with any labor dispute.

7 (b) Limitation.--A person shall not be appointed or receive
8 compensation as chief deputy or any other deputy except in
9 accordance with the act of February 9, 1984 (P.L.3, No.2), known
10 as the Sheriff and Deputy Sheriff Education and Training Act.

11 Section 1207-A. False statements in deputy's affidavit.

12 Any false statement contained in any affidavit shall
13 constitute and shall be punishable as perjury.

14 Section 1208-A. Filed items and public records.

15 The name, photograph and affidavit of any such person so
16 filed with the prothonotary, shall constitute a public record.

17 Section 1209-A. Public list of applicants for deputy sheriff.

18 The sheriff shall, from time to time, prepare a list of the
19 names of all persons who have applied for appointment as deputy
20 sheriff and who meet the qualifications for the position. The
21 list shall be posted in a public place for a period of not less
22 than 10 days, and thereafter shall be filed in the office of the
23 prothonotary. No deputies shall be appointed by the sheriff
24 whose names do not appear on said list.

25 Section 1210-A. Private services, gifts and payments
26 prohibited.

27 (a) General rule.--No sheriff, deputy sheriff, detective or
28 other county police officer whatsoever, shall perform, directly
29 or indirectly, any official services or official duties for any
30 person, association or corporation, or receive, directly or

1 indirectly, any compensation, gifts or gratuities from any
2 person, association or corporation during the period of official
3 services. Nothing herein contained shall prohibit such officers
4 from serving writs and other legal process as authorized by law.
5 Any compensation payable to any such officer for official duties
6 and services shall be paid only out of the proper county, or
7 other public funds, to the amount and in the manner prescribed
8 by law. Gifts, donations and gratuities of any nature whatsoever
9 made by any person, association or corporation to the county or
10 to any official or agent thereof, shall not constitute public
11 funds within the meaning of this section.

12 (b) Cause required.--Firearms and military supplies.--No
13 county, or any official or agent thereof, shall accept as a
14 gratuity, gift or donation any arms, ammunition, military
15 supplies, tear gas or equipment, or supplies or articles of a
16 similar character from, nor shall any such gratuity, gift or
17 donation be made by any person, association or corporation.

18 (c) Contract or agreement void.--Any contract or agreement,
19 whatsoever, made in violation of the provisions of this section,
20 shall be utterly void and of no effect, in law or in equity, and
21 is hereby declared to be contrary to public policy.

22 (d) Outside employment.--Notwithstanding any other provision
23 of this section, unless otherwise prohibited by resolution or
24 ordinance of the county, an individual who is employed as a
25 sheriff, deputy sheriff, detective or other county police
26 officer may engage in outside employment, including employment
27 in security, during a period in which the individual is not
28 scheduled to perform nor performing duty as a county employee.
29 The county is not liable for any damage resulting from an act of
30 an individual acting under this subsection.

1 Section 1211-A. Penalties.

2 A sheriff, deputy sheriff or other county police officer or
3 any other official of the county or any person, association or
4 corporation, who violates the provisions of sections 1206-A,
5 1209-A or 1210-A commits a misdemeanor and shall, upon
6 conviction, be sentenced to pay a fine of not less than \$100 nor
7 more than \$500, or to undergo imprisonment for not less than 90
8 days nor more than two years, or both.

9 Section 1212-A. Construction.

10 Nothing contained in section 1206-A or 1210-A shall be
11 construed to prohibit:

12 (1) The appointment, employment or compensation by any
13 county in the manner expressly provided by law of:

14 (i) Night watchmen.

15 (ii) Railroad police.

16 (iii) Bank police.

17 (iv) Payroll police.

18 (v) Special policemen to police and protect
19 cemeteries and grounds and buildings open to the public,
20 or to enforce laws for the prevention of cruelty to
21 persons or animals.

22 (vi) Fire police whose only duty shall be to direct
23 traffic and maintain order to, at or from fires.

24 (vii) Police or guards employed by nonprofit
25 corporations or organizations.

26 (2) The payment by any person, association or
27 corporation of fees or compensation for county police or
28 other peace officers assigned to exhibitions, athletic
29 contests or other recreational activities.

30 Section 1213-A. Chief deputy sheriff to act as sheriff in case

1 of vacancy.

2 If a sheriff is legally removed from office or dies or
3 resigns before the expiration of the term for which the sheriff
4 was commissioned, the chief deputy sheriff shall execute the
5 office of sheriff and perform all things thereunto appertaining
6 and receive and retain the compensation provided by law for
7 sheriffs until another sheriff is commissioned and notice
8 thereof is given to the chief deputy sheriff.

9 Section 1214-A. Sheriff to keep docket.

10 Every sheriff shall provide and keep in office a book or
11 books in which the sheriff shall enter all writs that may be
12 received and the proceedings thereon, and, at the expiration of
13 the term of office, such book or books shall be deposited in the
14 office of the prothonotary for the inspection of all persons
15 interested therein.

16 Section 1215-A. Not to exercise office until commission granted
17 and recorded; penalty.

18 No person elected or appointed to the office of sheriff shall
19 execute any of the duties of office before a commission shall
20 have been duly granted to the sheriff by the Governor and
21 properly recorded, under a penalty of imprisonment for a term
22 not exceeding six months, at the discretion of the court of
23 common pleas. Such person shall nevertheless be liable to any
24 person injured by any acts done by the sheriff under color of
25 such office.

26 ARTICLE XII-B

27 CORONER

28 SUBARTICLE A

29 PRELIMINARY PROVISIONS

30 Section 1201-B. Applicability.

1 Except as otherwise expressly provided under this article,
2 this article shall apply to counties of the second class, second
3 class A and third through eighth class.

4 Section 1202-B. Definitions.

5 The following words and phrases when used in this article
6 shall have the meanings given to them in this section unless the
7 context clearly indicates otherwise:

8 "Autopsy." The external and internal examination of the body
9 of a deceased person, including, but not limited to:

10 (1) Gross visual inspection and dissection of the body
11 and its internal organs.

12 (2) Photographic or narrative documentation of findings,
13 including microscopic, radiological, toxicological, chemical,
14 magnetic resonance imaging or other laboratory analysis
15 performed upon tissues, organs, blood, other bodily fluids,
16 gases or other specimens.

17 (3) The retention for diagnostic and documentary
18 purposes of the following which are necessary to establish
19 and defend against challenges to the cause and manner of
20 death of the deceased person:

21 (i) Tissues, organs, blood, other bodily fluids or
22 gases.

23 (ii) Any other specimen.

24 "Coroner." An elected or appointed coroner or an elected or
25 appointed medical examiner.

26 "Staff." The term includes an individual in the coroner's
27 office who engages in activities relating to death
28 investigation. The term may refer to a medical investigator,
29 forensic technician, laboratory director, forensic supervisor,
30 forensic investigator, scientist or autopsy or histology

1 technician.

2 SUBARTICLE B

3 GENERAL PROVISIONS

4 Section 1211-B. Deputies.

5 The coroner may appoint a deputy to act in the coroner's
6 place and may appoint staff to positions established in
7 accordance with section 1623 as the coroner determines. A deputy
8 shall have the same powers as the coroner.

9 Section 1212-B. Duties regarding county morgues.

10 (a) Coroner.--The coroner of a county in which a county
11 morgue is established shall:

12 (1) Make general rules and regulations for the morgue's
13 operation and control.

14 (2) Appoint a suitable individual in charge of the
15 morgue. An individual appointed under this paragraph may be
16 removed at the pleasure of the coroner.

17 (b) Salary board.--The salary board shall determine the
18 number of individuals appointed under subsection (a) (2) and the
19 individual's salaries.

20 Section 1213-B. Removal of bodies to morgue.

21 (a) Unidentified or unclaimed body.--When the body of a
22 deceased person is unidentified or unclaimed by a proper person
23 found within the county, the body shall be removed to the county
24 morgue or, in a county of the third through eighth class, to a
25 facility serving in lieu of the county morgue. If necessary, the
26 coroner shall have the body properly embalmed or prepared for
27 preservation for the length of time the coroner determines is
28 required to determine the deceased's identity, the identity of a
29 party responsible for the deceased and the cause and manner of
30 death. The body may only be examined or inspected by an

1 individual authorized by the coroner or who is admitted in the
2 coroner's presence.

3 (b) Removal from morgue.--A body may not be removed from a
4 morgue except upon the authorization of the coroner.

5 Section 1214-B. Removal of body, burial and vehicle.

6 (a) Removal and burial.--The county commissioners shall, in
7 consultation with the coroner, provide for the removal of a body
8 of a deceased individual to and from the morgue and for the
9 burial of an unclaimed body.

10 (b) Vehicle.--The county commissioners may provide an
11 ambulance or other vehicle for the purpose under subsection (a)
12 and for other official duties of the coroner, including
13 administrative, investigative or educational activities. The
14 coroner may provide rules and regulations for the use and
15 maintenance of the ambulance or other vehicle.

16 Section 1215-B. Unclaimed property and sales.

17 (a) Duty.--The coroner shall safely keep in the coroner's
18 charge:

19 (1) The personal effects and property that appear to
20 have been on or about the person at the time of death or have
21 been found on a decedent whose body is received at the county
22 morgue or at any other facility serving in lieu of the county
23 morgue.

24 (2) The effects and property that are delivered to the
25 coroner according to law.

26 (b) Required holding period.--The coroner shall hold the
27 property for one year unless the property is claimed by a legal
28 representative of the deceased or is duly and lawfully disposed
29 of or claimed.

30 (c) Property unclaimed after one year.--After one year, the

1 coroner shall direct the unclaimed or undisposed property to the
2 commissioners to be sold at public sale. Money and property as
3 security that may not be subject to a public sale shall be
4 turned over to the commissioners for proper disposition or use.

5 (d) Notice.--Notice of a public sale under subsection (c)
6 shall be published in at least one newspaper of general
7 circulation in the county once a week for three successive
8 weeks. The proceeds of each sale shall be paid immediately into
9 the county treasury. The provisions of this subsection shall be
10 in lieu of escheating to the Commonwealth.

11 Section 1216-B. Private morgue.

12 In a county of the third through eighth class in which a
13 county morgue is not maintained, the coroner may have a body
14 that the coroner is authorized to admit to a county morgue
15 removed to a private facility. The county commissioners shall
16 procure by contract, as provided under Article XVIII, the use of
17 a private facility in consultation with the coroner.

18 Section 1217-B. Requests for examinations and reports.

19 (a) Requests.--A request for an examination or other
20 professional service by another county or person may be complied
21 with at the discretion of the coroner under guidelines
22 established by the county commissioners.

23 (b) Fees and charges.--A fee and charge for an examination
24 or professional service shall be established by the coroner,
25 subject to approval by the county commissioners, and shall be
26 accounted for and paid to the county treasurer as provided under
27 section 1760. Payment for an examination or professional service
28 shall be the responsibility of the county or person requesting
29 the service.

30 Section 1218-B. Coroner's investigation.

1 (a) Duty.--The coroner having a view of the body shall
2 investigate the facts and circumstances concerning a death that
3 appears to have happened within the county, notwithstanding
4 where the cause of the death may have occurred, for the purpose
5 of determining whether or not an autopsy or inquest should be
6 conducted in the following cases:

7 (1) A sudden death not caused by a readily recognizable
8 disease or, if the cause of death cannot be properly
9 certified, by a physician on the basis of prior recent
10 medical attendance.

11 (2) A death occurring under suspicious circumstances,
12 including if alcohol, a drug or another toxic substance may
13 have had a direct bearing on the outcome.

14 (3) A death occurring as a result of violence or trauma,
15 whether apparently homicidal, suicidal or accidental,
16 including, but not limited to, a death due to mechanical,
17 thermal, chemical, electrical or radiational injury,
18 drowning, cave-in or subsidence.

19 (4) A death in which trauma, chemical injury, drug
20 overdose or reaction to a drug or medication or medical
21 treatment was a primary or secondary, direct or indirect,
22 contributory, aggravating or precipitating cause of death.

23 (5) A perioperative death in which the death is not
24 readily explainable on the basis of prior disease.

25 (6) A death in which the body is unidentified or
26 unclaimed.

27 (7) A death known or suspected to be due to contagious
28 disease and constituting a public hazard.

29 (8) A death occurring in prison or a penal institution
30 or while in the custody of the police.

1 (9) A death of an individual whose body is to be
2 cremated, buried at sea or otherwise disposed of so as to be
3 unavailable for examination thereafter.

4 (10) A sudden and unexplained infant death.

5 (11) A stillbirth.

6 (b) Purpose.--The purpose of an investigation under
7 subsection (a) shall be to determine:

8 (1) The cause and manner of the death.

9 (2) Whether or not there is sufficient reason for the
10 coroner to believe that the death may have resulted from a
11 criminal act or criminal neglect of a person other than the
12 deceased.

13 (c) Requirements.--As part of an investigation under
14 subsection (a), the coroner shall determine the identity of the
15 deceased and notify the next of kin of the deceased.

16 Section 1219-B. Autopsy, inquest and records.

17 (a) Autopsy.--If, after investigation, the coroner is unable
18 to determine the cause and manner of death, the coroner shall
19 perform or order an autopsy on the body.

20 (b) Inquest.--If the coroner is unable to determine the
21 cause and manner of death following an autopsy, the coroner may
22 conduct an inquest upon a view of the body as provided by law.
23 At the inquest, the coroner's duty shall be to:

24 (1) Ascertain the cause of death.

25 (2) Determine whether an individual other than the
26 deceased was criminally responsible by act or neglect and the
27 identity of the individual who may be responsible.

28 (3) Examine further evidence and witnesses regarding the
29 cause of death.

30 (c) Recording.--The proceedings at the inquest shall be

1 recorded, at the expense of the county, in a manner to be
2 provided by the county commissioners.

3 (d) Retention and disposal.--

4 (1) The coroner may retain a deoxyribonucleic acid (DNA)
5 specimen for diagnostic, evidentiary or confirmatory
6 purposes.

7 (2) Retained tissue, organs, blood, other bodily fluid,
8 gas or another specimen from an autopsy are medical waste and
9 shall be disposed of in accordance with applicable Federal
10 and State laws.

11 (e) Liability.--A coroner who, in good faith, orders or
12 performs a medical examination or autopsy under statutory
13 authority shall be immune from civil liability for damages for
14 ordering or performing the examination or autopsy.

15 Section 1220-B. Child deaths.

16 (a) General rule.--A coroner shall perform or order an
17 autopsy to be conducted in the case of the sudden unexplained
18 death of a child who is not more than three years of age. If an
19 autopsy is required, the autopsy shall be conducted in the
20 manner the coroner determines is the least invasive manner
21 appropriate.

22 (b) Investigation.--

23 (1) For a death of a child who is not more than three
24 years of age where the coroner has determined that an
25 investigation is appropriate, the investigation shall include
26 the following information:

27 (i) Demographic information on the child and the
28 child's primary caregivers.

29 (ii) Witness interview.

30 (iii) Infant medical history.

1 (iv) Biological mother's prenatal history.

2 (v) Incident scene investigation.

3 (vi) Scene and body diagrams.

4 (2) In conducting the investigation under paragraph (1),
5 the coroner shall consider nationally recognized standards
6 for pediatric death review.

7 (c) Deoxyribonucleic acid.--A deoxyribonucleic acid (DNA)
8 sample shall be collected for the purpose of aiding in the
9 research of the causes of sudden and unexplained infant deaths
10 and to provide genetic information as to the manner of death.

11 Section 1221-B. Sudden death.

12 (a) General rule.--The coroner shall regard a death as
13 sudden if:

14 (1) The death occurs without prior medical attendance by
15 an individual who may lawfully execute a certificate of death
16 in this Commonwealth.

17 (2) Within 24 hours of death the decedent:

18 (i) was discharged from medical attendance;

19 (ii) had a change of medical attendance occur; or

20 (iii) had medical attendance and the medical

21 attendant refuses or is unable to certify the cause of
22 death.

23 (b) Construction.--This section shall not be construed to
24 affect the coroner's discretion as to whether or not a death was
25 suspicious or to authorize a coroner to investigate a sudden
26 death further than necessary to determine the cause and manner
27 of death.

28 (c) Definition.--As used in this section, the phrase
29 "medical attendance" shall include treatment or care at a
30 facility providing medical services, including a hospital,

1 nursing home and hospice service.

2 Section 1222-B. Prohibition on moving a body.

3 (a) General rule.--Except as provided under subsection (b),
4 if a coroner has jurisdiction to investigate the facts and
5 circumstances of death, the body and the surroundings of the
6 body shall be left untouched until either:

7 (1) The coroner has conducted an initial investigation
8 of the scene of death, including viewing and photographing
9 the scene in the manner that most fully discloses how the
10 individual died.

11 (2) The coroner directs or authorizes the touching of a
12 body and the surroundings of a body, except as provided by
13 law or as circumstances may require.

14 (b) Exception.--A body on a public thoroughfare or other
15 place may be moved if necessary for the administration of
16 emergency care and as a precaution against a traffic accident or
17 another serious consequence that might reasonably be anticipated
18 if the body was left in place. The removal of the body shall be
19 done so as to not substantially destroy or alter possible
20 evidence.

21 Section 1223-B. Release of coroner's jurisdiction.

22 If a coroner assumes jurisdiction of a body under the
23 provisions of this article or another law, the body may not be
24 released or removed from the coroner's jurisdiction except upon
25 the coroner's directions and consent, in accordance with law.

26 Section 1224-B. Cooperation with district attorney.

27 In the exercise of duties under this article, the coroner
28 shall consult with and advise the district attorney as may be
29 practicable. The district attorney may act as counsel to the
30 coroner in matters relating to inquests.

1 Section 1225-B. Cooperation with other counties.

2 If one or more coroners deem it necessary to establish a
3 facility for conducting forensic testing and autopsies, a county
4 may establish and operate the facility.

5 Section 1226-B. Certificate of cause of death.

6 A coroner shall issue a certificate of cause of death in each
7 case:

8 (1) Referred to the coroner by the local registrar of
9 vital statistics under the act of June 29, 1953 (P.L.304,
10 No.66), known as the Vital Statistics Law of 1953.

11 (2) In which the coroner has jurisdiction and no
12 individual duly authorized by law certifies the cause of
13 death.

14 Section 1227-B. Subpoena and attachment.

15 The coroner may issue a subpoena and attachment, which shall
16 be served and executed by the sheriff, coroner or coroner's
17 deputy, for the following purposes:

18 (1) A death investigation.

19 (2) To obtain the attendance of an individual who may be
20 necessary to examine as a witness at an inquest.

21 (3) To compel attendance by attachment in a similar
22 manner and extent as a court of common pleas may do in a case
23 pending before the court.

24 (4) To compel the production of the following:

25 (i) A paper.

26 (ii) A document in any form or media, including a
27 medical and mental health record.

28 (iii) Another thing relative to the investigation or
29 inquest.

30 Section 1228-B. Inquest and jury.

1 (a) Jury.--The coroner may summon a jury of six individuals
2 and two alternates to be selected from the jury panels of the
3 court of common pleas.

4 (b) Function.--The function of the jury shall be to
5 determine the manner of death and whether a criminal act or
6 neglect of a known or unknown individual caused the death. The
7 jury shall be paid as provided by law as if the jury members
8 were serving the court of common pleas.

9 Section 1229-B. Oaths.

10 The coroner may administer an oath and affirmation to an
11 individual brought or appearing before the coroner. An
12 individual swearing or affirming falsely on the examination
13 commits perjury.

14 Section 1230-B. Commitment to county prison.

15 (a) Warrant.--An individual may be committed by a coroner to
16 the county jail by warrant directed to the sheriff or a
17 constable of the county if the individual does either of the
18 following while appearing before the coroner for examination:

19 (1) Refuses to take an oath or affirmation.

20 (2) Refuses to answer a question asked by the coroner on
21 the matter of the inquest after having been sworn or
22 affirmed.

23 (b) Case required.--The warrant under subsection (a) must
24 set forth particularly the cause of the commitment.

25 (c) Length.--The individual shall remain committed until the
26 individual submits to be sworn or affirmed, answers the
27 questions of the coroner or is otherwise legally discharged.

28 Section 1231-B. Inquests.

29 The following shall apply:

30 (1) In counties of the second through eighth classes,

1 the coroner may:

2 (i) Admit or exclude a member of the public from an
3 inquest or a part of an inquest.

4 (ii) Admit or exclude an individual interested or
5 suspected from the inquest or a part of an inquest.

6 (2) An excluded individual may not appear by attorney.

7 (3) An individual required to attend may have counsel at
8 the attendance.

9 (4) In counties of the third through eighth class,
10 representatives of the media may not be excluded from an
11 inquest or part of an inquest unless the representatives are
12 personally interested or suspected from the inquest or part
13 of the inquest.

14 Section 1232-B. Vacancy.

15 (a) Legal removal, death or resignation.--If a coroner is
16 legally removed from office, dies or resigns before the
17 expiration of the term for which the coroner was elected or
18 appointed, the chief deputy coroner shall execute the office of
19 coroner, perform related duties and receive and retain the
20 compensation provided by law for the coroner until another
21 coroner is appointed.

22 (b) Neglect or refusal.--Except as otherwise provided under
23 subsections (d) and (e), if an individual who is elected to the
24 office of coroner neglects or refuses for the two months after
25 the election to assume the duties of the office and to comply
26 with the requirements of the law, the office shall be deemed
27 vacant. The Governor shall notify the recorder of deeds and
28 appoint and commission a suitable individual to fill the vacancy
29 during the remainder of the term.

30 (c) Fees.--A fee may not be charged on a commission issued

1 to the coroner.

2 (d) Exception in certain counties.--In counties of the
3 second class A, the appointee of the Governor shall serve until
4 the first Monday of January next succeeding the first municipal
5 election which occurs at least two months after the vacancy, at
6 which time a new coroner shall be elected. The appointee shall
7 be confirmed by the Senate if the Senate is in session.

8 (e) Medical examiner.--In counties of the second class, the
9 appointee to the office of medical examiner shall serve and the
10 term of office shall be as provided by county ordinance.

11 Section 1233-B. Salary of solicitor and costs in counties of
12 the second class.

13 In counties of the second class, the following shall apply:

14 (1) The salary of the solicitor to the medical examiner
15 shall be determined by the salary board. The salary shall be
16 paid out of the fees received and paid into the office of the
17 coroner.

18 (2) Costs and expenses incurred by the coroner in a
19 manner connected with litigation or claims arising out of or
20 relating to the coroner's office shall be paid by the county
21 out of fees received by the coroner's office.

22 Section 1234-B. Anatomical gifts.

23 The coroner may order the removal of parts of a decedent's
24 body for donation purposes in accordance with 20 Pa.C.S. Ch. 86
25 (relating to anatomical gifts).

26 Section 1235-B. Execution of office.

27 An individual elected or appointed to the office of coroner
28 may not execute any of the duties of office before a commission
29 has been duly granted to the coroner by the Governor and
30 properly recorded. An individual who violates this section may

1 be sentenced to imprisonment for a term of not more than six
2 months. The individual shall be liable to a person injured by an
3 act done by the individual under authority of the office.

4 Section 1236-B. Records.

5 Records shall be maintained in the office of the coroner. If
6 no office is maintained, a public record providing the name of
7 the deceased, the date of death and the cause and manner of
8 death shall be deposited in the office of prothonotary for the
9 inspection of an individual with an interest in the record.

10 Except as provided under this article, public disclosure of a
11 coroner record shall be in accordance with the act of February
12 14, 2008 (P.L.6, No.3), known as the Right-to-Know Law.

13 SUBARTICLE C

14 FEEES AND COST RECOVERY

15 Section 1251-B. Disposition costs.

16 (a) Cost of disposition.--If legal representatives make
17 claim to property after disposition of the deceased has occurred
18 at county expense, any property retained from the deceased by
19 the coroner in accordance with 1215-B shall be subject to sale
20 to cover the cost of disposition with the balance, if any, going
21 to the representatives. No property shall be sold under this
22 subsection unless the coroner has provided written notice to the
23 representative of the all of the following:

24 (1) The costs of disposition.

25 (2) A list of the property held in accordance with
26 section 1215-B.

27 (3) An opportunity to pay the costs of disposition
28 within 60 days of the notice.

29 (b) Costs of securing.--In cases where the coroner secures
30 the premises of the deceased, the costs of securing may be

1 charged against the estate of the deceased.

2 (c) Civil liability.--A coroner who reasonably attempts to
3 secure or safeguard any real property where the deceased is
4 found and any personal property on or around the deceased is
5 immune from civil liability for damage to or loss of the
6 property or its contents.

7 Section 1252-B. Fees for reports.

8 (a) Fees to recover training costs.--The coroner shall
9 charge and collect a fee of \$500 for an autopsy report, \$100 for
10 a toxicology report, \$100 for an inquisition or coroner's
11 report, \$50 for a cremation or disposition authorization and
12 other fees as may be established from time to time for other
13 reports or documents requested by nongovernmental agencies in
14 order to investigate a claim asserted under a policy of
15 insurance or to determine liability for the death of the
16 deceased. The fees collected under this subsection shall be
17 accounted for and paid to the county treasurer in accordance
18 with section 1760 and shall be used to defray the expenses
19 involved in the county complying with the training of coroners
20 or coroner office personnel, as may be required or authorized by
21 this or any other act.

22 (b) Record disclosure.--This section may not be construed as
23 authorizing disclosure of a record exempt from public access in
24 accordance with the act of February 14, 2008 (P.L.6, No.3),
25 known as the Right-to-Know Law, or any provision of this act.

2 Section 1301. Election of [Prothonotaries, Clerks]
3 Prothonotary, Clerk of Courts, [Clerks] Clerk of Orphans' Court,
4 Register of Wills, Recorder of Deeds.--At the municipal election
5 preceding the expiration of the term of office of any
6 prothonotary, clerk of the [court of quarter sessions, clerk of
7 the court of oyer and terminer] courts of common pleas, register
8 of wills, clerk of the orphans' court or recorder of deeds of
9 any county and quadrennially thereafter, the electors of [such]
10 the county shall elect a person to fill [such] the office from
11 the first Monday of January next succeeding [such] the election,
12 for a term of four years and until [his] a successor is elected
13 and qualified. Where, under the provisions of this act or other

23 county advancing from the fifth to fourth class as a result of
24 census figures certified after the primary election in the year
25 of a municipal election may maintain the configuration of
26 offices in effect in the county as long as the county, in
27 consultation with the president judge of the court of common
28 pleas of the county, deems appropriate. At such time as a county
29 decides that reconfiguration of the offices in the county in
30 accordance with subsection (a) or any other general law

1 applicable to the holding of offices and to the classification
2 of the county is appropriate, the county shall wait until the

5 (a.2) Notwithstanding subsection (a) or (a.1) or any other
6 law, the county commissioners of a county advancing from the

10 shall otherwise provide.

11 (a.3) Notwithstanding subsection (a) or (a.1) or any other
12 law, the county commissioners of a county advancing from the
13 fifth to fourth class may adopt a resolution providing that one
14 person shall hold the offices of register of wills, recorder of
15 deeds and clerk of the orphans' court, unless local law applying
16 to such counties shall otherwise provide.

17 (b) In counties of the fifth class, one person shall hold
18 the offices of prothonotary and clerk of courts, one person the
19 offices of register of wills and clerk of the orphans' court,
20 and one person the office of recorder of deeds, unless local law
21 applying to such counties shall otherwise provide.

22 (b.1) Notwithstanding subsection (b) or any other law, the
23 county commissioners of a county advancing from the sixth to the
24 fifth class may adopt a resolution providing that one person
25 shall continue to hold the offices of register of wills,
26 recorder of deeds and clerk of the orphans' court, unless local
27 law applying to such counties shall otherwise provide.

28 (c) In counties of the sixth and seventh classes, one person
29 shall hold the offices of prothonotary and clerk of courts, and
30 one person the offices of register of wills, recorder of deeds

1 and clerk of the orphans' court, unless local laws applying to
2 such counties shall otherwise provide.

3 (d) In counties of the eighth class, one person shall hold
4 the offices of prothonotary, clerk of courts, clerk of the
5 orphans' court, register of wills and recorder of deeds, unless
6 local laws applying to such counties shall otherwise provide.

7 (e) This section does not repeal any of the provisions of
8 section one of the act, approved July two, one thousand eight
9 hundred thirty-nine (Pamphlet Laws 559), entitled "An act to
10 provide for the election of prothonotaries, clerks, recorders
11 and registers," nor any of the provisions of any other local
12 law.

13 (f) Any county in which the offices provided for herein are
14 not now held as hereinbefore provided, and which desires to
15 provide for the holding of two or more of said county offices by
16 the same person, may, at any time hereafter, accept the
17 provisions of this section in whole or in part, and provide for
18 the holding of its county offices, or any of them, in the manner
19 provided in this section for the class of counties to which it
20 belongs. The recombining of the offices that have been separated

12 Section 1401. District Attorney; Qualifications;
13 Eligibility; Compensation.--(a) The district attorney shall be
14 a resident of the county, at least twenty-five years of age, and
15 a citizen of the United States, shall have been admitted to
16 practice as an attorney before the Supreme Court of this
17 Commonwealth for at least one year prior to taking the oath of
18 office and shall have resided in the county for which [he] the
19 district attorney is elected or appointed for one year next
20 preceding [his] election or appointment.

21 (f) No district attorney shall be eligible for a seat in the
22 Legislature or to any other office under the laws and
23 Constitution of the Commonwealth, excepting an office or
24 commission, pursuant to 51 Pa.C.S. (relating to military

2 under this clause may not be made between the first day for the
3 circulation of nominating petitions for the office of district
4 attorney and January 1 of the subsequent year.

5 (2) The president judge of the county court of common pleas
6 orders that the office of district attorney shall be full time.
7 Upon motion of the district attorney, the president judge shall
8 conduct a hearing and shall issue an order whether the office of
9 district attorney shall be full time within 180 days of the
10 filing of the motion. The order may be appealed by the district
11 attorney or the county commissioners in accordance with the
12 rules of appellate procedure. An order under this clause shall
13 take effect in 60 days. An order under this clause directing
14 that the office of district attorney be full time shall be made
15 if the president judge finds that two or more of the following

5 subject to the alcoholic ignition interlock statutory provision
6 requirements exceeds thirty per year; or

7 (vi) the county constitutes a single and separate judicial

9 [(h) In counties of the third, fourth, fifth, sixth and
10 seventh class:

11 (1) Each part-time district attorney holding office on the
12 effective date of this subsection whose term expires January 7,
13 2008, shall become full time on January 2, 2006, if, after
14 exercising due diligence in conducting an assessment of the best
15 interests of public safety and the administration of criminal
16 justice in the county, the part-time district attorney provides
17 written notice to the chairman of the county commissioners, the
18 Secretary of Revenue and the State Treasurer, no sooner than
19 December 1, 2005, and no later than December 30, 2005, of the
20 part-time district attorney's choice to serve as a full-time
21 district attorney. Where a part-time district attorney holding
22 office on the effective date of this act does not provide such
23 notice, the office of district attorney shall remain part time
24 for the remainder of the current term of office.

25 (2) A person who has been elected to the office of district
26 attorney in a county where the district attorney is part time

1 justice in the county, the district attorney-elect has provided
2 written notice to the chairman of the county commissioners, the

6 district attorney. Where the district attorney-elect does not
7 provide such notice, the office of district attorney shall

12 part-time position after January 2, 2006, shall, upon election
13 and taking the oath of office, become a full-time district
14 attorney if, prior to the deadline for filing nomination
15 petitions or papers, the person has provided written notice to
16 the chairman of the county commissioners, the Secretary of
17 Revenue and the State Treasurer of the person's choice to serve
18 as a full-time district attorney. Where the person does not
19 provide such notice, the office of district attorney shall

23 (j) A full-time district attorney shall be compensated at

28 full time, the district attorney shall devote full time to the
29 office. The district attorney while in office, shall not derive
30 any other income as a result of honorariums, profit shares or

1 divisions of income from any firm with which the district
2 attorney was associated prior to election. This limitation shall
3 not be construed, however, to preclude payment of fees earned
4 for legal work done prior to, but not concluded until after the
5 earlier of his being made full time or being sworn in as a full-
6 time district attorney. In addition the district attorney shall
7 not engage in any private practice and must be completely
8 disassociated with any firm with which the district attorney was
9 affiliated prior to the earlier of being made full time or being

18 of the judicial district of the county; in a county of the fifth
19 or sixth class, the salary shall be fifty per cent of the annual

28 [(n) In the event of a vacancy in the office of district

1 (h) for the remainder of said term.]

2 (o) A district attorney shall be subject to the Rules of
3 Professional Conduct and the canons of ethics as applied to
4 judges in the courts of common pleas of this Commonwealth
5 insofar as such canons apply to salaries, full-time duties and
6 conflicts of interest. Any complaint by a citizen of the county
7 that a full-time district attorney may be in violation of this
8 section shall be made to the Disciplinary Board of the Supreme
9 Court of Pennsylvania. If any substantive basis is found, the
10 board shall proceed forthwith in the manner prescribed by the
11 rules of the Supreme Court and make such recommendation for
12 disciplinary action as it deems advisable, provided, however,
13 that if the Supreme Court deems the violation so grave as to
14 warrant removal from office, the prothonotary of the Supreme
15 Court shall transmit its findings to the Speaker of the House of
16 Representatives for such action as the House of Representatives

23 Prosequi.--(a) The district attorney shall sign all bills of
24 indictment and conduct in court all criminal and other
25 prosecutions, in the name of the Commonwealth, or, when the
26 Commonwealth is a party, which arise in the county for which
27 [he] the district attorney is elected, and perform all the
28 duties which, prior to May 3, 1850, were performed by deputy
29 attorneys general. The duties herein conferred shall be in

2 Section 1403. Expenses Incurred by District Attorney.--All

14 Section 1404. Filling of Vacancies.--(a) If any vacancy

16 the second class A or third class, either by death, resignation,
17 removal from office or from the county, or otherwise, the judges
18 of the court of common pleas shall supply such vacancy by the
19 appointment of a competent person to fill the office during the
20 balance of the unexpired term.

21 (b) If any vacancy shall occur in the office of district
22 attorney in a county of the fourth through eighth class, the
23 first assistant district attorney shall become district attorney
24 and discharge the duties of the district attorney until the
25 first Monday in January following the next municipal election
26 occurring not less than ninety days after the occurrence of the
27 vacancy. If the first assistant district attorney is unwilling
28 or unable to serve, the judges of the court of common pleas
29 shall fill the vacancy by the appointment of a competent person
30 to fill the office until the first Monday in January following

1 the next municipal election occurring not less than ninety days

3 Section 1405. Misconduct of District Attorney.--(a) If any
4 district attorney shall [wilfully] willfully and corruptly
5 demand, take or receive any other fee or reward than such as is
6 prescribed by law for any official duties required by law to be
7 executed by [him] the district attorney in any criminal
8 proceeding, or if such district attorney shall be guilty of
9 [wilful] willful and gross negligence in the execution of the
10 duties of [his] the office, [he] that individual shall be guilty
11 of a misdemeanor in office, and, on conviction thereof, be
12 sentenced to pay a fine not exceeding one thousand dollars
13 (\$1,000) and to undergo imprisonment not exceeding one year, and
14 [his] the office shall be declared vacant.

15 (b) Upon complaint in writing, verified by oath or
16 affirmation of the party aggrieved, made to the court in which
17 any district attorney shall prosecute the pleas of the
18 Commonwealth, charging such district attorney with [wilful]
19 willful and gross negligence in the execution of the duties of
20 [his] the office, the court shall cause notice of [such] the
21 complaint to be given to the district attorney and of the time
22 fixed by the court for [the] a hearing [of the same]. If [upon
23 such] after the hearing the court shall be of opinion that there
24 is probable cause for the complaint, they shall hand over or
25 commit the district attorney to answer the same in due course of
26 law. If the court shall be of opinion that there is no probable
27 cause for such complaint, they shall dismiss the same, with
28 reasonable costs to be assessed by the court.

29 Section 1406. District Attorney Charged with Crime.--If any
30 district attorney is charged, according to law, with any crime

1 or misdemeanor, before or bound over or committed by any court
2 to answer for [wilful] willful and gross negligence in the
3 execution of the duties of [his] the office, it shall be the
4 duty of the court to appoint [some] a competent attorney thereof
5 to prepare an indictment against such district attorney and to
6 prosecute the same on behalf of the Commonwealth until final
7 judgment. [Such] The attorney shall be paid by the county for
8 [his] services a reasonable compensation to be fixed by the
9 court. If [such] the district attorney [shall be] is convicted
10 of any crime for which [he] that individual may be sentenced to
11 imprisonment by separate or solitary confinement at labor, [his]
12 the office shall be declared vacant by the court.

13 Section 1407. [Law Books] Legal Resources for District
14 Attorney.--The county commissioners may purchase, for the use of
15 the office of the district attorney, out of the funds of the
16 county, such law books and other legal research resources as may
17 be selected by the district attorney[,] and, in counties of the
18 third through eighth classes, as approved by the president judge
19 of the court.

20 Section 1409. When Private Counsel May Prosecute.--If any
21 district attorney shall neglect or refuse to prosecute in due
22 form of law any criminal charge regularly returned to [him] the
23 district attorney or to the court [of the proper county], or if
24 at any stage of the proceedings the district attorney [of the
25 proper county] and the private counsel employed by the
26 prosecutor shall differ as to the manner of conducting the
27 trial, the prosecutor may present [his] a petition to the court
28 [of the proper county], setting forth the character of the
29 complaint, and verify the same by affidavit. If the court shall
30 be of the opinion that it is a proper case for a criminal

1 proceeding or prosecution, it may direct any private counsel
2 employed by such prosecutor to conduct the entire proceeding,
3 and where an indictment is necessary, to verify the same by
4 [his] the private counsel's own signature, as fully as the same
5 could be done by the district attorney.

6 (b) Assistant[, Special, Deputy] and Acting District
7 Attorneys, Stenographers and Clerks

8 Section 1420. Assistant[, Special Assistant and Deputy
9 Assistant] District Attorneys; Number; Compensation.--(a) The
10 district attorney may appoint such number of assistants,
11 [special assistants or deputy assistants, learned in the law]
12 licensed to practice law in this Commonwealth, to assist [him]
13 in the discharge of [his] duties. [, as is fixed by the salary
14 board of the county. The salary board shall fix the salary of
15 such assistants, special assistants and deputy assistants.] The
16 number and salary of such assistants shall be fixed by the
17 salary board.

18 (b) [The] In counties of the third through eighth classes,
19 the district attorney may appoint temporary assistants,
20 [temporary special assistants or temporary deputy assistants,
21 learned in the law] licensed to practice law in this
22 Commonwealth, to assist [him] in the discharge of [his] duties,
23 as provided by contract or other personnel agreement with the
24 county or the district attorney. Any attorney-at-law, including
25 a deputy Attorney General or an attorney employed by the
26 Commonwealth, may be appointed under this subsection.

27 (c) [An] In counties of the third through eighth classes, an
28 allegation of a violation of this section shall be timely raised
29 prior to the participation of the prosecutor in question. The
30 exclusive remedy for a violation of this section shall be

1 removal by quo warranto of the prosecutor from the appointment
2 that is in violation of this section.

3 (d) Subsections (b) and (c) shall apply to all cases pending
4 on the effective date of this subsection and all cases
5 thereafter, including, but not limited to, those cases on post-
6 trial or on appeal.

7 Section 1421. Designation of First Assistant; Powers and
8 Duties.--In all cases where more than one assistant district
9 attorney is appointed, the district attorney shall designate one
10 [of such assistants as his] assistant as the first assistant.
11 [Such] The first assistant or the assistant district attorney
12 where only one is appointed shall, in the absence of the
13 district attorney from the jurisdiction or during [his] the
14 district attorney's disability to perform the duties of [his]
15 the office through sickness or other cause, be vested with all
16 the duties, powers and privileges given by law to the district
17 attorney, and generally, at such time, be empowered to do and
18 perform all things in connection with [his] the office which the
19 district attorney may by law be entitled to do or perform. In
20 case of any [such] incapacity of the district attorney or [his]
21 the first assistant, or both, any or all of such duties, powers
22 and privileges may be done by such other assistant district
23 attorneys, if any, as may be designated by the district
24 attorney.

25 Section 1424. Court May Appoint a District Attorney for the
26 Time Being in Counties of the Third Through Eighth Classes.--It
27 shall be the duty of the court of [quarter sessions] common
28 pleas of any county of the third through eighth classes to
29 appoint a district attorney for the time being, in all cases
30 where the district attorney and [his] the assistants shall be

1 absent from the court. [Such] A person so appointed shall
2 perform all the duties of the office until the regular district
3 attorney or one of [his] the assistants shall appear in person
4 to perform the same, and shall be paid such compensation by the
5 county as may be fixed by the court.

6 Section 1425. Indictment and Cost Clerk in Counties of the
7 Fourth Class.--The district attorney of any county of the fourth
8 class, in addition to other assistants authorized in this
9 subdivision, may appoint an assistant, [learned in the law]
10 licensed to practice law in this Commonwealth, who shall be
11 designated as indictment and cost clerk, to assist the district
12 attorney in the discharge of [his] duties.

13 Section 1426. Stenographers and Clerks.--The salary board in
14 any county may provide for the appointment by the district
15 attorney of such clerks and stenographers in [his] the district
16 attorney's office as may be deemed necessary for the proper
17 dispatch of business.

18 Section 1440. Appointment; Duties and Compensation of County
19 Detectives.--(a) (1) In counties of the second class A, the
20 district attorney may appoint one chief county detective, an
21 assistant chief county detective, and as many county detectives,
22 sergeants, special county detectives and junior county
23 detectives as the salary board shall fix.

24 (2) In counties of the third and fourth classes, the
25 district attorney may appoint one chief county detective, one
26 assistant county detective and such other county detectives as
27 the salary board may authorize.

28 (b) In counties of the fifth, sixth, seventh and eighth
29 classes, the district attorney may appoint one chief county
30 detective and such other county detectives as the salary board

1 may authorize.

2 (c) County detectives shall, at all times, be subject to the
3 orders of the district attorney, and shall investigate and make
4 reports to [him] the district attorney as to the conduct in
5 office of magistrates, constables, deputy constables and other
6 officers connected with the administration of criminal law,
7 shall make investigations and endeavor to obtain evidence
8 required by the district attorney in criminal cases, and shall
9 perform such other duties as the district attorney may direct.

10 (d) County detectives shall be general police officers and
11 shall have the powers conferred on constables by the laws of
12 this Commonwealth, so far as they relate to criminal law and
13 procedures[.] and, in counties of the second class A, they shall
14 serve subpoenas in cases in which the Commonwealth is a party in
15 a court of record.

16 (e) [County] (1) In counties of the second class A, county
17 detectives of every grade and rank shall not be entitled to
18 receive any fees whatsoever, but shall each receive a salary as
19 shall be fixed by the salary board, together with all necessary
20 traveling expenses, which said salary and expenses, having been
21 verified by affidavit of the detective incurring the same, and
22 approved by the district attorney, shall be paid out of the
23 treasury of the county, on a certificate issued by the district
24 attorney directed to the controller of the county, who shall
25 order warrants for said amounts according to law.

26 (2) In counties of the third through the eighth class,
27 county detectives of every grade and rank, in addition to their
28 annual salary, shall be allowed their expenses actually and
29 necessarily incurred in the performance of their duties. Such
30 salaries and expenses shall be paid by the county as provided by

1 law. No county detective shall be entitled to any fee
2 whatsoever.

3 Section 1441. Appointment of Special Detective with Approval
4 of Court.--The district attorney of any county may, with the
5 approval of the salary board, whenever the court of [quarter
6 sessions] common pleas and district attorney may deem it
7 necessary for a particular and temporary assignment, appoint a
8 special detective, whose duty it shall be to assist in obtaining
9 such evidence as shall be directed by the district attorney for
10 the Commonwealth, and perform such other duties as the court may
11 direct. [He] The special detective shall be allowed expenses
12 necessarily and actually incurred in the performance of [his]
13 duties.

14 [Such] The special detective officer shall be a general
15 police officer and shall have all the powers that are conferred
16 on constables by the existing laws of this Commonwealth, so far
17 as they relate to crimes or criminal procedure.

18 Section 28. Article XV.1 of the act is repealed:

15 Section 1551. Counties of the Fourth Class.--The annual
16 salaries of the following county officers of counties of the
17 fourth class shall be as follows:

18 The district attorney, twelve thousand dollars (\$12,000).

19 The sheriff, eleven thousand four hundred dollars (\$11,400).

20 The prothonotary, eleven thousand one hundred sixty dollars
21 (\$11,160).

22 The clerk of courts, eleven thousand one hundred sixty
23 dollars (\$11,160).

24 The clerk of the orphans' court (other than the register of
25 wills acting as ex officio of orphans' court), eleven thousand
26 one hundred sixty dollars (\$11,160).

27 The register of wills and ex officio of the orphans' court,
28 eight thousand seven hundred sixty dollars (\$8,760).

29 The recorder of deeds, eleven thousand one hundred sixty
30 dollars (\$11,160).

1 The county treasurer, nine thousand eight hundred forty
2 dollars (\$9,840).

3 The county commissioners, twelve thousand dollars (\$12,000),

15 thousand six hundred dollars (\$9,600).

16 The coroner, five thousand four hundred dollars (\$5,400).

17 The prothonotary, nine thousand six hundred dollars (\$9,600).

18 The clerk of quarter sessions and oyer and terminer, nine
19 thousand six hundred dollars (\$9,600).

20 The clerk of the orphans' court, nine thousand six hundred
21 dollars (\$9,600).

22 The register of wills, nine thousand six hundred dollars
23 (\$9,600).

24 The recorder of deeds, nine thousand six hundred dollars
25 (\$9,600).

26 Provided, That where any of the officers above mentioned hold
27 two or more of the said offices, he shall receive nine thousand
28 six hundred dollars (\$9,600).

29 The county commissioners, ten thousand two hundred dollars
30 (\$10,200), each.

1 The county treasurer, nine thousand six hundred dollars
2 (\$9,600).

3 The jury commissioners, nine hundred dollars (\$900), each.

4 The district attorney, ten thousand two hundred dollars
5 (\$10,200).

6 Section 1553. Counties of the Sixth Class.--The annual
7 salaries of the following county officers of counties of the
8 sixth class shall be as follows:

9 The clerk of the court of quarter sessions, eight thousand
10 four hundred dollars (\$8,400).

11 The treasurer, eight thousand one hundred sixty dollars
12 (\$8,160).

13 The controller, eight thousand four hundred dollars (\$8,400).

14 The clerk of oyer and terminer, one thousand one hundred
15 dollars (\$1,100).

16 The clerks of the orphans' court, (other than the register of
17 wills acting as ex officio of orphans' court) seven thousand two
18 hundred dollars (\$7,200), each.

19 The prothonotary, eight thousand four hundred dollars
20 (\$8,400).

21 The recorder of deeds, eight thousand four hundred dollars
22 (\$8,400).

23 The register of wills, seven thousand two hundred dollars
24 (\$7,200).

25 Where any of the officers above mentioned hold two or more of
26 said offices, he shall receive the highest salary fixed for any
27 of the offices which he holds and the additional salary of seven
28 hundred fifty dollars (\$750).

29 The sheriff, eight thousand four hundred dollars (\$8,400).

30 The county commissioners, nine thousand three hundred fifty

1 dollars (\$9,350), each.

2 The district attorney, nine thousand four hundred fifty
3 dollars (\$9,450).

4 The jury commissioners shall each receive fifteen dollars
5 (\$15) for each day necessarily employed in the discharge of
6 their duties. The said compensation shall be paid from the
7 county treasury in the same manner as the salary or compensation
8 of other county officers and employees.

9 The county auditors shall each receive twenty dollars (\$20)
10 for each six hours of work in the discharge of their duties,

18 (\$3), to be paid out of the goods, chattels, lands, or tenements
19 of the slayer (in cases of murder or manslaughter), if any he
20 hath, if otherwise, by the county, with mileage at the rate of
21 ten cents for each mile circular traveled from the court house
22 to the place of viewing the body; executing any process or writs
23 of any kind, the same fees as are allowed to the sheriff and the
24 same mileage.

25 Section 1554. Counties of the Seventh Class.--The annual
26 salaries of the following county officers of counties of the
27 seventh class shall be as follows:

28 The sheriff, six thousand two hundred forty dollars (\$6,240).

29 The district attorney, six thousand five hundred dollars
30 (\$6,500).

1 The annual salary of each county commissioner shall be six
2 thousand dollars (\$6,000).

3 The jury commissioners shall each receive fifteen dollars
4 (\$15) for each day necessarily employed in the discharge of
5 their duties. The said compensation shall be paid from the
6 county treasury in the same manner as the salary or compensation
7 of other county officers and employees.

8 The county auditors shall receive twenty dollars (\$20) for
9 each six hours of work in the discharge of their duties,
10 together with ten cents (10¢) per mile circular from and to
11 their homes, once, each and every day so employed.

12 The prothonotary or clerks of the several courts of common
13 pleas, quarter sessions of the peace, oyer and terminer, and
14 orphans' courts, the register of wills, and the recorder of
15 deeds, shall keep, or cause to be kept, a fair and accurate
16 account of all fees received for services performed by them or
17 any person employed by them in their respective offices; and
18 shall also, on the first Monday of January of each year, furnish
19 a copy of said account, upon oath or affirmation, to the auditor
20 appointed by the court to settle the accounts of county
21 officers; and shall also pay to the county treasurer, for the
22 use of the county, after deducting all necessary clerk hire and
23 office expenses, fifty per centum on the amount of any excess
24 over and above the sum of seven thousand two hundred dollars
25 (\$7,200), which shall be found by the said auditor, appointed by
26 the court to settle the accounts of county officers, to have
27 been received by any officer in any one year: Provided, That if
28 two or more of said offices shall be held by one person, the
29 said auditor shall add together the fees received in the offices
30 so held, and shall charge the same percentage on the aggregate

2 said offices. A copy of the report of the said auditor, when
3 completed, shall be presented by him to the court of common
4 pleas of the county, and filed among the records of said court;

7 report of the county auditors.

23 Section 1555. Counties of the Eighth Class.--The annual
24 salaries of the following county officers of counties of the
25 eighth class shall be as follows:

26 The sheriff, in counties having a population of less than
27 twelve thousand (12,000), four thousand eighty dollars (\$4,080);
28 and in counties having a population of twelve thousand (12,000)
29 and more, but less than twenty thousand (20,000), four thousand
30 six hundred eighty dollars (\$4,680).

1 The county commissioners, in counties having a population of
2 less than twelve thousand (12,000), three thousand three hundred
3 eighty dollars (\$3,380) each, and in counties having a
4 population of twelve thousand (12,000) and more, four thousand
5 two hundred ninety dollars (\$4,290), each.

6 The district attorney, four thousand five hundred dollars
7 (\$4,500).

8 The county auditors shall each receive twenty dollars (\$20)
9 for each six hours of work in the discharge of their duties,
10 together with ten cents (10¢) per mile circular from and to
11 their homes, once, each and every day so employed.

12 The jury commissioners shall each receive fifteen dollars
13 (\$15) for each day necessarily employed in the discharge of
14 their duties. The said compensation shall be paid from the
15 county treasury in the same manner as the salary or compensation
16 of other county officers and employes.

17 The prothonotary or clerks of the several courts of common
18 pleas, quarter sessions of the peace, oyer and terminer, and
19 orphans' courts, the register of wills, and the recorder of
20 deeds, shall keep, or cause to be kept, a fair and accurate
21 account of all fees received for services performed by them or
22 any person employed by them in their respective offices; and
23 shall also, on the first Monday of January of each year, furnish
24 a copy of said account, upon oath or affirmation, to the auditor
25 appointed by the court to settle the accounts of county
26 officers; and shall also pay to the county treasurer, for the

9 SALARIES OF COUNTY OFFICERS

10 Section 1560. Salaries of county officers.

11 (a) Amount.--Except where otherwise expressly provided in
12 this act, the salaries of county officers shall be set in
13 accordance with the act of November 1, 1971 (P.L.495, No.113),
14 entitled "An act providing for the compensation of county
15 officers in counties of the second through eighth classes, for
16 compensation of district attorneys in cities and counties of the
17 first class, for compensation of district election officers in
18 all counties, for the disposition of fees, for filing of bonds
19 in certain cases and for duties of certain officers."

20 (b) Construction.--Nothing in this act shall be construed as
21 affecting the salaries of county officers existing as of the
22 effective date of this subsection. Any change in salary shall be
23 in accordance with the act referred to in subsection (a) or
24 other applicable law.

25 Section 1561. Insurance and other employee benefits.

26 In addition to any other authorized compensation, county
27 commissioners and other county officers and their dependents
28 shall be eligible for inclusion in group life, health,
29 hospitalization, medical service and accident insurance plans or
30 other employee benefits, or payments made in lieu of such

1 benefits, paid in whole or in part by the county, provided such
2 plans, benefits or payments are offered generally to employees
3 of the county.

4 Section 30. Article XVI heading and sections 1601, 1602,
5 1603, 1605, 1607, 1608, 1609, 1610, 1622 and 1623 of the act are
6 amended to read:

7 ARTICLE XVI

8 FEES OF SALARIED COUNTY OFFICERS; SALARY

9 BOARDS[; PAYMENT OF SOLICITORS APPOINTED

10 BY COUNTY OFFICERS]

11 Section 1601. Fees of Salaried County Officers to Belong to
12 County.--[All] Except where otherwise provided by law, fees
13 limited and appointed by law to be received by any county
14 officer, either elected or appointed, or which they shall
15 legally be authorized, required or entitled to charge or
16 receive, shall belong to the county [in the following
17 circumstances: (1) fees of every such officer in counties
18 containing over one hundred and fifty thousand inhabitants and,
19 (2) in counties containing one hundred and fifty thousand or
20 less inhabitants, fees of every officer for whom a salary is
21 fixed by law. The provisions of this subdivision shall apply to
22 all fees belonging to the county and to all officers
23 hereinbefore designated]. Each [of the said officers] officer
24 shall exact, collect and receive all such fees to and for the
25 use of [his respective] the county, except [such] taxes and fees
26 as are levied by the Commonwealth, which shall be to and for the
27 use of the Commonwealth. [None of said officers shall receive
28 for his own use or for any use or purpose whatever] No officer
29 shall use fees received for official services for any purpose,
30 except for the use of the [proper] county or [for] the

1 Commonwealth[, as the case may be, any fees for any official
2 services whatsoever, except where the statute expressly
3 designates the officer as agent of the Commonwealth and
4 authorizes him to retain a part of such moneys for his own use].

5 Section 1602. System of Accounts to be Kept; Fees to be Paid
6 to County Treasurer Monthly.--(a) Each [of said officers]
7 officer receiving fees shall keep a system of accounts, the form
8 of which shall be prescribed by the controller, or where such
9 [officer] office does not exist then by the county auditors, in
10 which or on which entry shall be made of all the moneys received
11 for fees and of all moneys earned and chargeable upon the
12 county, specifying the day and date, the title of the case, if
13 [any] applicable, for what service, and from whom received.

14 (b) At the times designated by resolution of the county
15 commissioners but not later than the [first Monday] tenth day of
16 each month, each of said officers shall [pay to]:

17 (1) Pay to the county treasurer [of the proper county] all
18 fees so received for each designated period. Duplicate receipts
19 therefor shall be taken, one of which [he] the treasurer shall
20 deposit with the county controller, or the chief clerk where the
21 office of controller does not exist. [On the first Monday of
22 each month, each of said officers shall deposit]

23 (2) Deposit with the county controller, or where the office
24 of controller does not exist, with the county [auditor] auditors
25 a transcript, in detail, of [his] the officer's system of
26 accounts for the preceding month. [He] The officer shall make
27 oath or affirmation before the county controller or the county
28 auditors where the office of controller does not exist that the
29 transcript contains a true and correct list of all the fees
30 received, earned or chargeable upon the county for services

1 rendered in [his] the office, either by [himself] the officer,
2 deputies or clerks, during the preceding month that said fees
3 were severally charged and collected at regular rates, and that
4 [he] the officer has not received and is not to receive [from
5 any person or persons whatsoever], for any official services or
6 duty, any other fees than those so entered on said transcript.

7 (c) It shall be the duty of the county controller, or the
8 county auditors where the office of county controller does not
9 exist, to receive such returns, to audit and verify the returns
10 for the preceding month and to charge the county treasurer with
11 the money for fees so paid in.

12 (d) Where fees are paid to one office which are for services
13 rendered or to be rendered by another, the officer receiving the
14 same shall specify the same on his account book and on his
15 transcript as of the office to which they properly belong.

16 Section 1603. Penalty for Receiving Gratuities or
17 Percentages.--If any of the officers included in this
18 subdivision shall receive or stipulate to receive from any
19 deputy or clerk or from any person [or persons] awarded any
20 contract [for advertising or any other contract] any sum [or
21 sums] of money as percentage on the salaries of said deputy or
22 clerk or on the amounts or profits of said contract, or any sum
23 [or sums] of money [whatsoever] as compensation for making any
24 of the said appointments or contracts, or shall neglect to
25 render the accounts or to pay over the money received for fees
26 as required by this subdivision, or shall [wilfully] willfully
27 neglect to make any proper entry in the book or books required
28 to be kept, or shall [wilfully] willfully neglect to charge for
29 any official services the fees allowed by law, or shall take to
30 [his] the officer's own use any such fees, or fail to comply

1 with any of the provisions of this subdivision, or neglect to
2 discharge any of the duties herein imposed, the same shall be
3 deemed a misdemeanor in office, and, in addition to the other
4 penalties for such offenses, [he] the officer shall, upon
5 conviction thereof, refund the said sum [or sums] of money
6 [thus] unlawfully received, and shall be deemed incapable of
7 holding the said office.

8 Section 1605. Officers Subject to This Subdivision to be
9 Paid Salaries.--All [county] officers to which this subdivision
10 applies[, whether elected by the people or appointed according
11 to law,] and their [several] deputies and clerks, shall be paid
12 for their services by fixed and specific salaries[, which]. The
13 salaries shall be a charge upon the treasury of the county to
14 which each shall respectively belong, to the extent of the fees
15 collected and paid in by each officer respectively, or earned,
16 where fees are chargeable upon the county treasury, except as
17 provided in section [one thousand six hundred eight, of the fees
18 collected and paid in by each officer respectively, or earned,
19 where fees are chargeable upon the county treasury, and said]
20 1608. The salaries shall be paid weekly, bi-weekly, semi-monthly
21 or monthly during the month in which the services were rendered,
22 at the discretion of the county commissioners [of the county].
23 No voucher check or warrant shall be drawn for the payment of
24 any [said officer, his] officers, deputies or clerks who shall
25 not have filed the receipt and transcript for that month
26 provided for in this subdivision.

27 Section 1607. Monthly Returns to be Made of Taxes and Fees
28 Due the Commonwealth.--(a) At the same time that monthly
29 returns are made, as required by section [one thousand six
30 hundred two of this act, of the fees received by said officers

1 to and for the use of their respective counties for the
2 preceding month] 1602, each of said officers shall make a
3 separate return, to the Department of Revenue, of all taxes or
4 fees collected or earned for the Commonwealth by [him] the
5 officer, if any. [The amounts so returned by any of said
6 officers, as received by him for the Commonwealth, shall be
7 separately paid by him into the State Treasury through the
8 Department of Revenue, quarterly, on the first Mondays of April,
9 July, October and January, for which he shall take duplicate
10 receipts.] Such taxes, fees and other amounts due the
11 Commonwealth shall be paid over, as required but no more often
12 than monthly, unless law or regulation provides otherwise.

13 (b) All commissions on the collection of any such taxes and
14 fees for the Commonwealth shall be deemed and taken as part of
15 the regular fees of the officer collecting the same and shall be
16 accounted for accordingly.

17 (c) The provisions of this section shall apply only to the
18 reporting and payment over of any such taxes or fees and to the
19 treatment of commissions thereon as are not otherwise provided
20 for by law.

21 Section 1608. Payment of Certain Officers.--The county
22 solicitor, county [jailer] prison warden, county commissioners,
23 county controller, county surveyor or engineer, county
24 detectives, county treasurer, interpreter of courts, district
25 attorney and his assistants, and in counties of the sixth,
26 seventh and eighth classes all county officers for whom a salary
27 is fixed by law and the deputies, clerks and employes of their
28 respective offices, shall severally be paid weekly, bi-weekly,
29 semi-monthly, or monthly, at the discretion of the county
30 commissioners of the county. They shall be paid the full amount

1 allowed them by law, but all fees and emoluments whatsoever that
2 may accrue to any of them by virtue of [his] the office shall be
3 paid by [him] the officer or employe to the county treasurer as
4 directed by law, and all other officers shall be paid the
5 amounts assigned them by law in accordance with the provisions
6 of this subdivision.

7 Section 1609. Salaries in Lieu of Fees.--Except to the
8 extent this section may be inconsistent with [the provisions of]
9 any other express provision of this act, the salaries fixed and
10 provided by law for county officers shall be in lieu of all or
11 any moneys, fees, perquisites, or mileage expenses, and other
12 allowances received or allowed to any such officer, and all such
13 moneys, fees, perquisites, or mileage expenses, and other
14 allowances, not governed by the aforesaid exceptions, shall
15 belong to the county and shall be paid into the county treasury,
16 except where required to be paid to the Commonwealth in the
17 manner provided by this subdivision for fees.

18 Section 1610. Rights of Action and Remedies for Collection
19 of Fees Extended to Counties.--All rights of action and all
20 other remedies heretofore granted or extended to [county]
21 officers to whom this subdivision applies for the collection of
22 their respective fees are hereby extended, and shall inure to
23 the benefit of the several counties affected by this subdivision
24 for the collection of all fees and costs that may accrue to
25 [said] counties under the provisions of this subdivision.

26 Section 1622. Salary Boards Created.--There is hereby
27 created in each county a salary board, which shall consist of
28 the three individual members of the board of county
29 commissioners and the county controller in counties where there
30 is a controller, or the county treasurer in counties where there

1 is no controller. The [chairman] chairperson of the board of
2 county commissioners shall be [chairman] chairperson of the
3 salary board and the county controller or county treasurer, as
4 the case may be, shall be secretary of the board. The board
5 shall meet and organize on the first Monday of January of each
6 year.

7 Section 1623. Number and Compensation of Officers, Deputies,
8 Assistants, Clerks and Employes; Revisions of Salary
9 Schedules.--[The] (a) At each annual meeting, the board,
10 subject to limitations imposed by law, shall fix the
11 compensation of all appointed county officers, and the number
12 and compensation of all deputies, assistants, clerks and other
13 persons whose compensation is paid out of the county treasury
14 (except employes of county officers who are paid by fees and not
15 by salary), and of all court criers, tipstaves and other court
16 employes, and of all officers, clerks, stenographers and
17 employes appointed by the judges of any court and who are paid
18 from the county treasury. [Thereupon] Between annual salary
19 board meetings whenever required by any judge, county officer or
20 executive head of any separate board, commission or division
21 whose deputies', assistants', clerks' and employes' numbers or
22 compensation is sought to be fixed, the board shall meet and
23 consider and shall fix and determine the same. All salaries
24 fixed under the provisions of this act shall be paid out of the
25 county treasury in the manner provided by law.

26 (b) Upon action by the board in accordance with subsection
27 (a), the number and compensation of all such officers, deputies,
28 assistants, clerks and persons, whether fixed by statute or by
29 any other method, are hereby repealed. In the event that any
30 salary board shall fail to fix the number or compensation of any

1 such officers, deputies, assistants, clerks or other employes as
2 required by this section, the number and compensation shall
3 continue, as fixed by or pursuant to law[, on the effective date
4 of this act,] with like effect as though the same had been so
5 fixed by the board, but the salary board shall have power to fix
6 any such number or compensation at a later time and with like
7 effect.

8 Section 31. Section 1624 of the act is repealed:

9 [Section 1624. Revisions of Salary Schedules.--At each
10 annual meeting, the board shall revise the salary schedule so
11 far as it shall deem such action necessary. From time to time
12 between annual meetings, whenever required by any judge, county
13 officer or executive head of any separate board, commission or
14 division, the number or compensation of whose deputies,
15 assistants, clerks and employes is sought to be fixed, the board
16 shall meet and consider and shall fix and determine the same.
17 All salaries fixed under the provisions of this act shall be
18 paid out of the county treasury in the manner provided by law.]

19 Section 32. Section 1625 of the act is amended to read:

20 Section 1625. Procedure and Action of Board.--(a) Except as
21 herein otherwise provided, whenever the board shall consider the
22 number or salaries of the deputies or other employes of any
23 county officer or agency, such officer or the executive head of
24 such agency shall sit as a member of the board, as long as any
25 matter affecting [his] the office or agency is under
26 consideration and no longer.

27 (b) Whenever the board shall consider the number or salaries
28 of the court criers or tipstaves or other court employes, the
29 president judge of the court shall sit as a member of the board,
30 as long as any matter affecting the court criers, tipstaves or

1 employes of [his] the court is under consideration and no
2 longer.

3 (c) (1) Whenever the board shall consider the number or
4 salaries of the officers or employes appointed by any judge of
5 any court, such judge shall sit as a member of the board, as
6 long as any matter affecting any of [his] the judge's appointees
7 is under consideration and no longer.

8 (2) In counties of the second class A, whenever the board
9 shall consider the number or salaries of the employes of the
10 prison board, the president judge of the court of common pleas
11 shall sit as a member of the board, and the board so constituted
12 shall fix the number and salaries of such employes,
13 notwithstanding any general, local or special law to the
14 contrary.

15 (d) The decision of a majority shall govern. Each board
16 shall keep a correct minute book of its proceedings in all cases
17 heard and determined by it. Such minute book shall be a public

22 Section 1630. Compensation of Solicitors Appointed by County
23 Officers.--The county commissioners may appropriate money for
24 the payment of any solicitor appointed pursuant to this act by a
25 county treasurer, sheriff, prothonotary, register of wills,
26 recorder of deeds, clerk of courts, coroner, a clerk of orphans'
27 court or the county controller or the county auditors.]

28 Section 34. Sections 1701.1, 1702, 1703, 1704, 1705, 1706
29 and 1720 of the act are amended to read:

30 Section 1701.1. Billing and Collection of Third, Fourth,

1 Fifth, Sixth, Seventh and Eighth Class County Taxes.--(a) The
2 county commissioners of each county of the third, fourth, fifth,
3 sixth, seventh and eighth class may, by resolution, provide for
4 the billing and collecting [by the county treasurer] of all
5 county and county institution district taxes levied within a
6 third class city [by the authorities empowered to levy such
7 taxes.] and may, in the resolution, vest the county treasurer
8 with the duties and responsibilities of billing and collecting
9 all the taxes. The resolution shall be adopted by the county and
10 the city treasurer shall be notified of adoption of the
11 resolution no later than the first day for the circulation of
12 nomination petitions for the office of tax collector within the
13 county and shall take effect upon the first day of the next
14 succeeding term of office of tax collector following adoption of
15 the resolution.

16 (a.1) The county commissioners of each county of the third,
17 fourth, fifth, sixth, seventh and eighth class may, by
18 resolution, provide for the billing and collection of all county
19 taxes in municipalities existing or organized under [the] 53
20 Pa.C.S. Pt. III Subpt. E (relating to home rule and optional
21 plan government) or under the former act of April 13, 1972
22 (P.L.184, No.62), known as the "Home Rule Charter and Optional
23 Plans Law," that have eliminated the elective office of tax
24 collector, by the authorities empowered to levy such taxes[.],
25 and by resolution, vest in the county treasurer the duties and
26 responsibilities of billing and collecting county taxes in those
27 municipalities.

28 [(b) In counties of the third, fourth, fifth, sixth, seventh
29 and eighth class, the county commissioners may provide, by
30 resolution, for the billing and collection of all county and

1 county institution district taxes levied in third class cities.
2 The county commissioners shall have the power and authority by
3 resolution, to vest in the county treasurer the duties and
4 responsibilities of billing and collecting county and county
5 institution district taxes in third class cities. The resolution
6 shall be adopted by the county no later than the first day for
7 the circulation of nomination petitions for the office of tax
8 collector within the county and shall take effect upon the first
9 day of the next succeeding term of office of tax collector
10 following adoption of the resolution.

11 (b.1) In counties of the third, fourth, fifth, sixth,
12 seventh and eighth class in which the county commissioners
13 provide, by resolution, for the billing and collection of all
14 county taxes levied in municipalities existing and organized
15 under the "Home Rule Charter and Optional Plans Law," that have
16 eliminated the elective office of tax collector, the county
17 commissioners shall have the power and authority, by resolution,
18 to vest in the county treasurer the duties and responsibilities
19 of billing and collecting county taxes.]

20 (b.2) Notwithstanding any law to the contrary, if, as a
21 result of a vacancy in the office of elected tax collector in a
22 municipality within a county of the third, fourth, fifth, sixth,
23 seventh or eighth class, an employe or paid official of the
24 municipality is appointed or directed by the governing body of
25 the municipality to assume the duties of tax collector, the
26 county commissioners may, by resolution, provide, until a
27 successor tax collector is elected in accordance with law, for
28 the following:

29 (1) the county treasurer to have the duties and
30 responsibilities of billing and collecting all county and county

1 institution district taxes levied within the municipality;

2 (2) payment to the municipality, rather than the employe or
3 paid official appointed or directed by the governing body of the
4 municipality to assume the duties of tax collector, the
5 compensation that otherwise would be attributable to the billing
6 and collecting of county and county institution district taxes
7 levied within the municipality; or

8 (3) an agreement with the tax collector in an adjoining or
9 conveniently located municipality to assume the duties of the
10 tax collector and receive the compensation that otherwise would
11 be attributable to the billing and collecting of county and
12 county institution district taxes levied within the
13 municipality.

14 (b.3) Notwithstanding any law to the contrary, if, as a
15 result of a vacancy in the office of elected tax collector in a
16 municipality, the county treasurer has been appointed or
17 directed by the county commissioners to bill and collect all
18 county and county institution district taxes within the
19 municipality, the governing body of the municipality and the
20 county commissioners may by agreement provide that the county
21 treasurer shall have the duties and responsibilities of billing
22 and collecting all taxes levied by the municipality in
23 accordance with section 4.4 of the act of May 25, 1945
24 (P.L.1050, No.394), known as the "Local Tax Collection Law."

25 (c) The county commissioners may appoint such other employes
26 as may be necessary to carry out the provisions of this section.

27 (d) [The] Except as may otherwise be provided in the "Local
28 Tax Collection Law," the compensation of personnel and other
29 expenses of billing and collecting county and institution
30 district taxes pursuant to this section shall be paid out of the

1 general fund in the county treasury. The compensation and number
2 of such employes other than the county treasurer shall be
3 governed by the provisions of this act relating to the county
4 salary board. If the county treasurer is designated as the
5 collector of the county and county institution district taxes
6 [he] that person shall not receive added compensation for
7 performing such functions.

8 (e) The treasurer shall be governed by the provisions of
9 [the act of May 25, 1945 (P.L.1050) known as] the "Local Tax
10 Collection Law" and its amendments.

11 Section 1702. Functions of the Controller.--(a) (1)
12 Subject to the power and duty of the county commissioners to
13 manage and administer the fiscal affairs of the county, the
14 controller shall supervise the fiscal affairs of the county
15 including the related accounts and official acts [relating
16 thereto] of all officers or other persons who shall collect,
17 receive, hold or disburse, or be charged with the management or
18 custody of, the public assets of the county. [The discretionary
19 powers of the controller shall not be applicable to the

3 or has not received approval according to law, or as to which
4 [he] the controller desires upon reasonable grounds to
5 investigate for or has already discovered any fraud, flagrant
6 abuse of public office or any criminal act or neglect of any
7 officer or other person of the county relating to their public
8 accounts and transactions. [He] The controller may at any time
9 require from any such officers or other persons, in writing, an
10 account of all assets which may have come into their control.
11 Immediately, on the discovery of any default or delinquency,
12 [he] the controller shall report the same to the commissioners
13 and to the district attorney of the county for such prosecution
14 as may be warranted, and shall take immediate measures to secure
15 the public assets.

16 (b) Pursuant to subsection (a), the county commissioners
17 [may], for the purpose of meeting Federal or State requirements,
18 may issue a request for proposals for and contract with [or
19 employ] an independent certified public accountant or employ a
20 public accountant for the purpose of preparing or conducting a
21 report or audit of the fiscal affairs of the county, independent
22 of and/or in addition to, that conducted by the county
23 controller or auditors. [Such contracts shall be discussed with
24 the controller prior to execution, and the] The controller shall
25 be afforded an opportunity to comment[.] on the request for
26 proposals prior to issuance and the contract prior to execution.
27 The contracts shall supplement, but not replace, the official
28 acts and audits of the controller.

29 Section 1703. Accounts of Officers.--The controller shall
30 furnish the commissioners of the county, whenever required by

1 them, a detailed account of any officer or other person having
2 in [his] that individual's possession or under [his] that
3 individual's control funds belonging to the county, and shall,
4 during regular office hours, give information respecting any of
5 said accounts to any taxpayer of the county demanding the same.

6 [He] The controller shall have power and authority to require
7 each and every county officer to make a quarterly statement with
8 respect to moneys in [his] the officer's possession or control
9 as a county officer, showing the amount of cash on hand and the
10 amount deposited in banks, banking institutions and trust
11 companies, together with the names of such institutions. [He]
12 The controller shall have power to examine every such account of
13 a county officer in any bank, banking institution or trust
14 company, to verify the accuracy of the statement of such county
15 officer. It shall be the duty of every such bank, banking
16 institution or trust company, its officers and agents, to
17 furnish full information to the controller in relation to the
18 account of such county officer. No bank, banking institution or
19 trust company, its officers or agents, shall be subject to
20 prosecution under other laws of this Commonwealth for disclosing
21 any such information with respect to any account of a county
22 officer.

23 Section 1704. Custody of Documents.--The controller shall
24 have [the] custody of and retain in original or other acceptable
25 form, as provided in the most recent edition of the County
26 Records Manual issued for the County Records Committee by the
27 Pennsylvania Historical and Museum Commission, all title deeds
28 to real estate owned by the county, and [of] all executed
29 contracts entered into by or on behalf of the county, and [of
30 all books, documents and papers] all records relating to its

1 financial affairs, and [of] all bonds and other obligations
2 issued by [said] the county, when paid. Such bonds and other
3 obligations, when so paid, shall be [distinctly cancelled]
4 monitored by the controller [and carefully and regularly filed,
5 a register], a ledger of which [cancellation] shall be [kept]
6 maintained by him or her in a book [to be provided for that
7 purpose.] or an electronic file dedicated for that purpose and
8 retained according to the most recent edition of the County
9 Records Manual.

10 Section 1705. [Books of Fiscal Affairs] Financial Records.--
11 The controller shall [keep] maintain a full and regular set of
12 [books] financial records, including the general ledger, in
13 electronic form or otherwise, which support financial statements
14 in accordance with generally accepted accounting principles of
15 all the fiscal operations of the county, embracing as many
16 accounts, under appropriate titles, as may be necessary to meet
17 Federal and State reporting requirements and to show distinctly
18 and separately all the property of the county, its revenue and
19 expenditures, and all debts and accounts due by the county
20 officers or others, and the amount raised from each source of
21 revenue, and the expenditures in detail, and classified by
22 reference to the objects thereof. [He] The controller shall
23 [prescribe] select and administer the form and manner of
24 [keeping] maintaining the official [books and papers] financial

26 Where the controller prescribes a change in the form and manner
27 of [keeping] maintaining the official [books and papers]
28 financial records, any costs necessary for implementation shall
29 be subject to the approval of the county commissioners. In
30 counties without a controller, the requirements of this section

1 shall be fulfilled by the office of the county commissioners.

2 Section 1706. Investment of Funds.--(a) [The] (1) In
3 counties of the second class A, the county treasurer shall have
4 the power, subject to subsection (b)(1) and any conditions and
5 limitations in this article, to invest and reinvest the moneys
6 of the general fund and special funds as shall have accumulated
7 beyond the ordinary needs of said various funds, and which are
8 not authorized by law to be invested by any board, commission or
9 county officer, consistent with sound business practice,
10 subject, however, to the exercise of that degree of judgment,
11 skill and care under the circumstances then prevailing which
12 persons of prudence, discretion and intelligence, who are
13 familiar with the matters, exercise in the management of their
14 own affairs not in regard to speculation, but in regard to the
15 permanent disposition of the funds, considering the probable
16 income to be derived therefrom as well as the probable safety of
17 their capital.

18 (2) In counties of the third, fourth, fifth, sixth, seventh,
19 or eighth class, the county commissioners (or any individual
20 other than the commissioners who serves in an elective county
21 office, as to such moneys not otherwise required by law to be
22 invested that [his] the individual's office is required to
23 collect, administer or disburse) shall invest such moneys
24 consistent with sound business practice, subject, however, to
25 the exercise of that degree of judgment, skill and care under
26 the circumstances then prevailing which persons of prudence,
27 discretion and intelligence, who are familiar with such matters,
28 exercise in the management of their own affairs not in regard to
29 speculation, but in regard to the permanent disposition of the
30 funds, considering the probable income to be derived therefrom

1 as well as the probable safety of their capital.

2 (b) [The] (1) In counties of the second class A, a board of
3 investment is hereby created. The board shall be composed of the
4 treasurer, who shall chair the board, the chairperson of the
5 county commissioners and the controller. The board shall provide
6 for an investment program, including temporary investments,
7 subject to restrictions contained in this act, and in any other
8 applicable statute and any rules and regulations adopted by the
9 board. County boards, commissions or other county officers
10 authorized to make investments under subsection (a)(1) shall
11 make investments in conformity with the board's investment
12 program.

13 (2) In counties of the third, fourth, fifth, sixth, seventh,
14 or eighth class, the commissioners shall provide for an
15 investment program, including temporary investments, subject to
16 restrictions contained in this act and in any other applicable
17 statute and any rules and regulations adopted by the
18 commissioners. Other elective officials authorized to make
19 investments under subsection [(a)] (a)(2) shall make investments
20 in conformity with the commissioners investment program.

21 (c) Authorized types of investments or financial products
22 for such moneys [shall be:], in addition to those authorized
23 under the act of July 25, 1973 (P.L.217, No.53), entitled "An
24 act authorizing cities of the first class and second class to
25 invest all funds received and deposited with the city treasurer
26 in certain commercial paper under certain terms and conditions;
27 and providing for investment of public corporation or municipal
28 authority funds," shall be:

29 [(1) United States Treasury bills.]

30 [(2) Short-term obligations of the United States Government

1 or its agencies or instrumentalities.

2 (3) Deposits in savings accounts or time deposits, other
3 than certificates of deposit, or share accounts of institutions
4 having their principal place of business in the Commonwealth and
5 insured by the Federal Deposit Insurance Corporation or the
6 Federal Savings and Loan Insurance Corporation or the National
7 Credit Union Share Insurance Fund or the Pennsylvania Deposit
8 Insurance Corporation or the Pennsylvania Savings Association
9 Insurance Corporation to the extent that such accounts are so
10 insured, and, for any amounts above the insured maximum,
11 provided that approved collateral as provided by law therefore
12 shall be pledged by the depository.

13 (4) Obligations of the United States of America or any of
14 its agencies or instrumentalities backed by the full faith and
15 credit of the United States of America, the Commonwealth of
16 Pennsylvania or any of its agencies or instrumentalities backed
17 by the full faith and credit of the Commonwealth, or of any
18 political subdivision of the Commonwealth of Pennsylvania or any
19 of its agencies or instrumentalities backed by the full faith
20 and credit of the political subdivision.

21 (5) Shares of an investment company registered under the
22 Investment Company Act of 1940, whose shares are registered
23 under the Securities Act of 1933, provided that the only
24 investments of that company are in the authorized investments
25 for county funds listed in clauses (1) through (4).

26 (6) Certificates of deposit purchased from institutions
27 having their principal place of business in the Commonwealth and
28 insured by the Federal Deposit Insurance Corporation or the
29 Federal Savings and Loan Insurance Corporation or the National
30 Credit Union Share Insurance Fund or the Pennsylvania Deposit

1 Insurance Corporation or the Pennsylvania Savings Association
2 Insurance Corporation to the extent that such accounts are so
3 insured, however, for any amounts above the insured maximum,
4 such certificates of deposit shall be collateralized by a pledge
5 or assignment of assets of the institution, and such collateral
6 may include loans (including interest in pools of loans) secured
7 by first mortgage liens on real property. Certificates of
8 deposit purchased from commercial banks shall be limited to an
9 amount equal to twenty per centum of a bank's total capital and
10 surplus. Certificates of deposit purchased from savings and loan
11 associations or savings banks shall be limited to an amount
12 equal to twenty per centum of an institutions assets minus
13 liabilities.

14 (7) Certificates of deposit purchased from institutions
15 having their principal place of business outside the
16 Commonwealth and insured by the Federal Deposit Insurance
17 Corporation or the Federal Savings and Loan Insurance
18 Corporation or the National Credit Union Share Insurance Fund to
19 the extent that such accounts are so insured, and, for any
20 amounts above the insured maximum, provided that approved
21 collateral as provided by law therefore shall be pledged by the
22 depository. Certificates of deposit purchased from commercial
23 banks shall be limited to an amount equal to twenty per centum
24 of a bank's total capital and surplus. Certificates of deposit
25 purchased from savings and loan associations or savings banks
26 shall be limited to an amount equal to twenty per centum of an
27 institution's assets minus liabilities.

28 (8) Any investment authorized by 20 Pa.C.S. Ch. 73 (relating
29 to fiduciaries investments) shall be an authorized investment
30 for any pension or retirement fund.

1 (9) "Commercial paper" and "prime commercial paper" as
2 provided for in subsection (d).]

3 (10) Obligations of the United States of America or any of
4 its agencies or instrumentalities backed by the full faith and
5 credit of the United States of America including United States
6 Treasury bills, of the Commonwealth of Pennsylvania or any of
7 its agencies or instrumentalities backed by the full faith and
8 credit of the Commonwealth, or of any political subdivision of
9 the Commonwealth of Pennsylvania or any of its agencies or
10 instrumentalities backed by the full faith and credit of the
11 political subdivision.

12 (11) Deposits in savings accounts or time deposits, other
13 than certificates of deposit, or share accounts of institutions
14 insured by the Federal Deposit Insurance Corporation or the
15 National Credit Union Share Insurance Fund to the extent that
16 the accounts are so insured, and, for any amounts above the
17 insured maximum, provided that approved collateral as provided
18 by law therefore shall be pledged by the depository. The
19 deposits are differentiated from savings or demand deposits as
20 authorized by the act of July 25, 1973 (P.L.217, No.53).

21 (12) Shares of an investment company registered under the
22 Investment Company Act of 1940 (54 Stat. 789, 15 U.S.C. § 80a-1
23 et seq.), whose shares are registered under the Securities Act
24 of 1933 (48 Stat. 74, 15 U.S.C. § 77a et seq.), if the only
25 investments of the company are in the authorized investments for
26 county funds in paragraphs (10) and (11) and:

27 (i) The investment company is managed in accordance with 17
28 CFR 270.2a-7 (relating to money market funds).

29 (ii) The investment company is rated in the highest category
30 by a nationally recognized rating agency.

1 (13) Certificates of deposit purchased from institutions
2 insured by the Federal Deposit Insurance Corporation or the
3 National Credit Union Share Insurance Fund to the extent that
4 the accounts are so insured, and, for any amounts above the
5 insured maximum, provided that approved collateral as provided
6 by law therefore shall be pledged by the depository. In addition
7 to the collateralization requirements, the following limitations
8 shall apply:

9 (i) Certificates of deposit purchased from commercial banks
10 shall be limited to an amount equal to twenty per centum of a
11 bank's total capital and surplus.

12 (ii) Certificates of deposit purchased from savings and loan
13 associations or savings banks shall be limited to an amount
14 equal to twenty per centum of an institution's assets minus
15 liabilities.

16 (14) Any investment authorized by 20 Pa.C.S. Ch. 73
17 (relating to municipalities investments) shall be an authorized
18 investment for any pension or retirement fund.

19 [(d) As used herein "commercial paper" shall mean unsecured
20 promissory notes issued at a discount from par by any
21 industrial, common carrier, public utility or finance company
22 and "prime commercial paper" shall mean notes issued by
23 corporations whose credit has been approved by the National
24 Credit Office, Incorporated, New York, or its successor. The
25 treasurer shall have obtained the following prior to any
26 commitment to purchase commercial paper:

27 (1) A certification or other evidence that such commercial
28 paper is rated prime by the National Credit Office,
29 Incorporated.

30 (2) A certification or other evidence that the paper

1 proposed to be delivered is not subordinate to any other debt of
2 the issuer.

3 (3) A certificate or other evidence that there is no
4 litigation pending or threatened affecting said paper.

5 (4) A certificate or other evidence that the issuer is not
6 in default as to the payment of principal and interest upon any
7 of its outstanding obligations.

8 (5) A certificate or other evidence that the issuer was
9 incorporated within the United States, is transacting business
10 within the United States, and has assets of one billion dollars
11 (\$1,000,000,000) or more, or is a wholly owned subsidiary of a
12 Pennsylvania corporation having assets of one billion dollars
13 (\$1,000,000,000) or more.

14 (6) The treasurer shall not, at any time, have invested in
15 prime commercial paper more than an aggregate of such total sum
16 as the board shall have prescribed.]

17 (d.1) Officials, as authorized in subsection (a) (1) or (2),
18 shall not, at any time, have invested in negotiable certificates
19 of deposit, bankers' acceptances or commercial paper,
20 respectively, as authorized by the act of July 25, 1973
21 (P.L.217, No.53), more than an aggregate of the total sum as the
22 investment policy of the board of investment or the board of
23 commissioners shall have prescribed.

24 (e) [In] Officials making investments of county funds, [the
25 commissioners (or other elected officials when authorized as
26 provided in subsection (a))] as authorized in subsection (a) (1)
27 or (2), shall have authority:

28 (1) To permit assets pledged as collateral under subsection
29 [(c) (3)] (c) (11), to be pooled in accordance with the act of
30 August 6, 1971 (P.L.281, No.72), entitled "An act standardizing

1 the procedures for pledges of assets to secure deposits of
2 public funds with banking institutions pursuant to other laws;
3 establishing a standard rule for the types, amounts and
4 valuations of assets eligible to be used as collateral for
5 deposits of public funds; permitting assets to be pledged
6 against deposits on a pooled basis; and authorizing the
7 appointment of custodians to act as pledgees of assets,"
8 relating to pledges of assets to secure deposits of public
9 funds.

10 (2) To combine moneys from more than one fund under county
11 control for the purchase of a single investment, provided that
12 each of the funds combined for the purpose shall be accounted
13 for separately in all respects and that the earnings from the
14 investment are separately and individually computed and recorded
15 and credited to the accounts from which the investment was
16 purchased.

17 (3) To join with one or more other political subdivisions
18 and municipal authorities in accordance with 53 Pa.C.S. Ch. 23
19 Subch. A (relating to intergovernmental cooperation) in the
20 purchase of a single investment, provided that the requirements
21 of clause (2) on separate accounting of individual funds and
22 separate computation, recording and crediting of the earnings
23 therefrom are adhered to.

24 (4) To join with the Commonwealth, political subdivision or
25 redevelopment authority in the purchase of real estate for the
26 purposes of community and economic development.

27 (5) To grant funds to the Commonwealth, political
28 subdivision or redevelopment authority for the purposes of
29 supporting community and economic development projects.

30 (f) All income earned on any of the investments shall inure

1 to the benefit of the county and shall be placed in the general
2 fund except as otherwise directed by the commissioners or
3 restricted by law.

4 Section 1720. Controller's or Auditors' Settlement of
5 Accounts; Report to Common Pleas; Publications; Financial Report
6 to Department of Community and Economic Development.--(a) The
7 controller or auditors, as may be the case, shall, at the end of
8 each fiscal year, complete the audit, settlement and adjustment
9 of the accounts of all county officers. [He] The controller or
10 auditors shall, before the first day of July in every year, make
11 a report, verified by oath or affirmation, to the [Court of
12 Common Pleas of said county] county court of common pleas,
13 unless upon due cause shown the court shall grant an extension
14 of time, of all receipts and expenditures of the county for the
15 preceding year, in detail, and classified by reference to the
16 object thereof, together with a full statement of the financial
17 conditions of the county. [A concise summary of this report]

18 (b) Within ten days after making a report to the court of
19 common pleas, notice that the report is available for public
20 inspection shall [thereupon] be published one time in [such
21 newspapers published in said] at least one newspaper of general
22 circulation in the county as the controller or auditors may
23 direct and shall be posted on the official publicly accessible
24 Internet website of the county, but the aggregate cost [thereof]
25 of newspaper publication shall not exceed fifteen hundred
26 dollars (\$1500) in any one year in any county, to be paid for
27 out of the county treasury. The entire report, which shall
28 include a concise summary, shall be available for public
29 inspection in the office of the controller or auditors during
30 regular business hours and on the official publicly accessible

1 Internet website of the county. Such report may also be
2 published in printed pamphlets at the cost of the county, the
3 number and cost of such pamphlets to be determined by the
4 controller or auditors and the county commissioners with
5 consideration of current budget allocations.

6 (c) The controller shall also, [before the first day of
7 July,] on or before the date required by section 123 of the act
8 of July 10, 1987 (P.L.246, No.47), known as the Municipalities
9 Financial Recovery Act, or the first of July, whichever is
10 first, make an annual report to the Department of Community and
11 Economic Development of the financial condition of the county,
12 on forms furnished by the Secretary of Community and Economic
13 Development[, and subject to the penalties provided in section
14 one thousand seven hundred twenty-one of this act for auditors
15 refusing or neglecting to make similar reports. Within the
16 summary of the auditor's or controller's report, there shall be
17 a notice to the public that the entire text of the report shall
18 be available for public inspection during regular business hours
19 in the office of the auditor or controller.]_.

20 (d) Any controller or auditors refusing or neglecting to
21 file a report with the Department of Community and Economic
22 Development as required by this section shall, upon conviction
23 in a summary proceeding brought at the instance of the
24 department, be sentenced to pay a fine of five dollars (\$5) for
25 each day's delay beyond said first day of July and costs. All
26 finances recovered shall be for the use of the Commonwealth.

27 Section 35. The act is amended by adding a section to read:

28 Section 1720.1. Audit of Additional Accounts.--(a) It shall
29 be the duty of the controller or county auditors to audit,
30 settle and adjust the accounts of:

1 (1) Every parole and probation officer, appointed by the
2 court under law, who shall receive from any person money paid
3 under any order, sentence or judgment of any court, and to
4 report the results of the audits to the court which has
5 appointed the officer.

6 (2) Any money appropriated by the county to units of the
7 National Guard.

8 (3) Each magistrate or district justice within the county
9 and report the results of the audits to the county
10 commissioners, the Auditor General and to the governing body of
11 each political subdivision which is entitled or has a right to
12 receive any money or funds collected by a magistrate or district
13 justice.

14 (4) The treasurer of the county with the State Treasury, and
15 each of the other officers in the county receiving money for the
16 use of the Commonwealth, as may be referred to them by the
17 Auditor General or the Department of Revenue, and to make a
18 separate report thereof to the court of common pleas, together
19 with a statement of the balances due from or to the treasurer or
20 other officer. A certified copy of the report shall be
21 transmitted to the Auditor General or the Department of Revenue,
22 as the case may be, within ten days after the same is prepared.

23 (5) Other county funds as may be prescribed by law for the
24 controller or county auditors to audit, settle and adjust.

25 (b) All taxes, penalties, fines and costs collected by the
26 county treasurer and belonging to any taxing district shall be
27 entered and carried in the records of the county in the same
28 manner as county money, shall be audited in like manner, and
29 when paid to the taxing district entitled thereto, as provided
30 by law, payments shall be made on voucher checks in the same

1 manner as payments are made of county money.

2 Section 36. Sections 1721, 1722, 1722.1, 1723 and 1724 of
3 the act are repealed:

4 [Section 1721. Audit of Accounts by Auditors; Report to
5 Common Pleas; Publications; Financial Report to Department of
6 Community and Economic Development.--(a) The auditors shall
7 audit, settle and adjust the accounts of all county officers of
8 the county, and make an annual report thereof, on or before the
9 first day of the following July, to the court of common pleas,
10 unless upon due cause shown the court shall grant an extension

20 settle and adjust the accounts of every parole and probation
21 officer, appointed by the court pursuant to law, who shall
22 receive from any person or persons moneys paid under any order,
23 sentence or judgment of any court, and to report the results of
24 such audits to the court which shall have appointed such
25 officer. The controller or county auditors shall likewise audit,
26 settle and adjust the accounts of any moneys appropriated by the
27 county to units of the National Guard.

28 Section 1722.1. Audit of Accounts of Minor Judiciary.--The
29 controller or county auditors shall annually audit the accounts
30 of every alderman, magistrate or district justice within the

1 county and report the results of such audits to the county
2 commissioners, the Auditor General and to the governing body of
3 each political subdivision which is entitled or has a right to
4 receive any moneys or funds collected by any such alderman,
5 magistrate or district justice.

6 Section 1723. Accounts and Audits of Moneys Collected for
7 Taxing Units Within the County; Payments.--All taxes, penalties,
8 fines and costs collected by the county treasurer and belonging
9 to any city, borough, township, incorporated town, school
10 district or institution district shall be entered and carried in
11 the books of the county in the same manner as county moneys,
12 shall be audited in like manner, and when paid to the taxing

22 of Revenue, and to make a separate report thereof to the court
23 of common pleas, together with a statement of the balances due

28 Section 37. Sections 1724.1, 1725 and 1727 of the act are

30 Section 1724.1. Audit of [Miscellaneous] Insurance and

1 Escrow Accounts.--For the purposes of this act relating to the
2 auditing of accounts and the purchasing of insurance, money held
3 by any county official in escrow shall be deemed the same as
4 county funds or public money.

5 Section 1725. Power of Subpoena and Attachment.--The
6 controller or auditors shall have power to issue subpoenas to

27 refusing to [make] answer [to such] questions [as shall be put

29 accounts or the official conduct of any public officers[, he
30 shall be guilty of a misdemeanor].

1 Section 38. Section 1730 of the act is amended by adding a
2 subsection to read:

3 Section 1730. Filing Reports.--* * *

4 (c) The amount of a balance and of any express surcharge
5 found in a report as provided in subsection (b) shall, if no
6 appeal is taken, or after an appeal has been finally determined
7 in favor of the county or Commonwealth, be entered by the
8 prothonotary as a judgment against the officer. The county or
9 Commonwealth, as the case may be, may execute on a final
10 judgment under this section against the property of the
11 defaulting officer in accordance with law and rule of court.

12 Section 39. Sections 1731, 1733, 1750, 1751, 1752, 1753,

14 Section 1731. Appeals from Reports.--(a) An appeal may be
15 taken from such reports to the court of common pleas, either by
16 the Commonwealth, the county or the officer. Such appeal may
17 also be taken by ten or more taxpayers in behalf of the county[,
18 in the manner and subject to the restrictions provided by
19 article twenty-eight of this act].

20 [Such] (b) The appeal shall be entered by the Commonwealth
21 within four months, and by the county [and the officer], the
22 officer or taxpayers within sixty days after the filing of the

5 (3) If in the opinion of the court the final determination
6 is in part more favorable to the Commonwealth or county and in
7 part more favorable to the officer involved in the surcharge
8 proceeding than that awarded by the controller or auditors, the
9 court may order the Commonwealth or the county to pay a portion
10 of reasonable attorney fees incurred by the officer in
11 connection with the surcharge proceeding or it may order the
12 officer who is the subject of the surcharge proceeding to pay a
13 portion of reasonable attorney fees incurred by the
14 Commonwealth, county or taxpayer in connection with the
15 surcharge proceeding.

16 (b) The attorney fees in case of appeals involving accounts
17 other than those of county officers shall be allocated in the

19 (c) In adjudications of the official actions of the auditors

21 the court may award reasonable attorney fees to the prevailing
22 party as may be just and equitable. Nothing in this section
23 shall be construed as authorizing personal liability for

25 Section 1750. Claims Against County.--The controller or the
26 county commissioners in counties having no controller shall
27 scrutinize, audit and decide on all bills, claims and demands
28 whatsoever against the county, except such as are otherwise
29 provided for in this subdivision. All persons having such claims
30 shall first present [the same] the claims to the controller or

1 to the county commissioners and, if required, make oath or
2 affirmation before [him or them] the controller or commissioners
3 to the correctness [thereof] of the claims. The controller or
4 the commissioners, as the case may be, may[, if he or they deem
5 it necessary,] require evidence, by oath or affirmation, of the

20 Section 1751. Procedure for Approval.--[The] (a) In
21 counties having a controller, the controller shall date, upon
22 receipt, all bills, claims and demands [presented to him] which
23 the controller approves, [which he approves and only for such as
24 he approves,] and shall forward the bills, claims or demands
25 along with checks therefor to the county commissioners for their
26 approval or, if already approved by the commissioners, for their
27 signatures as provided in this section. If the county
28 commissioners approve payment of a bill, claim or demand, at
29 least two commissioners shall sign the check as properly drawn
30 upon the county treasury. In such cases facsimiles of their

1 signatures may be used. The bill, claim or demand shall be
2 returned to the controller for filing in [his] the controller's

12 together with the check involved to the controller for filing in
13 [his] the controller's office.

14 (b) In counties not having a controller, the county
15 commissioners shall approve each transaction and the check shall
16 be drawn by their chief clerk who shall keep files of the bills,
17 claims or demands involved. At least two commissioners shall
18 sign the checks either personally or by facsimile, and they
19 shall be forwarded, together with a check register or similar
20 description of the corresponding bill, claim or demand providing
21 a clear description of the nature and purpose of the
22 expenditure, to the county treasurer for [his] the treasurer's
23 signature.

24 (c) In all cases the [cancelled] canceled checks or official
25 bank record thereof, shall be filed in the office of the county
26 treasurer, but [he] the treasurer shall transmit, at such times
27 as the controller shall establish, a list of all checks paid
28 from the county treasury and not previously transmitted, along
29 with appropriate identification. The county treasurer and the
30 controller in those counties having a controller are authorized

1 to use a facsimile signature on any check which they are
2 required to sign. Nothing in this section shall preclude the
3 receipt or transfer of funds to or from the county, or payment
4 of a bill, claim or demand, by electronic fund transfer,
5 provided that adequate and recognized fiscal and procedural
6 controls, together with proper system security, are in place.

7 Section 1752. Claims Not Approved by Controller.--If, upon
8 receipt, the controller does not approve a claim, bill or demand
9 [presented to him, he], the controller shall within [thirty]
10 fifteen days forward it to the county commissioners together
11 with [his] notice that [he] the controller has disapproved the
12 claim, bill or demand or is unable to approve the same and [his]
13 the reasons therefor. The county commissioners shall consider
14 the claim, bill or demand and, if they consider that it should
15 be paid by the county, they shall so notify the controller. If
16 the controller thereafter continues to refuse [his] approval no
17 payment shall be made thereon by the county except pursuant to
18 an order of court upon a proper issue thereto directing the
19 controller to approve payment.

20 Section 1753. Reports to Commissioners.--[The] At the request
21 of the commissioners, the controller shall report to the
22 commissioners monthly [or oftener, if required by them,] the
23 amount of outstanding checks registered and the amount of money
24 in the treasury or the amount of any particular unencumbered
25 appropriation items involved.

26 Section 1754. Fees of Witnesses and Jurors.--Fees of jurors
27 and witnesses shall be ascertained by the courts of the county
28 entered upon the records thereof and duly certified by their
29 respective clerks to the commissioners being first sworn to or
30 affirmed before the controller or the chief clerk of the

1 commissioners as the case may be. [The commissioners, then, may
2 draw checks therefor without approval of the controller. The
3 certificates shall be filed with the controller or the
4 commissioners where there is no controller after the checks are
5 issued.]

6 Section 1760. Receipts and Accounts of Money Due County.--
7 The county treasurer shall receive and receipt for all moneys
8 due or accruing to the county. [He] The treasurer shall keep
9 proper accounts of all moneys received and disbursed. [His
10 books] The treasurer's records shall be, at all times during
11 office hours, open to the inspection of the controller and the
12 commissioners, or any of [them] the commissioners in counties
13 having no controller. [He] The treasurer shall issue receipts[,
14 at least in triplicate,] for all moneys received for the county,
15 and shall transmit the duplicate or triplicate thereof daily to
16 the controller, or to the county commissioners in counties
17 having no controller. Said receipts shall be serially numbered,
18 shall indicate the amount of money received, from whom, on what
19 account and the date. [He] The treasurer shall likewise keep
20 daily records of all disbursements from the county treasury, and
21 shall forward daily records thereof to the controller, or the
22 commissioners as the case may be. The controller, or the chief
23 clerk of the commissioners where there is no controller, shall
24 have the right to [a certified daily or monthly deposit slip]
25 review depository account information upon request from the
26 county depository or depositories, without prejudice to the said
27 depositories, of all moneys deposited in the name of the county
28 by the treasurer. In counties having no controller, the
29 treasurer shall render, at least quarterly and oftener, if
30 required, a statement of all moneys received and disbursed since

1 [his] the treasurer's last statement, showing the balance
2 remaining in [his] the accounts and the names of the collectors
3 having arrearages in taxes with the amounts thereof. [He] The
4 treasurer shall state [his] the accounts at the end of each
5 fiscal year, which statement shall be examined by the
6 commissioners and delivered by them to the auditors for
7 settlement.

8 Section 40. Section 1761 of the act is repealed:

9 [Section 1761. Moneys Paid for the Redemption of Unseated
10 Land Sold for Taxes.--The treasurer shall pay over to his
11 successor in office all moneys paid to him for the redemption of
12 unseated land sold for taxes, which have not been called for by
13 the purchasers at treasurer's sale or their legal
14 representatives during the continuance in office of such
15 treasurer. The county controller or auditor shall charge the
16 moneys so received to said treasurer, in the same manner that
17 other money received by him is charged, and the same shall be
18 paid to said purchasers, or their legal representatives when
19 called for, by orders drawn by the commissioners of the county
20 upon the treasurer as in other cases.]

21 Section 41. Sections 1762, 1770, 1770.1 and 1771 of the act
22 are amended to read:

23 Section 1762. Depositories.--(a) The county commissioners
24 together with the county treasurer shall, from time to time,
25 designate, by resolution, a depository or depositories for all
26 county funds to be deposited. Such depository or depositories
27 shall be banks, banking institutions or trust companies, located
28 in the Commonwealth.

29 (b) (1) Depositories so designated shall, upon receipt of
30 notice of their selection as a depository of county funds,

1 [furnish a bond to secure payment of deposits and any interest
2 to the county, secured by a surety company, or by the depositing
3 in escrow of securities to be approved by the county
4 commissioners. The parties may, by agreement, provide for
5 substitution of securities so held in escrow, the securities in
6 every case to be approved by the commissioners. Such bonds shall
7 be in a sum to be fixed by resolution of the county
8 commissioners.] collateralize deposits of public funds in
9 accordance with the act of August 6, 1971 (P.L.281, No.72),
10 entitled "An act standardizing the procedures for pledges of
11 assets to secure deposits of public funds with banking
12 institutions pursuant to other laws; establishing a standard
13 rule for the types, amounts and valuations of assets eligible to
14 be used as collateral for deposits of public funds; permitting
15 assets to be pledged against deposits on a pooled basis; and
16 authorizing the appointment of custodians to act as pledgees of
17 assets," which authorizes financial institutions to pledge
18 collateral in an account in the name of the county, or utilize a
19 letter of credit from the Federal Home Loan Bank, to secure
20 public deposits in excess of Federal Deposit Insurance
21 Corporation insurance limits. The depository shall provide a
22 monthly report within fifteen days after the end of each month
23 to the commissioners in accordance with the reporting
24 requirements in the act of August 6, 1971 (P.L.281, No.72),
25 including the composition of the collateral and related market
26 value.

27 (2) Counties may elect to require that any depositories must
28 pledge collateral in an account in the name of the county to
29 collateralize deposits above the Federal Deposit Insurance
30 Corporation limit. These accounts may be custodied with the

1 depository's trust department or at a third-party financial
2 institution. The arrangement with the depository may be governed
3 by a written agreement, approved by the board of directors or
4 loan committee of the depository, with approval reflected in the
5 minutes of the board or committee, which are kept continuously
6 as an official record of the depository and include the
7 following if collateral is pledged instead of a Federal Home
8 Loan Bank Letter of Credit:

9 (i) Collateral shall be marked to market daily.

10 (ii) Collateral shall be in investments as prescribed in the
11 investment program provided by the board of investment or board
12 of commissioners.

13 (iii) If the financial institution serves as the custodian,
14 the pledged collateral shall be held in a separate account,
15 established under the act of August 6, 1971 (P.L.281, No.72), in
16 the depository's trust department.

17 (iv) The market value of the pledged collateral shall be at
18 least one hundred and two per centum of the county deposits in
19 excess of federally insured limits.

20 (v) A monthly report shall be provided as specified in
21 paragraph (1).

22 (3) The depository shall not be required to [furnish a bond
23 or deposit securities in escrow to] secure payment of deposits
24 and interest insured by the Federal Deposit Insurance
25 Corporation.

26 (c) The county treasurer shall, upon the designation of such
27 depository or depositories, immediately, transfer thereto all
28 county funds to be deposited, and shall, thereafter, keep such
29 deposits solely in such depository or depositories in the name
30 of the county. Withdrawals from such depository shall be only

1 drawn by the treasurer, upon properly authorized checks or by
2 other commercially accepted methods of electronic funds transfer
3 which have been specifically approved by the board of
4 commissioners.

5 (d) Neither county commissioners nor treasurer complying
6 with the provisions of this [section] article, nor their surety
7 or sureties, shall be chargeable with losses of county funds
8 caused by the failure or negligence of such depository or
9 depositories.

10 Section 1770. Tax Levies.--(a) No tax shall be levied on
11 personal property taxable for county purposes where the rate of
12 taxation thereon is fixed by law other than at the rate so
13 fixed. The county commissioners shall fix, by resolution, the
14 rate of taxation for each year.

15 (a.1) The tax levied in counties of the second class A shall
16 be for the purpose of creating a general fund to pay expenses
17 incurred for general county purposes, for the payment of the
18 matters connected with roads under section 2707, for the payment
19 of the matters connected with parks and related matters under
20 section 2507. No tax for general county purposes in any county
21 of the second class A shall in any one year exceed the rate of
22 forty mills on every dollar of the adjusted valuation. The rate
23 of taxation for payment of interest and principal on any
24 indebtedness incurred pursuant to 53 Pa.C.S. Pt. VII Subpt. B
25 (relating to indebtedness and borrowing), or any prior or
26 subsequent act governing the incurrence of indebtedness of the
27 county shall be unlimited. In fixing the rate of taxation, the
28 county commissioners if the rate is fixed in mills, shall also
29 include in the resolution a statement expressing the rate of
30 taxation in dollars and cents on each one hundred dollars of

1 assessed valuation of taxable property.

2 (a.2) The county commissioners in counties of the second
3 class A shall have the power to levy a tax for institution
4 district purposes and for the payment of the obligations of the
5 predecessor poor districts on real estate, trades, occupations
6 and professions, in the same manner and at the same time as
7 county taxes, annual taxes to pay the current expense of the
8 institution district, none of which shall exceed fifteen mills
9 on the dollar of the last adjusted assessed valuation for county
10 purposes. No tax shall be levied and collected on trades,
11 occupations and professions at the same time a per capita tax on
12 individuals is levied and collected.

13 (b) No tax for general county purposes in [counties] a
14 county of the third, fourth, fifth, sixth, seventh [and] or
15 eighth [classes] class, exclusive of the requirements for the
16 payment of rentals to any municipal authority, shall in any one
17 year exceed the rate of twenty-five mills on every dollar of the
18 adjusted valuation, unless the county commissioners by majority
19 action shall, upon due cause shown by resolution, petition the
20 court of common pleas, in which case the court may order a rate
21 of not more than five mills additional to be levied: Provided,
22 however, That the rate of taxation for payment of interest and
23 principal on any indebtedness incurred [pursuant to the act of
24 July 12, 1972 (P.L.781, No.185), known as the "Local Government
25 Unit Debt Act,"] under 53 Pa.C.S. Pt. VII Subpt. B or any prior
26 or subsequent act governing the incurrence of indebtedness of
27 the county shall be unlimited. Tax for payment of rentals to any
28 municipal authority shall not exceed the rate of ten mills on
29 every dollar of the adjusted valuation and shall be in addition
30 to the twenty-five mill limitation for general county purposes.

1 In fixing the rate of taxation, the county commissioners, if the
2 rate is fixed in mills, shall also include in the resolution a
3 statement expressing the rate of taxation in dollars and cents
4 on each one hundred dollars of assessed valuation of taxable
5 property.

6 (c) In a county of the fourth, fifth, sixth, seventh or
7 eighth class:

8 (1) The rate of taxation fixed for any occupation tax levied
9 by a county [of the fourth, fifth, sixth, seventh or eighth
10 class] shall not in any one year exceed twenty mills. The county
11 commissioners may, by resolution, abolish the levy and
12 collection of occupation taxes for county purposes.

13 (2) The county commissioners [of counties of the fourth,
14 fifth, sixth, seventh and eighth classes] may levy and collect
15 an annual per capita tax on persons for county purposes.

16 (3) Any county [of the fourth, fifth, sixth, seventh or
17 eighth class] which shall become a county of the third class may
18 collect for a period of four years after such status has been
19 certified a per capita tax from any person not in any one year
20 to exceed a total of five dollars (\$5) for county purposes.

21 (d) In a county of the third, fourth, fifth, sixth, seventh
22 or eighth class:

23 (1) No tax shall be levied and collected for county purposes
24 on offices and posts of profits, or on professions, trades and
25 occupations at the same time during which a per capita tax on
26 persons is levied and collected for county purposes.

27 (2) Any per capita taxes levied upon and collected from any
28 person shall not in any one year exceed a total of five dollars
29 (\$5) for county and institution district purposes.

30 (3) Any county may, by ordinance or resolution, exempt any

1 person whose total income from all sources is less than [ten
2 thousand dollars (\$10,000)] the dollar amount per annum as
3 provided in section 301.1(b) of the act of December 31, 1965
4 (P.L.1257, No.511), known as The Local Tax Enabling Act, from
5 any per capita tax levied under this act.

6 Section 1770.1. Additions and Revisions to Duplicates.--
7 Whenever in any county there is any construction of a building
8 or buildings not otherwise exempt as a dwelling after January
9 first of any year, and such building is not included in the tax
10 duplicate of the county, the authority responsible for
11 assessments in the county shall, upon the request of the board
12 of county commissioners, cause to be inspected and reassessed,
13 subject to the right of appeal and adjustment provided by the
14 act of Assembly under which assessments are made, all taxable
15 property in the county to which major improvements have been
16 made after January first, and to give notice of such
17 reassessments [within ten days] in accordance with 53 Pa.C.S. §
18 8841(c) (relating to assessment roll and interim revisions) to
19 the authority responsible for assessments, the county
20 commissioners and the property owner. Such property shall then
21 be added to the duplicate and shall be taxable for county
22 purposes at the reassessed valuation for that proportionate part
23 of the fiscal year of the county remaining after the property
24 was improved. Any improvement made during the month shall be
25 computed as having been made on the first of the month. A
26 certified copy of the additions or revisions to the duplicate
27 shall be furnished by the board of county commissioners to the
28 proper tax collector for the county and, within ten days
29 thereafter, the tax collector shall notify the owner of the
30 property of the taxes due the county.

1 Whenever an assessment is made for a portion of a year as
2 above provided, the same shall be added to the duplicate of the
3 following or succeeding year unless the value of the
4 improvements has already been included in said duplicate.

5 Section 1771. Temporary Loans.--Whenever the funds of a
6 county have been exhausted, the county commissioners may
7 borrow[, on the credit of the county,] money in anticipation of
8 taxes to be collected for the current fiscal year[, and issue a
9 certificate of indebtedness] in accordance with 53 Pa.C.S. Pt.
10 VII, Subpt. B (relating to indebtedness and borrowing), payable
11 on a certain date, not exceeding [one year from the date of
12 issue] the last day of the fiscal year in which the tax
13 anticipation note is issued.

14 Section 42. The act is amended by adding sections to read:

15 Section 1773. Supplemental Appropriations, Transfers of
16 Funds and Appropriation Limits.--(a) The commissioners may:

17 (1) At any time, by resolution, make supplemental
18 appropriations for any lawful purpose from any funds on hand or
19 estimated to be received within the fiscal year and not
20 otherwise appropriated, including the proceeds of any borrowing
21 now or hereafter authorized by law.

22 (2) Authorize the transfer of:

23 (i) Any unencumbered balance of any appropriation item or
24 any portion thereof.

25 (ii) Within the same fund, any unencumbered balance or any
26 portion thereof from one spending agency to another.

27 (3) During the last fifteen days of a fiscal year, authorize
28 the transfer of any unencumbered balance, or any portion
29 thereof, from any county fund to any fund of the institution
30 district, and to reappropriate that money to the institution

1 district.

2 (b) No work shall be hired to be done, no materials
3 purchased, no contracts made and no order issued for the payment
4 of any money by the county commissioners which will cause the
5 sums appropriated to be exceeded.

6 Section 1774. Banks Authorized to Receive Taxes in Counties
7 of the Second Class A.--The county commissioners together with
8 the county treasurer and the county controller in second class A
9 counties shall have authority to designate any bank, savings
10 bank, bank and trust company, trust company or national banking
11 association located within the county as a deputy county tax
12 collector, for the sole purpose of receiving and receipting for
13 county taxes paid to the deputy county tax collector at the
14 collector's place of business. The county tax collector shall
15 not be held responsible for losses occasioned by the failure of
16 any institution, for money received by it as a deputy. Each
17 institution acting as a deputy county tax collector shall,
18 within five days after the last day of each calendar month,
19 transmit to the county tax collector all money received by it as
20 the deputy during the preceding month. Each payment shall be

3 Section 43. Section 1780 of the act is amended to read:

4 Section 1780. Fiscal Year and [Passage of Budgets]
5 Preparation of Proposed Annual Budget.--(a) The fiscal year of
6 each county shall begin on the first day of January and end on
7 the thirty-first day of December of each year.

8 (a.1) The commissioners, at least ninety days prior to
9 adopting the budget, shall begin the preparation of the proposed
10 budget for the succeeding fiscal year. The budget may be
11 prepared based upon information collected and transmitted by the
12 controller, as under subsection (b), or by the commissioners, a
13 finance department or a designated person employed, and
14 qualified, by the commissioners.

15 (b) At the request of the commissioners, but in no case less
16 than sixty days prior to adoption of the budget by the
17 commissioners, the controller shall prepare and transmit to the
18 commissioners:

19 (1) A comparative statement of revenues for the current and
20 the immediately preceding fiscal year, and a comparative
21 statement of expenditures, including interest due and to fall
22 due on all lawful interest bearing debts of the county for the
23 same years. In counties where the controller is a participant in
24 the development of the budget, the controller shall also include
25 balances projected for the close of the current fiscal year.

26 (2) The amounts of all appropriation requests, submitted to
27 the controller or to the commissioners and supplied by them to
28 the controller, from the several county offices and agencies,
29 including estimates of expenditures contemplated by the
30 commissioners as forwarded by them to the controller.

1 (c) The information requested by the commissioners in
2 accordance with subsection (a.1) or (b) shall be in form and
3 detail as the commissioners direct upon the form or forms
4 furnished, as under this subdivision, by the Department of
5 Community and Economic Development. With this information as a
6 guide, the commissioners shall, within a reasonable time, begin
7 the preparation of a proposed budget for the succeeding fiscal
8 year.

9 Section 44. Section 1781 of the act is repealed:

10 [Section 1781. Preparation of Proposed Annual Budget.--(a)

11 The commissioners, at least ninety days prior to adopting the
12 budget, shall begin the preparation of the proposed budget for
13 the succeeding fiscal year.

14 (b) At the request of the commissioners, but in no case less
15 than sixty days prior to adoption of the budget by the
16 commissioners, the controller shall transmit to the
17 commissioners a comparative statement of revenues for the
18 current and the immediately preceding fiscal year, and a
19 comparative statement of expenditures, including interest due
20 and to fall due on all lawful interest bearing debts of the
21 county for the same years. In counties where the controller is a
22 participant in the development of the budget, the controller
23 shall also include balances projected for the close of the
24 current fiscal year.

25 (c) The controller's statement shall also indicate the
26 amounts of all appropriation requests, submitted to the
27 controller or to the commissioners and supplied by them to the
28 controller, from the several county offices and agencies,
29 including estimates of expenditures contemplated by the
30 commissioners as forwarded by them to the controller.

1 (d) Said statements shall be in such form and detail as the
2 commissioners direct. With this information as a guide, the
3 commissioners shall, within a reasonable time, begin the
4 preparation of a proposed budget for the succeeding fiscal year.

5 (e) In counties not having a controller, the commissioners
6 shall prepare the statements hereinbefore required.]

7 Section 45. Sections 1782, 1782.1 and 1782.2 of the act are
8 amended to read:

9 Section 1782. Adoption of Budget; Publication of Proposed
10 Budget and Notice of Final Action Date.--(a) The proposed
11 budget shall be prepared and adopted [not later than December
12 thirty-first, and notice thereof shall be published, and the
13 proposed budget shall be made available for public inspection
14 for at least twenty days prior to the date set for adopting the
15 budget. The date set for final action on the budget shall
16 likewise be made a matter of public notice for at least ten days
17 prior thereto.] as follows:

18 (1) The public shall be given notice by publication in one
19 newspaper at least twenty days before the date set for the
20 adoption of the budget that the budget is available for public
21 inspection. The notice shall contain the date set for the
22 adoption of the budget and the manner in which the proposed
23 budget has been made available for public inspection.

24 (2) The budget shall be adopted on or before December 31.

25 (b) [Should it appear upon] If any revision of the proposed
26 budget[,] is made after it has been published, such that the
27 estimated expenditures in the adopted budget would be increased
28 more than ten per centum in the aggregate [or more than twenty-
29 five per centum in any function] over the proposed budget as
30 made available for public inspection, such revised budget shall

1 not be adopted with any such increases therein, unless it be
2 again made available for public inspection, and for protest of
3 such increases, for a period of at least ten days after notice
4 to that effect is published as hereinbefore provided.

5 Section 1782.1. Amending Budget; Notice.--During the month
6 of January next following any municipal election the
7 commissioners [of any county] may amend the budget and the levy
8 and tax rate to conform with its amended budget. [A period of
9 ten days' public inspection at the office of the chief clerk of
10 the proposed amended budget, after notice by the chief clerk to
11 that effect is published once in a newspaper as provided in
12 section 110 of this act, shall intervene between the proposed
13 amended budget and the adoption thereof.] The county shall
14 provide public notice by publication in one newspaper that an

29 together with their warrant for the collection of the same at
30 least fifteen days prior to the date of the tax bill.

1 (b) Notwithstanding the provisions of subsection (a), the
2 [county] commissioners shall have the option to make out and
3 deliver the duplicates of taxes assessed to the respective tax
4 collectors together with their warrant for collection of the
5 same no later than the final date for a school district to make
6 out and deliver the duplicates for school real estate taxes
7 under section 682 of the act of March 10, 1949 (P.L.30, No.14),
8 known as the "Public School Code of 1949." The option authorized

10 commissioners find that exercise of the option will result in

14 Section 46. Section 1784 of the act is repealed:

15 [Section 1784. Supplemental Appropriations; Transfers of
16 Funds; Appropriation Limits.--The commissioners may at any time,
17 by resolution, make supplemental appropriations for any lawful
18 purpose from any funds on hand or estimated to be received
19 within the fiscal year and not otherwise appropriated, including
20 the proceeds of any borrowing now or hereafter authorized by
21 law. The commissioners may authorize the transfer of any
22 unencumbered balance of any appropriation item or any portion
23 thereof. During the last fifteen days of any fiscal year, they
24 may authorize the transfer of any unencumbered balance, or any
25 portion thereof, from any county fund to any fund of the
26 institution district, and to reappropriate such moneys to the
27 institution district. No work shall be hired to be done, no
28 materials purchased, no contracts made, and no order issued for
29 the payment of any moneys by the county commissioners, which
30 will cause the sums appropriated to be exceeded.]

1 Section 47. Sections 1784.1, 1784.3, 1785(a), (c) and (e)
2 and 1790 of the act are amended to read:

3 Section 1784.1. Take Money and Property by Gift, Etc.--The
4 [county] commissioners may take by gift, grant, devise or
5 bequest any money or property, real, personal or mixed, for the
6 benefit of the county.

7 Section 1784.3. Operating Reserve Fund.--(a) The county
8 commissioners shall have the power to create and maintain a
9 separate operating reserve fund in order to minimize future
10 revenue shortfalls and deficits, provide greater continuity and
11 predictability in the funding of vital government services,
12 minimize the need to increase taxes to balance the budget in
13 times of fiscal distress, provide the capacity to undertake
14 long-range financial planning and develop fiscal resources to
15 meet long-term needs.

16 (b) The county commissioners may annually make
17 appropriations from the general county fund to the operating
18 reserve fund, but no appropriation shall be made to the

9 (d) The operating reserve fund shall be invested, reinvested
10 and administered in a manner consistent with the provisions of
11 section 1706.

12 Section 1785. Committee to Prepare Uniform Forms.--(a) The
13 report forms specified in the foregoing sections of this article
14 shall be prepared by a committee consisting of three
15 representatives from the County Commissioners Association of
16 Pennsylvania, three representatives from the Pennsylvania State
17 Association of County Controllers, three representatives from
18 the Pennsylvania State Association of County Auditors, one
19 certified public accountant, one member of the Senate and one
20 member of the House of Representatives of the General Assembly,
21 who shall be members of the Local Government Commission,
22 designated by the chairman of said commission, and the Secretary
23 of Community and Economic Development or [his] the secretary's
24 agent who shall be a person trained in the field of municipal
25 finance.

27 (c) The committee shall meet at the call of the Secretary of
28 Community and Economic Development or [his] the secretary's
29 agent, who shall serve as chairman of the committee. The
30 Secretary of Community and Economic Development may call

1 meetings of the committee, and shall do so at the request of the
2 secretary of either of said associations, but in every case
3 there shall be at least two weeks' notice to each member of the
4 committee of any such meeting.

5 * * *

6 (e) It shall be the duty of the Secretary of Community and
7 Economic Development or [his] the secretary's agent to see to it
8 that the forms required by this section are prepared in
9 cooperation with said committee. Should said committee for any
10 reason fail to furnish such cooperation, the Secretary of
11 Community and Economic Development or [his] the secretary's
12 agent shall complete the preparation of the forms. After their
13 preparation, [he] the secretary shall issue said forms and
14 distribute them annually, as needed, to the commissioners,
15 controller or auditors of each county.

17 Section 1790. Membership.--In each county there [shall] may
18 be a sinking fund commission, composed of the commissioners, the
19 controller, or auditors in counties not having a controller, and
20 treasurer.

21 Section 48. The act is amended by adding a section to read:

22 Section 1800. Contracting.--The commissioners may make
23 contracts for lawful purposes and for the purposes of carrying
24 into execution the provisions of this article and the laws of
25 this Commonwealth.

26 Section 49. Sections 1801, 1802, 1803, 1805, 1806 and 1807
27 of the act are amended to read:

28 Section 1801. Commissioners Sole Contractors for County
29 Generally.--(a) [The county] In counties of the third, fourth,
30 fifth, sixth, seventh or eighth class, the commissioners shall

1 contract for and purchase all services referred to in section
2 [five hundred eight] 508 and personal property for county
3 officers and agencies. All contracts and purchases not in excess
4 of the base amount of eighteen thousand five hundred dollars
5 (\$18,500), subject to adjustment under subsection (b.1), shall
6 be by note or memorandum, in writing, signed by the [county]
7 commissioners, or their designee. A copy of all [such] notes and
8 memorandums and all executed written contracts, or electronic
9 copies of executed written contracts, shall be filed in the
10 office of the controller, if any, and, if not, then with the
11 chief clerk of the commissioners.

12 (b) [Written] Except as otherwise provided in section
13 1802(h)(4), in the case of counties in the third, fourth, fifth,
14 sixth, seventh or eighth class, written or telephonic price
15 quotations from at least three qualified and responsible
16 contractors shall be requested for all contracts in excess of
17 the base amount of ten thousand dollars (\$10,000), subject to
18 adjustment under subsection (b.1), but are less than the amount
19 requiring advertisement and competitive bidding or, in lieu of
20 price quotations, a memorandum shall be kept on file showing
21 that fewer than three qualified contractors exist in the market
22 area within which it is practicable to obtain quotations. A
23 written record of telephonic price quotations shall be made and
24 shall contain at least the date of the quotation, the name of
25 the contractor and the contractor's representative, the
26 construction, reconstruction, repair, maintenance or work which
27 was the subject of the quotation and the price. Written price
28 quotations, written records of telephonic price quotations and
29 memoranda shall be retained for a period of three years.

30 (b.1) Adjustments to the base amounts specified under

1 subsections (a) and (b) shall be made as follows:

2 (1) The Department of Labor and Industry shall determine the
3 percentage change in the Consumer Price Index for All Urban
4 Consumers: All Items (CPI-U) for the United States City Average
5 as published by the United States Department of Labor, Bureau of
6 Labor Statistics, for the twelve-month period ending September
7 30, 2012, and for each successive twelve-month period
8 thereafter.

9 (2) If the department determines that there is no positive
10 percentage change, then no adjustment to the base amounts shall
11 occur for the relevant time period provided for in this
12 subsection.

13 (3) (i) If the department determines that there is a
14 positive percentage change in the first year that the
15 determination is made under paragraph (1), the positive
16 percentage change shall be multiplied by each base amount, and
17 the products shall be added to the base amounts, respectively,
18 and the sums shall be preliminary adjusted amounts.

19 (ii) The preliminary adjusted amounts shall be rounded to
20 the nearest one hundred dollars (\$100) to determine the final
21 adjusted base amounts for purposes of subsections (a) and (b).

22 (4) In each successive year in which there is a positive
23 percentage change in the CPI-U for the United States City
24 Average, the positive percentage change shall be multiplied by
25 the most recent preliminary adjusted amounts, and the products
26 shall be added to the preliminary adjusted amount of the prior
27 year to calculate the preliminary adjusted amounts for the
28 current year. The sums thereof shall be rounded to the nearest
29 one hundred dollars (\$100) to determine the new final adjusted
30 base amounts for purposes of subsections (a) and (b).

1 (5) The determinations and adjustments required under this
2 subsection shall be made in the period between October 1 and
3 November 15 of the year following the effective date of this
4 subsection and annually between October 1 and November 15 of
5 each year thereafter.

6 (6) The final adjusted base amounts and new final adjusted
7 base amounts obtained under paragraphs (3) and (4) shall become
8 effective January 1 for the calendar year following the year in
9 which the determination required under paragraph (1) is made.

10 (7) The department shall publish notice in the Pennsylvania
11 Bulletin prior to January 1 of each calendar year of the annual
12 percentage change determined under paragraph (1) and the
13 unadjusted or final adjusted base amounts determined under
14 paragraphs (3) and (4) at which competitive bidding is required
15 under subsection (a) and written or telephonic price quotations
16 are required under subsection (b), respectively, for the
17 calendar year beginning the first day of January after
18 publication of the notice. The notice shall include a written
19 and illustrative explanation of the calculations performed by
20 the department in establishing the unadjusted or final adjusted
21 base amounts under this subsection for the ensuing calendar
22 year.

23 (8) The annual increase in the preliminary adjusted base
24 amounts obtained under paragraphs (3) and (4) shall not exceed
25 three per centum.

26 (c) The commissioners shall, where possible, anticipate the
27 needs of the various officers, agencies and operations of the
28 county and endeavor to purchase in wholesale quantities, where
29 practicable and where savings could be achieved thereby. The
30 commissioners may make contracts and purchases for all purposes

1 expressly or impliedly authorized by law.

2 Section 1802. Contract Procedures; Terms and Bonds;
3 Advertising for Bids.--(a) All contracts for services and
4 personal property where the base amount thereof exceeds the sum
5 of eighteen thousand five hundred dollars (\$18,500), subject to
6 adjustment under section 1801(b.1), shall be written and shall,
7 except as otherwise hereinafter specified, be made by
8 advertising for bids.

9 (b) Contracts or purchases in excess of the base amount of
10 eighteen thousand five hundred dollars (\$18,500), subject to
11 adjustment under section 1801(b.1), except those [hereinafter
12 mentioned] specified in subsection (h) and except as provided by
13 the act of October 27, 1979 (P.L.241, No.78), entitled "An act
14 authorizing political subdivisions, municipality authorities and
15 transportation authorities to enter into contracts for the
16 purchase of goods and the sale of real and personal property
17 where no bids are received," shall not be made except with and
18 from the lowest responsible and responsive bidder submitting a
19 bid in conformity with the specifications approved by the board
20 of commissioners for the contract or purchase, after due notice
21 in one newspaper of general circulation, published or
22 circulating in the county, at least two times at intervals of
23 not less than three days where daily newspapers of general
24 circulation are employed for such publication, or in case weekly
25 newspapers are employed then the notice shall be published once
26 a week for two successive weeks. The first advertisement shall
27 be published not less than ten days prior to the date fixed for
28 the opening of bids. The requirements of this subsection need
29 not be followed in cases of emergency, but in such cases the
30 actual emergency shall be declared and stated by resolution of

1 the commissioners.

2 (c) All bids shall be received by the controller, or, in the
3 case of a county of the third, fourth, fifth, sixth, seventh or
4 eighth class, if there be no controller, then by the chief clerk
5 of the [county] commissioners, in sealed envelopes. [Bids]

6 (1) In the case of a county of the second class A, bids
7 shall be opened publicly at a time and place to be designated in
8 the advertisement for bids. All the figures shall be announced
9 publicly by the chief clerk or the chief clerk's designee and
10 referred to the appropriate departments for tabulation without
11 the presence of the commissioners.

12 (2) In the case of a county of the third, fourth, fifth,
13 sixth, seventh or eighth class, bids shall be opened publicly at
14 a time and place specified in the advertisement for bids, in the
15 presence of the controller, or chief clerk as the case may be,
16 by the commissioners or their designee. The controller, or the
17 chief clerk as the case may be, shall keep a record of all such
18 bids [and awards, and the controller shall certify no checks for
19 contracts not made agreeably thereto].

20 (d) The amount or price of the contract shall, in all cases
21 whether of straight sale price, conditional sale, lease, lease
22 purchase or otherwise, be the entire amount which the county
23 pays to the successful bidder, or his assigns, less the value of
24 personal property transferred from the county to the bidder, or
25 his assigns, at any time during the duration of the contract, in
26 order to obtain the services or property, or both, and shall not
27 be construed to mean only the amount which is paid to acquire
28 title, or to receive any other particular benefit or benefits of
29 the whole bargain. The value of personal property transferred to
30 the bidder or his assigns upon execution of the contract shall

1 be specified in the bid. The method of determining the value of
2 personal property transferred to the bidder or his assigns at a
3 time during the duration of the contract shall be specified in
4 the bid and shall be determined using generally accepted
5 valuation methods.

6 (e) The acceptance of bids by advertising required herein
7 shall be made by the [commissioners] controller, in the case of
8 a county of the second class A, or by the commissioners, in the
9 case of a county of the third, fourth, fifth, sixth, seventh or
10 eighth class, and shall only be made by public announcement at
11 the meeting at which bids are opened, or at a subsequent
12 meeting, the time and place of which shall be publicly announced
13 when bids are so opened. If for any reason the award is not made
14 at either of the above meetings, the same business may be
15 transacted at any subsequent meeting, the time and place of
16 which shall have been announced at the previous meeting held for
17 such award. The contract shall be awarded, or all bids shall be
18 rejected, within thirty days of the opening of the bids, except
19 for bids subject to 62 Pa.C.S. (relating to procurement).
20 Thirty-day extensions of the date for the award may be made by
21 the mutual written consent of the commissioners and any bidder
22 who wishes to remain under consideration for award. The
23 commissioners shall excuse from consideration any bidder not
24 wishing to agree to a request for extension of the date for the
25 award and shall release such bidder from any bid bond or similar
26 bid security furnished under subsection (f). All contracts shall
27 be filed with the controller, or with the chief clerk as the
28 case may be, immediately after their execution.

29 (f) The commissioners may require, as a necessary condition
30 of considering a bid, that any bids advertised be accompanied by

1 [cash, by a certified check,] a cashier's check[, bank good
2 faith check] or other irrevocable letter of credit in a
3 reasonable amount drawn upon a bank authorized to do business in
4 this Commonwealth or by a bond with corporate surety in a
5 reasonable amount. [Whenever it is required that a bid be
6 accompanied by cash, certified check, cashier's check, bank good
7 faith check or other irrevocable letter of credit or bond, no
8 bid shall be considered unless so accompanied.] In the event any
9 bidder shall, upon award of the contract to [him] the bidder,
10 fail to comply with the requirements [hereinafter stated] of
11 subsection (g) as to security guaranteeing the performance of
12 the contract, the security furnished under this subsection shall
13 be forfeited to the county as liquidated damages.

14 (g) [The] Whenever a formal bid is required by this article,
15 the successful bidder[, when a formal bid is required herein,]
16 may be required to furnish a bond or irrevocable letter of
17 credit or other security in an amount sufficient to the
18 commissioners guaranteeing performance of the contract within
19 thirty days after the contract has been awarded, unless the
20 commissioners shall prescribe a shorter period. The successful
21 bidder for a contract which involves the construction, erection,
22 installation, completion, alteration, repair of or addition to
23 any public work or improvement of any kind shall furnish
24 security as provided in section 2318 of this act. Performance
25 security for services and contracts for labor and materials
26 delivered on a periodic basis, including, but not limited to,
27 food service contracts, home health services and janitorial
28 services and supplies, may be computed on the expected average
29 value for one or more months at the discretion of the
30 commissioners. Upon failure to furnish such security within the

1 time fixed, the previous awards shall be void. Deliveries,
2 performances and guarantees may be required in all cases of
3 expenditures, including the exceptions [herein] as under
4 subsection (h).

5 (h) The contracts or purchases made by the commissioners
6 which shall not require advertising, bidding or price
7 quotations, as hereinbefore provided, are as follows:

8 (1) Those for maintenance, repairs or replacements for
9 water, electric light, or other public works of the county where
10 they do not constitute new additions, extensions or enlargements
11 of existing facilities and equipment. Security may be required
12 by the commissioners as in other cases for work done.

13 (2) Those made for improvements, repairs and maintenance of
14 any kind, made or provided by the county through its own
15 employes. This shall not apply to construction materials used in
16 a street improvement.

17 (3) Those where particular types, models or pieces of new
18 equipment, articles, apparatus, appliances, vehicles or parts
19 thereof, are desired by the commissioners, which are patented
20 and manufactured or copyrighted products.

21 (4) Those involving any policies of insurance or surety
22 company bonds, those made for public utility service and
23 electricity, natural gas or telecommunication services, provided
24 that, in the case of utilities not under tariff with the
25 Pennsylvania Public Utility Commission, contracts made without
26 advertising and bidding shall be made only after receiving
27 written or telephonic price quotations in accordance with the
28 procedures specified in section 1801(b) of this article.

29 (5) Those involving services of members of the medical or
30 legal profession, registered architects, engineers, certified

1 public accountants or other personal services involving
2 professional expertise.

3 (6) Those involving contracts entered into by nonprofit
4 cooperative hospital service associations for hospitals and
5 nursing homes which are part of the institutional district or
6 which are owned by the county, operated by the county or
7 affiliated with the county by the purchasing of, or
8 participating in contracts for, materials, supplies and
9 equipment.

10 (6.1) Those involving tangible client services provided by
11 nonprofit agencies. For the purposes of this clause, the term
12 "tangible client services" shall mean congregate meals, home-
13 delivered meals, transportation or chore services provided
14 through area agencies on aging.

15 (7) Those made with any public body, including, but not
16 limited to, the sale, lease or loan of any supplies or materials
17 to the county by a public body, provided that the price thereof
18 shall not be in excess of that fixed by the public body. The
19 requirements of 53 Pa.C.S. Ch. 23 Subch. A (relating to
20 intergovernmental cooperation) shall not apply when a county
21 purchases cooperatively with another public body which has
22 entered into a contract for supplies or materials. As used in
23 this paragraph, "public body" shall mean any of the following:

- 24 (i) the Federal Government;
- 25 (ii) the Commonwealth of Pennsylvania;
- 26 (iii) any other state;
- 27 (iv) a political subdivision, local or municipal authority,
28 council of government, entity created in accordance with 53
29 Pa.C.S. Ch. 23 Subch. A (relating to intergovernmental
30 cooperation) or other similar local entity of the Commonwealth

1 or any other state; or

2 (v) an agency of the Federal Government, the Commonwealth or
3 any other state.

4 (7.1) In the case of counties of the second class A, those
5 involving the purchase of milk.

6 (8) Those exclusively involving construction management
7 services.

8 (9) Those involving computer software.

9 (i) Notwithstanding the provisions of this article to the
10 contrary, the [county] commissioners shall have authority to
11 enter into contracts for equipment and services related to
12 technology and information systems on the basis of best value
13 procurement. Contracts under best value procurement shall be
14 made only after the county has solicited proposals based on
15 performance and outcome specifications developed by the county
16 and describing at minimum the objectives to be met by the
17 system, the tasks to be performed by the system, the users of
18 the system, system security issues, the time frame for system
19 implementation, potential operating technologies, compatibility
20 with existing systems, training and maintenance and shall
21 indicate the process by which the contract shall be awarded.
22 Best value procurement shall not require a sealed bid process
23 and shall permit the commissioners to negotiate the terms of the
24 agreement with any responsive and responsible vendor.

25 (j) Every contract subject to this article shall comply, as
26 applicable, with the provisions of [the]:

27 (1) The act of August 15, 1961 (P.L.987, No.442), known as
28 the "Pennsylvania Prevailing Wage Act."

29 (2) The act of December 20, 1967 (P.L.869, No.385), known as
30 the "Public Works Contractors' Bond Law of 1967."

1 (3) The act of January 23, 1974 (P.L.9, No.4), referred to
2 as the Public Contract Bid Withdrawal Law.

3 (4) The act of March 3, 1978 (P.L.6, No.3), known as the
4 "Steel Products Procurement Act[," the act of October 28, 1983
5 (P.L.176, No.45), known as the "Antibid-Rigging Act," the act of
6 December 20, 1967 (P.L.869, No.385), known as the "Public Works
7 Contractors' Bond Law of 1967," the act of August 15, 1961
8 (P.L.987, No.442), known as the "Pennsylvania Prevailing Wage
9 Act," the act of November 26, 1978 (P.L.1309, No.317), known as
10 the "Public Works Contract Regulation Law," the act of February
11 17, 1994 (P.L.73, No.7), known as the "Contractor and
12 Subcontractor Payment Act," the act of January 23, 1974 (P.L.9,
13 No.4), referred to as the Public Contract Bid Withdrawal Law,
14 and the act of April 4, 1984 (P.L.193, No.40), known as the
15 "Motor Vehicle Procurement Act]."

16 (5) The act of February 17, 1994 (P.L.73, No.7), known as
17 the "Contractor and Subcontractor Payment Act."

18 (6) 62 Pa.C.S. Chs. 37 Subch. B. (relating to motor
19 vehicles), 39 (relating to contracts for public works) and 45
20 (relating to antibid-rigging).

21 (k) No person, consultant, firm or corporation contracting
22 with a county for purposes of rendering personal or professional
23 services to the county shall share with any county officer or
24 employe and no county officer or employe shall accept, any
25 portion of the compensation or fees paid by the county for the
26 contracted services provided to the county except under the
27 following terms or conditions:

28 (1) Full disclosure of all relevant information regarding
29 the sharing of the compensation or fees shall be made to the
30 board of commissioners.

1 (2) The board of commissioners must approve the sharing of
2 any fee or compensation for personal or professional services
3 prior to the performance of said services.

4 (3) No fee or compensation for personal or professional
5 services may be shared except for work actually performed.

6 (4) No shared fee or compensation for personal or
7 professional services may be paid at a rate in excess of that
8 commensurate for similar personal or professional services.

9 Section 1803. Evasion of Advertising Requirements.--(a) No
10 commissioner or commissioners shall evade the provisions of
11 section one thousand eight hundred two of this act, as to
12 advertising for bids or purchasing or contracting for services
13 and personal properties piece-meal, for the purpose of obtaining
14 prices under the base amount of eighteen thousand five hundred
15 dollars (\$18,500), subject to adjustment under section
16 1801(b.1), upon transactions which should in the exercise of
17 reasonable discretion and prudence be conducted as one
18 transaction amounting to more than the base amount of eighteen
19 thousand five hundred dollars (\$18,500), subject to adjustment
20 under section 1801(b.1). This provision is intended to make
21 unlawful the practice of evading advertising requirements by
22 making a series of purchases or contracts each for less than the
23 advertising requirement price, or by making several simultaneous
24 purchases or contracts each below said price, when in either
25 case the transaction involved should have been made as one
26 transaction for one price. Any [county commissioners]
27 commissioner who so [vote] votes in violation of this provision
28 and who know that the transaction upon which they so vote is or
29 ought to be a part of a larger transaction and that it is being
30 divided in order to evade the requirements as to advertising for

1 bids shall be, jointly and severally, subject to surcharge for
2 any loss sustained. Wherever it shall appear that a commissioner
3 may have voted in violation of this section, but the purchase or
4 contract on which he so voted was not approved by the board of
5 [county] commissioners, this section shall be inapplicable.

6 (b) Any [county] commissioner who votes to unlawfully evade
7 the provisions of section [one thousand eight hundred two] 1802
8 of this act and who knows that the transaction upon which he so
9 votes is or ought to be a part of a larger transaction and that
10 it is being divided in order to evade the requirements as to
11 advertising for bids commits a misdemeanor of the third degree
12 for each contract entered into as a direct result of that vote.
13 This penalty shall be in addition to any surcharge which may be
14 assessed pursuant to subsection (a).

15 Section 1805. Sales of Personal Property and Surplus Farm
16 Products.--(a) No personal property [of the county] and no
17 surplus farm products [of counties of the fourth, fifth, sixth,
18 seventh or eighth classes] of the county shall be disposed of by
19 sale or otherwise, except upon resolution of the commissioners.
20 When the commissioners approve a sale of such property or [in
21 counties of the fourth, fifth, sixth, seventh or eighth classes
22 of] farm products, they shall estimate the sale value of the
23 entire lot to be disposed of, and, if the estimate be less than
24 [one thousand dollars (\$1,000)] two thousand dollars (\$2,000),
25 they shall require notice of the proposed sale to be posted, for
26 at least ten days, in a prominent place in the court house,
27 describing and itemizing the property to be sold, and directing
28 that bids may be made thereon at the office of the chief clerk
29 of the commissioners. Thereafter, the commissioners may sell
30 such property in whole or in part for the best price or prices

1 obtainable.

2 (b) If the commissioners estimate the sale value of the
3 personal property or of such surplus farm products to be sold at
4 [one thousand dollars (\$1,000)] two thousand dollars (\$2,000) or
5 more, the entire lot shall be advertised for sale, once, in at
6 least one newspaper of general circulation in the county, and
7 sale of the property so advertised shall be made to the highest
8 and best bidder. The bids shall not be opened until at least ten
9 days after the said advertisement. The commissioners may sell
10 any such property at auction, but the provisions as to notice
11 contained in this section shall be likewise observed as to the
12 holding of auction sales. The provisions of this section shall
13 not be mandatory where county property is to be traded-in or
14 exchanged for new personal property. The provisions of this
15 section shall not apply to sale of personal property with real
16 property as a single unit pursuant to section 2306.1.

17 (c) A public auction of personal property may be conducted
18 by means of an online or electronic auction sale. During an
19 electronic auction sale, bids shall be accepted electronically
20 at the time and in the manner designated in the advertisement.
21 During the electronic auction, each bidder shall have the
22 capability to view the bidder's bid rank or the high bid price.
23 Bidders may increase bid prices during the electronic auction.
24 The record of the electronic auction shall be accessible for
25 public inspection. The purchase price shall be paid by the high
26 bidder immediately or at a reasonable time after the conclusion
27 of the electronic auction as determined by the commissioners. In
28 the event that shipping costs are incurred, the shipping costs
29 shall be paid by the high bidder. A county that has complied
30 with the advertising requirements of this section may provide

1 additional public notice of the sale by bids or public auction
2 in any manner deemed appropriate by the commissioners. The
3 advertisement for electronic auction sales authorized in this
4 subsection shall include the publicly accessible Internet
5 website or means of accessing the electronic auction and the
6 date, time and duration of the electronic auction.

7 Section 1806. County Officers Not to Be Interested in
8 Contracts, Generally.--[Restrictions] (a) Except as provided in
9 subsection (b), restrictions on the involvement of elected and
10 appointed county officers in any county contract shall be as
11 prescribed in 65 Pa.C.S. Ch. 11 (relating to ethics standards
12 and financial disclosure)[.], and subject to the limitations and
13 procedures under section 1802(k).

14 (b) Notwithstanding subsection (a), the following shall
15 apply:

16 (1) It shall be unlawful for any architect or engineer, in
17 the employ of any county of the second class A, and engaged in
18 the preparation of plans, specifications or estimates, to bid or
19 negotiate on any public work at any letting of work by the
20 county, except that an architect or engineer who shall have
21 prepared preliminary plans only shall not be prohibited from
22 bidding or negotiating on the final contract for the work.

23 (2) It shall be unlawful for the officers of any county of
24 the second class A charged with the duty of letting any public
25 work, to award a contract to an architect or engineer, in the
26 employ of the county who is in any way interested in a contract
27 for public work for the county or for any architect or engineer
28 to receive any remuneration or gratuity from any person
29 interested in the contract except under the terms and conditions
30 as provided in section 1802(k).

1 (3) Any person violating any of the provisions of paragraph
2 (1) or (2) shall be guilty of a misdemeanor in office, and upon
3 conviction, shall forfeit the office and be sentenced to pay a
4 fine not exceeding five hundred dollars (\$500), or to undergo
5 imprisonment for not more than six months, or both.

6 Section 1807. Application of Contract Provisions.--The
7 provisions of this article shall apply to all the contractual
8 powers of the [county] commissioners contained in this act, or
9 other laws insofar as they are not inconsistent therewith, and
10 the mention of powers of contract outside this article shall not
11 be construed as being in disregard of the applicable provisions
12 of this article in relation thereto.

13 Section 50. The act is amended by adding sections to read:

14 Section 1807.1. Printing Contracts in Certain Counties.--In
15 counties of the second class A, the commissioners may, by proper
16 resolution, require that printing firms presenting bids for
17 county printing shall establish consideration as responsible
18 bidders by requiring:

19 (1) That the printing firms shall file, with the chief clerk
20 of the commissioners, a sworn statement to the effect that
21 employees, in the employ of the firm or firms which are to
22 produce the printing, are receiving the prevailing wage rate and
23 are working under conditions prevalent in the locality in which
24 the work is produced.

25 (2) That whenever a collective bargaining agreement shall be
26 in effect between an employer and employees who are represented
27 by a responsible organization which is in no way influenced or
28 controlled by the management, the agreement and the provisions
29 of the agreement shall be considered as conditions prevalent in
30 the locality and shall be the minimum requirements for being

1 adjudged a responsible bidder under this act.

2 (3) That in case any dispute arises as to what is the
3 prevailing rate of wages for work applicable to the contract,
4 which cannot be adjusted by the commissioners, the matter shall
5 be referred to the county salary board and the board's decision
6 shall be conclusive.

7 (4) The words "prevailing wage rate," as used in this
8 section, shall be construed to mean at least the minimum wages
9 which are received by employes of any printing firm or firms, in
10 second class A counties, as a result of collective bargaining
11 agreements negotiated by an employer or employers with a
12 responsible organization representing the employes. If the wage
13 rates, so arrived at, vary in any district in a county, then any
14 printing firm which pays wages at least equal to those provided
15 for in any of such agreements, shall, for the purposes of this
16 act, be deemed to be paying the prevailing wage rate.

17 Section 1807.2. Certain Contract Provisions Prohibited.--No
18 political subdivision or authority in a county of the second
19 class A may enter into any contract related to a redevelopment
20 capital assistance project as provided under section 318 of the
21 act of February 9, 1999 (P.L.1, No.1), known as the "Capital
22 Facilities Debt Enabling Act," which contains a provision
23 requiring that a specified percentage of a contracting party's
24 work force be residents of a specific municipality.

25 Section 51. Subdivisions (a), (b) and (c) of Article XIX of
26 the act are repealed:

27 [(a) Appropriations for Military Purposes

28 Section 1901. Appropriation of Money or Land for National
29 Guard Armories.--(a) The board of commissioners may, either
30 independently or in connection with any other county, or with

1 any city, town, borough, or township, provide and appropriate
2 moneys, or convey land to the Commonwealth of Pennsylvania, to
3 assist the Armory Board of the State of Pennsylvania in the
4 erection, wherever deemed most advantageous by the Armory Board,
5 of armories for the use of the National Guard of Pennsylvania.
6 The board of commissioners may acquire land for such purpose,
7 either by purchase, at tax sale, by gift, by the right of
8 eminent domain, or otherwise.

9 (b) The board of commissioners may also furnish water,
10 light, or fuel, either or all free of cost to the Commonwealth
11 of Pennsylvania, for use in any armory of the National Guard and
12 may do all things necessary to accomplish such purpose.

13 Section 1902. Appropriation for Maintenance of National
14 Guard.--(a) The board of commissioners may appropriate,
15 annually, from any moneys in the county treasury, not otherwise
16 appropriated, a sum not exceeding seven hundred and fifty
17 dollars (\$750) for the support and maintenance, discipline and
18 training, of any dismounted company or similar unit of the
19 National Guard, and a sum not to exceed fifteen hundred dollars
20 (\$1500) for the support and maintenance, discipline and
21 training, of any mounted or motorized troop or similar unit of
22 the National Guard. Where such units are organized as a
23 battalion, regiment or similar organization, the total amount
24 due may be paid to the commanding officer of the battalion,
25 regiment or similar organization.

26 (b) Any moneys so appropriated shall be paid by voucher
27 check of the commissioners, drawn to the order of the commanding
28 officer of such company, battalion, regiment or similar
29 organization, only when it shall be certified to the
30 commissioners by the Adjutant General of the State that such

1 unit or units have satisfactorily passed the annual inspection
2 provided by law. The moneys so appropriated shall be used and
3 expended solely and exclusively for the support and maintenance,
4 discipline and training, of the said company, battalion,
5 regiment or similar organization, and the commanding officer
6 shall account, by proper vouchers to the said county each year,
7 for the expenditure of the money so appropriated, and no
8 appropriation shall be made for any subsequent year, until the
9 expenditure of the previous year is duly and satisfactorily
10 accounted for.

11 (c) The accounts of such expenditures shall be subject to
12 the inspection of the Department of Military Affairs, and shall
13 be audited by the auditors, or the controller as the case may
14 be, in the manner provided by law for the audit of accounts of
15 county moneys.

16 Section 1903. Appropriation to Rifle-Clubs in Time of War.--

17 (a) At any time a state of war exists, the board of
18 commissioners may appropriate money to civilian rifle clubs,
19 duly chartered by the National Rifle Association of the United
20 States of America, for the maintenance and rental of rifle-
21 ranges, the employment of competent instructors and necessary
22 employes, and for the equipment and uniforms for the members of
23 such clubs, who volunteer for special military duty in their
24 respective counties, or answer any call of the Governor of the
25 Commonwealth.

26 (b) No moneys shall be appropriated to any such club, unless
27 practice on such rifle-range by the members of the club shall be
28 with the United States Military rifle or arms approved by the
29 State Adjutant General.

30 (b) Burial of Deceased Service Persons

1 and Surviving Spouses

2 Section 1908. Definitions.--(a) The term deceased service
3 person, as used in this subsection, shall mean and include:

4 (1) Any deceased person who, at the time of his or her
5 death, was serving (whether or not in a combat zone) in the
6 Army, Navy, Air Force, Marine Corps, Coast Guard, or any women's
7 organization officially connected therewith, during any war or
8 armed conflict in which the United States has been, is now or
9 shall hereafter be engaged, or who, at the time of his or her
10 death, was serving in a zone where a campaign or state or
11 condition of war or armed conflict then existed, in which the
12 United States was, is or shall be a participant. The existence
13 of a campaign or state or condition of war or armed conflict,
14 and the participation of the United States therein, as well as
15 the fact that the deceased person served in a zone where such
16 campaign or state or condition of war or armed conflict existed,
17 shall, in each case, be established by the records of the
18 Department of Defense of the Federal Government; or

19 (2) Any deceased person, who had so served at any time
20 during his or her life, and whose separation from such service
21 was honorable, whether by discharge or otherwise, or who at the
22 time of his or her death was continuing in such service after
23 the cessation of the war, armed conflict, campaign or state or
24 condition of war during or in which he or she served; or

25 (3) Any deceased person who was in active service in the
26 militia of the State of Pennsylvania under and in pursuance of
27 any proclamation issued by the Governor during the Civil War,
28 who was not duly mustered into the service of the United States,
29 but was honorably discharged or relieved from such service.

30 (b) The term "legal residence" as used in this subsection,

1 shall be construed as synonymous with "domicile" and is hereby
2 defined as actual residence, coupled with intention that it
3 shall be permanent, or a residence presently fixed with no
4 definite intention of changing it, or of returning to a former
5 residence at some future period. Legal residence is to be
6 determined by abode of person and his or her intention to
7 abandon his or her former domicile and establish a new one. The
8 legal residence of a deceased service person shall be prima
9 facia in the county where he or she made his or her abode at the
10 time of his or her death.

11 Section 1909. Funeral Expenses of Deceased Service
12 Persons.--(a) Any county is hereby authorized and directed to
13 contribute the sum of seventy-five dollars (\$75) and may
14 contribute an additional sum of twenty-five dollars (\$25)
15 towards the funeral expenses of each deceased service person in
16 the cases enumerated below, where in each case application
17 therefor is made within one year after the date of his or her
18 death. In the case of any deceased service person who died while
19 in the service, application need not be made within one year
20 after the date of his or her death, but may be made at any time
21 thereafter.

22 (b) Payments shall be made under the following
23 circumstances:

24 (1) Where the deceased service person at the time of his or
25 her death had his or her legal residence in the county, whether
26 or not he or she died in the county, and whether or not he or
27 she was buried in the county. It is hereby declared to be the
28 intent of the General Assembly that every deceased service
29 person having a legal residence in this Commonwealth at the time
30 of his or her death shall be entitled to the benefits of this

1 section, regardless of where he or she may have died or where he
2 or she may be buried, and that the liability therefor shall be
3 on the county, where the deceased service person shall have had
4 his or her legal residence at the time of his or her death.

5 (2) Where the deceased service person died and was buried in
6 the county, but at the time of his or her death did not have
7 legal residence within this Commonwealth, if the county
8 commissioners of the county where he or she died are notified in
9 writing by any organization of veterans that the body is
10 unclaimed by relatives or friends, and upon investigation shall
11 find such condition to exist.

12 (3) Where a deceased service person has died while a member
13 of the Pennsylvania Soldiers' and Sailors' Home at Erie,
14 Pennsylvania, and such home incurs all funeral expenses and
15 buries the soldier in a cemetery in the City of Erie,
16 Pennsylvania, or the home furnishes clothing, casket and
17 shipping case, and ships the body to the county from which he
18 was admitted to the home, the county from which he was admitted
19 shall reimburse and pay to the Pennsylvania Soldiers' and
20 Sailors' Home the amount of seventy-five dollars (\$75) or so
21 much thereof as was actually expended by the home.

22 Section 1910. Burial of Spouses of Deceased Service
23 Persons.--Upon due application and proof, the county is hereby
24 authorized and directed to contribute the sum of seventy-five
25 dollars (\$75) and may contribute an additional sum of twenty-
26 five dollars (\$25) from the county funds towards the funeral
27 expenses of any spouse of any deceased service person, who at
28 the time of his or her death had a legal residence in the
29 county, whether or not he or she died in the county and whether
30 or not he or she was buried in the county. The county shall not

1 contribute any moneys toward the funeral expenses of any spouse
2 of a deceased service person who had remarried after the death
3 of such deceased service person, nor unless application for the
4 payment of such moneys shall be made within one year after the
5 date of the death of such spouse.

6 Section 1911. Payment.--(a) It shall be the duty of the
7 county to cause a voucher check to be drawn upon the treasury of
8 their county in the sum of seventy-five dollars (\$75), or one
9 hundred dollars (\$100) if the additional sum of twenty-five
10 dollars (\$25) is authorized, for each body buried in accordance
11 with the provisions of this subdivision, to be paid out of the
12 funds of the county, and such checks shall be made payable to
13 the applicant or applicants if the application shows that the
14 funeral expenses have been paid, otherwise to the undertaker
15 performing the services with notice to the applicant.

16 (b) Application for such contribution shall be made by the
17 personal representative of such deceased service person or
18 deceased service person's spouse, if there be such personal
19 representative, and if no such personal representative has
20 qualified then by any next of kin, individual, or veterans'
21 organization, who or which assumes responsibility for the cost
22 of burial of the body. The application shall be sustained by
23 affidavit as to the facts.

24 (c) The application shall be on forms prescribed by the
25 Department of Military Affairs and shall set forth whether or
26 not the funeral expenses have been paid. The application shall
27 have attached thereto a certified copy of the death certificate
28 and a certification by the undertaker, who had charge of the
29 burial of the body, and to the effect that the undertaker did
30 render such service.

1 Section 1912. Notification of County Commissioners.--The
2 coroners and all other public officers, agents and servants and
3 all officers, agents and servants of any county, city, township,
4 borough, district or other municipality, or of any prison,
5 morgue, hospital, home or other public institution, having the
6 control or custody of the body of the deceased service person
7 whose body is entitled to be buried under the provisions of this
8 subdivision, shall, immediately upon the death or arrival of the
9 body of such deceased service person, notify the county
10 commissioners of the county wherein such death occurred, or
11 wherein such deceased service person shall have had his legal
12 residence.

13 Section 1913. Markers for Graves; Headstones.--(a) The
14 county commissioners of each county shall, from time to time as
15 they consider expedient, procure appropriate markers for the
16 graves of deceased service persons and the graves of all other
17 deceased persons who served in the Army, Navy, Air Force, Marine
18 Corps, Coast Guard, Merchant Marine during World War II or any
19 organization officially connected therewith and whose separation
20 from such service was honorable, whether by discharge or
21 otherwise. Such markers shall be of cast bronze, aluminum or a
22 suitable substitute material.

23 (b) The county commissioners shall procure bronze, aluminum
24 or suitable substitute material markers from some manufacturer
25 or manufacturers, engaged in the manufacturing of the same, and
26 in the contract for the furnishing thereof, the manufacturer
27 furnishing the bronze markers shall warrant that the same are
28 made of the following metals, and in the following proportions:
29 copper, eighty-five per centum; tin, five per centum; zinc, five
30 per centum; and lead, five per centum.

1 (c) The manufacturer shall be liable to the county to an
2 amount equal to the sum paid to him by the county for the
3 markers, if the above proportions of metals are not contained in
4 the markers.

5 (d) Nothing, except actual fraud on the part of the county
6 commissioners, shall render them liable for any amount if it is
7 established that the markers are not composed of the metals in
8 the proportions above recited.

9 (e) No officer, trustee, association, corporation or person
10 in control of any cemetery, or a public burying ground, shall
11 have the right to question the composition of such bronze
12 markers, or to require that any of them be chemically analyzed
13 before being placed in the cemetery, or under any circumstances
14 to refuse to permit the erection thereof in the cemetery, or
15 public burying ground, or to charge for making the foundations
16 for the same more than is charged for making similar foundations
17 of the same proportion. Any person who violates any of the
18 provisions of this subsection shall, upon conviction thereof in
19 a summary proceeding, be sentenced to pay a fine of not less
20 than ten dollars (\$10) nor more than one hundred dollars (\$100)
21 for each offense.

22 (f) The county commissioners of each county are hereby
23 authorized and directed to place a marker upon the grave of each
24 deceased service person and the graves of all other deceased
25 persons who served in the Army, Navy, Air Force, Marine Corps,
26 Coast Guard, Merchant Marine during World War II or any
27 organization officially connected therewith and whose separation
28 from such service was honorable, whether by discharge or
29 otherwise, who, at the time of his or her death, had his or her
30 legal residence in the county, whether or not he or she died in

1 the county, and whether or not he or she was buried in the
2 county, and upon the grave of each deceased service person
3 buried in the county, who at the time of his or her death did
4 not have a legal residence within this Commonwealth. When such
5 deceased service person shall have been a veteran of any war or
6 campaign for which the Government of the United States issued
7 discharge buttons, the markers designated for their graves shall
8 include a facsimile of said discharge button. When such markers
9 are upright flag holders they shall consist of cast bronze or
10 any other weather resistant material. When such deceased service
11 person shall have been a veteran of the Korean Conflict, the
12 markers designated for their graves shall include a circular
13 emblem with the words "Korea, U.S., 1950-1953" in the border
14 thereof, and shall incorporate the insignia of the Army, Navy,
15 Marine Corps, Air Force, and Coast Guard, in the form approved
16 by the State Veterans' Commission.

17 (g) It shall be the duty of the county commissioners of each
18 county, upon or at any time subsequent to the death of any
19 deceased service person and the graves of all other deceased
20 persons who served in the Army, Navy, Air Force, Marine Corps,
21 Coast Guard, Merchant Marine during World War II or any
22 organization officially connected therewith and whose separation
23 from such service was honorable, whether by discharge or
24 otherwise, who, at the time of his or her death, had his or her
25 legal residence in the county, on application as hereinafter
26 provided, to cause a headstone or bronze memorial tablet to be
27 placed at the head of or on the grave of each such deceased
28 service person.

29 (h) Each headstone shall contain his or her name and the
30 rank and organization to which he or she belonged or in which he

1 or she served, in letters raised or cut in at least three-
2 sixteenth of an inch deep. The headstone shall be of either
3 marble or granite, and shall be placed or set in a concrete base
4 at least three feet deep, or if a headstone has been provided
5 for such grave by the United States Government, the county
6 commissioners shall provide the concrete base therefor, or if
7 lettering only on an existing memorial is desired by the family,
8 the county commissioners shall provide such lettering.

9 (i) In the event the body of any deceased service person
10 either cannot or will not be returned to the United States of
11 America, it shall be the duty of the county commissioners to
12 cause a headstone to be placed in the family plot of such
13 deceased service person. Said headstone shall have inscribed
14 thereon, (1) the name, rank and organization of such deceased
15 service person, (2) the name of the country, location or manner
16 in which such person lost his or her life, and (3) the cemetery
17 or location in which the body, if buried, was finally laid to
18 rest. Application therefor shall in each case be made on forms
19 prescribed by the Department of Military Affairs and may be made
20 by any relative of the deceased service person, or by a friend
21 if there is no objection by the nearest relative. Each
22 application must be approved by an organization of veterans of
23 any war in which the United States has been, is now or shall
24 hereafter be engaged.

25 (j) The expense in each case shall be borne by the county in
26 which the deceased service person had his or her legal residence
27 at the time of his or her death, whether or not he or she died
28 in the county, and whether or not he or she was buried in the
29 county. The expense shall not exceed the sum of one hundred
30 dollars (\$100) for each headstone or concrete base or lettering

1 or bronze memorial tablet and the county commissioners of each
2 county, acting under this section, shall cause to be drawn a
3 voucher check on the treasury of the county for the payment of
4 said expense in favor of the party or parties furnishing such
5 headstone or concrete base or lettering or bronze memorial
6 tablet.

7 (k) In cases of dispute concerning the legal residence of a
8 deceased service person, the county in which a deceased service
9 person is buried shall perform the duties hereinbefore set
10 forth. No such payment or payments shall be made, unless the
11 application therefor shall be approved before the commencement
12 of the project by the county commissioners.

13 (l) Any person who shall wilfully, maliciously, or
14 carelessly destroy, mutilate, remove or deface any grave marker,
15 headstone or flag holder, placed or erected under the provisions
16 of this section, shall be guilty of the grade of offense in
17 relation to the dollar amount of the theft or damage done in
18 accordance with 18 Pa.C.S. § 3903 (relating to grading of theft
19 offenses).

20 Section 1914. Burial Plots.--The county commissioners of the
21 several counties are hereby authorized to purchase plots of
22 ground, in any cemetery or burial ground in their respective
23 counties, for the interment of deceased service persons whose
24 bodies are entitled to be buried under the provisions of this
25 subdivision, and to cause to be drawn a voucher check upon their
26 county treasury for the payment of the same. The purchase price
27 of said plots of ground shall not be charged against or allotted
28 as part of the cost of burial of such deceased service persons
29 who may be buried in any of said plots under the provisions of
30 this subdivision.

1 Section 1915. Care of Graves and Markers.--The county
2 commissioners of each county shall, at all times, see that the
3 graves and tombstones of all deceased service persons who are
4 buried in such county, receive proper and fitting care, and may
5 employ all necessary assistants to carry out the provisions of
6 this section. The expense of the care of such graves and
7 tombstones shall be borne by the county where said graves are
8 located, except where suitable care is otherwise provided. Money
9 so appropriated may be expended directly by the county
10 commissioners, or paid over to the person, firm, association or
11 corporation owning or controlling any cemetery or burial place
12 in the county where any such grave is situated. The sum so paid
13 over in any year shall not exceed for each grave the charge for
14 the annual care and maintenance of like graves in the same
15 cemetery, or, if no such fixed charge is established in that
16 cemetery, it shall not exceed the sum charged in other
17 cemeteries in the same county for like service.

18 Section 1916. Proof of Service, Et Cetera.--(a) In each
19 case, where application is made for a contribution toward the
20 funeral expenses of a deceased service person, or the surviving
21 spouse of a deceased service person, or for a headstone or
22 concrete base or lettering or bronze memorial tablet, the county
23 commissioners shall, before expending any money therefor,
24 require proof of the following facts:

25 (1) The service of the deceased service person which
26 entitles him or his surviving spouse to the benefits of this
27 subdivision. Such proof shall be by the production of an
28 honorable discharge or other official record showing service
29 during any war in which the United States is or was engaged, or
30 by the records of the Department of Defense of the Federal

1 Government, or by copies thereof filed in the Department of
2 Military Affairs showing the existence of a campaign or state or
3 condition of war, the participation of the United States
4 therein, and the service of the deceased service person in a
5 zone where such campaign or state or condition of war existed.

6 (2) The death of the deceased service person.

7 (3) In the case of the burial of the surviving spouse of a
8 deceased service person, the death of such surviving spouse, and
9 the fact that the spouse was married to the deceased service
10 person at the time of his death, and that the spouse has not
11 since remarried. The proof required by clauses one and two of
12 this subsection shall also be required in such cases.

13 (4) Except in cases where persons not having a legal
14 residence within this Commonwealth are entitled to any of the
15 benefits of this subdivision, the legal residence within the
16 county of the deceased service person, or of the surviving
17 spouse of a deceased service person, as the case may be.

18 (b) Death shall in all cases be proved by death certificate
19 where the same is procurable, otherwise by affidavit of one or
20 more persons personally acquainted with the deceased, and the
21 fact of his or her death, or by proof of the record of death
22 kept by the attending physician, or by proof of the record of
23 burial kept by the undertaker by whom he or she was buried, or
24 by the church burial association or cemetery company maintaining
25 the graveyard, burial ground or cemetery in which he or she was
26 buried.

27 (c) Where any proof required by this subdivision has been
28 furnished to the county commissioners, no further proof of the
29 same facts shall be required in order to obtain any other
30 benefit under the provisions of this subdivision.

1 (c) Memorial Observances

2 Section 1921. Appropriations to Veterans' Organizations for
3 Expenses of Memorial Day, Veterans' Day, Flag Day and
4 Independence Day.--(a) The board of commissioners may
5 appropriate, annually, to each camp of the United Spanish War
6 Veterans, and to each post of the American Legion, and to each
7 post of the Veterans of Foreign Wars, and to each post of the
8 Veterans of World War I of the U. S. A., Inc., and to each post
9 of the American War Veterans of World War II (AMVETS), and to
10 each post of the Society of the Twenty-eighth Division, AEF,
11 Incorporated, and to each post of the Italian American War
12 Veterans of the United States, Incorporated, and to each
13 detachment of the Marine Corps League, and to each Naval
14 Association, and to each post of the Grand Army of the Republic,
15 and to each post of the Disabled American Veterans of the World
16 War, and to each organization of American Gold Star Mothers, and
17 to each organization of ex-service persons incorporated under
18 the act of April twenty-nine, one thousand eight hundred
19 seventy-four (Pamphlet Laws 73), and the supplements thereto, in
20 the county, any sum budgeted to aid in defraying the expenses of
21 Memorial Day, Veterans' Day, Flag Day and Independence Day.

22 (b) Where the Grand Army of the Republic has ceased to exist
23 or to function, such appropriation may be made to the Sons of
24 Union Veterans of the Civil War or, in the absence of such
25 order, to a duly constituted organization which conducts the
26 decorating of graves of Union Veterans of the Civil War.

27 (c) Such payments shall be made to defray actual expenses
28 only. Before any payment is made, the organization receiving the
29 same shall submit verified accounts of their expenditures.

30 Section 1922. Flags to Decorate Graves.--(a) It shall be

1 the duty of the county commissioners to provide flags on each
2 Memorial Day with which to decorate the graves of all deceased
3 service persons and the graves of all other deceased persons who
4 served in the Army, Navy, Air Force, Marine Corps, Coast Guard,
5 Merchant Marine during World War II or any organization
6 officially connected therewith and whose separation from such
7 service was honorable, whether by discharge or otherwise, buried
8 within the county. The flags to be used for such purposes shall
9 be of one standard size, colorfast and American made, and shall
10 be purchased at the expense of the county from moneys in the
11 county treasury.

12 (b) Such flags shall be furnished to the various veterans'
13 organizations in such numbers as they shall require for their
14 respective communities.

15 (c) The moneys expended by any county under the provisions
16 of this section shall be in addition to moneys appropriated by
17 counties for Memorial Day purposes.

18 (d) The authorities in charge of any cemetery are authorized
19 to remove such flags when the same become unsightly or
20 weatherworn at any time not before the first working day after
21 Independence Day of each year.

22 (e) Any authority or person in charge of any cemetery who
23 shall remove or cause the removal of the flags prior to the
24 first working day after Independence Day shall be guilty of a
25 summary offense and, upon conviction thereof, shall be sentenced
26 to pay a fine in the amount of three hundred dollars (\$300) and,
27 upon failure to pay such fine, to undergo imprisonment not to
28 exceed ninety days.

29 Section 1923. Compilation of War Records; Director of
30 Veterans' Affairs.--(a) The county commissioners of each county

1 are hereby authorized and directed, at the expense of the
2 county, to compile a record of the burial places within such
3 county of deceased service persons. Such record, so far as
4 practicable, shall indicate the name of each such person, the
5 service in which he or she was engaged, the number of the
6 regiment or company or command, the rank and period of service,
7 the name and location of the cemetery or other place in which
8 his or her body is interred, the location of the grave in such
9 cemetery or other place, and the character of headstone or other
10 marker, if any, at such grave. Such record shall be known as the
11 Veterans' Grave Registration Record
12 of County, and shall be a public
13 record, open to inspection during business hours.

14 (b) The county commissioners of each county shall cause
15 record blanks to be prepared, according to forms prescribed by
16 the Department of Military Affairs, whereby the information
17 required for such record may be transmitted to them.

18 (c) Every person, firm, association, or corporation,
19 including a municipal corporation, owning or controlling any
20 cemetery or burial place within the Commonwealth, in which are
21 interred the bodies of deceased service persons, shall file with
22 the county commissioners of the county in which such cemetery is
23 located a certificate, on the record blanks provided by said
24 county commissioners, of the facts required for such record, as
25 far as the same are within the knowledge of such person, firm,
26 association, corporation, or the agents thereof.

27 (d) The county commissioners shall cause record blanks to be
28 distributed to such persons, firms, associations, and
29 corporations as they deem advisable, with the request that such
30 information be transmitted to them. Any such person, firm,

1 association or corporation, except municipal corporations, upon
2 receipt of such blanks or forms, who shall refuse or neglect to
3 fill out and transmit to the county commissioners such blanks or
4 forms within six months after receipt of same, upon conviction
5 thereof in a summary proceeding, shall be sentenced to pay a
6 fine of one hundred dollars (\$100).

7 (e) For the purpose of locating the burial places of persons
8 who have served in the military or naval service or other
9 branches of the combative forces of the United States during any
10 war or armed conflict in which the United States was engaged,
11 the Grand Army of the Republic, the United Spanish War Veterans,
12 the Veterans of Foreign Wars of the United States, the American
13 Legion, the Disabled American Veterans, the Veterans of World
14 War I of the U. S. A., Inc., the American Veterans of World War
15 II (AMVETS), the Marine Corps League, and the Italian American
16 War Veterans of the United States, Incorporated, through their
17 local camps, posts and branches in this Commonwealth, are
18 authorized, without expense to the county, to collect the
19 required data and prepare and file with the county commissioners
20 certificates embodying the information provided for in this
21 section.

22 (f) For the purpose of carrying into effect the provisions
23 of this section, the county commissioners shall appoint a
24 director of veterans affairs, who shall receive such
25 compensation as the salary board may fix.

26 (g) It shall also be the duty of the director of veterans
27 affairs to:

28 (1) Assist the county commissioners in administering the

30 deceased service persons and their surviving spouses and to

1 furnishing markers and placing headstones on their graves.

20 Nutrition and Community Development.--[The board of
21 commissioners may make appropriations annually for agricultural
22 and home economics extension work, in cooperation with the
23 Pennsylvania State University in encouraging improved methods of
24 farm management and home economics and giving practical
25 instruction and demonstrations in agriculture, for the purpose
26 of improving and developing the agricultural resources of the
27 county. An educational program will be conducted to include the
28 body of scientific knowledge in agriculture, family living, and
29 resource development and to encourage application of the same.]
30 The board of commissioners may make annual appropriations for

1 Cooperative Extension work, in cooperation with the Pennsylvania
2 State University, to support improved methods of agricultural
3 production and management, economic development, family and
4 youth programming and practical instruction and demonstrations,

6 help communities, businesses and people solve problems and

22 [State Colleges or] Pennsylvania State System of Higher
23 Education universities and State-related universities, including
24 the Pennsylvania State University, Lincoln University, Temple
25 University and the University of Pittsburgh, within such county
26 to assist the institution or trust in the financing of the
27 functions specified by the board of commissioners.

28 Section 1999b. Federal Health and Welfare Programs.--Any
29 county may, through the commissioners, enter into agreements
30 with the Federal government, or with any city, borough, town,

1 township, nonprofit corporation or association located or
2 carrying on its functions within such county or serving the
3 residents of such county and which city, borough, town,
4 township, nonprofit corporation or association has or is about
5 to contract with the Federal government or with any agency of
6 State government whereby the Federal government will provide a
7 portion of the funds necessary, payable either to the county or
8 State government or directly to the city, borough, town,
9 township, nonprofit corporation or association for any program
10 not in conflict with an existing or hereafter established state
11 program offered by the Federal government for the promotion of
12 the health or welfare of its citizens[, including but not
13 limited to the young, the poor and the aged,] and in the
14 furtherance of said programs may comply with conditions, rules
15 or regulations attached by the Federal or State governments.

16 The county may accept gifts or grants of money, property or
17 services from any source, public or private, and may appropriate
18 such funds as may be necessary to carry out said programs.

19 Section 1999c. Appropriations for Reservoirs and Water
20 Resources.--(a) The board of commissioners may borrow,
21 appropriate and expend money for the construction, acquisition
22 by purchase, lease or otherwise, operation and maintenance of
23 dams, reservoirs, wells and other facilities for the utilization
24 of surface, subsurface, and ground water resources and all
25 related structures, appurtenances and equipment necessary for
26 the use of said dams, reservoirs, wells and other facilities,
27 and may acquire by purchase, lease, gift, or the exercise of
28 power of eminent domain, sites for the same: Provided, That the
29 board of commissioners shall obtain a permit from the Department
30 of Environmental [Resources] Protection whenever such permit is

1 required by law: And provided further, That the board of
2 commissioners shall not acquire by the exercise of power of
3 eminent domain the property of a public utility subject to the
4 jurisdiction of Pennsylvania Public Utility Commission or
5 [Federal Power Commission] the Federal Energy Regulatory
6 Commission.

7 (b) The board of commissioners may enter into agreements for
8 the regulation of withdrawals and diversions of waters from said
9 dams, reservoirs, wells and other facilities, and the sale of
10 the same, subject to approval of State, Federal or interstate
11 agencies which may have primary jurisdiction over water
12 resources. Dams, wells and reservoirs acquired by purchase,
13 lease or otherwise, or constructed by the commissioners may be
14 for the sole purpose of water supply or in conjunction with any
15 other purposes, except the generation of electric energy.

16 (c) The board of commissioners may enter into contracts or
17 long-range cooperative programs with State, Federal, interstate
18 and local government agencies or public utilities for the
19 development and use of the county's water resources.

20 (d) It shall be lawful for any county to execute such
21 agreements and contracts as it may deem necessary or advisable
22 with an authority organized by such county to provide, design,
23 acquire, hold, construct, improve, own, lease, as lessor or
24 lessee, maintain and operate dams, reservoirs, wells and other
25 facilities for the utilization of surface, subsurface and ground
26 water resources and all related structures, appurtenances and
27 equipment necessary for the use of the same; also to grant,
28 convey, lease, transfer, encumber, mortgage and pledge to such
29 authority, its dams, reservoirs, wells and related facilities
30 and any improvements and additions thereto; to assign and pledge

1 to such authority rentals, rates and charges charged and
2 collected by it for the use thereof and to assign to such
3 authority its power to collect the same. No such agreement,
4 contract, grant, conveyance, lease, assignment, encumbrance,
5 mortgage or pledge shall be construed to prevent the affected
6 county from thereafter using its tax revenues for the purpose of
7 maintaining, repairing, altering, inspecting or improving such
8 dams, reservoirs, wells and related facilities.

9 [Every such agreement, contract, grant, conveyance, lease,
10 transfer, assignment, encumbrance, mortgage and pledge
11 heretofore made to or with any authority organized by any county
12 is hereby ratified, confirmed and made valid and the same shall
13 be and remain lawful, valid and enforceable according to its
14 terms.]

15 (e) Any county may enter into an agreement and contract for
16 the sale of water to any other [county, city, borough,
17 incorporated town, township] municipality, authority or public
18 utility at reasonable and uniform rates to be determined
19 exclusively by it.

20 Section 1999d. Tourist Promotion Agencies; Appropriations.--

21 (a) The board of commissioners of any county may create or may
22 join with other counties in the creation of a tourist promotion
23 agency, as defined under the act of July 4, 2008 (P.L.621,
24 No.50), known as the "Tourism Promotion Act," for the purpose of
25 making studies, surveys and investigations and for planning and
26 carrying out promotional programs and projects designed to
27 stimulate and increase the volume of tourist, visitor and
28 vacation business within such county or counties and may
29 appropriate funds for such purposes.

30 (b) The board of commissioners may appropriate annually such

1 amount of money as may be deemed necessary to any tourist
2 promotion agency, as defined under the "Tourism Promotion Act,"
3 to assist such agencies in carrying out tourism promotional
4 activities.

5 (x) Crime Detection Laboratory and Police Training School
6 in Counties of the Third Class

7 Section 1999f. Parking Facilities.--The board of
8 commissioners of any county may appropriate moneys from the
9 county treasury for the purpose of purchasing, constructing,
10 maintaining and operating as a county facility a motor vehicle
11 parking facility, or may create a municipal authority and
12 appropriate moneys to such authority for such purpose, and the
13 county commissioners, or the municipal authority created for
14 such purpose, may lease to any city, borough or township wherein
15 the parking facility is or shall be constructed, or to a parking
16 authority created by the city, borough or township, the land to
17 be used for a parking facility, or a parking facility, for the
18 use, benefit, health, safety and general welfare of the citizens
19 of the Commonwealth. [The county, at the discretion of the
20 commissioners, may establish or designate parking areas
21 exclusively reserved for parking by handicapped individuals and
22 may post signs indicating such restriction.]

23 (z) [Non-debt] Revenue Bonds for Industrial Development
24 Projects

25 Section 1999g. Issuance of [Non-Debt] Revenue Bonds for
26 Industrial Development Projects.--The board of commissioners of
27 any county is empowered to issue [non-debt] revenue bonds of the
28 county pursuant to provisions of [the act of June 25, 1941
29 (P.L.159). known as the "Municipal Borrowing Law," and its
30 amendments] 53 Pa.C.S. Pt. VII Subpt. B (relating to

1 indebtedness and borrowing), to provide sufficient moneys for
2 and toward the acquisition, construction, reconstruction,
3 extension, equipping or improvement of an industrial development
4 project or projects, consisting of any building or facility or
5 combination or part thereof occupied or utilized by an
6 industrial, manufacturing, or research and development
7 enterprise now existing or hereafter acquired, including any or
8 all buildings, improvements, additions, extensions,
9 replacements, appurtenances, lands, rights in land, water
10 rights, franchises, machinery, equipment, furnishings,
11 landscaping, utilities, railroad spurs and sidings, wharfs,
12 approaches and roadways necessary or desirable in connection
13 therewith or incidental thereto, said bonds to be secured solely
14 by the pledge of the whole or part of the fees, rents, tolls or
15 charges derived from the ownership or operation of such
16 facilities or for the use or services of the same.

17 Said industrial development project or projects financed by
18 the issuance of [non-debt] revenue bonds as in this section
19 provided may be leased by the county in whole or in part to a
20 lessee or lessees for a period of years equal in time to the
21 period of maturity of the bonds so issued.

22 Included in the cost of the issue may be any costs and
23 expenses incident to constructing and financing the facilities
24 and selling and distributing the bonds.

25 The board of commissioners [in] is further empowered to sell,
26 lease, lend, grant, convey, transfer or pay over to any
27 authority created pursuant to the [act of August 23, 1967 (Act
28 No. 102), known as the "Industrial Development Authority Law,"]
29 act of August 23, 1967 (P.L.251, No.102), known as the "Economic
30 Development Financing Law," with or without consideration, any

1 project or any part or parts thereof, or any interest in real or
2 personal property or any funds available for industrial
3 development purposes, including the proceeds of [non-debt]
4 revenue bonds hereafter issued pursuant hereto, for industrial
5 development purposes, and to assign, transfer and set over to
6 any such authority and contracts which may have been awarded for
7 the construction of projects not begun or, if begun, not
8 completed.

9 The board of commissioners [are] is further empowered to
10 enter into any and all contracts or agreements with any such
11 authority and/or with any tenant or proposed tenant of any
12 industrial development project and to do any or all things
13 necessary or proper to effectuate the public purpose of this
14 section.

15 Section 69. Article XIX of the act is amended by adding
16 subdivisions to read:

17 (z.3) Civil Service in Counties
18 of the Second Class A

19 Section 1999j. Civil Service for Certain Employes.--The
20 county commissioners in a county of the second class A are
21 hereby authorized to establish by ordinance a merit system for
22 the selection, tenure, promotion and discharge of employes
23 involved in any work for which the county receives or is
24 eligible to receive Federal or State grants-in-aid.

25 (z.4) Insuring County Against Loss or Liability

26 Section 1999k. Insurance.--(a) The commissioners may
27 provide for such insurance as they deem appropriate on the real
28 and personal property of the county, including, but not limited
29 to, all grounds, buildings and contents, vehicles and
30 information technology.

1 (b) In addition to any form of comprehensive, general or
2 umbrella liability insurance, the commissioners may acquire
3 insurance against any form of loss or liability, including
4 crime, fire, natural disaster, errors and omissions of officers
5 or employes, vehicle operation and use of information
6 technology.

7 (z.5) Lot and Block System in Counties
8 of the Second Class A

9 Section 1999l. Lot and Block System, Generally.--Any county
10 of the second class A which, upon the effective date of this
11 section, has adopted and maintains a lot and block system for
12 the registration of land titles, for the accumulation of county
13 tax liens and for the enumeration of the parcels of real estate
14 for the assessment of real estate taxes in one or more political
15 subdivisions of the county may continue to operate a lot and
16 block system until such time as the commissioners deem
17 appropriate.

18 Section 1999m. Duties of county officers and employees under
19 lot and block system.--(a) Where a lot and block system under
20 section 1999l remains in effect, the portion of the system
21 relating to the plats, plat books and the upkeep of the same
22 shall remain in the custody of the deed registry office of the
23 county. The portion of the system containing the files, cards,
24 indexes and other records relating to the liening of county
25 taxes shall remain in and be maintained by the office of the
26 controller of the county.

27 (b) (1) The district assessors appointed by the county
28 board of assessment appeals, whose assessments are being made
29 within the municipal subdivisions that have had the lot and
30 block system completed therein, shall use the lot and block

1 system descriptive numbers in their original books of
2 assessment.

3 (2) The board of assessment appeals shall, within municipal
4 subdivisions covered by lot and block system, correct any
5 assessment where the lot and block system descriptive number is
6 absent.

7 (3) The recorder of deeds shall receive for recording any
8 deed that refers to a specific parcel of real estate. If the
9 deed does not bear the certification by the custodian of the lot
10 and block system that the descriptive numbers incorporated in
11 the description of the real estate described therein are
12 correct, then, before transcribing any such deed lacking the
13 certification, the recorder of deeds shall obtain the same from
14 the custodian of the lot and block system.

15 (4) The treasurer or tax collector of each city, borough,
16 town, township or school district where the lot and block system
17 has been completed under the order of court shall place upon
18 each tax bill sent out, and upon each tax receipt issued upon
19 payment, the lot and block system descriptive numbers.

20 (5) The controller, in the case of the county, and the
21 treasurer, tax collector or solicitor, as the case may be, in
22 each city, borough, township or school district, within which
23 the lot and block system has been completed, shall, at the time
24 of filing liens for unpaid taxes with the prothonotary, set
25 forth on such liens the individual lot and block system
26 descriptive numbers, and the prothonotary shall not receive and
27 file such liens unless the descriptive numbers are contained
28 thereon.

29 (6) For the purposes of the sale of real estate for
30 delinquent taxes, either by the sheriff of the county or by the

1 commissioners and treasurer of the county, or by the treasurer
2 of any city, borough, town, township or school district, the lot
3 and block system descriptive numbers are hereby declared to be
4 sufficient description for the advertising preceding such sale,
5 for the oral description read at such sale prior to receiving
6 bids and for the purposes of the description to be inserted in
7 any tax deed to be given to the purchaser at such sale.

8 Section 70. The act is amended by adding an article to read:

9 ARTICLE XIX-A

10 MILITARY AND VETERANS AFFAIRS

11 (a) Appropriations for Military Purposes

12 Section 1901-A. Appropriation of money or land for National
13 Guard Armories.

14 (a) Conveyance of land.--The board of commissioners of a
15 county may convey land to the Commonwealth to assist the State
16 Armory Board in the erection of armories for the use of the
17 Pennsylvania National Guard. The board of commissioners may
18 acquire land for this purpose in a lawful manner.

19 (b) Board.--The board of commissioners may also furnish
20 water, light or fuel, free of cost to the Commonwealth, for use
21 in an armory of the National Guard and may do all things
22 necessary to accomplish this purpose.

23 Section 1902-A. Appropriation for maintenance of National
24 Guard.

25 (a) Support and maintenance.--The board of commissioners of
26 a county may make appropriations for the support, maintenance,
27 discipline and training of one or more units of the National
28 Guard. If units are organized as a battalion, regiment or
29 similar organization, the total amount due may be paid to the
30 commanding officer of the battalion, regiment or similar

1 organization.

2 (b) Requirements.--All money appropriated shall be paid to
3 the order of the commanding officer of the company, battalion,
4 regiment or similar organization only when it shall be certified
5 to the commissioners by the Adjutant General that the unit or
6 units have satisfactorily passed the annual inspection provided
7 by law. The money appropriated shall be used and expended solely
8 and exclusively for the support, maintenance, discipline and
9 training of the company, battalion, regiment or similar
10 organization, and the commanding officer shall account by proper
11 vouchers to the county each year for the expenditure of the
12 money appropriated. No appropriation shall be made for a
13 subsequent year until the expenditure of the previous year is
14 duly and satisfactorily accounted for.

15 (c) Inspection.--Accounts of expenditures shall be subject
16 to the inspection of the Department of Military and Veterans
17 Affairs and shall be audited by the auditors or the controller,
18 as the case may be, in the manner provided by law for the audit
19 of accounts of county money.

20 Section 1903-A. Appropriation to rifle clubs in time of war.

21 (a) Appropriation.--At any time a state of war exists, the
22 board of commissioners of a county may appropriate money to
23 civilian rifle clubs, duly chartered by the National Rifle
24 Association of America, for the maintenance and rental of rifle
25 ranges, the employment of competent instructors and necessary
26 employees and for the equipment and uniforms for the members of
27 clubs who volunteer for special military duty in their
28 respective counties or answer a call of the Governor.

29 (b) Restriction.--No money shall be appropriated to a club
30 unless practice on a rifle range by the members of the club is

1 with a United States military rifle or arms approved by the
2 Adjutant General.

3 (b) Interment of Deceased Servicepersons
4 and Surviving Spouses

5 Section 1908-A. Definitions.

6 As used in this subdivision, the following words and phrases
7 shall have the meanings given to them in this section unless the
8 context clearly indicates otherwise:

9 "Deceased serviceperson." The term includes:

10 (1) A deceased person who, at the time of death, was
11 serving, whether or not in a combat zone, in the Army, Navy,
12 Air Force, Marine Corps, Coast Guard or a women's
13 organization officially connected to those forces, during a
14 war or armed conflict in which the United States has been, is
15 now or shall be engaged, or who, at the time of death, was
16 serving in a zone where a campaign or state or condition of
17 war or armed conflict then existed, in which the United
18 States was, is or shall be a participant. The existence of a
19 campaign or state or condition of war or armed conflict, and
20 the participation of the United States in the conflict as
21 well as the fact that the deceased person served in a zone
22 where a campaign or state or condition of war or armed
23 conflict existed shall, in each case, be established by the
24 records of the Department of Defense of the Federal
25 Government.

26 (2) A deceased person who had served at any time during
27 the person's life and whose separation from service was
28 honorable, whether by discharge or otherwise, or who, at the
29 time of death, was continuing in service after the cessation
30 of the war, armed conflict, campaign or state or condition of

1 war during or in which the person served.

2 (3) A deceased person who was in active service in the
3 militia of the Commonwealth under a proclamation issued by
4 the Governor during the Civil War and who was not duly
5 mustered into the service of the United States but was
6 honorably discharged or relieved from service.

7 "Legal residence." An actual residence, coupled with
8 intention that it shall be permanent, or a residence presently
9 fixed with no definite intention of changing it or of returning
10 to a former residence at some future period. Legal residence is
11 to be determined by abode of a person and the person's intention
12 to abandon a former domicile and establish a new one. The legal
13 residence of a deceased serviceperson shall be prima facia in
14 the county where the person resided at the time of death.

15 Section 1909-A. Funeral expenses of deceased servicepersons.

16 (a) Contributions.--Each county shall contribute at least
17 \$75 towards the funeral expenses of each deceased serviceperson
18 in the cases provided in subsection (b) where, in each case,
19 application for the contribution is made within one year after
20 the date of the deceased serviceperson's death. In the case of a
21 deceased serviceperson who died while in service, application
22 may be made at any time. All contributions made under this
23 section shall be uniform as to eligible deceased servicepersons
24 within the same calendar year.

25 (b) Payments.--Payments shall be made under the following
26 circumstances:

27 (1) Where the deceased serviceperson, at the time of
28 death, had a legal residence in the county, whether or not
29 the person died in the county and whether or not the person
30 was interred in the county. Every deceased serviceperson

1 having a legal residence in this Commonwealth at the time of
2 death shall be entitled to the benefits of this section,
3 regardless of where the person may have died or where the
4 person may be interred, and the liability shall be on the
5 county where the deceased serviceperson shall have had legal
6 residence at the time of death.

7 (2) Where the deceased serviceperson died and was
8 interred in the county but, at the time of death, did not
9 have legal residence within this Commonwealth, if the board
10 of commissioners of the county where the person died are
11 notified in writing by an organization of veterans that the
12 body is unclaimed by relatives or friends and, upon
13 investigation, shall find such conditions to exist.

14 Section 1910-A. Interment of spouses of deceased
15 servicepersons.

16 Upon due application and proof, the county shall contribute
17 at least \$75 towards the funeral expenses of a spouse of a
18 deceased serviceperson who, at the time of death, had a legal
19 residence in the county, whether or not the person died in the
20 county and whether or not the person was interred in the county.
21 The county shall not contribute money toward the funeral
22 expenses of a spouse of a deceased serviceperson who had
23 remarried after the death of the deceased serviceperson. In each
24 case, application for the contribution shall be made within one
25 year after the date of the death of the spouse. All
26 contributions made under this section shall be uniform as to
27 eligible spouses within the same calendar year.

28 Section 1911-A. Payment.

29 (a) Funeral expenses.--The county shall make a payment in
30 the amount authorized or required under section 1909-A or 1910-A

1 for each deceased serviceperson or spouse of a deceased
2 serviceperson in accordance with the provisions of this
3 subdivision, to be paid out of the funds of the county, and
4 payments shall be made payable to the applicant or applicants if
5 the application shows that the funeral expenses have been paid.
6 Otherwise, payments shall be made to the funeral director
7 performing the services, with notice to the applicant.

8 (b) Personal representative.--Application for contributions
9 shall be made by the personal representative of a deceased
10 serviceperson or a deceased serviceperson's spouse. If no
11 qualified personal representative is available, the application
12 then may be made by the next-of-kin, an individual or a
13 veterans' organization, who or which assumes responsibility for
14 the cost of burial. The facts contained in the application shall
15 be sustained by affidavit. A person who knowingly files an
16 application under this section which is false in any material
17 manner shall be guilty of a misdemeanor in accordance with 18
18 Pa.C.S. § 4903 (relating to false swearing).

19 (c) Application.--The application shall be on forms
20 prescribed by the Department of Military and Veterans Affairs
21 and shall verify whether the funeral expenses have been paid.
22 The application shall be attached to a certified copy of the
23 death certificate and an affidavit prepared by the funeral
24 director who had charge of the interment, which certifies that
25 the funeral director did render the service.

26 Section 1912-A. Flag holders for graves.

27 (a) Flag holders.--The commissioners of each county shall,
28 from time to time, as they consider expedient, procure
29 appropriate upright flag holders for the graves of deceased
30 servicepersons and the graves of all other deceased persons who

1 served in the Army, Navy, Air Force, Marine Corps, Coast Guard
2 or Merchant Marine during World War II or an organization
3 officially connected to those forces and whose separation from
4 service was honorable, whether by discharge or otherwise. Such
5 flag holders shall be of bronze, aluminum or a suitable weather-
6 resistant substitute material.

7 (b) Requirement for flag holders.--The commissioners of each
8 county shall place an upright flag holder upon the grave of each
9 deceased serviceperson and the graves of all other deceased
10 persons who served in the Army, Navy, Air Force, Marine Corps,
11 Coast Guard or Merchant Marine during World War II or an
12 organization officially connected to those forces whose
13 separation from service was honorable, whether by discharge or
14 otherwise who, at the time of death:

15 (1) had legal residence in the county, whether or not
16 the person died in the county and whether or not the person
17 was interred in the county; or

18 (2) did not have a legal residence within this
19 Commonwealth.

20 (c) Design of flag holders.--If a deceased serviceperson was
21 a veteran of a war or campaign for which the Federal Government
22 issued discharge buttons, the upright flag holders designated
23 for their graves shall include a facsimile of the discharge
24 button. If a deceased serviceperson was a veteran of the Korean
25 Conflict, the markers designated for their graves shall include
26 a circular emblem with the words "Korea, U.S., 1950-1953" in the
27 border and shall incorporate the insignia of the Army, Navy,
28 Marine Corps, Air Force or Coast Guard, as appropriate, in the
29 form approved by the State Veterans' Commission.

30 (d) Memorial certificate.--In the case of a county of the

1 second class A, in lieu of placing an upright flag holder on the
2 grave, if the next-of-kin of a veteran so requests, a memorial
3 certificate may be issued to the next-of-kin of a deceased
4 serviceperson who, at the time of death, had legal residence in
5 the county, whether or not the person died in the county and
6 whether or not the person was interred in the county. The
7 memorial certificate shall indicate the deceased serviceperson's
8 name and designate the war or campaign in which the deceased
9 serviceperson served.

10 Section 1913-A. Memorial benefit.

11 (a) Memorial.--The county commissioners shall provide a
12 memorial designated in subsection (b) on the graves of deceased
13 servicepersons who, at the time of death, had legal residence in
14 the county, as well as on the graves of all other deceased
15 servicepersons who served in the Army, Navy, Air Force, Marine
16 Corps, Coast Guard or Merchant Marine during World War II or an
17 organization officially connected to those forces and whose
18 separation from service was honorable, whether by discharge or
19 otherwise.

20 (b) Specifications.--The commissioners shall provide a
21 concrete or granite base for a headstone provided by the Federal
22 Government, or if lettering only on an existing memorial is
23 desired by the family, the county commissioners shall provide
24 the lettering.

25 (c) Commissioner requirements.--In the event the body of any
26 deceased serviceperson either cannot or will not be returned to
27 the United States, it shall be the duty of the county
28 commissioners to provide a memorial benefit in the family plot
29 of the deceased serviceperson. If lettering of an existing
30 memorial is desired by the family, the inscription shall

1 include:

2 (1) the name, rank and organization of the deceased
3 serviceperson;

4 (2) the name of the country, location or manner in which
5 the person lost his or her life; and

6 (3) the cemetery or other interment site where the
7 deceased serviceperson has been interred, if any.

8 (d) Expense for benefit.--The expense for a benefit provided
9 under this section shall be paid for by the county in which the
10 deceased serviceperson had legal residence at the time of death,
11 whether or not the person died in the county and whether or not
12 the person was interred in the county. The expense shall not
13 exceed the actual cost of providing the concrete or granite base
14 or lettering. The county commissioners of each county shall pay
15 from the treasury to the party or parties furnishing the
16 benefit.

17 (e) Legal disputes.--In cases of dispute concerning the
18 legal residence of a deceased serviceperson, the county in which
19 a deceased serviceperson is interred shall perform the duties
20 required under this section. No payment shall be made unless the
21 application is approved by the county commissioners before the
22 commencement of the project.

23 (f) Offense.--Any person who intentionally, recklessly or
24 negligently destroys, mutilates, removes or defaces a grave
25 marker, headstone or flag holder commits an offense under 18
26 Pa.C.S. § 3903 (relating to grading of theft offenses).
27 Section 1914-A. Burial plots.

28 The county commissioners of each county are authorized to
29 purchase plots of ground in each cemetery or other interment
30 site for the interment of deceased servicepersons whose bodies

1 are entitled to be interred under this subdivision. Costs under
2 this section shall be paid by the county commissioners from the
3 county treasury. The purchase price of plots of ground shall not
4 be charged against or allotted as part of the cost of interment
5 of deceased servicepersons who may be interred in any of the
6 plots under this subdivision.

7 Section 1915-A. Care of graves and headstones.

8 The county commissioners of each county may ensure that the
9 graves and headstones of all deceased servicepersons and all
10 other veterans who are buried in the county receive proper and
11 fitting care and may employ all necessary assistants to carry
12 out the provisions of this section. The expense of the care of
13 the graves and headstones may be paid for by the county where
14 the graves are located, except where suitable care is otherwise
15 provided. Money appropriated may be expended directly by the
16 county commissioners or paid over to the person, firm,
17 association or corporation owning or controlling a cemetery or
18 other interment site in the county where a grave is situated.
19 The sum paid for a grave each year shall not exceed the charge
20 for the annual care and maintenance of like graves in the same
21 cemetery or, if no fixed charge is established in that cemetery,
22 shall not exceed the sum charged in other cemeteries in the same
23 county for like service.

24 Section 1916-A. Determining eligibility for interment benefits.

25 (a) Proof required.--In each case where application is made
26 for a contribution toward the funeral expenses of a deceased
27 serviceperson or the surviving spouse of a deceased
28 serviceperson or for a memorial benefit under section 1913-A,
29 the county commissioners shall, before expending any money,
30 require proof of the following:

1 (1) The service of the deceased serviceperson which
2 entitles that person or the surviving spouse to the benefits
3 under this subdivision. Proof shall be made by the production
4 of an honorable discharge or other official record showing
5 service during a war in which the United States is or was
6 engaged, or by the records of the United States Department of
7 Defense, or by copies filed in the Department of Military and
8 Veterans Affairs showing the existence of a campaign or state
9 or condition of war, the participation of the United States
10 and the service of the deceased serviceperson in a zone where
11 a campaign or state or condition of war existed.

12 (2) The death of the deceased serviceperson.

13 (3) In addition to paragraphs (1) and (2), in the case
14 of the interment of the surviving spouse of a deceased
15 serviceperson, the death of the surviving spouse and the fact
16 that the spouse was married to the deceased serviceperson at
17 the time of the serviceperson's death and that the spouse has
18 not since remarried.

19 (4) Except in cases where persons not having a legal
20 residence within this Commonwealth are entitled to any of the
21 benefits under this subdivision, the legal residence within
22 the county of the deceased serviceperson or of the surviving
23 spouse of a deceased serviceperson, as the case may be.

24 (b) Documentation required.--Death shall, in all cases, be
25 proven by a death certificate, if procurable, or else by one of
26 the following:

27 (1) Affidavit of one or more persons personally
28 acquainted with the deceased and the fact of the person's
29 death.

30 (2) Proof of the record of death kept by the attending

1 physician.

2 (3) Proof of the record of interment kept by the funeral
3 director.

4 (4) Records of the church burial association or cemetery
5 company maintaining the graveyard, burial ground, cemetery or
6 other interment site in which the deceased serviceperson was
7 interred.

8 (c) Satisfaction of proof.--If proof required by this
9 subdivision has been furnished to the county commissioners, no
10 further proof of the same facts shall be required in order to
11 obtain any other benefit under this subdivision.

12 (c) Memorial Observances

13 Section 1921-A. Appropriations to veterans' organizations for
14 expenses of Memorial Day, Veterans' Day, Flag Day and
15 Independence Day.

16 (a) Appropriations.--The board of commissioners may make
17 appropriations to aid in defraying the expenses of Memorial Day,
18 Veterans' Day, Flag Day and Independence Day to each camp, post,
19 detachment or organization in the county of the following:

20 (1) The United Spanish War Veterans.

21 (2) The American Legion.

22 (3) The Veterans of Foreign Wars.

23 (4) The Veterans of World War I of the USA, Inc.

24 (5) The American War Veterans of World War II (AMVETS).

25 (6) The Society of the Twenty-eighth Division, AEF,
26 Incorporated.

27 (7) Italian American War Veterans of the United States,
28 Incorporated.

29 (8) The Marine Corps League.

30 (9) Each naval association.

1 (10) The Grand Army of the Republic.
2 (11) The Disabled American Veterans.
3 (12) The American Gold Star Mothers.
4 (13) The Sons of Union Veterans of the Civil War, the
5 Daughters of Union Veterans of the Civil War or, in the
6 absence of orders, a duly constituted organization that
7 decorates graves of Union Veterans of the Civil War.

8 (14) Any other nationally chartered veterans'
9 organization or other veterans' organization recognized by
10 the county.

11 (b) Payments.--Payments under this section shall be made to
12 defray actual expenses only. Before any payment is made, the
13 organization receiving the payment shall submit verified
14 accounts of their expenditures.

15 Section 1922-A. Flags to decorate graves.

16 (a) Memorial Day flags.--It shall be the duty of the county
17 commissioners of each county to provide flags on each Memorial
18 Day with which to decorate the graves of all deceased
19 servicepersons and the graves of all other deceased persons who
20 served in the Army, Navy, Air Force, Marine Corps, Coast Guard
21 or Merchant Marine during World War II or an organization
22 officially connected to those forces, whose separation from
23 service was honorable, whether by discharge or otherwise, and
24 who are interred within the county. The flags to be used shall
25 be standard size, colorfast and American-made and shall be
26 purchased at the expense of the county from money in the county
27 treasury.

28 (b) Veterans' organizations.--Flags required under this
29 section shall be furnished to the various veterans'
30 organizations in numbers required for their respective

1 communities.

2 (c) Appropriations.--Money expended by each county under
3 this section shall be in addition to money appropriated by
4 counties for Memorial Day purposes.

5 (d) Maintenance.--Annually, the authorities in charge of
6 each cemetery are authorized to remove flags when flags become
7 unsightly or weatherworn any time on or after the first working
8 day after Veterans' Day.

9 (e) Offense.--An authority or person in charge of a cemetery
10 who removes or causes the removal of flags prior to the first
11 working day after Independence Day shall be guilty of a summary
12 offense and, upon conviction, shall be sentenced to pay a fine
13 of \$300 and, upon failure to pay a fine, to undergo imprisonment
14 not to exceed 90 days.

15 Section 1923-A. Compilation of war records.

16 (a) Records required.--The county commissioners of each
17 county are authorized and directed, at the expense of the
18 county, to compile a record of the interment sites within the
19 county of deceased servicepersons and all other veterans.
20 Records, so far as practicable, shall indicate the name of each
21 deceased serviceperson, the service in which the person was
22 engaged, the number of the regiment, company or command, the
23 rank and period of service, the name and location of the
24 cemetery or other place in which the person's body is interred,
25 the location of the grave in a cemetery or other place and the
26 character of headstone or other marker, if any, at the grave.
27 The record shall be known as the Veterans' Grave Registration
28 Record of County, and shall be a
29 public record, open to inspection during business hours.

30 (b) Record blanks.--The county commissioners of each county

1 shall ensure that record blanks are prepared, according to forms
2 prescribed by the Department of Military and Veterans Affairs,
3 whereby the information required for the record may be
4 transmitted to the commissioners upon request.

5 (c) Certificate required.--Every person, firm, association
6 or corporation, including a municipal corporation, owning or
7 controlling a cemetery or interment site in this Commonwealth
8 which inters bodies of deceased servicepersons shall file with
9 the county director of veterans' affairs of the county in which
10 the cemetery is located a certificate, on the record blanks
11 provided by the county commissioners, of the facts required for
12 the record if the facts are within the knowledge of the person,
13 firm, association or corporation or a designated agent.

14 (d) Offense.--The county commissioners of each county shall
15 ensure that record blanks are distributed to a person, firm,
16 association or corporation, as they deem advisable, with the
17 request that the information required under this section be
18 transmitted to the county. A person, firm, association or
19 corporation, except municipal corporations, that refuses or
20 neglects to fill out and transmit to the county commissioners
21 the blanks or forms within six months after receipt of the
22 blanks or forms is guilty of a summary offense and, upon
23 conviction, shall be sentenced to pay a fine of \$100.

24 (e) Location of interment sites.--For the purpose of
25 locating the interment sites of persons who have served in the
26 armed forces of the United States during a war or armed conflict
27 in which the United States was engaged, any veterans'
28 organization listed in section 1921-A(a) or otherwise recognized
29 by the county is authorized, without expense to the county, to
30 collect the required data and prepare and file with the county

1 commissioners certificates embodying the information required
2 under this section.

3 (f) Written notice.--Notwithstanding any provision to the
4 contrary, any organization that accepts remains under section
5 506.2 of the act of June 29, 1953 (P.L.304, No.66), known as the
6 Vital Statistics Law of 1953, which allows certain veterans'
7 service organizations to claim the remains of certain deceased
8 veterans, shall give written notice of the location and manner
9 of the final disposition of the remains to the county director
10 of veterans' affairs of the county in which the final
11 disposition of the remains is made.

12 Section 1924-A. Director of veterans' affairs.

13 (a) Appointment.--The county commissioners of a county shall
14 appoint an eligible person under 51 Pa.C.S. § 1731(a) (relating
15 to accreditation) to serve as the director of veterans' affairs,
16 who shall receive compensation as fixed by the salary board.

17 (b) Responsibility of director.--It shall also be the duty
18 of the director of veterans' affairs to:

19 (1) Assist all veterans and their families in securing
20 rights relating to their person, property and care of family
21 under any of the laws of the United States and this
22 Commonwealth.

23 (2) Assist the county commissioners in administering the
24 provisions of this subdivision which relate to the interment
25 of deceased servicepersons and their surviving spouses and to
26 furnishing flagholders and placing headstones on their
27 graves.

28 (3) Compile and maintain war records and records of
29 interment sites of deceased servicepersons in accordance with
30 the provisions of this subdivision.

1 (4) Perform other duties provided by statute, including,
2 but not limited to, the duties required under 51 Pa.C.S. §
3 1731(c).

4 (c) Compensation.--For services performed under subsection
5 (b), the director of veterans' affairs shall be entitled to
6 expenses incurred and additional compensation. Both expenses and
7 compensation shall be subject to the approval of the salary
8 board.

9 Section 71. Section 2101 of the act is amended to read:

10 Section 2101. Health Work.--The [board of county]
11 commissioners may provide and annually appropriate from any
12 moneys in the county treasury not otherwise appropriated such
13 sum or sums as they deem necessary for the protection of the
14 health, cleanliness, convenience, comfort and safety of the
15 people of the county.

16 Section 72. Subdivision (b) of Article XXI of the act is
17 repealed:

18 [(b) County and Joint County Hospitals

19 Section 2110. Expenses of Maintenance, Care and Treatment.--
20 All expenses incident to the maintenance and operation of any
21 county or joint county contagious disease hospitals, and of
22 buildings, wings and units at general hospitals, erected and
23 equipped for such diseases, under the provisions of this act,
24 shall be paid by the county, or by the counties so joining, out
25 of county funds in accordance with the agreement made between or
26 among the participating counties, or between or among the county
27 and any municipalities within the county, in the case of joint
28 county hospitals, or of buildings, wings and units at general
29 hospitals jointly agreed upon by counties under the provisions
30 of this act. The county, or each county in the case of joint

1 arrangements, shall separately be liable to pay the cost of the
2 care and treatment of its indigent patients and those unable to
3 pay the entire cost of care and treatment in such contagious
4 disease hospitals, and in buildings, wings and units at general
5 hospitals, and for such purposes any county, or the counties so
6 joining, shall have power to appropriate county funds.

7 Section 2111. Administration of County and Joint County
8 Hospitals.--After any county hospital for contagious diseases is
9 erected and equipped and ready for occupancy, it shall be
10 operated by and under the authority of the county commissioners
11 of the county in the same manner that other county buildings and
12 institutions are operated, and in the case of joint county
13 hospitals, the operation shall be in the manner provided in the
14 agreement between the counties. All county or joint county
15 contagious disease hospitals heretofore erected and constructed
16 shall hereafter be maintained and operated in the manner
17 provided by this subdivision.

18 Section 2112. Removal of Contagious Cases to Hospital.--In
19 any county having a hospital for the care and treatment of
20 contagious diseases, any lawfully authorized health authorities
21 of or within the county may remove cases of contagious disease
22 to such hospital for treatment and isolation, whenever proper
23 quarantine measures cannot otherwise be enforced.

24 Section 2113. Advisory Board for County Hospital for
25 Tuberculosis.--(a) If a majority of the electors voting upon
26 the question submitted to them, pursuant to the provisions of
27 this act, at an election, shall be in favor of the establishment
28 of a hospital by the county for treatment of persons afflicted
29 with tuberculosis, the court of common pleas of the county shall
30 immediately appoint an advisory board of five members, all of

1 whom shall be electors of the county and one of whom shall be a
2 licensed physician. The members of said board shall be
3 appointed, one for a term of five years, one for a term of four
4 years, one for a term of three years, one for a term of two
5 years and one for a term of one year or until their successors
6 are appointed and have qualified. All appointments at the
7 expiration of any term shall be for a term of five years.

8 (b) The board shall meet monthly and at such other times as
9 it may be deemed necessary. The board shall visit and inspect
10 and keep in close touch with the management and operation of
11 said hospital, and shall, from time to time, make such
12 recommendations and suggestions to the county commissioners for
13 changes or improvements in said management and operation as may
14 be deemed advisable. It shall also make an annual report to the
15 county commissioners concerning the management and operation of
16 said hospital.

17 (c) The county commissioners shall, at the expense of the
18 county, provide a meeting place for said board, and furnish all
19 supplies and materials necessary to carry on its work.

20 (d) The members of the board shall not receive any
21 compensation for their services, but shall be allowed all actual
22 and necessary expenses, incurred in the discharge of their
23 duties, which shall be paid by the county.

24 Section 2114. Employees' Salaries in County Hospital for
25 Tuberculosis.--The county commissioners may, after consultation
26 with the advisory board, employ a superintendent and such
27 physicians, nurses and other employes as may be necessary to
28 properly conduct and manage such hospital and the salary board
29 shall fix their compensation. All such salaries shall be paid by
30 the county treasurer in the usual manner.

1 Section 2115. Management.--The county commissioners shall
2 have power, after consulting with the advisory board, to make
3 general rules and regulations for the management of the county
4 hospital for tuberculosis, and shall have power to do all acts
5 deemed necessary to promote the usefulness of the hospital in
6 the prevention of tuberculosis.

7 Section 2116. Use of Hospital.--Every hospital established
8 under the provisions of this act for the treatment of
9 tuberculosis shall be used for the benefit of all inhabitants
10 afflicted with tuberculosis resident within the county in which
11 the hospital is located, and all such persons shall be entitled
12 to occupancy, nursing, care, treatment and maintenance according
13 to the rules and regulations prescribed by the county
14 commissioners. The county commissioners may exclude from the use

23 Section 2117. Patients from Other Counties; Donations.--(a)
24 The county commissioners may admit patients to the county
25 hospital for tuberculosis who are resident within any other
26 county of the Commonwealth, provided such other county agrees to
27 reimburse the county in which the hospital is located for all
28 charges in connection with the admission, maintenance, care and
29 treatment of such patients, and not paid by the patients
30 themselves. Authority is hereby conferred upon all counties in

1 the Commonwealth to pay to any other county in which such
2 hospital is located reasonable charges for patients cared for by
3 said hospital resident in the county paying such charges.

4 (b) All money received from the care and maintenance of
5 patients or from gifts or donations shall be paid into the
6 county treasury and shall be used only for the maintenance of
7 such hospitals. County commissioners are authorized and
8 empowered to receive contributions, donations, property and
9 trust funds for the erection and maintenance of such hospitals
10 as provided in this act.

11 Section 2118. Appropriations; Tax Levy.--The advisory board
12 for county hospitals for tuberculosis herein provided for shall,
13 by September thirtieth of each year, furnish to the county
14 commissioners and the county controller, if any, a schedule of
15 expenses deemed necessary for the maintenance and operation of
16 the hospital for the ensuing year. The county commissioners
17 shall, after considering the schedule submitted by the advisory
18 board, annually make appropriations deemed by them sufficient to
19 properly manage and operate said hospital. The county
20 commissioners shall levy a special tax sufficient to produce the
21 moneys appropriated to said hospital, which tax shall be
22 collected in the same manner as other county taxes and shall be
23 paid into the county treasury. All payments from the county
24 treasury shall be made by voucher checks in the usual manner.

25 Section 2119. Hospitals for Tuberculosis Established Under
26 Other Laws.--In any county where any hospital for tuberculosis
27 has been begun or erected under the provisions of any act of
28 Assembly heretofore repealed, such proceedings and hospital may
29 be completed and the said hospital may thereafter be managed and
30 operated in accordance with the provisions of this act.]

1 Section 73. Section 2130 of the act is amended to read:

2 Section 2130. Appropriations to Hospitals[, Tuberculosis
3 Sanitaria], Health Clinics and Homes.--The [board of]
4 commissioners may [appropriate moneys for the] make
5 appropriations to support [of any] a hospital or health clinic
6 or comparable facility, [located within or without the limits of
7 such county] which is engaged in charitable work and extends
8 treatment and medical attention to residents of [such] the
9 county, and may also appropriate moneys for the support of any
10 home or place of detention of dependent, delinquent and
11 neglected children located within the county[, and may also
12 appropriate moneys for the support of any sanitarium for the
13 treatment of persons afflicted with tuberculosis located within
14 the Commonwealth of Pennsylvania, which sanitarium is engaged in

17 Section 74. Section 2131 of the act is repealed:

18 [Section 2131. Appropriation to Society Maintaining

22 persons suffering from tuberculosis, so much money as may be
23 necessary for the maintenance of indigent persons, residents of
24 the county, who may be inmates of such sanitarium and under
25 treatment for tuberculosis. Said appropriation shall not exceed
26 for each indigent inmate the sum of ten dollars (\$10) per week,

5 commissioners may [appropriate moneys from the county treasury]

7 incorporated towns or townships] municipal corporations in the
8 construction or maintenance of sewers or [sewage treatment
9 works] waste water treatment facilities[, where such sewers and

14 Section 76. The act is amended by adding a section to read:

15 Section 2133. Aid to Municipal Corporations for Water

18 public water systems, if the project has first received all
19 necessary approvals or permits from the Department of
20 Environmental Protection.

21 Section 77. Sections 2150, 2151, 2152, 2160, 2162, 2163,
22 2164 and 2165 of the act are amended to read:

23 Section 2150. [Secretary of Agriculture to Cooperate;]

24 Elimination and Abatement of Larvae Breeding Places; Liens.--

25 [(a) The Secretary of Agriculture of the Commonwealth is hereby
26 authorized and empowered to cooperate with and assist the county
27 commissioners of any county in the effective carrying out the
28 provisions of this subdivision. He may authorize a deputy to
29 meet with the commissioners as his representative. The necessary
30 expenses actually incurred by the secretary and his deputy, in

1 compliance with this section, shall be allowed and paid by the
2 Commonwealth as a part of the expenses of the Department of
3 Agriculture. He shall furnish the said commissioners with such
4 surveys, maps, information and advice as they may require for
5 the prosecution of their work or as in his opinion will be of
6 advantage in connection therewith.]

7 (b) The county commissioners of counties of the third
8 through eighth class shall have power to eliminate [all]
9 breeding places of mosquitoes[,] on private or public
10 property[,] within the county [and to do and perform]. The
11 commissioners may provide for all acts, including entry upon
12 private or public property, [and] to carry out all plans which,
13 in their opinion and judgment through consultation with public

19 (c) Any water, in which mosquito larvae breed, is hereby

24 the commissioners, be abated they shall, in writing, order the

17 and shall from time to time, make such reports to such
18 department as it shall require.

19 Section 2163. Powers and Duties.--The county commissioners
20 of counties of the fourth, fifth, sixth, seventh and eighth
21 classes shall have the power and their duty shall be:

22 (1) To erect, equip, maintain, repair, alter and add to
23 institutions for the care of dependents[, and to equip,
24 maintain, cultivate and improve farms, using their produce for
25 the support of dependents, or if a surplus of farm products
26 should exist, the commissioners may sell the surplus pursuant to

3 Section 2164. Further Powers and Duties.--The county
4 commissioners of counties of the fourth, fifth, sixth, seventh
5 and eighth classes shall have the power and it shall be their
6 duty, with funds of the county, according to rules, regulations
7 and standards established by the Department of [Public Welfare]
8 Human Services:

9 (1) To care for any dependent [having a settlement] in the
10 county, who is not otherwise cared for[: Provided, however, That
11 no applicant for public nursing home care under the medical
12 assistance for aged provisions of the "Public Assistance Law,"
13 who resides in Pennsylvania, shall be rendered ineligible for
14 such care by lack of settlement in the county].

15 (2) To contract with other counties[, any institution
16 district,] or any individual, association, corporation or other
17 entity for the care of any dependent.

18 (3) To contract with any association in Pennsylvania
19 organized to provide a home or employment for [deaf and dumb or
20 blind persons having a settlement in the county, or to care for
21 any dependent having a settlement in the county, who is deaf and
22 dumb or blind or to help him through employment] persons with
23 disabilities.

24 (4) To pay the cost or part of the cost [with respect to
25 mental or other patients imposed by law upon county institution
26 districts.] imposed by law upon county institution districts for
27 patients with mental health needs or intellectual disability.

28 (5) To take any other action authorized by law.

29 (6) To contract with any individual, association,
30 corporation, institution or governmental agency for the purpose

1 of providing foster home care for persons over eighteen years of
2 age. If, in the discretion of the county commissioners, such
3 foster home care is advisable, the county commissioners may
4 expend funds for such foster home care in addition to any funds
5 paid by the Commonwealth or any individual, association,
6 corporation, institution or governmental agency to or for such
7 persons over eighteen years of age.

8 (7) To require that any person cared for in an institution
9 as defined herein shall pay for the cost of his care to the
10 extent of his available resources.

11 (8) To provide or to contract with any individual,
12 corporation, institution or governmental agency to provide care
13 and services designed to help dependents remain in or return to
14 community living, outside county institutions.

15 Section 2165. Care of Persons Referred by Department of
16 [Public Welfare] Human Services.--The county commissioners of
17 counties of the fourth, fifth, sixth, seventh and eighth classes
18 shall have power to care for any dependent or other indigent
19 person in the county who is referred to them by the Department
20 of [Public Welfare] Human Services or by a local board under its
21 supervision[, pending the determination of such person's legal
22 settlement].

23 Section 78. Section 2167 of the act is repealed:

24 [Section 2167. Treatment of Persons in Danger of
25 Hydrophobia.--The county commissioners of counties of the
26 fourth, fifth, sixth, seventh and eighth classes shall provide,
27 with approved medical care and proper attendance (including the
28 so-called Pasteur treatment, where prescribed), all indigent
29 persons settled within their district who may be assumed to be
30 in danger of suffering from hydrophobia or rabies by reason of

1 having been bitten by an animal believed to have been suffering
2 from the disease, and to order payment of the expenses so
3 incurred out of the funds of the county for the care of
4 dependents.]

5 Section 79. Sections 2168, 2169, 2170, 2172, 2173 and 2174
6 of the act are amended to read:

7 Section 2168. Powers and Duties of County Commissioners as
8 to Children.--The county commissioners of any county of the
9 fourth, fifth, sixth, seventh or eighth class shall have the
10 power and for the purpose of protecting and promoting the
11 welfare of children and youth, it shall be their duty to provide
12 those child welfare services designed to keep children in their
13 own homes, prevent neglect, abuse and exploitation, help
14 overcome problems that result in dependency, neglect or
15 delinquency, to provide in foster family homes and child caring
16 institutions adequate substitute care for any child in need of
17 such care and upon the request of the court, to provide such
18 services and care for children and youth who have been
19 adjudicated dependent, neglected or delinquent.

20 [No child under the age of sixteen years shall, unless he is
21 mentally or physically handicapped and no other care is
22 available for him, be admitted to, or maintained in, an
23 institution conducted by the county commissioners of fourth,
24 fifth, sixth, seventh or eighth class counties other than a
25 hospital or sanitarium.]

26 Section 2169. Contributions for Medical Care.--The
27 commissioners of each county of the fourth, fifth, sixth,
28 seventh or eighth class shall have the power to make annual
29 appropriations from the funds of the county for the support of
30 any public institution operated, or to any nonprofit corporation

1 organized, to give medical care to the dependents and children
2 of the county [without discrimination as to membership in any
3 organization or as to race or sect].

4 Section 2170. Inspections by Department of [Public Welfare]
5 Human Services.--The institutions and books, accounts and
6 records of each county pertaining to its powers and duties
7 authorized by this subdivision shall, at all times, be open to
8 the inspection of the Department of [Public Welfare] Human
9 Services and its agents.

10 Section 2172. Rules and Regulations.--The county
11 commissioners of each county of the fourth, fifth, sixth,
12 seventh and eighth class shall have power to make such rules and
13 regulations, not inconsistent with this act and not inconsistent
14 with the rules and regulations of the Department of [Public
15 Welfare] Human Services, as may be deemed proper, convenient and
16 necessary for the government of its institutions and to properly
17 care for dependents.

18 Section 2173. Providing Certain Services Without Charge
19 Prohibited.--Notwithstanding any other provisions of law, no
20 county commissioners shall provide without charge any items of
21 care or service which an individual is entitled to receive as
22 assistance under the ["Public Assistance Law,"] act of June 13,
23 1967 (P.L.31, No.21), known as the "Human Services Code," but
24 this section shall not be construed to preclude county
25 commissioners from [supplementing such public assistance]
26 providing additional forms of assistance not inconsistent with
27 the Human Services Code or the regulations of the Department of
28 Human Services.

29 Section 2174. Payments by County Commissioners for
30 Assistance.--The county commissioners shall pay monthly to the

1 Department of [Public Welfare] Human Services, as such county
2 commissioners payment for assistance, the amount expended by the
3 department during the preceding month as assistance on behalf of
4 patients receiving public nursing home care in a county medical
5 institution, and on behalf of children in foster family homes
6 and child-caring institutions, plus the cost of administering
7 such assistance, minus the amount of Federal funds properly
8 received or to be received by the Department of [Public Welfare]
9 Human Services on account of such expenditures increased or
10 reduced, as the case may be, by any amount by which the sum paid
11 for any previous month differed from the amount which should
12 have been paid for such previous month and by the proportionate
13 share of refunds of such assistance as provided in the ["Public
14 Assistance Law."] act of June 13, 1967 (P.L.31, No.21), known as
15 the "Human Services Code." The Department of [Public Welfare]
16 Human Services shall certify to the county commissioners the
17 amount to be paid by them to the department.

18 Section 80. Sections 2175, 2176 and 2177 of the act are
19 repealed:

20 [Section 2175. Settlement.--For the purposes of this
21 subdivision:

22 (1) A person is first settled in the county of birth unless
23 the child's parents or the custodial parent if the parents do
24 not live together or other legal guardian if neither parent has
25 custody of the child has an established settlement elsewhere, in
26 which case the first settlement of such person is in the county
27 of his or her custodian. If the child resides with both parents
28 and they have different settlements the settlement of the child
29 shall be the same as that of the parent whose settlement
30 coincides with the family residence. If neither parent's

1 settlement coincides with the family residence, the child's
2 settlement shall be in the place of the child's birth.

3 (3) The settlement of a person in a county continues until a
4 new one is acquired in this Commonwealth or elsewhere. A
5 settlement is lost only by acquiring a new one, except that a
6 person who has settlement in this Commonwealth, and who is
7 residing in another state, shall be deemed to have lost
8 settlement in this Commonwealth if a person from such other
9 state, in like circumstances, could have acquired settlement in
10 this Commonwealth by residence in this Commonwealth, as
11 hereinafter provided; and except that a person having settlement
12 in this Commonwealth, who has been absent therefrom and who has
13 been residing in another state, shall be deemed to have lost
14 settlement in this Commonwealth if a resident of such other
15 state, who is residing in this Commonwealth, would lose
16 settlement in such other state as a result of absence therefrom
17 for a period of equal duration or for a period of lesser
18 duration.

19 (4) Except as hereinafter otherwise provided, every adult
20 and every emancipated minor, whether married or single, may
21 acquire a new settlement in any county of this Commonwealth or
22 in the Commonwealth by coming bona fide to establish a permanent
23 abode therein and continuing to reside therein for one whole
24 year, if such person or minor is of sufficient mental ability to
25 make a bargain, and is not or does not become a public charge
26 during such year.

27 (6) A minor cannot be emancipated before age sixteen, and
28 becomes emancipated absolutely at age eighteen, if then of
29 sufficient mental ability to make a bargain. After age sixteen
30 and before age eighteen, a minor of sufficient mental ability to

1 make a bargain may become emancipated by his own acts or the
2 acts of the parent, stepfather or stepmother having had the
3 custody. When a person is emancipated, he or she is capable of
4 establishing a new settlement.

5 (7) A minor who is so mentally deficient as to be unable to
6 make a bargain cannot be emancipated after age sixteen, and such
7 a person does not become emancipated at age eighteen and so long
8 thereafter, as the mental condition continues. The settlement of
9 such a person shall at all times during mental disability be
10 ascertained as provided in clauses (8) and (9) of this section
11 for the settlement of minors not emancipated.

12 (8) Before emancipation, the settlement of a minor is and
13 remains that of the natural parents or custodial parent, should
14 the natural parents not live together, or of any other legal
15 guardian, or if the parents live together and have different
16 settlements, that of the natural parent whose settlement
17 coincides with the family residence, except that if the parents
18 live together with the child and have different settlements
19 neither of which coincides with the family residence, the
20 settlement of a minor before emancipation shall be and remain in
21 the place of the child's birth.

22 (10) If a person has no known settlement in this
23 Commonwealth and cannot for any reason whatever be removed into
24 the state or country where settled, he shall have a quasi-
25 settlement in the county where he or she becomes a public
26 charge, which county shall, if he be a dependent, be liable for
27 his or her support, otherwise such liability shall be upon the
28 Commonwealth.

29 (11) If a person becomes a public charge in a county other
30 than the one in which settled, such county, if he be a

1 dependent, otherwise the Commonwealth, shall be liable for
2 support until the county, state or country of settlement is
3 discovered, and removal to such county, state or country takes
4 place. Any county of settlement shall be liable to the county in
5 which the person became a dependent for the cost of care
6 advanced and the expenses of removal.

7 Section 2176. Removal to County of Settlement.--In case any
8 person does not have a settlement in the county of the fourth,
9 fifth, sixth, seventh or eighth class wherein he has become, or
10 is likely to become, a dependent, it shall be the duty of the
11 county commissioners to notify the county commissioners of the
12 county of his settlement of the facts. If the county
13 commissioners, so notified, refuse or neglect to receive him or
14 to make arrangements for his proper care and to pay the amount
15 advanced, the county commissioners during such care may apply to
16 the court of quarter sessions of their county, or to any judge
17 thereof, by petition, asking for a citation to the county
18 commissioners, so refusing or neglecting, requiring them to
19 appear before such court at a time specified therein, and to
20 show cause why an order should not issue for the removal of such
21 dependent into their county. The court shall proceed to hear and
22 determine the cause upon its merits, and its decree shall be
23 final, unless an appeal therefrom be taken within thirty days.

24 The citation accompanied by a copy of the petition shall be
25 served by the sheriff of the county, who may, for that purpose,
26 deputize the sheriff of the cited county, upon one or more of
27 the county commissioners named therein, or, with the approval of
28 the court, service may be had by sending such copy by registered
29 mail. The service of mailing shall be at least ten days before
30 the day fixed for such hearing. Upon the hearing and argument

1 before the court, it shall be lawful for either of the parties
2 to the issue to except to any decision of the court upon any
3 point of evidence or law, which exception shall be noted by the
4 court and filed of record as in civil cases. An appeal to an
5 appellate court may be taken by either party from the judgment
6 or decree of the court.

7 Section 2177. Liability for Costs.--In case an order of
8 removal is granted by any court of quarter sessions, the court,
9 in the same order, shall require the county of settlement to pay
10 the petitioners the cost of the proceedings, the expense of
11 removal, and the proper charges for the care of the dependent,
12 from the date of the notice first above provided for, all of
13 which expense, cost, and charges shall be ascertained and
14 allowed by the court. If an order of removal is refused, the
15 cost of the proceeding shall be paid by the county petitioning
16 therefor.

17 The court of quarter sessions shall have full and complete
18 authority and jurisdiction to enforce by appropriate methods its
19 orders or directions made in such proceeding.]

20 Section 81. Section 2180 of the act is amended to read:

21 Section 2180. Attendance at Training Courses and
22 Conferences.--The commissioners of any county may approve
23 attendance at county expense by county health, [welfare] human
24 services or probation personnel at appropriate training courses
25 or at state or national conferences in the health, welfare or
26 correctional fields. [Such expenses may include maintenance
27 fees, if any, and transportation or mileage, if use of personal
28 automobile is authorized.] Each person attending a training
29 course or conference shall submit an itemized account of
30 expenses related to the event according to the provisions of

1 section 446.

2 Section 82. Sections 2185, 2186, 2187, 2188, 2189, 2190,
3 2191, 2192, 2193, 2193.1, 2193.2, 2194, 2195, 2195.1, 2195.2,
4 2196, 2197, 2198, 2199, 2199.1 and 2199.2 are repealed:

5 [Section 2185. Board of Health Jurisdiction
6 Incompatibility.--Each county of the third class may, by
7 ordinance, create a board of health as herein provided. The
8 jurisdiction of every such board of health shall extend to all
9 parts of the country in which created: Provided, That whenever
10 there is a board of health in any city, borough or township of
11 the county, the rules and regulations of any such board of
12 health shall supersede any rules and regulations of the county
13 board in any particular matter where such rules and regulations
14 are more stringent. The board of health shall have five members
15 appointed by the board of county commissioners, who shall serve
16 without compensation. Except as otherwise herein provided,
17 membership on the board of health shall be incompatible with
18 every other county office.

19 Section 2186. Qualifications; Term; Removal.--The members of
20 the board of health shall be residents of the county, except in
21 the case of physicians who shall have their main office in the
22 county. At least two members shall be reputable physicians of
23 not less than two years experience in the practice of their
24 profession. Upon the creation of the board, the board of county
25 commissioners shall designate for one appointee a term of one
26 year, for another a term of two years, and so on up to five;
27 thereafter, one member of the board shall be appointed annually
28 to serve for a term of five years from the first Monday of April
29 succeeding his appointment. The board of county commissioners,
30 after due notice and hearing, may remove members of the board

1 for official misconduct or neglect of duty. All vacancies shall
2 be filled for the unexpired term.

3 Section 2187. Oath of Office; Organization; Secretary.--Each
4 member of the board of health shall take the oath of office
5 prescribed in section 403 of this act. The board shall organize
6 annually at its regular meeting date in January. The board shall
7 elect a president annually from among the members and shall
8 appoint a secretary who is not a board member. The secretary
9 shall take the aforesaid oath and shall give a fidelity bond
10 with corporate surety to the county in such amount as the board
11 of county commissioners requires. The secretary shall receive
12 such salary as the board of county commissioners shall approve.

13 Section 2188. Duties of Secretary.--The secretary of the
14 board shall perform such duties as shall be assigned to him by
15 the board of health or the health officer.

16 Section 2189. Health Officer; Qualifications; Oath and
17 Bond.--The board shall appoint as a health officer a person with
18 experience and training in public health work in accordance with
19 rules and regulations of the Advisory Health Board of the State
20 Department of Health, and who shall not enter upon his duties
21 until he has been certified for the office of health officer by
22 the State Department of Health. The health officer shall take
23 the oath required of members of the board, and shall give bond
24 with corporate surety approved by the board of county
25 commissioners to the county for the faithful performance of his
26 duties. The amount of the bond shall be fixed by the board of
27 county commissioners. The health officer shall be the agent of
28 the board of health.

29 Section 2190. Duties of Health Officer.--It shall be the
30 duty of the health officer to attend all stated and special

1 meetings of the board of health and to be available for the
2 prompt performance of his official duties at all times. He shall
3 quarantine places of communicable diseases in accordance with
4 law and with the rules and regulations of the State Department
5 of Health or of the board of health. He shall execute all laws
6 and rules or regulations for the disinfection of quarantined
7 places. He shall serve written notice on teachers and persons in
8 charge of public, parochial, Sunday and other schools, requiring
9 the exclusion from school of children who are suffering from, or
10 who reside with persons who are suffering from, communicable
11 diseases, and shall make sanitary inspections, and shall execute
12 the orders of the board of health and all other laws, rules and
13 regulations and orders pertaining to his office. He shall, in
14 the performance of his duties, have the power and authority of a
15 peace officer.

16 Section 2191. Duties of Board of Health.--The board of
17 health shall enforce the health laws of the Commonwealth and the
18 rules and regulations of the State Department of Health
19 pertaining thereto. The board shall enforce those orders of the
20 State Department of Health for which the State Department of
21 Health reimburses the county for its costs pertaining thereto.
22 The board shall undertake to prevent or diminish the
23 introduction or further spread of infectious or contagious
24 diseases, and otherwise to protect and increase the public
25 health by regulating communication with places of infection or
26 contagion, by isolating carriers of infection or contagion or
27 persons who have been exposed to any infectious or contagious
28 disease, by abating or removing all nuisances which the board
29 shall deem prejudicial to the public health, and by enforcing
30 the vaccination laws; and the boards shall make all such rules

1 and regulations as to it appear proper for the preservation or
2 improvement of the public health, consistent with this article
3 and the laws of the Commonwealth. The board shall transmit to
4 the State Department of Health all of its reports and
5 publications and such other information regarding public health
6 in the county as may be requested by the department.

7 Section 2192. Powers of Board of Health.--The board of
8 health shall have authority:

9 (1) To employ agents and employes at such rates or salaries
10 as the salary board shall approve.

11 (2) To establish and staff emergency hospitals, with the
12 consent of the board of county commissioners, in case of the
13 prevalence or threat of any contagious or infectious disease or
14 other serious peril to public health, and to provide for and
15 regulate the management of such hospitals.

16 (3) To enter upon any premises whatsoever within county as a
17 body or by committee or by its agents or employes, which
18 premises are suspected of infectious or contagious disease or of
19 any other nuisance prejudicial to the public health, or of the
20 danger of them, for the purpose of examining the premises or of
21 preventing, confining or abating public nuisances.

22 (4) To conduct investigations and to hold public hearings in
23 the performance of its duties and powers, wherein the president
24 and secretary of the board shall have full power to administer
25 oaths and affirmations but shall receive no fee therefor. For
26 such purposes, the board of health may require the attendance of
27 witnesses and their books and papers.

28 (5) To establish a force of sanitarians for the enforcement
29 of its rules and regulations, wherever in the opinion of the
30 board the public health of the county requires. To fix the

1 number of such police and the duration of their service and to
2 have the exclusive control and direction of them.

3 (6) To publish and enforce its rules and regulations.

4 (7) To provide for or cooperate in providing for general and
5 gratuitous vaccination, disinfection and other public health
6 control programs, and likewise to make available medical relief
7 in such ways as in its opinion will benefit the public health.

8 (8) To certify to the board of county commissioners
9 expenditures in excess of the board of county commissioner's
10 appropriations therefor, necessarily incurred by the board by
11 reason of an epidemic, or upon approval of the board of county
12 commissioners for any other immediate and serious peril to
13 public health. The board of county commissioners shall thereupon
14 appropriate sufficient money to meet such additional
15 expenditures.

16 (9) To prevent, abate or remove conditions found by it to be
17 detrimental to the public health as public nuisances, or to
18 declare and certify to the board of county commissioners such
19 conditions and the premises or ways or places harboring them to
20 be public nuisances.

21 (10) To prescribe regulations for the erection or operation
22 of bone boiling establishments or of repositories of dead
23 animals in the county, and in accordance therewith, to permit or
24 refuse to permit such erections or operations within the county.
25 Any person who shall erect or operate any such establishment or
26 repository in the county without the permission of the board of
27 health, or in violation of its regulations pertaining thereto,
28 shall forfeit and pay to the county the sum of three hundred
29 dollars (\$300) for every such offense, and the like amount for
30 each months's continuance thereof, to be collected by an action

1 before any alderman or justice of the peace, and shall also be
2 subject to indictment for the common law offense of creating and
3 maintaining a nuisance. Nothing herein shall limit the remedies
4 of injunction or abatement as to any such establishment.

5 (11) To determine whether or not the keeping or slaughtering
6 of stock animals or fowls in or about any dwelling or part
7 thereof, or in the yard, lot or adjoining property of any such
8 building within the county or parts thereof, is or may become
9 detrimental to the public health. The board of county
10 commissioners may prohibit any such keeping or slaughtering
11 which the board certifies to it as detrimental, or the board may
12 issue permits in accordance with regulations adopted by it for
13 the keeping of such animals or fowls within the county or parts
14 thereof. No such permit shall extend beyond the calendar year
15 within which it was issued, and the fee for each permit shall be
16 fixed by the board of health upon approval of the county
17 commissioners.

18 (12) To make provisions for the compilation of vital
19 statistics, maternal and child care, health education, control
20 of chronic diseases, or needed laboratory services.

21 Section 2193. Effect of Rules and Regulations.--The rules
22 and regulations of the board of health shall be subject to prior
23 approval of the board of county commissioners and when printed
24 and advertised by the board of county commissioners as required
25 by this act in section 110, shall have the force of ordinances
26 of the county, and all penalties, fines or imprisonment
27 prescribed therein for violations thereof, together with the
28 expenses necessarily incurred in carrying the rules and
29 regulations into effect and the costs of proceedings incident
30 thereto, shall be recoverable for the use of the county.

1 Section 2193.1. Prohibition of Political Activity.--No
2 person appointed to any position or employed by a county board
3 of health shall be a member of or delegate or alternate to any
4 political convention, nor shall he participate at any such
5 convention, except in the performance of his official duty or as
6 a visitor, nor shall he serve as a member of any committee of
7 any political party, or take an active part in political
8 management or in political campaigns, or use his office or
9 position to influence political movements or to influence the
10 political action of any officer or employe in the classified
11 service, nor shall he circulate or seek signatures to any
12 nominations or other petition required by any primary or
13 election law, nor shall he seek or accept election, nomination
14 or appointment as an officer of a political club or
15 organization, or serve as a member of a committee of any such
16 club or organization, nor shall he in any manner participate in
17 or interfere with the conduct of any election or the preparation
18 therefor at the polling place or with the election officers
19 while counting the votes or returning the election material to
20 the place provided by law for that purpose, save only for the
21 purpose of making and depositing his own ballot as speedily as
22 it reasonably can be done, nor shall he be within the polling
23 place or within fifty feet thereof, except for the purpose of
24 carrying out official duties and of ordinary travel or residence
25 during the period of time beginning with one hour preceding the
26 opening of the polls for holding such election and ending with
27 the time when the election officers shall have finished counting
28 the votes and have left the polling place for the purpose of
29 depositing the election material in the place provided by law
30 for that purpose, excepting only police officers, who may

1 temporarily approach or enter the polling place in order to make
2 any arrest permitted by law or for the purpose of preserving
3 order and in each case remain only long enough to accomplish the
4 duties aforesaid after which the said officers shall at once
5 withdraw: Provided, however, That the rights of any individual
6 as a citizen are not impaired hereby, and the prerogative to
7 attend meetings, to hear or see any candidate or nominee, nor to
8 express one's individual opinion privately, shall remain
9 inviolate.

10 Section 2193.2. Prohibition of Assessments.--No person shall
11 orally or by written or printed communication, directly or
12 indirectly, demand, solicit, collect or receive or be in any
13 manner concerned in demanding, soliciting, collecting or
14 receiving any money or valuable thing or any assessment,
15 subscription or contribution, whether voluntary or involuntary,
16 from any officer or employe of a county board of health for any
17 political purpose whatever. No officer or employe of a county
18 board of health shall orally or by written or printed
19 communication, directly or indirectly, demand, solicit, collect
20 or receive or be in any manner concerned in demanding,
21 soliciting, collecting or receiving any money or valuable thing
22 for any political purpose whatever. No person in the service of
23 the county shall remove, suspend, furlough, demote or promote or
24 in any manner change the official status or compensation of any
25 officer or employe of a county board of health or promise or
26 threaten to do so for withholding or neglecting to make any
27 contribution of money or service or other valuable thing for any
28 political purpose. No person shall take part in preparing any
29 political assessment, subscription or contribution with the
30 intent that the same shall be sent or presented to or collected

1 from any officer or employe of a county board of health, and no
2 person shall knowingly send or present, directly or indirectly,
3 in person or by letter, any political assessment, subscription
4 or contribution to, or request its payment by, any officer or
5 employe of a county board of health.

6 Section 2194. Fees and Penalties.--All fees and penalties
7 collected or received by the board or any officer thereof in his
8 official capacity shall be paid monthly to the county treasurer
9 for the use of the county.

10 Section 2195. Proceedings of Board to be Public.--The
11 proceedings of the board shall be public and its journal or
12 proceedings shall be opened to the inspection of any taxpayer.

13 Section 2195.1. Employes of Boards of Health.--The
14 recruiting, selection, tenure, removal and working conditions of
15 all personnel employed by any board of health shall conform to
16 standards of personnel administration formulated by the board of
17 health and reviewed and approved first by the county
18 commissioners and finally by the State Department of Health,
19 except that the State Department of Health shall exercise no
20 authority with respect to the selection, compensation and
21 removal of any individual employed in accordance with such
22 standards, other than the approval of the qualifications of the
23 county health director by the State Secretary of Health.

24 Section 2195.2. Program Controls.--Should the State
25 Secretary of Health find any of the activities of the board of
26 health to be incompatible with the rules, regulations, or
27 programs of the State Department of Health, he shall so advise
28 the county commissioners and the board of health which shall
29 take steps to remove such incompatibility. Should conditions
30 exist which constitute a menace to the health of the people of

1 the county, the State Secretary of Health may, after giving
2 notice which is reasonable under the particular circumstances,
3 take charge of the county board of health during the existence
4 of such menace of which remedial action has not been taken by
5 the board of health.

6 Section 2196. Definition.--Any condition or usage whatsoever
7 in or about the buildings, structures or land, or the streets or
8 private ways and places, or elsewhere within the county of the
9 third class, whether public or private, which the board of
10 health shall find to be detrimental to the public health is
11 hereby declared to be a public nuisance. Whenever in this
12 subdivision the words "public nuisance" or "nuisance" are used
13 they shall be deemed to mean a nuisance detrimental to the
14 public health, unless a different meaning is specified. The
15 powers of investigation and entering upon premises vested in the
16 board of health and its agents and employes pursuant to its
17 orders shall be available for the determination of public
18 nuisances.

19 Section 2197. Procedure for the Abatement of Public
20 Nuisances.--Whenever the board of health shall determine, after
21 such examination, investigation or hearing as shall suffice to
22 inform its judgment, that a public nuisance exists or is about
23 to exist, it may order the nuisance to be removed, abated,
24 suspended, altered, or otherwise prevented or avoided. Notice of
25 such order, bearing the official title of the board and the
26 number of days for compliance therewith and the alternative
27 remedy of the board in case of non-compliance, shall be served
28 upon the person, if any, whom the board deems responsible
29 therefor or concerned therein, and upon the owner or abutting
30 owner of the land, premises or other places whereon such

1 nuisance is or is about to be, if any. In case no such party or
2 parties can be discovered by the board, the order shall be
3 served by posting a copy or copies thereof conspicuously upon
4 the premises for a period of at least ten days.

5 Section 2198. Contents of Notice.--The notice of the board's
6 order shall clearly specify:

7 (1) The place and manner of the nuisance or anticipated
8 nuisance as determined by the board;

9 (2) The nature or condition thereof;

10 (3) The board's order with respect to the nuisance or
11 anticipated nuisance;

12 (4) The names of the persons found by the board to be
13 responsible therefor or concerned therewith and the name of the
14 owner, if any, of the land or premises involved;

15 (5) The date of the board's order and the number of days
16 therefrom allowed for compliance with it;

17 (6) The alternative remedy of the board in case of non-
18 compliance;

19 (7) Notice that the persons affected thereby may apply,
20 within the time set for compliance with the order, to the board
21 for a hearing, and may request such stay of execution or
22 modification or rescission of the said order as they shall
23 believe just and proper;

24 (8) The signature of the president of the board, attested by
25 the secretary.

26 Section 2199. Hearing; Disposition.--If any person affected
27 thereby shall apply for a hearing within the time provided, the
28 board shall promptly notify all interested parties of the time
29 and place of the hearing. The board shall enter upon its minutes
30 such facts and proofs as it may receive, and its proceedings on

1 such hearing and thereafter may rescind, modify or reaffirm its
2 order and require execution of the original or of a new or
3 modified order, as it shall determine and direct. The persons
4 affected shall be notified of the board's final order, and may
5 appeal therefrom, which appeal may operate as a supersedeas if
6 the court, upon proper cause shown, so orders, and provided the
7 appellants post bond, approved by the court, for the use of the
8 county, with sufficient surety to cover all the expense and cost
9 of executing the board's order.

10 Section 2199.1. Abatement of Public Nuisances by Board of
11 Health or County.--In any case where the persons ordered by the
12 board of health to abate or prevent a public nuisance or
13 anticipated public nuisance refuse or neglect to do so within
14 the time specified in the original or any subsequent order of
15 the board, then, unless the said order shall have been suspended
16 by appeal to the court and proper bond posted, the board may
17 direct its health officer and employes to execute the said
18 order; or if the execution of the said order requires the
19 grading, paving or repaving of private alleys or any similar
20 work upon any property whatsoever within the county or any other
21 work or service that may best be performed or contracted for by
22 the agencies and employes of the county itself, then the board
23 shall certify its order to the board of county commissioners and
24 the board of county commissioners shall thereupon proceed to
25 cause the execution of the order. In any case where the board of
26 health or the board of county commissioners thus abates or
27 prevents or causes the abatement or prevention of a public
28 nuisance, the cost and expense of such work, services and
29 materials shall be charged to the persons affected in their
30 proper proportions; and upon non-payment of such charges, the

1 county may file a lien therefor upon the affected premises in
2 the name of and for the use of the county, as provided by law
3 for municipal claims, in addition to the other remedies
4 available for the collection of debts due the county. The lien
5 shall attach as of the time the work was commenced, which shall
6 be fixed by the certificate of the health officer or of the
7 county engineer filed with the chief clerk of the county
8 commissioners.

9 Section 2199.2. Penalties.--Any person violating any
10 provision of this subdivision or any order of the board of
11 health made under the authority of this subdivision, or of any
12 law or ordinance therein referred to or authorized, or who shall
13 obstruct or interfere with any person in the execution of any
14 order of said board, or wilfully and illegally omit to obey any
15 such order, shall upon conviction thereof in a summary
16 proceeding, be sentenced to pay a fine not exceeding one hundred
17 dollars (\$100) or undergo imprisonment not exceeding ninety
18 days, or both.]

30 transportation), a county may establish, construct and provide

1 for [air navigation facilities] airports in accordance with the
2 provisions of this article. For purposes of this article, the
3 term "airports" shall be defined as provided in 74 Pa.C.S. §
4 5102 (relating to definitions).

5 Section 2202. Counties May Hold or Acquire Lands for
6 Aeronautical Purposes.--(a) Any county may use for the purpose
7 of any [air navigation facilities] airport any land within the
8 county and owned by the county when the county commissioners
9 determine such land necessary for such purposes.

10 (b) Any county may appropriate for the purposes of any [air
11 navigation facilities] airport, any lands purchased by it at any

27 as may be agreed upon between the authorities thereof and the
28 county commissioners [of the county], and such joint facilities
29 may be operated and leased, as hereinbefore provided, upon the
30 joint action of the authorities involved and the county

1 commissioners.

2 Section 2206. Engineering and Construction;
3 Appropriations.--Any county acquiring any land for any
4 [aeronautical] airport purposes may, by resolution of the board
5 of commissioners, appropriate such funds as are necessary for
6 the engineering design, surveys and construction of such
7 facilities, either wholly by themselves or in cooperation with
8 State, Federal or other public agencies supplying a portion of
9 the necessary funds for said work.

10 Section 2207. Contracts for Construction and Repairs.--In
11 establishing, maintaining and operating [air navigation] airport
12 facilities where construction and repair of roadways, runways,
13 buildings and facilities, or the purchase thereof, are deemed
14 necessary within or for use within the limits of land acquired
15 for such purpose, there shall be no necessity for submission
16 thereof to [the court of quarter sessions] any court or grand
17 jury of any county, but contracts therefor shall be entered into
18 as provided for [the general business of the county] in Article
19 XVIII, and in the case of joint establishment, operation and
20 maintenance with any other political subdivision, contracts
21 relating thereto shall be entered into as provided for the

24 Section 2208. Validation of Contracts.--Any contracts

29 purchase thereof within or for use within the limits of land

6 Section 2209. Appropriating Money to Assist Political

10 municipal corporation or other political subdivision, or
11 municipality airport authority, within such county or within any
12 adjacent county to acquire, establish, operate and maintain any

24 (b) Existing commission.--A county transit and traffic
25 commission existing on the effective date of this section may
26 continue to exist under this subdivision.

27 (c) Composition.--The county transit and traffic commission
28 shall be composed of nine members in accordance with the
29 following:

30 (1) Each of the nine members shall be residents of the

1 county in accordance with the following:

2 (i) Not more than four of the members shall be
3 residents of cities in the county.

4 (ii) Not more than two of the members shall be
5 regular employees of a publicly financed body.

29 (a.1) The commissioners may lease any estate in real
30 property owned by the county or such real property for which the

1 county is the lessee. In the case of any lease of county
2 property hereunder, such property, with any and all improvements
3 or additions thereon or thereto, shall, in the hands of the
4 lessee, be subject to taxation by such county and any other
5 political subdivision therein, in the same manner as other real
6 estate located in the county. Such taxes shall be levied and
7 assessed against and paid by the lessee. [This section shall not
8 apply to leases or sales of county property or other property
9 which are otherwise specifically provided for by law.]

10 (b) The provisions of subsection (a) shall not be mandatory
11 where county real property is to be sold to any of the
12 following:

13 (1) A [city, borough, town, township, institution district,
14 school district] political subdivision, volunteer fire company,
15 volunteer ambulance service or volunteer rescue squad located
16 within the county.

17 (2) A municipal authority pursuant to [the act of May 2,
18 1945 (P.L.382, No.164), known as the "Municipality Authorities
19 Act of 1945."] 53 Pa.C.S. Ch. 56 (relating to municipal
20 authorities).

21 (3) A nonprofit corporation or limited partnership in which
22 a nonprofit corporation is a general partner and managing agent
23 engaged in community industrial, commercial or affordable
24 housing development or reuse for its exclusive use for
25 industrial, commercial or affordable housing development. This
26 exemption shall not apply to property owned and operated by a
27 county or subcontracted or operated on the behalf of a county in
28 order to conduct existing government functions.

29 (4) A person for [his] the exclusive use of the property in
30 an industrial development program.

1 (5) A nonprofit corporation organized as a public library
2 for its exclusive use as a library.

3 (6) A nonprofit medical service corporation for its
4 exclusive use as a site for a medical service facility.

5 (7) A nonprofit housing corporation [for its exclusive use
6 for housing for the elderly or for low-income housing].

7 (8) The Federal Government.

8 (9) The Commonwealth.

9 (10) An authority pursuant to the act of August 23, 1967
10 (P.L.251, No.102), known as the "Economic Development Financing
11 Law."

12 (11) A redevelopment authority pursuant to the act of May
13 24, 1945 (P.L.991, No.385), known as the "Urban Redevelopment
14 Law."

15 (12) A public utility.

16 (13) A nonprofit organization providing community service or
17 development activities.

18 (14) A nonprofit corporation established for the
19 preservation of historical, architectural or aesthetic sites or
20 artifacts.

21 (15) A nonprofit association or nonprofit corporation
22 organized to acquire and maintain real property for the
23 preservation, conservation and stewardship of open space.

24 (16) A council of government, consortium, cooperative or
25 other similar entity created pursuant to 53 Pa.C.S. Ch. 23
26 Subch. A (relating to intergovernmental cooperation).

27 When the real property is to be sold or leased to a qualified
28 entity under this subsection, the [board of] commissioners may
29 elect to accept such nominal consideration for such sale as [it
30 shall deem] the commissioners deem appropriate. Real property

1 sold pursuant to this subsection to any entity under this
2 subsection, other than a city, borough, town, township,
3 institution district, school district, municipal authority
4 pursuant to [the "Municipality Authorities Act of 1945,"] 53
5 Pa.C.S. Ch. 56 located within the county, the Federal Government
6 or the Commonwealth shall be subject to the condition that when
7 the property is not used for the purposes of the entity the
8 property shall revert to the county.

9 (c) This section shall not apply to leases or sales of
10 county property or other property which are otherwise
11 specifically provided for by law.

12 (d) The commissioners shall provide for the transfer of any
13 interest in real property under this section by deed, or by
14 written lease, under the seal of the county, as applicable.

15 Section 2306.1. Authority to Sell Certain Real Property and
16 Personal Property as a Single Unit.--Notwithstanding any other
17 provisions of law, whenever the [county] commissioners [of a
18 county] determine that the continued ownership and operation of
19 an institution for the care of dependents is economically
20 unfeasible, the [county] commissioners may sell the real
21 property belonging to the county and being used for such
22 purposes, together with all of the contents of personal property
23 used in connection with and incidental to the operation of the
24 institution, as a single unit. Any such sale of real property
25 and personal property as a single unit shall be deemed a sale of
26 real property only and need only comply with the provisions of
27 this act relating to the sale of real property.

28 Section 92. Sections 2307, 2308, 2309 and 2310 of the act

2 lease of any real estate belonging to the county, which they are

6 Section 2308. Conveyances to General State Authority.--Any
7 county may grant, assign and convey to the General State
8 Authority, with or without consideration, any lands, easements

10 structures therein or thereon, now owned by such county or
11 hereafter acquired by it, needed or convenient as a site for a
12 county court house, or may lease to the Authority for a term,
13 not exceeding ninety-nine years, at a nominal or such other
14 rental as may be determined, any or all such lands, easements or
15 rights in lands, together with any improvements, structures or
16 buildings therein or thereon.

17 Section 2309. Leasing from General State Authority.--Any
18 county may enter into contracts with the General State Authority
19 to lease as lessee from the Authority, any county court house or
20 any improvement thereto and the furnishings and equipment
21 thereof constructed by the Authority, for a term not exceeding
22 thirty years, at such rental or rentals as may be determined by
23 the Authority. Upon the completion of such county court house or
24 improvements and the furnishings and equipment thereof, the
25 county may lease the same as lessee from the Authority for a
26 term not exceeding thirty years, at such rental or rentals as
27 may be determined by the Authority.

28 Section 2310. Acquisition of Lands for Conveyance to General
29 State Authority.--Any county may acquire lands or interests in
30 lands by purchase, gift or condemnation which may be required to

1 carry out the purposes of the two sections immediately
2 preceding.]

3 Section 93. Sections 2311, 2315, 2316, 2317, 2319, 2325 and
4 2326 of the act are amended to read:

5 Section 2311. Disposing of County Property for Other Uses;
6 Demolition.--[Whenever any new county building is constructed to
7 replace a county building no longer suitable for the purposes of
8 its use, or whenever the county has or acquires, incident to
9 purchase at tax sale or to any other acquisition of land
10 authorized by law, any building, title and interest to which is
11 in the county, and any such replaced or acquired building is
12 deemed no longer suitable or not suitable for use as a county
13 building or for use as an auxiliary to any county building, the
14 county commissioners may devote said replaced or acquired
15 building to such other public use or purpose as shall be found

19 Section 2315. Authority and Procedure for Acquiring,
20 Constructing or Altering County Buildings[; Exceptions].--(a)
21 The [county] commissioners may purchase or take by gift any
22 building at the county seat or elsewhere as authorized by law
23 deemed suitable and proper by them for use as a county building.

24 (b) The [county] commissioners may provide[, in accordance
25 with this section,] for the construction or alteration,
26 including enlargement of [a county court house, county jail,
27 prison, workhouse, detention house and such other county
28 buildings, as may be required or authorized by law. Such
29 construction or alteration shall be done at the county seat or

18 (b) Notwithstanding the separate specification provisions of
19 subsection (a), an authority organized under the act of August
20 23, 1967 (P.L.251, No.102), known as the "Economic Development
21 Financing Law," which is engaged to erect, construct or alter a
22 public purpose facility for a county of the second class A may
23 elect to use an alternative contracting procedure as follows:

24 (1) The authority may, in its sole discretion, elect to use
25 an alternative contracting procedure for a project involving
26 selected public purpose facilities. If the authority elects to
27 utilize an alternative contracting procedure, its board shall
28 adopt a resolution that the use of an alternative contracting
29 procedure is the most efficient, economical and timely method to
30 proceed with a project. Upon adoption of a resolution, the

1 authority shall request written proposals from proposers for a
2 project involving selected public purpose facilities under an
3 alternative contracting method. In its request for proposals,
4 the authority shall include such terms, conditions and
5 requirements which it deems necessary to protect the authority
6 and the interests of the public.

7 (2) In reviewing and evaluating the proposals for a project
8 involving selected public purpose facilities, the authority
9 shall, in addition to compliance with the terms, conditions and
10 requirements set forth in the request for proposals, consider
11 the following criteria:

12 (i) The cost of the project.

13 (ii) Experience of the proposer.

14 (iii) Adherence to the act of March 3, 1978 (P.L.6, No.3),
15 known as the "Steel Products Procurement Act."

16 (iv) Adherence to prevailing wage laws and other work force
17 standards.

18 (v) Commitment to enter into voluntary contracts with
19 disadvantaged business enterprises. After due consideration of
20 proposals under the criteria described in this paragraph, the
21 authority may, in its discretion, upon recommendation of its
22 designee or project end user, select a proposal and award a
23 contract to a responsible proposer under an alternative
24 contracting procedure. The award of a contract for the project
25 need not be awarded to the lowest priced proposer.

26 (3) Any contract awarded under this subsection shall be
27 exempt from the act of May 1, 1913 (P.L.155, No.104), referred
28 to as the Separations Act, or from any subsequent enactment or

1 (4) As used in this section, the following words and phrases
2 shall have the meanings given to them in this subsection:

3 "Alternative contracting procedure" shall mean a procedure
4 under which a proposer would be responsible for all aspects or

6 property. Such aspects or phases of development may include, but
7 not necessarily be limited to, the planning, design, finance,

9 "Design/build contract" shall mean a construction contract in
10 which the contractor is responsible for both the design and

30 that the contractor shall accept, in so far as the work covered

1 by any such contract is concerned, the provisions of the
2 [Workers' Compensation Act and any reenactments, supplements or
3 amendments thereto,] act of June 2, 1915 (P.L.736, No.338),
4 known as the "Workers' Compensation Act," and that the [said]
5 contractor will insure his liability thereunder or file with the

24 Section 2339.1. Scope.

25 This subdivision shall apply to counties of the second class
26 A.

27 Section 2339.2. Room or building for juvenile offenders waiting
28 trial.

29 The commissioners shall provide, furnish and heat within the
30 county a separate room or rooms or a suitable building to be

1 used exclusively for the confinement of alleged or adjudicated
2 delinquent children or dependent children as defined in 42
3 Pa.C.S. § 6302 (relating to definitions) who are in custody
4 awaiting trial or hearing in the courts of the county and
5 provide for the maintenance and care of the children while in
6 custody.

7 Section 2339.3. Management of houses for detention of juveniles
8 and appointment of board and ex officio members.

9 The management of houses for the detention and reception of
10 juveniles awaiting trial, hearing or judicial investigation
11 under the laws of this Commonwealth shall be in a board of
12 managers consisting of three county commissioners, the county
13 controller and six private citizens, three to be appointed by
14 the president judge of the court of common pleas and three to be
15 appointed by the chairperson of the board of county

8 Section 2355. Monuments [and], Memorials and Memorial Halls

15 which the United States has been or may hereafter be engaged.]
16 with a division of the armed forces of the United States.

17 Section 2356. Assistance to Private or Municipal Agencies.--
18 The [board of] commissioners may[, in order to prevent
19 duplication,] appropriate money to assist any individual,
20 private corporation[, city, borough, town or township,] or
21 municipal corporation in the erection of any monument [or
22 memorial for said soldiers, sailors and marines], memorial or
23 memorial hall authorized under section 2355.

24 Section 98. Sections 2357 and 2358 of the act are repealed:

25 [Section 2357. Erection or Completion of Monuments and
26 Memorials on Petition to Court.--Upon the petition of at least
27 fifty citizens of the county, to the court of quarter sessions,
28 for the erection or completion and maintenance at the county

11 Section 2401. Eminent Domain; County May Enter Upon Land;
12 Etc.--In all cases where the power of eminent domain is
13 conferred upon the county by law, the county may enter upon,
14 appropriate, take, injure or destroy private lands, property or
15 material.

16 Section 2402. Certain Property Not to be Taken by Eminent
17 Domain.--The power conferred by this article shall not be
18 exercised to enter upon, appropriate, take, injure or destroy
19 any church property, graveyard or cemetery, and the right-of-way

14 by publication in one newspaper of general circulation in the
15 county once and in accord with the provisions of section one
16 hundred ten of this act, of the time and place of their first
17 meeting, and shall also give notice thereof by handbills posted
18 in conspicuous places in the vicinity of the said proposed
19 public improvement.

20 (c) All the viewers shall act unless prevented by sickness
21 or other unavoidable cause, but a majority of the viewers may
22 hear, determine, pass upon and report all matters relating to
23 the view for which they were appointed.

24 Section 2409. Time of Appointment of Viewers; Cost.--(a)
25 The viewers provided for in the preceding section may be
26 appointed either before or at any time within six years after
27 the entry upon, taking, appropriating or injuring of said land,
28 property or material.

29 (b) The cost of said viewers and all court costs incurred,
30 including all advertising and notices in connection therewith,

1 shall be paid by the county, except that when the right of
2 eminent domain has been exercised by the county acting with the
3 corporate authorities of any city, borough, town or township,
4 then all costs shall be borne equally by the county and city,
5 borough, town or township.

6 Section 2410. Petition for Appointment of Viewers to Specify
7 Liens on Property.--In all proceedings hereafter instituted for
8 the condemnation and appropriation of land and property by
9 eminent domain, the petition for the appointment of viewers
10 shall contain allegations specifying any judgments, mortgages or
11 other claims (hereinafter designated "liens") which are liens
12 upon the land and property sought to be appropriated or
13 condemned as aforesaid.

14 Section 2411. Testimony and Evidence Concerning Liens.--
15 Testimony shall be taken in said proceedings to ascertain the
16 amounts of said liens and the dates of the entry of the same,
17 and the amounts of said liens and the dates of entry thereof
18 shall be found as facts by the viewers in said proceedings.
19 Certified lists of liens from the courts of the Commonwealth and
20 the United States shall be prima facie evidence of the
21 existence, dates, amounts, dates of entry and places of record
22 of said liens, and unless modified or overcome by oral or
23 documentary evidence, shall be conclusive upon the parties
24 thereto.

25 Section 2412. Procedure; Rights and Liabilities Where Liens
26 Exist.--When it appears that liens exist which are liens upon
27 property sought to be condemned and appropriated, a report of
28 the facts found shall be made to the court. Such report shall be
29 subject to exceptions in manner to be regulated by the Supreme
30 Court by general rule. When the court has finally determined the

1 findings in relation to the liens, the court shall make an order
2 directing the payment and distribution of the amount found to be
3 payable as compensation to the parties entitled thereto, first
4 to the owners of said liens, then to the owners of the property
5 appropriated as aforesaid. The parties interested shall have the
6 right of appeal from said order of distribution to the Superior
7 and Supreme Courts. Payment in accordance with the order of
8 distribution, evidenced by a receipt of record in the
9 proceedings, shall absolutely discharge the party making the
10 payment from all liens by any person, copartnership, association
11 or corporation as against said property. In such receipt and on
12 the record thereof, any claimant may reserve the right to
13 proceed against any other property or assets of the owner of the
14 property condemned for any balance due upon his lien.

15 Section 2413. Proceedings by and Before Viewers.--The said
16 viewers, having been duly sworn or affirmed faithfully, justly
17 and impartially to decide and true report to make concerning all
18 matters and things to be submitted to them and in relation to
19 which they are authorized to inquire and having viewed the
20 premises and examined the land, property or material to be
21 appropriated, injured or destroyed, shall hear all parties
22 interested and their witnesses, and, having a due regard to and
23 making just allowance for the advantages which may have resulted
24 or which may seem likely to result to the owner or owners of
25 said lands or materials in consequence of the proposed
26 improvement, shall estimate, determine and assess the damages
27 for the land, property or material taken, injured or destroyed,
28 and to whom the same is payable, and the benefits, if any, in
29 connection therewith. Having so estimated, determined and
30 assessed the damages and benefits, they shall prepare a schedule

1 thereof, and give notice to all parties to whom damages are
2 allowed or against whom benefits are assessed of a time, not
3 less than ten days thereafter, and of a place, where said
4 viewers shall meet and exhibit said schedule and hear all
5 exceptions thereto and evidence.

6 Section 2414. Notice of Meeting.--Notice of the time and
7 place of said meeting shall be given in the manner provided by
8 law for the service of summons in a personal action upon all
9 parties allowed damages and against whom benefits have been
10 assessed, as shown by said schedule, if the said parties can be
11 found in the county, or upon an adult person, if any, residing
12 upon the property affected in case the owner or reputed owner
13 cannot be found, and to all others by publication in the
14 newspaper or newspapers in which the first notices of said view
15 were published. When no service is made upon the owner, reputed
16 owner or upon an adult person residing upon the property
17 affected, said notice, where publication thereof has also been
18 made, shall be deemed to have been properly served if tacked or
19 conspicuously posted on the premises. The court may provide by
20 whom the notice provided by this act shall be posted, given and
21 served, and fix the compensation for said service.

22 Section 2415. Plans of Properties Condemned to be Furnished
23 to Viewers.--In all proceedings to assess damages for the
24 taking, injury or destruction of private property for public
25 use, the county taking, injuring or destroying property for said
26 purpose shall furnish the board of viewers with a correct plan
27 of all properties affected, showing all buildings or other
28 structures thereon, their width, length, elevation and cubical
29 contents, names of all owners, tenants or occupiers thereof, the
30 topography of the land and the grades and widths of all highways

1 running through or abutting on said properties, and all other
2 data necessary for a proper determination of the amount of
3 damages caused by the taking, injury or destruction of said
4 private property.

5 Said plans shall be prepared and ready for the use of the
6 viewers at their first meeting, and copies thereof shall be
7 furnished to all owners, tenants and occupiers of the property
8 and all other parties affected thereby without charge.

9 Section 2416. Report to Court.--After making whatever
10 changes are deemed necessary, the said viewers shall make report
11 to the court showing all the damages allowed and benefits
12 assessed in each case, and file therewith a plan showing the
13 improvement and the land, properties and materials taken,
14 injured or destroyed. When said report is filed, notice thereof
15 shall be given by publication once in the newspaper or
16 newspapers in which first notices of said view were published.
17 Said notice shall state the date of filing of the report and
18 shall contain a schedule of the damages and benefits shown
19 therein, and shall further state that, unless exceptions thereto
20 are filed within thirty days from the date of filing, the said
21 report will be confirmed absolutely.

22 Section 2417. Certain Testimony Authorized.--In all
23 proceedings arising from the exercise of the right of eminent
24 domain, it shall be competent for all witnesses called, when
25 duly qualified.

26 (1) To state in detail and costs all the elements of the
27 property before the exercise of the right of eminent domain and
28 as unaffected by it and its market value immediately after the
29 exercise of the right of eminent domain and as affected thereby.

30 (2) To state in detail and costs all the elements of benefit

1 or damage which they have taken into consideration in arriving
2 at their opinion.

3 (3) In arriving at their opinion as to the market value
4 immediately after the exercise of the right of eminent domain,
5 to add to their opinion of the market value before such exercise
6 the cost or value of all the elements of benefit or advantage
7 and to deduct therefrom all disadvantages or damage in order to
8 arrive at the market value after such exercise of the right of
9 eminent domain and as affected thereby.

10 (4) In all proceedings to assess damages or benefits for the
11 opening of any road or highway, to take into consideration as
12 one of the elements of advantage or disadvantage the cost of
13 highway improvements.

14 Section 2418. Value of Property.--In all claims for damages
15 against a county arising from the exercise of the right of
16 eminent domain, it shall be competent for the party or parties
17 claiming damages to offer in evidence the value of the property
18 affected as assessed for the purpose of taxation.

19 Section 2419. Unlawful Assessments.--In all cases of
20 appropriation of land for public use, other than for roads or
21 highways, it shall be unlawful to assess any portion of the
22 damage done to or value of the land so appropriated against the
23 other property adjoining or in the vicinity of the land so
24 appropriated.

25 Section 2420. Vacation of Road When No Property is Taken.--
26 Whenever viewers are appointed to vacate any road or highway and
27 the vacation of the same takes no land from the owner abutting
28 thereon, if, in the opinion of the viewers, such vacation
29 damages the property of the abutting owner, they may award
30 damages to such owner as though land has been actually taken.

1 Section 2421. Procedure When Building is on Line of Proposed
2 Road.--Whenever in locating, relocating, opening, widening,
3 straightening or extending any road or highway or parts thereof
4 the same shall be found to pass through, take or injure
5 buildings, barns or other valuable improvements thereon, the
6 said viewers or a majority of them shall have the right to
7 recommend that such buildings and improvements, situate in part
8 or in whole on the road or highway so to be improved, opened,
9 widened, straightened or extended, shall be permitted to remain
10 thereon for such time as shall be deemed wise and proper, and if
11 the court shall approve the finding and report of said viewers
12 or a majority of them, the owner or owners of such buildings or
13 improvements may continue to use and enjoy the same during the
14 time so fixed and determined. In case of the destruction,
15 vacation or abandonment of any such building within the time
16 they are so authorized to remain, such owners or owner shall not
17 have the right to re-erect and reconstruct or retake such
18 buildings or improvements within the line of such road or
19 highway.

20 Section 2422. Time Limit for Report of Viewers.--Viewers
21 appointed to assess the damages and benefits due to the
22 appropriation, injury or destruction of land, property and
23 materials shall make their reports within a time which the court
24 shall fix when so appointing them. If the viewers so appointed
25 shall, for any reason appearing sufficient to the court, be
26 unable to file their report within the period so fixed, the
27 court may, either before or after the expiration of the time
28 fixed, extend the time for the filing of such report.

29 Section 2425. Payment of Damages and Costs; Interest on
30 Awards.--All damages agreed upon or awarded and all costs and

1 expenses incurred shall be paid by the county, except in cases
2 where an appeal is taken by any party in interest from the award
3 of the viewers and the appellant does not recover any greater
4 amount than the viewers award, in which case the appellant shall
5 pay all costs of such appeal.

6 The amount of damages allowed in a report of viewers for the
7 taking, injury or destruction of property by the exercise of the
8 right of eminent domain shall, as finally confirmed, bear
9 interest at the rate of six per cent per annum from the date of
10 the final decree.

11 Section 2426. Collection of Awards.--Upon the final
12 confirmation of the report of the viewers, the party or parties
13 to whom an award has been made shall have the right to take such
14 further appropriate legal proceedings as may be necessary and
15 proper to enforce payment of said confirmed award, either in
16 nature of a writ of mandamus, execution or otherwise.

17 Section 2427. Title to Vest upon Payment of Award.--(a)
18 Upon payment of the compensation for land or property in
19 accordance with the order of distribution, title to such land or
20 property shall vest in the county in accordance with provisions
21 of the law under which the appropriation is made, and all claims
22 for compensation shall be deemed paid and satisfied.

23 (b) In counties of the third and fourth classes upon payment
24 of the compensation for land or property in accordance with the
25 order of distribution or upon the filing of a bond by such
26 county of the third or fourth class in an amount which shall be
27 fixed by the court having jurisdiction, which amount shall not
28 be less than the amount fixed by the viewers as the value of the
29 land or property, title to such land or property shall vest in
30 the respective third or fourth class county in accordance with

1 provisions of the law under which the appropriation is made, and
2 all claims for compensation shall be deemed paid and satisfied,
3 except where title vests by virtue of a bond having been filed,
4 seventy-five per centum of the amount of damages as fixed by the
5 viewers as the value of the land or property shall be paid to
6 the owner within six months after the date of the filing of the
7 bond and the balance due shall be determined by judicial
8 proceedings and promptly paid thereafter.

9 Section 2428. Money to be Paid Into Court in Case of Adverse
10 Claims.--(a) If any person or persons shall claim adversely to
11 each other any estate or interest in the land, property or
12 materials selected by the board of commissioners to be
13 appropriated, injured or destroyed for the purposes mentioned in
14 this act, and the viewers shall not be able to determine who are
15 the owner or owners of said land, property or materials, or the
16 value of their estates and interests therein, they shall so
17 report, valuing the land, property or materials as a whole, and
18 upon the confirmation by the court of the report of said
19 viewers, if no appeal shall be taken therefrom, the
20 commissioners of the county shall pay into the court the whole
21 of the said valuation money; thereupon, the title of the land,
22 property or material and the estates and interests of all the
23 owners thereof shall become vested in fee in the county
24 acquiring and taking said land, property or materials.

25 (b) The court of common pleas shall, by rule, process or
26 motion, require all said claimants to appear therein and may, by
27 an issue framed between them to be tried by a jury or by a
28 reference to a master or by such orders and decisions as shall
29 appear to be just under all the circumstances of the case,
30 determine the estates and interest of said claimants in said

1 valuation money. Upon the final determination of such
2 proceeding, the court shall direct said valuation money to be
3 paid to the person or persons ascertained to be entitled
4 thereto.

5 Section 2429. Appeals by Adverse Claimants.--(a) In case
6 any of said claimants shall appeal from the award of said
7 viewers, the county commissioners, upon filing in the court and
8 having approved thereby a bond in double amount of said award to
9 the said owners and claimants for the benefit of the persons
10 owning said land, property or materials, with at least two
11 sufficient sureties conditioned for the payment by the county of
12 such an amount as the owner or owners shall be entitled to
13 receive for said ground when the same shall have been finally
14 ascertained by due course of law, may lawfully enter upon and
15 take possession of said land, property or materials.

16 (b) The said court shall thereupon proceed to determine the
17 estates and interest of said claimants in said land, property or
18 material, as is hereinbefore provided when the valuation money
19 is paid into court. Said proceeding shall be finally determined
20 before the issue framed upon the said appeal shall be tried, and
21 if it be determined that the party appellant has no estate or
22 interest in said land, property or materials, his appeal shall
23 be disallowed.

24 Section 2430. Payment into Court When Award is Refused or
25 When Parties Cannot be Found.--Any amount of money awarded, as
26 herein provided, if refused by the person or persons entitled
27 thereto, or if the person or persons entitled thereto cannot be
28 found, shall be paid into court, and thereafter all such persons
29 shall look to said fund for all damages accruing by reason of
30 the appropriation, injury or destruction of such land, property

1 or material.

2 Section 2431. Notice to Vacate; Ejectment.--In case any land
3 or property selected by the board of commissioners or by the
4 board of commissioners in conjunction and acting with the
5 corporate authorities of any city, borough, town or township to
6 be appropriated, injured or destroyed, and said land or property
7 has improvements thereon in the actual occupancy of any person
8 or persons, and such person has had his, her or their damages
9 assessed and paid, thirty days' notice to vacate the same shall
10 be given to the party or parties so in actual possession. In
11 case of refusal or neglect on the part of any one to obey said
12 notice, the board of commissioners may, at the expiration of
13 said thirty days, be entitled to a writ of habere facias
14 possessionem or may enter upon and eject or cause to be ejected
15 any of the parties so refusing or neglecting to vacate, and use
16 force enough by themselves, agents or employes to accomplish the
17 same.

18 Section 2432. Appropriations of Right of Way or Easement.--
19 In any action brought to ascertain or recover damages caused to
20 any owner of lands by reason of the appropriation of a right of
21 way or easement in such lands by any county, where such owner of
22 lands and such county cannot agree upon the amount of damages
23 payable to such owner, the parties may by agreement waive the
24 right to have such damages assessed by viewers. Such owner may
25 thereupon file his statement and claim in the court of common
26 pleas and rule the defendant to plead thereto within twenty days
27 from notice of such rule duly served upon said county, and the
28 said suit shall be proceeded with the same as if an award of
29 viewers had been filed and an appeal had been taken therefrom.

30 Either party to such action shall have the right during the

1 trial to demand and have the jury which may be selected to try
2 said cause visit and view the premises over or through which the
3 right of way or easement extends before rendering a verdict in
4 such case.

5 Section 2433. Discontinuance of Proceedings by County.--In
6 case the county shall discontinue any proceedings taken
7 providing for the appropriation, injury or destruction of any
8 land, property or materials prior to the entry upon, taking or
9 appropriation thereof and before judgment therein, the said
10 county shall not thereafter be liable to pay any damages which
11 have been or might have been allowed, but all costs upon any
12 such proceedings had thereon shall be paid by the county,
13 together with any actual damages, loss or injury sustained by
14 reason of such proceeding, and the amount of the same may be
15 determined and fixed by the court in which such proceeding was
16 pending.]

18 Section 106. The act is amended by adding an article to

20 ARTICLE XXIV-A

21 EMINENT DOMAIN AND INJURY TO PROPERTY

22 Section 2401-A. Exercise of eminent domain.

23 A county may enter upon, appropriate, injure or destroy
24 private lands, property or material, or lands previously granted
25 or dedicated to public use that are no longer used for the
26 purpose for which the lands were granted, according to the
27 proceedings set forth in 26 Pa.C.S. (relating to eminent
28 domain), for any purpose conferred upon the county by law.

29 Section 2402-A. Restrictions as to certain property.

30 (a) Prohibition.--Except as provided in subsection (b), no

1 land or property used for a cemetery, burying ground or place of
2 public worship may be taken or appropriated by virtue of a power
3 contained in this article.

4 (b) Exception for certain counties.--The prohibition in
5 subsection (a) shall not apply in the case of a county of the
6 second class A where the land or property is taken or
7 appropriated according to the provisions of the act of May 12,
8 1887 (P.L.96, No.47), entitled "A supplement to an act, entitled
9 'An act supplementary to an act relative to burial grounds and
10 cemeteries situated in incorporated boroughs,' approved the
11 nineteenth day of May, one thousand eight hundred and seventy-
12 four, changing the title of said act, and authorizing the court
13 to make orders and decrees required by the act, and to enforce
14 the same by process, approved the thirteenth day of May,
15 eighteen hundred and seventy-six, further empowering courts to
16 direct removal of remains in boroughs, cities, and towns from
17 burial grounds where interments have ceased or have become so
18 neglected as to become a public nuisance, or such remains
19 interfere with the improvements, extensions, and interests of
20 such cities, boroughs, or towns."

21 (c) Restrictions as to railroad property.--In the case of
22 counties of the third through eighth classes, the right-of-way
23 of a railroad company shall not be acquired or occupied without
24 the consent of the company owning or operating or in possession
25 of the property.

26 Section 2403-A. Declaration of intention.

27 A county shall declare its intention to acquire, enter upon,
28 take, use and appropriate any private property or land for any
29 of the purposes authorized by this article through a duly
30 enacted ordinance.

1 Section 2404-A. Application of 26 Pa.C.S.

2 Eminent domain proceedings must conform to the provisions of
3 26 Pa.C.S. (relating to eminent domain), including payment of
4 damages and costs.

5 Section 107. Sections 2501, 2502, 2503 and 2504 of the act
6 are amended to read:

7 Section 2501. Acquisition of Land and Buildings for
8 Recreation Places.--(a) The county commissioners may [in any
9 county] designate and set apart for use as [public parks,
10 parkways, bridle paths, foot paths, playgrounds, playfields,
11 gymnasiums, public baths, swimming pools, agricultural
12 fairgrounds, or other indoor or outdoor recreation centers, all
13 of which shall hereinafter be referred to as recreation places,]
14 recreation places or for the enlarging or extending of
15 recreation places, any lands or buildings owned by such county
16 and not dedicated or devoted to other public use. [They may also
17 designate and set apart any such land or buildings for the
18 enlarging or extending of any such recreation places.]

19 (b) The county commissioners may also acquire [for use as
20 any such recreation place, or the extension or enlargement
21 thereof,] lands or buildings, by gift[, purchase or the power of
22 eminent domain. They may also lease lands or buildings within
23 the county for use for any such purpose.] or purchase, or may
24 lease lands for use as, or the extension or enlargement of,
25 recreation places.

26 (b.1) The county commissioners may, in accordance with the
27 provisions of this act and 26 Pa.C.S. (relating to eminent
28 domain):

29 (1) In counties of the third through eighth class, acquire
30 private property by the power of eminent domain for use as, or

1 the extension or enlargement of, recreation places.

2 (2) In counties of the second class A, acquire private
3 property for the purpose of establishing, making, enlarging,
4 extending, operating and maintaining public parks and multiuse
5 recreational trails within the limits of the county.

6 (c) [The exercise of the power of eminent domain shall be in
7 accordance with the provisions of this act.] The power to
8 acquire lands or buildings, by gift or purchase, shall not
9 extend beyond the limits of the particular county, except upon
10 the consent of the adjoining county and [municipality or
11 township] municipal corporation which would be affected thereby.

12 (d) A county may exercise the powers granted in this article
13 jointly with any political subdivision.

14 Section 2502. Construction, Equipment and Maintenance;
15 General Powers.--The county commissioners of any county may
16 build, alter, extend, enlarge, manage, supervise, equip,
17 ornament, operate and maintain recreation places, and may vest
18 their authority to do so in any existing body or board, or in a
19 park board, recreation board or fair board, any of which may be
20 established by the county commissioners [of any county, except a
21 county of the second class,] for any or all of the aforesaid
22 purposes, functions and places as the county commissioners may
23 determine. For the purpose of carrying out the provisions of
24 this article, the county commissioners, or any body or board
25 vested with their authority, may employ play leaders, recreation
26 directors, supervisors, superintendents or any other officers or
27 employes, as they deem proper. The number and salary thereof to
28 the extent that such salary is paid from the funds of the county
29 shall be determined by the salary board. All such recreation
30 places shall be kept in good order and repair.

1 Section 2503. Fair, Park and Recreation Boards.--[If the
2 county commissioners of any county shall determine that the
3 power to supervise any or all recreation places shall be
4 exercised by a park board or recreation board or fair board,
5 they may establish in said county such] The county commissioners
6 may establish a fair board, park board or recreation board,
7 which shall possess all the powers and be subject to all the
8 responsibilities of the [respective] county commissioners in the
9 management, supervision, operation and maintenance of such
10 recreation places. Any [such boards, when established,] board
11 shall consist of a minimum of five persons and a maximum of nine
12 persons. The members of such boards shall be appointed by the
13 commissioners [of the county and shall be appointed] for a term
14 to extend no longer than five years and the terms of the members
15 shall be staggered in such a manner that at least one expires
16 annually. Members of such board shall serve without pay.
17 Vacancies in such board occurring otherwise than by expiration
18 of term shall be for the unexpired term and shall be filled in
19 the same manner as original appointments.

20 [If, on the effective date of this amendment, there is a
21 recreation board established in any county that is not comprised
22 of nine members, additional persons may be appointed but if
23 there are more than nine members, vacancies shall not be filled
24 until the membership is less than nine.]

25 Section 2504. Officers of Board.--The members of a fair
26 board, park board or recreation board[, established pursuant to
27 this article,] shall elect their own chairman and secretary and
28 select all other necessary officers, to serve for a period of
29 one year, and may, with the consent and approval of the county
30 commissioners, employ such persons as may be needed, as provided

1 by this article. Such boards shall have power to adopt rules and
2 regulations for the conduct of all business within their
3 jurisdiction.

4 Section 108. Section 2505 of the act is repealed:

5 [Section 2505. Joint Action.--Any county authorized by this
6 article to acquire property for and operate and maintain any
7 recreation places may acquire property in the manner provided in
8 this article for such purposes, and operate and maintain the
9 same jointly with any other county or any city, borough,
10 township or school district.]

11 Section 109. Sections 2506, 2507, 2508, 2509, 2510, 2511,
12 2512(a) and 2513 of the act are amended to read:

13 Section 2506. Indebtedness.--The county commissioners may
14 issue bonds, in accordance with [the Municipal Borrowing Law] 53
15 Pa.C.S. Pt. VII Subpt. B (relating to indebtedness and
16 borrowing), for the purpose of acquiring lands or buildings for
17 recreation places and for the construction, extension,
18 enlargement, alteration or equipment thereof.

19 Section 2507. Payment of Expenses; Taxation; Annual Fairs;
20 State Contributions.--(a) All expenses incurred in the
21 operation of [such] recreation places, established as herein
22 provided, shall be payable from the treasury of [such] the
23 county. The county commissioners may annually appropriate and
24 cause to be raised by taxation [such tax] funds for any or all
25 of the purposes authorized in this article, including debt

27 second class A, the amount of the tax may not exceed two mills

10 to collect the rents and other considerations, including license
11 fees provided therefor.

12 Section 2509. Use of Receipts.--All rents, license charges
13 and fees, all fines, proceeds of sales, and profits of
14 whatsoever kind, to be collected, received, or realized from
15 [said] recreation places and buildings in any county, shall be
16 paid into the county treasury. Moneys or property given or
17 bequeathed to the county commissioners upon specified trusts
18 shall be received and receipted for by the county treasurer and
19 held and applied according to the trusts specified.

20 Section 2510. Damages; Forfeiture of Leases; Penalties.--(a)
21 Any person violating any rules and regulations adopted for
22 [such] recreation places shall be [further] liable to the full
23 extent of any damage by him or her committed, in trespass or
24 other action, and any tenant or licensed party who shall violate
25 any rules and regulations [or any of them], or consent to or
26 permit the same to be violated on [his or her or their] the
27 premises, shall forfeit [his or her or their] the lease or
28 license and shall be liable to be forthwith removed by a vote of
29 the county commissioners. Every lease and license shall contain
30 a clause making it cause of forfeiture for the lessee or party

1 licensed to violate or permit or suffer any violation of any
2 such rules and regulations.

3 (b) In counties of the second class A, the violation of any
4 rules or regulations of the county commissioners for the
5 government of public parks shall constitute a summary offense.

6 Section 2511. Employes; Police.--(a) For the purpose of
7 performing all necessary duties relating to the establishing,
8 making, enlarging, extending and maintaining public parks,
9 buildings and other county-owned properties and for enforcing
10 the rules and regulations ordained or resolved by the county
11 commissioners or by any body or board of control where no
12 penalty or fine is involved, the county commissioners of the
13 county are hereby authorized to employ or appoint and equip
14 proper persons, in such numbers and at such compensation as may
15 be authorized by the salary board, to do all necessary and
16 proper work connected therewith, including police or guard duty.

17 (b) The board of commissioners of any county of the third
18 class that is contiguous to a county of the second class may, by
19 ordinance, create or disband a county park police force within
20 the county. When such a county park police force is created in
21 accordance herewith, the county commissioners shall have power
22 to employ the number of officers as may be fixed by the salary
23 board of the county. The compensation of the county park police
24 officers shall be paid by the county.

25 Section 2512. Duty of Police.--(a) It shall be the duty of
26 the police, county park police or guards appointed to duty in
27 any recreation places, buildings and other county-owned
28 properties, without warrant, forthwith to arrest any offender
29 against the rules and regulations, ordained or resolved by the
30 county commissioners, that they may detect in the commission of

1 such offense, and to take the person so arrested forthwith
2 before a [magistrate, alderman or justice of the peace]
3 magisterial district judge having competent jurisdiction.

4 * * *

5 Section 2513. [Commissioners May Hold] Property Held in
6 Trust.--(a) Where the owner or owners of any real property,
7 with or without improvements thereon, adapted to the use or
8 purpose of public agriculture fairs or exhibits are willing to
9 convey or devise said real property to the county wherein
10 located, to be held in trust for the citizens and inhabitants of
11 the county, the county commissioners may take title thereto and
12 hold such real property in trust for the benefit of the citizens
13 and inhabitants of the county.

14 (b) The county commissioners may receive and accept
15 contributions in buildings or materials for additional
16 improvements on the real property conveyed or devised and held
17 in trust.

18 (c) The county commissioners may lease real property
19 acquired under this section to any incorporated agriculture
20 association willing and financially able to manage the premises,
21 on condition that the premises will be used annually for
22 agriculture fairs and exhibitions without any liability on the
23 part of the county and with no expense to the county. Upon
24 failure of any lessee to comply with terms of any lease, the
25 county shall retake possession of the leased property.

26 (d) If, for a period of five years, no public use of the
27 real property as contemplated by the grant or gift to the county
28 is made, it may be sold on petition to the court of common pleas
29 as provided by this act for the sale of county real property.

30 Section 110. Sections 2514, 2515 and 2516 of the act are

1 repealed:

2 [Section 2514. Contributions for Additional Improvements.--
3 The county commissioners of any county may receive and accept
4 contributions in buildings or materials for additional
5 improvements on the real property conveyed or devised and held
6 in trust as hereinbefore provided.

7 Section 2515. Leases for Agricultural Fairs.--The county
8 commissioners may lease real property so conveyed or devised to
9 any incorporated agriculture association willing and financially
10 able to manage said premises, on condition that said premises
11 will be used annually for agriculture fairs and exhibitions
12 without any liability on the part of the county and with no
13 expense to the county. Upon failure of any lessee to comply with
14 terms of any lease, the county shall retake possession of the
15 leased property.

16 Section 2516. Power of Sale.--If for a period of five years
17 no public use of said real property as contemplated by the grant
18 or gift to the county is made, the county commissioners may sell
19 real estate on petition to the court of common pleas as provided
20 by this act for the sale of county real property.]

21 Section 111. Sections 2517, 2601, 2604, 2611, 2612, 2616,
22 2633, 2634, 2635, 2636, 2650, 2651, 2652 and 2653 of the act are
23 amended to read:

24 Section 2517. Appropriations to Political Subdivisions for
25 Recreation Places.--The board of commissioners, in counties of
26 the third through eighth class, may appropriate moneys from the
27 county treasury to aid [cities of the third class, boroughs,
28 incorporated towns and townships] municipal corporations in the
29 purchase, construction, operation and maintenance of [lands and
30 buildings for public parks, parkways, bridle paths, foot paths,

1 playfields, gymnasiums, public baths, swimming pools, golf
2 courses, tennis courts, agricultural fair grounds, or other
3 indoor or outdoor recreation centers and facilities] recreation
4 places.

5 Section 2601. Authority to Provide Bridges, Viaducts and
6 Culverts; Definitions; Application of Article.--(a) The
7 [county] commissioners of any county may locate, lay out, open,
8 construct, reconstruct, widen, straighten, extend, otherwise
9 alter, replace, remove and in all other respects provide for
10 bridges and viaducts over streams and other topographical
11 impediments to public traffic, as parts or adjuncts of the roads
12 within the county for vehicles and pedestrians or for
13 pedestrians only, and culverts within the county or partly
14 within and partly without the county, in accordance with [the
15 procedures and requirements established by the provisions of]
16 this article. The provisions of this [section and of this]
17 article shall apply equally to all necessary approaches,
18 abutments, slopes, walls, embankments, fills, piers and other
19 things pertaining to bridges, viaducts and culverts as to the
20 bridges, viaducts and culverts themselves.

21 (b) As used in this article "streams" include streams,
22 rivers, creeks, ponds, lakes and all other such natural waters;
23 "road" includes roads, streets, highways, lanes, alleys and all
24 other such public thoroughfares; and "bridge" shall for the
25 purpose of convenience include the bridges, provided for in this
26 article, and also the viaducts and culverts and all things
27 pertaining to such bridges, viaducts and culverts wherever such
28 meanings may reasonably be intended.

29 (c) The provisions of this article shall not apply to any
30 matters relating to such county bridges, viaducts or culverts

1 [as are covered and] to the extent they are covered by the
2 provisions of the State Highway Law, or of any other law vesting
3 in the Secretary or Department of Transportation and the various
4 counties of the Commonwealth, rights, powers and duties. The
5 terms of the foregoing limitation shall apply as well in the
6 case of the Public Utility Law and the Public Utility
7 Commission.

8 (d) No county of the third through eighth class shall, in
9 the exercise of any authority or duty conferred in this article,
10 enter upon any road or property of any city or borough of, or
11 adjacent to the county, or act in derogation of the lawful
12 authority of any such political subdivision, except with the
13 proper consent of such political subdivision.

14 (e) No bridge provided for by this article shall obstruct
15 any canal or railroad, and nothing in this article shall be
16 deemed to release any railroad or other public utility from the
17 requirements of existing law.

18 Section 2604. Plans and Surveys for Bridges and Viaducts.--
19 Whenever the commissioners [of any county] resolve to provide a
20 bridge or viaduct, pursuant to this article, they shall cause to
21 be prepared plans and surveys showing the location of the
22 proposed structure, its approaches and the property or rights of
23 property affected thereby, together with any roads in any [city,
24 borough, incorporated town or township] municipal corporation
25 proposed to be used in connection therewith.

26 Section 2611. Authorization to Contract with Municipality
27 for Sharing of Certain Costs.--When any bridge is proposed to be
28 located in any municipality, the county may enter into an
29 agreement with such municipality providing that the municipality
30 shall bear a portion of the cost of the location, laying out,

1 opening, construction and maintenance of such bridge or that the
2 municipality shall provide or maintain the approach thereto
3 within the municipality or bear the costs of property damages of
4 said approach. Every [such] agreement shall be entered into in
5 writing and at least one executed copy thereof shall be
6 furnished to each party thereto. Every such bridge shall be a
7 county bridge and the duty of maintaining the same, except as
8 otherwise herein provided, shall devolve upon the county. The
9 expense thereof shall be provided out of any county funds
10 authorized for use in the maintenance of county bridges.

11 Section 2612. Bridges on Boundary Between Two Counties.--

12 (a) Whenever any bridge provided for by this article is on the
13 boundary line between two counties or within one-fourth of a
14 mile therefrom and necessary for the accommodation of the
15 inhabitants of both counties, the commissioners of such counties
16 shall act jointly in the exercise of all powers conferred upon
17 them and in the performance of all duties imposed upon them.

18 [Whenever] Except in a county of the second class A, whenever a
19 petition of residents or taxpayers is required, such petition
20 shall be made by the required number of petitioners in each
21 county in relation to a boundary bridge under this section to
22 the county commissioners of their county. Whenever any other
23 petitions are required, such petitions shall be made to the
24 county commissioners in each of such counties. Each of the
25 boards of county commissioners shall act on such petitions and
26 shall communicate its approval or disapproval to the other
27 board.

28 (b.1) If one of the counties is a county of the second class
29 A, and whenever the appointment of viewers or inspectors is
30 required, the court of each county shall appoint a full number

1 of viewers or inspectors and order a view in the manner and with
2 like powers, duties and procedure provided for in the case of
3 public roads. The total number thereof shall act together in the
4 view or inspection and shall make a joint report and
5 recommendations to each court. Exceptions to the report of
6 viewers may be filed in and appeals therefrom made to the courts
7 of either county, in which case the courts of the two counties
8 sitting together shall hear and determine the same. Whenever
9 publication of notice is required, the publications shall be
10 made in each county. The approval of both boards of
11 commissioners and of both courts shall be necessary in order to
12 authorize any action requiring such approval.

13 (c) Whenever publication of notice is required, such
14 publication shall be made in each county. The approval of both
15 boards of commissioners shall be necessary in order to authorize
16 any action requiring such approval.

17 (d) Whenever the procedure provided in Article XXIV of this
18 act is to be followed, such procedure shall be carried out only
19 in and by the county in which the lands, other property or
20 materials entered upon, taken or damaged are located and the
21 damages shall be paid by such county only.

22 (e) Any such bridge shall be a joint county bridge. All
23 costs and expenses pertaining to such bridge and the maintenance
24 thereof shall be borne by the two counties, jointly, in such
25 proportions as shall be agreed upon, from time to time, by the
26 commissioners thereof.

27 (f) For the purposes of this section, "joint county bridge"
28 shall include a bridge over the boundary line between two
29 counties constructed or proposed to be constructed as part of
30 the laying out, alteration or vacation of roads intended to form

1 a continuous highway from one county to another.

2 Section 2616. Acceptance of Bridge Donated to County.--(a)
3 The commissioners of any county may accept, take charge of and
4 enter upon the records as a county bridge, any bridge within the
5 county which has been built at the expense of private persons or
6 by public subscriptions, and has been opened to free public
7 travel, used by the public and become necessary and convenient
8 for the use of the public, upon notice in writing of the persons
9 who built it or of the subscribers to the original subscription
10 on which the money was raised to build the same, or the heirs or
11 assigns of such persons or subscribers, or of a duly authorized
12 board of trustees representing such persons or subscribers, that
13 they desire to give the bridge to the county in which it is
14 located. Where the bridge crosses the boundary line between two
15 counties, the person or the person's heirs or the assignees,
16 subscribers or trustees representing the person, shall give
17 notice in writing to the county commissioners of each county of
18 the intention to donate the bridge to the counties jointly.

19 (c) All costs shall be paid out of the treasury of the
20 county. The [county] commissioners may require the owner of said
21 bridge to file, together with their notice, a bond sufficient to
22 secure payment of the costs.

23 Section 2633. Temporary Substitutes for Bridges.--When any
24 county bridge is destroyed or rendered impassable, the [county]
25 commissioners may provide at the expense of the county, ferries
26 or other temporary ways as a substitute for such destroyed or
27 impassable bridge, until such bridge has been rebuilt or
28 rendered fit for public travel. Where [such bridge shall have
29 been] the bridge was maintained at the joint expense of two
30 adjoining counties, the establishment and maintenance of such

1 ferry or temporary way shall be by joint discretionary action of
2 the boards of commissioners of both counties, and the expense
3 thereof shall be borne by said counties in the same proportions
4 as the maintenance of [such] the bridge was borne before it was
5 destroyed or rendered impassable.

6 Section 2634. Closing, Vacating, Abandoning and Removing
7 County Bridges.--Whenever it appears to the [county]
8 commissioners that any county bridge including but not limiting
9 to any destroyed or partially destroyed bridge has, from any
10 cause, become burdensome and is no longer necessary for the
11 accommodation of public travel, they may close, vacate, abandon
12 and remove such bridge.

13 Section 2635. Contracts for Special Use of Bridge.--The
14 commissioners [of any county] may enter into a contract or lease
15 with any street railway, telegraph or telephone company or other
16 public utility, their successors or assigns, desiring to use a
17 county bridge and its approaches for other than ordinary public
18 foot or vehicular traffic for the concurrent use of such portion
19 of said public bridge and approaches as will not substantially
20 impair or restrict the public use and enjoyment thereof, upon
21 such terms and conditions as shall be agreed upon, and may
22 charge tolls or rentals for such special use. No such contract
23 or lease shall be entered into for a longer period than twenty
24 years nor shall any such contract or lease be entered into
25 unless approved by the Public Utility Commission or become
26 effective except in accordance with the provisions of the Public
27 Utility Law.

28 Section 2636. Contracts with Railroad Companies for Use,
29 Purchase, Removal, Replacing or Exchange of County Bridge.--(a)
30 Any railroad company whose tracks or other facilities are

1 located upon any county bridge may contract and agree with the
2 commissioners of the county for the use, purchase, removal,
3 replacing or exchange of such bridge, or for the compensation to
4 be paid to the county by [said] the company for the use and
5 occupancy of the bridge or [such] parts thereof [as may be used
6 and occupied by said company. For such purpose the commissioners
7 may contract with said company, and may do all acts necessary
8 and proper to carry out such contract effectually].

9 (b) All moneys due and all obligations incurred by said
10 companies under any such contract may be collected and enforced
11 in the same manner as debts of like amount are recovered and
12 similar obligations enforced in the Commonwealth.

13 Section 2650. Procedure for Taking Over Bridge by County;
14 Aid to Political Subdivisions in Construction and Maintenance of
15 Bridge.--(a) Whenever the construction of any new bridge, or of
16 any bridge to replace any existing bridge, over a stream, or
17 over or under a railroad, and forming part of any road in any
18 city, borough, town or township, or between any two or more
19 [such political subdivisions] municipal corporations is
20 necessary, and requires more expense than it is reasonable that
21 [such political subdivision, or any two of them jointly,] the
22 municipal corporations, individually or jointly, should bear,
23 and if it shall appear to the commissioners [of the county] that
24 such bridge is necessary, [and would be too expensive for such
25 political subdivision or adjoining political subdivisions to
26 bear, it] the bridge may, at the discretion of the [county]
27 commissioners, be entered on record as a county bridge. Such
28 bridge shall thereupon be erected, maintained and kept in repair
29 in the same manner as other county bridges constructed under the
30 provisions of subdivision (a) of this article.

1 (b) If the [county] commissioners refuse to have such bridge
2 entered on record as a county bridge, the county may pay the
3 entire cost or any part of the cost of constructing such bridge
4 including damages. Such bridge shall thereupon be a municipal
5 [or township] bridge to be maintained and kept in repair by such
6 [political subdivision] municipal corporation. The county
7 commissioners may, at their discretion, furnish [such political
8 subdivision] the municipal corporation the whole or any part of
9 the money necessary to maintain such municipal [or township]
10 bridge.

11 (b.1) The commissioners shall keep a record of all
12 proceedings under this section.

13 (c) [Where the cost to the county will not exceed ten
14 thousand dollars (\$10,000), the county commissioners may furnish
15 such aid in the construction of such bridge without following
16 the procedure herein stipulated.] In addition to the provisions
17 of Articles XVIII and XXIII of this act relating to contracting
18 for services and personal property, whenever the county
19 commissioners propose to build or repair a bridge upon the line
20 between the two adjoining counties, required advertising shall
21 be done in each county and a copy of the plans and
22 specifications shall be kept in the commissioner's office of
23 each county.

24 Section 2651. Change in Location of Bridge and Roads.--
25 [When] In counties of the third through eighth classes, when
26 such bridge is to take the place of an existing bridge, the
27 viewers may change the location thereof so that it may be
28 located and built in the most suitable place, or at the least
29 expense, or in the best manner, and, in the case of the change
30 of location of such bridge, they shall also report what change

1 in the course or bed of the road to be connected therewith will
2 be necessary, and shall also report the vacation of the old or
3 existing bridge, and the vacation of such portion of the road
4 connecting therewith as they may deem proper.

5 Section 2652. Construction of Embankments and Causeways as
6 County Improvements[.--Where] in Certain Counties.--In counties
7 of the third through eighth classes, where a stream over which
8 it may be necessary to build a bridge crosses a public road, and
9 the building of such bridge requires the construction of an
10 embankment or causeway leading to either end of such bridge, the
11 erection of which embankment or causeway requires more expense
12 than it is reasonable that one or more adjoining townships
13 should bear, [and if it shall appear that for the use and
14 enjoyment of said bridge by the public it is necessary to
15 construct an embankment or causeway the construction of which
16 would be too expensive for such township or townships to bear,
17 it] the bridge may, in the discretion of the county
18 commissioners, be entered on record as a county improvement and
19 constructed as county bridges are constructed.

20 Section 2653. Contract for Parts of Municipal Bridges Where
21 County Might Have Built Bridge.--(a) Where a [city of the third
22 class, a borough or a township] municipal corporation is
23 authorized to construct a bridge or viaduct over a stream or
24 other place over which the county is authorized to build bridges
25 and such [political subdivision] municipal corporation is
26 authorized to contract with the county and with railroads,
27 street railways and other companies or parties interested for
28 the building and maintenance of such bridge or viaduct and for
29 the payment of any damages caused by the location or building
30 thereof, the county commissioners may contract with such [**city,**

1 borough or township] municipal corporation for that part or
2 portion of the bridge which crosses any of the places
3 hereinbefore mentioned, including the abutments and piers
4 thereof. Such part shall thereafter be maintained as a county
5 bridge.

6 (b) In lieu of the contract above provided for, the county
7 commissioners may contract for any part or portion of the whole
8 structure equal to or greater than the part or portion which the
9 county might have built.

10 (c) The contracts provided for in this section may stipulate
11 that the county shall pay a certain portion of the whole
12 contract price or cost of the work, including damages, or may
13 stipulate that the county shall construct or pay for the
14 construction of a certain part of the work, and may otherwise
15 provide for the payment of the damages. The amount to be paid by
16 the county shall be paid directly to the contractor as may be
17 provided by the contract. The agreements may also provide for
18 the maintenance of the viaducts and bridges after their
19 erection.

20 Section 112. The act is amended by adding a section to read:

21 Section 2653.1. Contribution Where County Might Not Have
22 Built Bridge in Certain Counties.--When a bridge or viaduct is
23 built by a municipality and does not cross any place over which
24 the county is authorized to construct a bridge but crosses
25 merely railroad or railroads and private property, the
26 commissioners of counties of the second class A may contract to
27 pay an amount of money, not exceeding thirty per centum of the
28 entire cost of the proposed bridge or viaduct. The bridge or
29 viaduct shall thereafter be maintained as a municipal structure,
30 and the county shall not be liable for any part of the cost of

1 maintenance or repair thereof.

2 Section 113. Sections 2655 and 2656 of the act are amended
3 to read:

4 Section 2655. Aiding Municipality in Constructing Bridge
5 Over Ravine or Valley.--Whenever different parts of any
6 municipality or any two municipalities are separated by an
7 intervening valley or ravine, and the commissioners of the
8 county in which such municipality or municipalities are located
9 shall decide it necessary that a public bridge, to connect the
10 territories thus separated, be constructed, [such] the county
11 may contract with [such] the municipality or municipalities for
12 the laying out and construction of [such] the bridge by such
13 municipality or municipalities, and may pay to the municipality
14 or municipalities such portion of the cost thereof as the county
15 commissioners shall deem reasonable.

16 Section 2656. Entry of Municipal Bridge on Record as County
17 Bridge.--Whenever a public bridge has been built or maintained
18 by [any municipality, or by any two municipalities] one or more
19 municipal corporations, and it shall afterwards appear to the
20 commissioners that the care, maintenance and responsibility of
21 said bridge is greater than it is reasonable that the said
22 [political subdivisions] municipal corporations should bear, the
23 commissioners may enter such bridge upon record as a county
24 bridge, and it shall thereafter be a county bridge in the same
25 manner as if it had originally been so entered on record, if the
26 proper local authorities having the maintenance, supervision and
27 control of such bridge shall tender the same to the said county
28 [commissioners] free and without charge.

29 Section 114. Section 2670 of the act is repealed:

30 [Section 2670. Building or Repair of Bridges.--In addition

1 to the provisions of Articles XVIII and XXIII of this act
2 relating to contracting for services and personal property,
3 whenever the county commissioners propose to build or repair a
4 bridge at a cost in excess of ten thousand dollars (\$10,000)
5 upon the line between two adjoining counties, the advertising
6 shall be done in each of said counties, and a copy of the plans
7 and specifications shall be kept in the commissioners' office of
8 each county.]

9 Section 115. Sections 2701, 2702, 2703 and 2704 of the act
10 are amended to read:

11 Section 2701. Definitions.--The words defined in section
12 [two thousand six hundred one of this act] 2601 shall be
13 construed to have like meanings when used in this article.

14 Section 2702. Establishing County Roads.--(a) For the
15 purpose of providing public roads, specially constructed,
16 improved and maintained, the county commissioners may[, upon
17 approval by the court of quarter sessions, originally lay out
18 and open any road, and take possession of and exercise control
19 over any existing township road or part thereof, and build and
20 maintain roads as county roads within their respective limits.
21 They may, at any time, straighten, widen, extend and alter any
22 such road or part thereof, and vacate so much thereof as may
23 become unnecessary and useless. Any road so]:

4 county road and be subject to the control and supervision of the
5 county commissioners. It shall be the duty of the county to keep
6 and maintain county roads established under this act and all
7 other county roads in repair, the expense thereof to be paid by
8 the county in the manner hereinafter provided.

9 Section 2703. Acquisition of Rights of Way of Abandoned
10 Railroads.--(a) The county commissioners [of any county] may
11 take over any abandoned rights of way or bridge of a railroad
12 company or any part thereof for the purpose of relocating any
13 existing or locating a new county road, and they may purchase
14 such abandoned right of way or bridge or such part thereof, as
15 may be necessary for the relocating or locating of said county
16 road, from the owner thereof[, at a fair price, to be approved
17 by the court of quarter sessions of the county].

18 (b) Whenever [any such] an abandoned right of way or bridge
19 of a railroad company or any part thereof is purchased under the
20 provisions of this section, a county road shall be laid out and
21 located thereon and shall thereafter be constructed, improved

23 taken over shall become a county bridge and shall be maintained,
24 rebuilt and repaired accordingly.

25 Section 2704. Joint Action by Counties.--The provisions of
26 this article may also be exercised jointly by adjoining counties

29 The procedure and jurisdiction in each county in such cases
30 shall be the same as to any portion of such road lying within

1 its limits, except that the petition, plans and surveys of such

5 [several portions thereof] portions of the road lying within
6 limits of each county shall be treated in all proceedings as one
7 continuous road.

8 Section 116. Section 2705 of the act is repealed:

9 [Section 2705. To Be County Road as Soon as so Decreed.--All
10 roads and parts thereof heretofore and hereafter decreed by the
11 court, under this or any former acts of Assembly, to be a county
12 road shall be subject to the control and supervision of the
13 county commissioners. Upon the decree or order making an
14 existing township road or part thereof a county road, the same
15 shall immediately be kept in repair, made, constructed and
16 maintained by the county and the township relieved of any duty
17 thereto as a township road.]

18 Section 117. Sections 2706, 2707, 2708, 2709, 2710, 2721,
19 2722 and 2723 of the act are amended to read:

20 Section 2706. Maintenance and Repair of County Roads.--The
21 commissioners shall have prepared plans and estimates, as often
22 as required, for the repair and maintenance of all roads which
23 the county is required by law to maintain and repair. [They may
24 invite proposals for maintaining and repairing such roads or
25 parts thereof in accordance with such plans and estimates and
26 award the contract therefor in like manner as contracts for new
27 improvements, or they may make the necessary repairs themselves.
28 For the purpose of making such repairs, the commissioners may
29 employ or appoint the proper persons and buy the necessary
30 materials and buy or rent the necessary machinery.] Maintenance

1 and repair may be undertaken by contract or through the use of
2 county personnel, supplies and equipment. Any county may also
3 lease any of its [machinery] equipment to any political
4 subdivision within the county, upon such terms and conditions as
5 may be agreed upon.

6 Section 2707. Annual Tax.--The commissioners may levy,
7 assess and collect [an annual tax, of not more than two mills
8 upon the dollar,] annual taxes upon all real and personal
9 property within said county taxable for county purposes for the
10 purpose of acquiring and securing a fund from which to pay all
11 costs, damages and expenses required in the locating, opening,
12 building, improving, widening, straightening, extending,
13 maintaining, repairing or vacating of roads or parts thereof
14 [covered by the provisions of subdivision (a) 1 of this
15 article], and for the taking and use of [such] land as may be
16 necessary in constructing and maintaining proper slopes,
17 embankments, fills [and], culverts, embankment approaches and
18 termini for roads, tunnels, subways and underground roads. The
19 moneys so raised shall not be expended for any other purposes
20 [than those named in this section] other than those for which
21 the tax was levied, except for the maintenance, repair,
22 construction and reconstruction of any county bridge or bridges
23 whether or not located on a county road or roads. [All checks
24 for the payment of any portion of the money raised for the
25 purposes aforesaid shall be issued, in the manner provided by
26 this act, upon estimates which shall be made from time to time
27 by the persons charged with such duty. The amount and time
28 within which the same shall be paid shall be fixed and
29 determined in the contract made for the public work.] The taxes
30 shall be at the following rates, and retained, respectively, for

1 the following purposes:

2 (1) Not more than two mills on the dollar for any purpose
3 set forth in subdivision (a) 1 of this article.

4 (2) Not more than two mills on the dollar for any purpose
5 set forth in subdivision (a) 2 of this article.

6 (3) Not more than two mills on the dollar for any purpose
7 set forth in subdivision (a) 3 of this article.

8 Section 2708. Borrowing Money; Bond Issue and Tax Levy.--The
9 county commissioners may borrow money and secure any
10 indebtedness created by them for the purposes authorized under
11 [subdivision (a) 1 of this article, by issuing bonds in
12 accordance with the provisions of the Municipal Borrowing Law]
13 this article, in accordance with 53 Pa.C.S. Pt. VII Subpt. B
14 (relating to indebtedness and borrowing).

15 Section 2709. Changing Part of Road [Without View] Upon
16 Agreement.--Whenever the board of commissioners deem it
17 advisable to construct or alter any part of any road under their
18 supervision and can agree with the property owners affected by
19 such change as to damages, they may, upon payment of the damages
20 agreed upon, construct or alter such part of such public road as
21 contemplated in such agreement without the formality of a view.
22 [This authority shall not extend to any construction or
23 alteration, the cost and expenses of which to such county,
24 including damages, shall exceed one thousand dollars (\$1000). A
25 petition setting forth the facts, accompanied by a map or draft
26 of such proposed change, shall be presented to the court of
27 quarter sessions for approval before such actual change is made,
28 whereupon the new location, thus approved by the court, shall be
29 the public road to all intents and purposes and the old location
30 shall be vacated.] The old location of the road shall be vacated

1 in accordance with this act.

2 Section 2710. Assessment of Benefits.--Whenever, in any
3 county, any road or highway shall be originally located, laid
4 out or constructed or relocated, opened, straightened, widened,
5 extended or altered, or any part thereof vacated, the viewers
6 appointed to assess damages [for taking, injuring or destroying
7 property] in accordance with 26 Pa.C.S. (relating to eminent
8 domain), after having determined the amount of damages
9 sustained, shall assess the whole or such part of such damages
10 as may be represented by benefits upon the properties abutting
11 on and benefited by [such] the improvements. The remaining part
12 of such damages, if any, not so assessed against the abutting
13 properties, shall be paid by the county. The total assessments
14 for benefits shall in no case exceed the total damages awarded
15 and agreed upon.

16 [The viewers shall in such cases file their report showing
17 the balance struck between the damages awarded and the benefits
18 assessed.]

19 Section 2721. Improvement of [Borough and Township]
20 Municipal Roads.--Whenever such system of main thoroughfares had
21 been adopted or when the adoption thereof is contemplated within
22 two years after the commencement of such improvement, the
23 commissioners may[, upon approval by the court of quarter
24 sessions as hereinafter provided,] take exclusive control of and
25 improve any road or section thereof located either wholly or in
26 part[,] in any [borough or township] municipal corporation,
27 whether existing by their authority or laid out in whole or in
28 part by virtue of this act or otherwise. For that purpose, they
29 may originally locate, lay out, establish in whole or in part
30 relocate, straighten, widen, extend, alter and open roads, and

1 construct and improve the same, and vacate so much of any roads
2 as may be thereby rendered unnecessary and useless. Any road as
3 established or altered, constructed and improved, under the
4 provisions of this section, shall, by ordinance enacted by each
5 [borough or by resolution adopted by the commissioners or
6 supervisors of each township] municipal corporation through
7 which such road shall pass, become [borough or township]
8 municipal roads, and the duty of maintaining and keeping the
9 same in repair shall devolve upon each respective [township or
10 borough] municipal corporation through or into which the same
11 extends.

12 Section 2722. Plan of System to Be Followed; Variations.--
13 After such plans have been adopted and recorded pursuant to law,
14 all applications under the preceding section [to the court of
15 quarter sessions] shall be restricted and shall relate only to
16 the establishing, opening, construction and improvement of the
17 proposed roads of said system or parts thereof and the vacation
18 of roads supplied by the portion opened and improved. The
19 commissioners[, upon approval by the court of quarter sessions
20 as hereinafter provided,] may relocate, straighten, widen,
21 extend, alter and open, construct and improve, the proposed
22 roads as laid out, surveyed, marked and shown upon the plans of
23 said system, or to originally locate, lay out and establish,
24 construct and improve roads which substantially supply said
25 system or parts thereof which, although not parts of said
26 system, are deemed by the court to be main thoroughfares of
27 sufficient importance to be improved by the county and to be
28 added to said plan, and in such case to vacate so much of the
29 roads of the system and of roads already established as may be
30 rendered unnecessary by the changes or by an entirely new

1 location.

2 Section 2723. Improvement of Roads Not Part of System on
3 Contribution From Parties Interested.--The commissioners may
4 also originally locate, lay out and establish in whole or in
5 part, relocate, straighten, widen, extend, alter and open,
6 construct and improve roads not parts of said system nor deemed
7 main thoroughfares, upon parties interested therein paying or
8 securing to be paid[, in a manner to be approved by the court of
9 quarter sessions,] such proportion of the cost of the original
10 construction and improvement as the commissioners may deem just,
11 which shall not be less than one-fourth of the cost in any case.

12 Section 118. Sections 2724 and 2725 of the act are repealed:

13 [Section 2724. Annual Tax.--The commissioners may levy,
14 assess and collect an annual tax, of not more than two mills
15 upon the dollar, upon all real and personal property within the
16 county taxable for county purposes, for the purpose of acquiring
17 and securing a fund from which to pay all costs, damages and
18 expenses required in locating, opening, widening, straightening,
19 extending, building, improving, maintaining, repairing or
20 vacating of the roads or parts thereof improved under the
21 provisions of subdivision (a) 2 of this article, and for the
22 taking and using of such land as may be made necessary in
23 constructing and maintaining proper slopes, embankments, fills
24 and culverts. The moneys so raised shall not be expended for any
25 other purposes than those named in this section. All checks for
26 the payment of any portion of the money raised for the purposes
27 aforesaid shall be issued, in the manner provided by this act,
28 upon estimates which shall be made from time to time by the
29 person charged with such duty, and the amount and time within
30 which the same shall be paid shall be fixed and determined in

1 the contract made for the public work herein authorized.

2 Section 2725. Borrowing Money and Bond Issue.--Any county
3 may borrow money and secure such indebtedness by issuing bonds
4 in accordance with the provisions of the Municipal Borrowing Law
5 for the purpose of building and improving the roads or any part
6 thereof constructed under the provisions of subdivision (a) 2 of
7 this article.]

8 Section 119. Sections 2730, 2731 and 2732 of the act are
9 amended to read:

10 Section 2730. Purchase, Location, Construction, Operation
11 and Maintenance Authorized.--Whenever the county commissioners
12 shall deem it expedient [so to do and upon the approval thereof
13 by the court of quarter sessions as hereinafter provided], they
14 may cause to be purchased, located, constructed, operated and
15 maintained roads, tunnels, subways or underground roads anywhere
16 within the county, either wholly or partly within the boundaries
17 of any [city, borough, town or township] municipal corporation.
18 Any road, tunnel, subway or underground road, purchased or
19 constructed under the provisions of subdivision (a) 3 of this
20 article, shall forever thereafter be a county road, tunnel,
21 subway or underground road, and the duty of maintaining and
22 keeping the same in repair shall devolve upon the county. The
23 expense thereof shall be paid by the county as hereinafter
24 provided.

25 Section 2731. Contracts or Lease for Special Use of
26 Improvements.--The commissioners[, subject to the approval of
27 the court of quarter sessions,] may make a contract or lease
28 with any street railway or transportation company, its
29 successors and assigns, for the concurrent use of such a portion
30 of said road, tunnel or subway or underground road, as shall not

1 substantially impair or restrict the public use and enjoyment
2 thereof, upon such terms and conditions as shall be agreed upon.
3 [No such contract or lease for the concurrent use of a portion
4 of such improvement shall be for a longer term or period than
5 twenty years. Any such contract or lease shall be made in
6 accordance with applicable provisions of the Public Utility
7 Law.]

8 Section 2732. Taking Street or Other Property of [City or
9 Borough] Municipal Corporation.--Should the commissioners of any
10 county deem it necessary or advisable to enter upon or
11 appropriate any road or property of any [city or borough]
12 municipal corporation in the county, or take any other action
13 affecting the property rights or authority of such [city or
14 borough] municipal corporation, for the purpose of constructing
15 or maintaining a road, tunnel, subway or underground road, or in
16 connection with the improvement of any of them, which has been
17 or is about to be purchased by the county or otherwise, the
18 consent thereto of such [city or borough] municipal corporation
19 by ordinance shall be obtained before the actual entering in or
20 upon or the appropriation of such road or property. After such
21 entry and appropriation, the county shall be liable and charged
22 with the supervision, control and maintenance of said roads and
23 properties, or so much thereof as is taken and used for the
24 purpose of constructing and maintaining such road, tunnel,
25 subway or underground road, or in connection with the
26 improvement of any of them, purchased or to be purchased as
27 aforesaid.

28 Section 120. Sections 2733, 2734, 2740, 2741, 2742, 2743,
29 2744 and 2745 of the act are repealed:

30 [Section 2733. Annual Tax Levy.--The commissioners may levy,

1 assess and collect an annual tax, of not more than two mills on
2 the dollar, on all real and personal property within the county
3 taxable for county purposes for the purpose of acquiring and
4 securing a fund from which to pay all costs, damages and
5 expenses required in the purchasing, improving, locating,
6 opening, constructing, maintaining and repairing roads, tunnels,
7 subways and underground roads, purchased or constructed under
8 the provisions of subdivision (a) 3 of this article, and the
9 taking and using of such land as may be made necessary in
10 constructing the same and in maintaining proper slopes,
11 embankments approaches and termini for said roads, tunnels,
12 subways and underground roads. The money so raised shall not be
13 used or expended for any other purposes than those herein named.
14 All checks for the payment of any portion of the money raised
15 for the purposes aforesaid shall be issued, in the manner
16 provided by this act, upon estimates which shall be made from
17 time to time by the person charged with such duty. The amount
18 and time within which the same shall be paid shall be fixed and
19 determined in the contract made for the public work herein
20 authorized.

21 Section 2734. Borrowing Money and Bond Issue.--Any county
22 may borrow money and incur indebtedness in accordance with the
23 provisions of the Municipal Borrowing Law, to an amount not
24 exceeding the constitutional limitations, for the purchase and
25 improvement or construction of such roads, tunnels, subways and
26 underground roads.

27 Section 2740. Procedure to Obtain Approval of Quarter
28 Sessions.--(a) When the county commissioners resolve to
29 exercise any of the powers conferred in subdivision (a) of this
30 article, they shall cause to be prepared surveys and plans of

1 such road or tunnel, subway or underground road showing the
2 improvement proposed to be made, together with any proposed
3 changes in existing roads, and they shall present such surveys
4 and plans, together with their petition, on behalf of such
5 county, to the court of quarter sessions, praying for approval
6 of such proposed exercise of powers. Such petition shall briefly
7 describe the proposed improvement and the estimated cost thereof
8 and, if the method of construction has not been fully
9 determined, the estimated cost thereof according to each of the
10 several methods in which the improvement may practically be
11 made.

12 (b) On the filing of such petition, the court shall fix a
13 time for a hearing thereon. Notice of said hearing shall be
14 given, by an advertisement published at least ten days prior to
15 the hearing in two newspapers of general circulation in the
16 county, which notice shall briefly describe the location of the
17 improvement proposed to be made and the time, place and purpose
18 of said hearing. Upon the hearing thereof, the court may, for
19 proper cause shown, disapprove the petition; otherwise, it shall
20 approve the same and order that the improvement be made and
21 constructed in accordance with the plans and surveys
22 accompanying the petition. Thereupon, any original location,
23 relocation, opening, widening, straightening, extension,
24 alteration or vacation of any road as set forth in the
25 proceedings and the right to proceed with such improvement shall
26 become absolute.

27 (c) The words "improved" or "improvement" as herein used
28 mean each and every power conferred upon counties under the
29 terms of any of the preceding sections of this article.

30 Section 2741. Right of Eminent Domain.--For the purposes

1 described in subdivision (a) of this article, the county
2 commissioners may enter upon private or public property and may
3 take, injure and destroy the same in the manner and subject to
4 the restrictions and procedure prescribed by Article XXIV of
5 this act.

6 Section 2742. Contracts for Improvements.--After said
7 surveys and plans and the petition to the court of quarter
8 sessions have been approved by the court, and the road, tunnel,
9 subway or underground road, ordered to be made and constructed
10 in accordance therewith, the commissioners shall invite
11 proposals and let contracts for the making and constructing of
12 the same or such parts of the same as the commissioners shall
13 deem proper, in accordance with the provisions of Article XVIII
14 of this act and of sections two thousand three hundred eighteen
15 and two thousand three hundred nineteen and such provisions of
16 Article XXVI of this act as establish additional requirements
17 for advertising for bids, for inspection of plans and
18 specifications by bidders, and for the dating and marking of
19 bids filed.

20 Section 2743. Procedure Where Property is Left Without
21 Outlet by Reason of Vacating of Part of Old Road.--Whenever, by
22 reason of the relocating, opening, widening, straightening or
23 extending of any road or any part thereof, any part of the road
24 involved becomes useless and is vacated, and the property of one
25 owner shall intervene between the new road and the lands of
26 another owner, having no outlet by reason of said relocation,
27 opening, extending, straightening and widening, it shall be the
28 duty of the said county commissioners to obtain from the owner
29 of said intervening property and the owner of the formerly
30 contiguous or adjoining land an agreement satisfactory to such

1 parties for providing an outlet for the said land. If the
2 parties shall not agree to the transfer of the properties so
3 intervening upon the new road, and any such lot or piece of
4 land, in the opinion of the said county commissioners, be
5 insufficient for building purposes, it shall be taken and used
6 as part of said road or highway.

7 Section 2744. Parties Making Application for New Road to
8 Notify Local Road Authorities.--In all cases wherein any
9 proceedings are about to be had before the county commissioners
10 or court for the laying out, opening and construction of new
11 roads for public use, it shall be the duty of the parties making
12 application to the commissioners or to the court for the
13 appointment of viewers, reviewers or re-reviewers to lay out,
14 open or construct such road, to give written notice of such
15 application to the supervisors or commissioners of the territory
16 through which the proposed road is designated to be laid out and
17 constructed, of the time and place of such application, and the
18 time and place of the meeting of viewers, reviewers and re-
19 reviewers. A copy of said written notice, properly attested,
20 shall be filed among the records of the court having cognizance
21 of the matter. Failure to comply with the provisions of this
22 section as to such notice shall be sufficient grounds for an
23 application to set aside whatever proceedings may have been
24 taken of which said supervisors or commissioners had no written
25 notice.

26 Section 2745. Unlawful to Raise Road Above Ordinary Grade
27 Over Drain or Culvert.--In the construction or repair of any
28 road, it shall be unlawful for the person or persons in charge
29 of such construction or repair to raise such road or permit the
30 same to be raised or elevated above the ordinary grade thereof,

1 when a drain or culvert shall be constructed under such road or
2 when such road shall be constructed or repaired over such drain
3 or culvert.]

4 Section 121. Sections 2750, 2753, 2756, 2757, 2758, 2759 and
5 2760 of the act are amended to read:

6 Section 2750. Vacation as County Roads.--Upon petition of
7 the county commissioners, the court of [quarter sessions] common
8 pleas may vacate as a county road any portions of any abandoned
9 or condemned [turnpike] road, or any portions of any [turnpike]
10 road purchased by the county, or of any road, the permanent
11 location or improvement whereof has been ordered or made under
12 this or former acts relating to county roads. All portions of
13 such roads so vacated shall become [and be township roads] and
14 be roads of the municipal corporation through which they pass.
15 Written notice of the contents of said petition and the time
16 when the same will be presented to the court shall be given by
17 the county commissioners to the [supervisors or commissioners of
18 the township or townships] governing body of the municipal
19 corporation through which said road passes, at least ten days
20 before the date of presenting the same. At the time said
21 petition is presented, the court may fix a time for hearing in
22 open court, or may refer the matter to an examiner to take
23 testimony and report his findings to the court at such time as
24 the court shall direct. At any hearing in open court or before
25 an examiner appointed by the court, all parties in interest may
26 appear and be heard. After such hearing, the court, if it shall
27 find that the conditions prescribed by this act have been
28 complied with, may grant the [prayer] request of the petitioners
29 and make a decree accordingly or make such order in the premises
30 as it deems right and just. No order of vacation shall be made

1 until the [township] municipal corporation affected shall have
2 consented thereto by an ordinance or resolution certified to the
3 court.

4 Section 2753. Laying Out; Altering; Vacating.--Roads forming
5 or intended to form a continuous highway from one county to
6 another, which cross a river, creek or rivulet forming a
7 boundary line between said counties, may be laid out or altered
8 or vacated in the manner provided in the case of other roads.[,
9 except that the court of quarter sessions of each county shall
10 appoint three viewers and that a report as aforesaid shall be
11 made to each court respectively, and that each court shall
12 otherwise have and exercise concurrent jurisdiction therein.]

13 Section 2756. Municipal Streets Connecting Two Ends of
14 County Road.--When a city or borough intervenes between two ends
15 of a county road, and the [municipality] municipal corporation
16 has failed to properly improve the municipal streets
17 constituting the shortest and most reasonable route through
18 [said municipality which] the municipal corporation that will
19 connect the two ends of such county road, the board of
20 commissioners may contract with the [corporate authorities of
21 the municipality that] governing body of the municipal
22 corporation to improve the shortest and most reasonable route
23 [through said municipality] connecting the two ends of such
24 highway [be improved].

25 Section 2757. Municipal Streets as Terminus of County
26 Road.--(a) When a county road terminates at the corporate
27 limits of a city or borough in the same or in another county and
28 connects with a municipal street which the [municipality]
29 municipal corporation has failed to properly improve, and the
30 commissioners of the county in which the [municipality]

1 municipal corporation is located deem the improvement of such
2 municipal street necessary in order to make such county road
3 easily accessible to [the residents of the municipality]
4 residents or to the traveling public, the county commissioners
5 may contract with the [corporate officials of the municipality
6 that such municipal street or any part thereof be improved, and
7 also that there be improved, when necessary, any parts of the
8 streets connected therewith which connect said] governing body
9 of the municipal corporation to improve municipal streets,
10 including, where necessary, streets connecting a county road
11 with the business districts of [said municipality] the municipal
12 corporation or with a system of improved streets therein or
13 which connect the said road with another county road terminating
14 at the limits of [said municipality] the municipal corporation.

15 (b) If several [municipalities] municipal corporations are
16 contiguous to each other and at the corporate limits of any one
17 of them a county road terminates and one or more [of such
18 municipalities] have failed to properly improve any municipal
19 street therein, and the county commissioners deem the
20 improvement of such street necessary in order to make such
21 county road easily accessible to [the residents of the
22 municipality] residents or to the traveling public, the board of
23 commissioners may enter into a similar contract with [the
24 corporate authorities of such municipality or municipalities]
25 any of the municipal governing bodies.

26 Section 2758. Improvements.--The board of commissioners may
27 widen, repave or otherwise improve said municipal streets
28 whenever the same is necessary to accomplish any of the purposes
29 of sections [two thousand seven hundred fifty-six and two
30 thousand seven hundred fifty-seven] 2756 and 2757 of this act.

1 Whenever such improvement is made to a municipal street, the
2 county may pay the total cost of such improvement, or the cost
3 may be divided between or among the [municipality or
4 municipalities] municipal corporations and the county. [The
5 contract for any such improvement may be taken by the county
6 upon the stipulation by any municipality to pay its
7 proportionate share of the cost, if any, upon the completion of
8 the work, or it may be taken by any municipality upon a like
9 stipulation of the county, or the improvement may be made by
10 joint contract.]

11 Section 2759. Maintenance.--Before any municipal street is
12 so improved, the board of commissioners and the [council of such
13 municipality] governing body of the municipal corporation shall
14 agree upon the maintenance of such street. Such agreement may
15 provide that such street shall be kept and maintained in good
16 repair by the [municipality] municipal corporation, in which
17 case, upon the completion of said improvement, all further
18 liability and responsibility of the county shall [cease and
19 determine] terminate, or it may provide that it shall be kept
20 and maintained in good repair by the county and the share of the
21 [municipality] municipal corporation shall be paid annually to
22 the county.

23 Section 2760. Contracts With [Borough, Township or
24 Incorporated Town] Municipal Corporations.--(a) The board of
25 commissioners may contract with the [authorities of any borough
26 or township or any incorporated town] governing bodies of
27 municipal corporations, separately or jointly, providing that
28 the commissioners shall construct an improved road in a similar
29 manner as a county road. The expense or cost of said
30 construction shall be borne jointly by the [borough, township or

1 incorporated town] municipal corporations and the county in such
2 ratio or proportions as may be agreed on in said contract or
3 contracts, irrespective of whether the [municipality] municipal
4 corporation intervenes between two ends of the county road or
5 not, or whether [or not the municipality] it is the terminus of
6 a county road, State highway or township road.

7 (b) Payment for the construction of roads under this section
8 shall be made by the county, which shall be reimbursed by the
9 municipal corporation in such sums as agreed upon in said
10 contract or contracts.

11 (c) Any road jointly constructed under this section shall be
12 repaired and maintained at the expense of the county, but
13 nothing shall prevent the governing body of a municipal
14 corporation from entering into a contract or contracts with the
15 county for the maintenance of said improved road under such
16 terms and conditions as may be mutually satisfactory.

17 Section 122. Sections 2761 and 2762 of the act are repealed:

18 [Section 2761. Payment.--Payment for the construction of
19 said road or roads shall be made by the county, which shall be
20 reimbursed by the borough, township or incorporated town in such
21 sums as agreed upon in said contract or contracts, upon
22 presentation to them, from time to time, of estimates and bills
23 for work already performed and paid for.

24 Section 2762. Repair and Maintenance.--Any such road,
25 constructed jointly, shall be repaired and maintained at the

1 Section 123. Section 2763 of the act is amended to read:

2 Section 2763. Where Center Line of Highway is Boundary

3 Between City or Borough and Township.--(a) Whenever the center

4 line of any road constitutes the dividing line between any city

5 or borough and a township located in the same county, the board

6 of county commissioners and the commissioners or supervisors of

7 such township may enter into a contract with the city or borough

8 providing for the grading, curbing and macadamizing or paving of

9 the roadway of said road. The cost thereof shall be borne one-

10 half by the city or borough and one-half by the county and

11 township, in equal portions.

12 (b) Alterations or improvements under this section shall be

28 governing the construction of such alterations or improvements

29 in said city or borough, and in further compliance with plans

30 and specifications to be agreed upon in writing between the said

1 city or borough and the board of commissioners of the county and
2 commissioners or supervisors of the township. The cost of
3 repairs shall be borne one-half by the city or borough and one-
4 half by the township, or by the county and township in equal
5 portions or such other proportion as may be agreed upon by the
6 county and township.]

7 Section 125. Section 2765 of the act is amended to read:

8 Section 2765. Where Center Line of Road is Boundary Between
9 City or Borough and Township in Adjoining County.--(a) Whenever
10 the center line of any road constitutes a dividing line between
11 a township and a city or borough located in an adjacent county,
12 the board of commissioners of the county and the commissioners
13 or supervisors of such township may enter into a contract with
14 the city or borough providing for the grading, curbing,
15 macadamizing or paving of the roadway of said road. The cost
16 thereof shall be borne one-half by the city or borough and one-
17 half by the township and the county in which such township shall
18 be situated, in equal portions.

19 (b) Alterations or improvements under this section shall be

1 [Section 2766. Alteration, Improvement and Repairs.--Said

5 construction or improvement by such city or borough, and in
6 further compliance with plans and specifications to be agreed
7 upon in writing between such municipality and board of
8 commissioners of the county and the commissioners or supervisors
9 of the township. The cost of repairs shall be borne one-half by
10 the municipality and one-half by the township, or by the county
11 and township in equal portions or such other proportion as may
12 be agreed upon by the county and township.]

13 Section 127. Section 2767 of the act is amended to read:

14 Section 2767. Improvement on Order of Common Pleas.--(a) In
15 all cases in which it shall be found impossible to enter into
16 [such] contracts or agreements under section 2765, or where
17 either the city or borough and the township or the county in
18 which such township is situated shall refuse to enter into such
19 contract or agreement, either [the municipality] a municipal
20 corporation or the county [or township] may present its petition
21 to the court of common pleas of either county setting forth the
22 facts and circumstances, including the condition of the road
23 from which the necessity and desirability for the grading,
24 curbing, macadamizing or paving of the roadway appears, and the
25 estimated cost thereof, and that the terms of such contract
26 cannot be agreed upon by the [municipality and county or
27 township] municipal corporations and the county, or either or
28 any of them, or that either such [municipality or the county or
29 township] municipal corporations or the county or any of them

1 (b) The petition may [pray] request that the court, after
2 hearing all the parties concerned, make its order or decree

7 provided for. A copy of said petition, duly certified, shall be
8 served upon the [municipality or county and township] municipal

15 reasonable the township should bear, the court of quarter
16 sessions having jurisdiction shall, on the representation of the

28 Section 2769. Improvements of Roads Connecting With State
29 Highway.--The county may, singly, or jointly with any [city or
30 borough] municipal corporation, appropriate and expend moneys

1 for the improvement of any road, not more than one mile in
2 length in distance, outside of the limits of such [city or
3 borough] municipal corporation, for the purpose of connecting
4 improved streets in such [cities or boroughs] municipal
5 corporations with a State highway.

6 Section 2770. Purchase of Road [Machinery] Equipment;
7 Renting of Road [Machinery] Equipment to [Townships] Municipal
8 Corporations.--The county commissioners of any county may
9 purchase such [machinery] equipment for the preparation of road
10 material and the construction and maintenance of roads as they
11 deem necessary and pay for the same out of the general funds of
12 the county. Such [machinery] equipment may be rented by the
13 county commissioners to any of the [townships] municipal
14 corporations within such county applying for same, under such
15 regulations and at such rentals as the county commissioners
16 shall prescribe and fix. All [machinery] equipment, purchased

20 Section 2775. Laying Out Detours When County Road is
21 Closed.--(a) Except in the case of emergency wherein the safety
22 of the public would be endangered, no county road shall be
23 closed to vehicular traffic except upon order of the county
24 commissioners, nor for a longer period than is necessary for the
25 purpose for which such order is issued. Except for temporary
26 emergency police measures wherein the safety of the public would
27 be endangered if it were not temporarily closed, no county road
28 shall be closed to vehicular traffic when the same has been
29 designated as a detour by the Department of [Highways of the
30 Commonwealth] Transportation unless the written consent of the

1 Department of [Highways] Transportation has first been obtained,
2 or unless the county commissioners having jurisdiction over said
3 road shall, by resolution, declare such closing necessary for
4 the protection of the public safety.

5 (b) Whenever any county road shall be closed to vehicular
6 travel, the board of commissioners shall immediately designate
7 or lay out a detour, on which they shall cause to be erected and
8 maintained, while such detour is in use, legible signs at each
9 public road intersection throughout its entire length indicating
10 the direction to the main highway. During the period when such
11 detour is in use, the county commissioners shall maintain such
12 detour in safe and passable condition. They shall also
13 immediately remove all detour signs when the highway originally
14 closed is again opened for traffic.

15 (c) The county commissioners shall, as soon as possible,
16 repair the road designated as a detour and place it in a
17 condition at least equal to its condition when designated as a
18 detour.

19 [(d) "Highways" as used in this act includes all public
20 thoroughfares and ways equally with the word "road", for
21 convenience of expression.]

22 Section 2776. Detour Over Private Lands.--Whenever necessary
23 in the creation of a detour as aforesaid, the county
24 commissioners responsible for laying out the detour may enter
25 into an agreement with the owners of private lands covering the
26 acquisition of right of way privileges over private property for
27 the period when the main highway shall be closed to traffic. In
28 the exercise of the rights conferred by this section, the county
29 commissioners responsible [are hereby empowered to] may pay for
30 the necessary maintenance, subsequent repair and land rental out

1 of such funds as are available for the construction and
2 maintenance of the roads in their charge.

3 Section 2777. Fines and Damages.--(a) Any person who shall
4 [wilfully] willfully remove, deface, destroy or disregard any
5 barricade, light, danger sign, detour sign [or], warning or
6 traffic control device of any character whatsoever, erected or
7 placed under authority of section [two thousand seven hundred
8 seventy-five of this act] 2775, or who shall drive on, over or
9 across any road which had been closed by proper authority,
10 shall[, upon conviction thereof in a summary proceeding before a
11 magistrate, alderman or justice of the peace, be sentenced to
12 pay a fine of not less than twenty-five dollars (\$25) nor more
13 than one hundred dollars (\$100), and the cost of prosecution,
14 and in default of the payment thereof, shall be imprisoned one
15 day for each dollar of fine and costs unpaid] be convicted of a
16 summary offense: Provided, however, That persons who have no
17 outlet due to the closing of a road may drive on, over or across
18 such road, with the consent in writing of and subject to such
19 conditions as may be prescribed by the county commissioners
20 responsible for the closing, or their agents or contractors,
21 without being subject to the fines imposed by this section.

22 (b) In addition to the fines herein provided, the county
23 commissioners responsible for the maintenance of a road which
24 has been closed to vehicular traffic, or their agents or
25 contractors, may, in an action at law, recover damages from any
26 person or persons who have damaged a road when it is closed to
27 vehicular traffic.

28 (c) All fines collected under the provision of this section
29 shall be paid [by the officer receiving the same to the
30 treasurer of the boroughs, towns or townships in which the

1 offenses shall have been committed] to the county treasurer for
2 the general fund use of the county.

3 Section 130. Sections 2781, 2782, 2783 and 2784 of the act
4 are repealed:

5 [Section 2781. County Road Caretakers.--The persons
6 appointed by the board of commissioners to inspect and repair
7 roads improved and maintained as county roads shall be
8 designated county road caretakers. The caretakers shall have all
9 the power and authority now vested by law in the constables of
10 the several cities, boroughs and townships of this Commonwealth
11 to keep the peace in and along the county roads of such county,
12 and to enforce all laws regulating the speed of automobiles and
13 other vehicles thereon, and to enforce all rules or regulations
14 governing the use of such roads, and to make arrests therefor.

15 Section 2782. Caretakers Not Entitled to Fines or
16 Penalties.--No such caretaker shall be entitled to any portion
17 of any fine or penalty imposed upon any person or persons for
18 any violation of any act of Assembly or rule relating thereto,
19 but all such fines and penalties, when the proceeding is
20 initiated by such caretaker, shall belong to and be paid into
21 the county treasury for the benefit of the county.

22 Section 2783. Badge of Caretaker.--The board of
23 commissioners shall furnish each of said caretakers, as an
24 evidence of his authority, a badge having impressed thereon the
25 words "Police County Road
26 Caretaker".

27 Section 2784. Rules for Protection of Road; Penalty for
28 Violation.--(a) For the purpose of preventing unreasonable wear
29 and destruction of public roads improved and maintained by the
30 county, the board of commissioners may adopt and prescribe

1 reasonable rules, regulating and restricting the use of said
2 roads within the county by any means of locomotion and prescribe
3 pecuniary penalties for the enforcement thereof. All such rules
4 adopted by the board of commissioners shall, before becoming
5 operative, be published once a week for three weeks in two
6 newspapers of general circulation in the county to which the
7 rules apply, and be recorded in the office of the recorder of
8 deeds of said county.

9 (b) Any resident of the county within which the violation of
10 any rule so adopted shall occur may institute and prosecute to
11 judgment and execution an action of assumpsit, in any court
12 having jurisdiction of such actions and the amounts involved,
13 for the recovery of any penalty for the violation of any rule
14 prescribed by the board of commissioners, of which penalty the
15 plaintiff shall be entitled to one-half and the county shall be
16 entitled to the other half, payable to the county treasurer, who
17 shall add the same to the fund for the improvement of said
18 county roads.

19 (c) Any person violating any rule so adopted shall, upon
20 summary conviction, be sentenced to pay a fine of not less than
21 five dollars (\$5) or more than one hundred dollars (\$100),
22 payable to the county treasurer, who shall add the same to the
23 fund for the improvement of said county roads. From any judgment
24 obtained for said penalty and from said summary conviction an
25 appeal shall lie as provided by law.]

26 Section 131. Section 2785 of the act is amended to read:

27 Section 2785. Penalty for Destroying, Et Cetera, Index
28 Boards.--(a) It shall be unlawful for any person to [wilfully]
29 willfully destroy, remove, injure or deface any sign or index
30 board erected upon or near any public street, road or bridge by

1 the authorities of any county, or erected, with the consent of
2 such authorities, by any club, association or other organized
3 body, for the direction, guidance or safety of travelers. Any
4 and all such signs of wood, metal or other substance, affixed to
5 trees or posts in or upon any roads, properly erected in such
6 manner that they do not interfere with travel, or upon fences,
7 telegraph, telephone, trolley or other poles, with the
8 permission of the owners thereof, or upon private grounds, where
9 consent has been obtained from the owners and tenants thereof,
10 and which are close to roads, shall be within the provisions of
11 this section.

12 (b) Any person violating the provisions of this section
13 shall[, upon summary conviction, be sentenced to pay a fine of
14 not less than ten dollars (\$10) nor more than twenty-five
15 dollars (\$25) with all costs of prosecution, together with the
16 value of such sign so destroyed, removed or defaced. In default
17 of payment of said fine, costs and expenses, such person shall
18 undergo an imprisonment for a period of not less than five nor
19 more than sixty days.] be convicted of a summary offense and, in
20 addition to other fines and penalties provided by law, may be
21 required to provide reimbursement for the value of a sign
22 destroyed.

23 Section 132. Nothing in this act shall be construed as
24 requiring a county to liquidate any investment, in whole or in
25 part, by disposing of securities or withdrawing funds on deposit
26 if the investment was lawfully authorized prior to the effective
27 date of this act.

28 Section 133. Repeals are as follows:

29 (1) The General Assembly declares that the repeal under
30 paragraph (2) is necessary to implement the amendment of

1 section 405 of the act of August 9, 1955 (P.L.323, No.130),
2 known as The County Code.

3 (2) Section 210(2) and (2.1) of the act of July 28, 1953
4 (P.L.723, No.230), known as the Second Class County Code.

5 Section 134. This act shall take effect in 60 days.
