AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in school health services, providing
- for early intervention depression screening.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1425. Early Intervention Depression Screening. -- (a)
- 13 All children of school age shall receive a depression screening
- 14 while in sixth grade and thereafter in accordance with the
- 15 schedule for mandated medical examinations under section
- 16 <u>1402(e)</u>. The comprehensive health examination for a child of
- 17 school age shall include written confirmation from the child's
- 18 physician or other qualified health care professional that the
- 19 <u>screening was completed.</u>
- 20 (B) (1) IF THE PARENT OR GUARDIAN CHOOSES TO SHARE THE

- 1 RESULTS OF THE SCREENING WITH THE SCHOOL ENTITY AND THE
- 2 SCREENING INDICATES THE PRESENCE OF THOUGHTS OR BEHAVIORS OFTEN
- 3 ASSOCIATED WITH A DIAGNOSIS OF DEPRESSION, THE SCHOOL ENTITY
- 4 SHALL REFER THE CHILD:
- 5 (I) TO THE SCHOOL'S STUDENT ASSISTANCE PROGRAM;
- 6 (II) TO THE SCHOOL PSYCHOLOGIST FOR EVALUATION; OR
- 7 (III) FOR EVALUATION UNDER THE INDIVIDUALS WITH DISABILITIES
- 8 EDUCATION ACT (PUBLIC LAW 91-230, 20 U.S.C. § 1400 ET SEQ.) OR
- 9 <u>UNDER SECTION 504 OF THE REHABILITATION ACT OF 1973 (PUBLIC LAW</u>
- 10 <u>93-112</u>, <u>29 U.S.C.</u> § 794).
- 11 (2) THE SCHOOL ENTITY SHALL NOTIFY THE PARENT OR GUARDIAN AT
- 12 THE POINT OF REFERRAL THAT AN EVALUATION UNDER THIS SUBSECTION
- 13 WILL NOT BE PERFORMED UNLESS THE PARENT OR GUARDIAN CONSENTS TO
- 14 THE EVALUATION.
- 15 (C) Each school entity shall provide notice of the <--
- 16 requirement under subsection (a) to the parent or guardian of
- 17 each child. The notice shall be developed by the Department of
- 18 <u>Health and made available on the school entity's publicly</u>
- 19 accessible Internet website or included in any other materials
- 20 used to effectively communicate with parents or quardians
- 21 regarding the medical examination requirement and shall:
- 22 (1) Explain that a physician or other qualified health care
- 23 professional shall conduct the depression screening as required
- 24 under subsection (a) and provide the school entity in which the
- 25 child is enrolled with written confirmation that the screening
- 26 was completed.
- 27 (2) State that a parent or guardian may opt out of the
- 28 depression screening required under subsection (a).
- 29 (3) Specify that the decision to act on screening results
- 30 rests entirely with the parent or quardian.

- 1 (4) State that the school entity will not receive the
- 2 results of the screening unless the parent or quardian chooses
- 3 to share the results of the screening with the school entity.
- 4 <u>(5) State the following:</u>
- 5 (i) If the parent or quardian chooses to share the results
- 6 of the screening with the school entity and the screening
- 7 <u>indicates the presence of thoughts or behaviors often associated</u>
- 8 with a diagnosis of depression, the school entity shall refer
- 9 the child:
- 10 (A) to the school's student assistance program;
- 11 (B) to the school psychologist for evaluation; or
- 12 (C) for evaluation under the Individuals with Disabilities
- 13 Education Act (Public Law 91-230, 20 U.S.C. § 1400 et seq.) or
- 14 under section 504 of the Rehabilitation Act of 1973 (Public Law
- 15 <u>93-112, 29 U.S.C. § 794).</u>
- 16 <u>(ii) The parent or guardian shall be notified at the point</u>
- 17 of referral and that an evaluation under this paragraph may not
- 18 be performed unless the parent or quardian consents to the
- 19 evaluation.
- 20 (c) (D) The Department of Health, in conjunction with the
- 21 Department of Education, shall make available materials:
- 22 (1) That at a minimum explain the following:
- 23 (i) The importance of early diagnosis for mental health and
- 24 common challenges for students with undiagnosed or untreated
- 25 depression.
- 26 (ii) Related Federal and State privacy protections and
- 27 parental rights in relation to the health requirements of
- 28 children of school age.
- 29 (2) To school entities in print format, which shall also be
- 30 and posted on the publicly accessible Internet websites of the

- 1 Department of Health and the Department of Education.
- 2 (d) (E) The academic records of a child of school age shall <--
- 3 not include the child's screening results or information
- 4 <u>indicating whether a screening was completed.</u>
- 5 (e) (F) The Department of Health shall amend the standard <--
- 6 private or school physical examination of school age student
- 7 form to accommodate the depression screening required under
- 8 <u>subsection (a). The form shall require the physician or other</u>
- 9 <u>qualified health care professional completing the form to</u>
- 10 indicate confirmation that a depression screening was completed
- 11 or not completed or that the parent or guardian of the student
- 12 opted out of the screening. The physician or other qualified
- 13 <u>health care professional who completes the screening may use</u>
- 14 this form or a form that provides substantially similar
- 15 <u>information to provide confirmation of the screening or that the</u>
- 16 parent or guardian has opted out of the screening to the school
- 17 entity of the child of school age.
- 18 (f) (G) Nothing in this section shall be construed to <--
- 19 create, establish or expand civil or criminal liability on the
- 20 part of a school entity or school employe.
- 21 (g) (H) Within ninety (90) days of the effective date of <--
- 22 this section, each school entity shall adopt or revise existing
- 23 procedures concerning the school entity's response if it is
- 24 provided with a depression screening indicating that a student
- 25 <u>has thoughts or engages in behaviors that are often associated</u>
- 26 with a diagnosis of depression.
- 27 (h) (I) The Department of Health shall promulgate
- 28 regulations necessary to implement this section, including a
- 29 <u>determination of who can be deemed a qualified health care</u>
- 30 professional for the purpose of this section and privacy

- 1 procedures that apply when depression screening is conducted in
- 2 a school entity by a school physician or other practitioner
- 3 contracted for the purposes of conducting medical examinations
- 4 <u>under section 1402(e).</u>
- 5 (i) (J) As used in this section, "school entity" shall mean <--
- 6 <u>a school district, charter school, cyber charter school,</u>
- 7 regional charter school, area vocational-technical school,
- 8 <u>intermediate unit or nonpublic school in this Commonwealth.</u>
- 9 Section 2. This act shall take effect August 1, 2018.
