A RESOLUTION

1 2	Condemning acts of hate and vandalism against the Jewish community.
3	WHEREAS, Individuals who show cultural insensitivity and an
4	animus to a particular group of people are harming all
5	Pennsylvanians; and
6	WHEREAS, There has been a recent alarming increase in the
7	number of acts of hate toward members of the Jewish faith and
8	this increase cannot be ignored; and
9	WHEREAS, Recent acts of hate number more than 150, since the
10	beginning of 2017, and include bomb threats or acts of vandalism
11	against museums, houses of worship, advocacy groups and
12	cemeteries; and
13	WHEREAS, This disturbing trend has occurred both in this
14	Commonwealth and across the nation; and
15	WHEREAS, In late February 2017, vandals toppled more than 100
16	gravestones at Mount Carmel Cemetery in Philadelphia, a historic

1 cemetery that dates back to the 1890s; and

2 WHEREAS, Families and loved ones had to endure the emotional 3 trauma of seeing desecrated headstones and come to terms with 4 such horrific acts of hate; and

5 WHEREAS, The perpetrators of these acts have not been 6 apprehended and the families affected continue to suffer from 7 these acts of cowardice and hate; and

8 WHEREAS, In early March, multiple Jewish community centers 9 across the country, including one in York and one in Harrisburg, 10 were evacuated after receiving threats; and

11 WHEREAS, Staff at the York Jewish Community Center (JCC) 12 received a call from a man who claimed there was a bomb in the 13 building; and

14 WHEREAS, The JCC staff evacuated the building and allowed the 15 authorities to sweep the building with bomb-sniffing dogs; and 16 WHEREAS, Children in the JCC's day care were evacuated as 17 parents were contacted and felt a sense of panic; and 18 WHEREAS, The families who endured threats remain fearful of 19 the possibility of another similar act; and

20 WHEREAS, The community in York, the York authorities, the 21 Department of Justice and the Federal Bureau of Investigation 22 continue to investigate these acts and remain determined to 23 bring those responsible for these acts to justice; and 24 WHEREAS, Throughout the country, police have reported threats 25 to Jewish institutions; and

26 WHEREAS, Most recently over the Purim holiday, the Louis S. 27 Wolk Jewish Community Center in Rochester, New York, was 28 evacuated on the morning of Sunday, March 12, for the second 29 time in less than a week as the Rochester JCC served as a 30 warming center for people whose homes had lost power due to a

1 windstorm; and

2 WHEREAS, These acts reflect a continuing and disturbing3 pattern of intimidation and hate; and

4 WHEREAS, We all stand united against such cowardly acts; and 5 WHEREAS, Our Commonwealth cannot be defined by these acts but 6 rather should be defined by our residents' response to these 7 acts; therefore be it

8 RESOLVED, That the Senate condemn acts of hate and vandalism 9 that have been committed against the Jewish community; and be it 10 further

11 RESOLVED, That the Senate encourage all Pennsylvanians to 12 remain steadfast in rejecting cultural insensitivity and use 13 this time as a moment when we can come together and begin 14 educating young people and adults on understanding and 15 appreciating all members of our community and residents of this 16 Commonwealth.
