A RESOLUTION

Urging the Governor and the Office of the Attorney General to file lawsuits against pharmaceutical companies that engage in 2 practices that caused the ongoing opioid epidemic within this 3 Commonwealth. 4 5 WHEREAS, Prescription opioids are narcotics that are derived 6 from or possess properties similar to opium and heroin; and 7 WHEREAS, Certain pharmaceutical companies spend hundreds of millions of dollars to mislead the public about the 8 9 addictiveness of powerful prescription opioid drugs; and 10 WHEREAS, These pharmaceutical companies continue to engage in 11 fraud, conspiracy and negligence in the development and 12 marketing of highly addictive opioid drugs; and 13 WHEREAS, These pharmaceutical companies continue to use 14 sophisticated and highly deceptive and unfair marketing 15 campaigns in an effort to reverse the medical community's 16 understanding of opioids to increase opioid drug use; and 17 WHEREAS, These pharmaceutical companies know that prolonged use of opioids is addictive, subject to abuse and that opioids 18 19 should be used only as a last resort; and

- 1 WHEREAS, These pharmaceutical companies know that prolonged
- 2 use of opioids causes the effectiveness of the drugs to wane,
- 3 requiring an increase in the dosage and markedly increasing the
- 4 risk of significant side effects and addiction; and
- 5 WHEREAS, These pharmaceutical companies continue to use
- 6 misleading scientific data to convince the medical community to
- 7 increasingly prescribe opioid drugs; and
- 8 WHEREAS, Certain pharmaceutical companies have used illegal
- 9 kickbacks in the past to encourage physicians and nurses to
- 10 prescribe opioid products; and
- 11 WHEREAS, Certain pharmaceutical companies' marketing efforts
- 12 and the lack of medical breakthroughs prescribing opioids for
- 13 chronic pain opened the floodgates of opioid use and abuse; and
- 14 WHEREAS, A recent study published in JAMA Internal Medicine
- 15 found a direct correlation between physicians receiving
- 16 manufacturer-sponsored meals and increased prescribing rates of
- 17 drugs promoted during the meal; and
- 18 WHEREAS, Certain opioid pharmaceutical companies set sales
- 19 quotas for their sales representatives that are impossible to
- 20 meet unless the drugs are promoted for off-label use; and
- 21 WHEREAS, These pharmaceutical companies continue to earn
- 22 billions of dollars in profits from their questionable opioid
- 23 products and sales tactics; and
- 24 WHEREAS, Americans represent only 4.6% of the world's
- 25 population but consume 80% of the world's opioids and 99% of the
- 26 global hydrocodone supply; and
- 27 WHEREAS, Opioid sales generated \$8 billion in revenue for
- 28 drug companies in 2012 and an estimated \$15.3 billion in 2016;
- 29 and
- 30 WHEREAS, The Associated Press and the Center for Public

- 1 Integrity published an investigation outlining how certain
- 2 pharmaceutical companies and their allies have adopted a 50-
- 3 state strategy that includes hundreds of lobbyists and nearly \$1
- 4 billion spent on lobbying and campaign contributions from 2006
- 5 through 2015 to help kill or weaken measures aimed at stemming
- 6 the tide of prescription opioids; and
- WHEREAS, In the 2014 National Drug Threat Assessment, the
- 8 Drug Enforcement Agency (DEA) reported that approximately 129
- 9 people die every day as a result of drug poisoning and more than
- 10 60% of those overdose deaths are due to pharmaceutical opioids
- 11 or are heroin related; and
- 12 WHEREAS, According to the Centers for Disease Control and
- 13 Prevention, in 2015, 52,000 people died from drug overdoses and
- 14 approximately two-thirds of them had used prescription opioids;
- 15 and
- 16 WHEREAS, Recent data for this Commonwealth shows 10,394,466
- 17 prescriptions for opioid medications were filled by individuals
- 18 in 2015; and
- 19 WHEREAS, In 2015, a report from the DEA identified 3,383
- 20 drug-related overdose deaths in this Commonwealth, an increase
- 21 of 23.4% over 2014; and
- 22 WHEREAS, This Commonwealth is in the midst of an opioid and
- 23 heroin epidemic causing thousands of overdose deaths and
- 24 destroying communities and families; and
- 25 WHEREAS, Opioid abuse causes a \$78.5 billion loss to the
- 26 United States economy each year; and
- 27 WHEREAS, The financial toll this epidemic is having on the
- 28 limited resources of the Commonwealth is staggering; and
- 29 WHEREAS, States have historically filed lawsuits against
- 30 industries that engage in illegal business practices, such as

- 1 the tobacco industry in the 1990s, in order to protect their
- 2 residents; therefore be it
- 3 RESOLVED, That the Senate urge the Governor and the Office of
- 4 Attorney General to initiate lawsuits against pharmaceutical
- 5 companies that engage in practices that caused the ongoing
- 6 opioid epidemic within this Commonwealth; and be it further
- 7 RESOLVED, That the Senate urge the Governor and the Office of
- 8 the Attorney General, should they initiate lawsuits and prevail,
- 9 to place any funds recovered in a reserve account to be used for
- 10 drug, alcohol and mental health treatment programs.
