A RESOLUTION

- Designating May 15, 2018, as "Trauma Registrars Day" in Pennsylvania.
- 3 WHEREAS, Each accredited trauma center in Pennsylvania is
- 4 required to have a trauma registrar; and
- 5 WHEREAS, The trauma registrar's primary role is to abstract
- 6 data into the trauma center's trauma registry, which is an
- 7 important management tool composed of a file of uniform data
- 8 elements that describe the injury, event, demographics,
- 9 prehospital information, diagnosis, care and outcomes and costs
- 10 of treatment of injured patients; and
- 11 WHEREAS, The trauma registrar also engages in other
- 12 processes, such as report generation, data analysis and research
- 13 assistance; and
- 14 WHEREAS, The trauma registrar is a vital and integral part of
- 15 the trauma team, the overall performance improvement process at
- 16 a trauma center and the public health; and
- 17 WHEREAS, Trauma registrars must abstract data in compliance

- 1 with the Pennsylvania Trauma Systems Foundation guidelines as
- 2 well as the National Trauma Data Bank guidelines; and
- 3 WHEREAS, Trauma registrars come from diverse backgrounds,
- 4 such as nursing, medical records, computer science and medical
- 5 informatics, among others; and
- 6 WHEREAS, Trauma registrars must be continuous learners and
- 7 attend courses such as the American Trauma Society's Trauma
- 8 Registrar Course or an equivalent provided by a state trauma
- 9 program and the Association for the Advancement of Automotive
- 10 Medicine's Injury Scaling Course; and
- 11 WHEREAS, A certifying examination is available through the
- 12 sponsorship of the American Trauma Society's Registrar
- 13 Certification Board, leading to the designation of certified
- 14 specialist in trauma registries; and
- 15 WHEREAS, It is important to acknowledge that high-quality
- 16 data begins with high-quality data entry and it is the trauma
- 17 registrar who is responsible for performing this task;
- 18 therefore be it
- 19 RESOLVED, That the Senate designate May 15, 2018, as "Trauma
- 20 Registrars Day" in Pennsylvania.
