- 22 This act shall be known and may be cited as the General
- 23 Appropriation Act of 2019.
- 24 Section 102. Definitions.
- 25 The following words and phrases when used in this act shall
- 26 have the meanings given to them in this section unless the
- 27 context clearly indicates otherwise:
- "Current fiscal year." The fiscal year beginning July 1,
- 29 2019, and ending June 30, 2020.
- 30 "Employees." Includes all directors, superintendents, bureau

- 1 or division chiefs, assistant directors, assistant
- 2 superintendents, assistant chiefs, experts, scientists,
- 3 engineers, surveyors, draftsmen, accountants, secretaries,
- 4 auditors, inspectors, examiners, analysts, statisticians,
- 5 marshals, clerks, stenographers, bookkeepers, messengers and
- 6 other assistants in a department, board or commission.
- 7 "Expenses" and "maintenance." Includes all printing, binding
- 8 and stationery, food and forage, materials and supplies,
- 9 traveling expenses, training, motor vehicle supplies and
- 10 repairs, freight, express and cartage, postage,
- 11 telecommunication devices and telecommunication rentals and toll
- 12 charges, newspaper advertising and notices, public advertising
- 13 by or through any medium, fuel, light, heat, power and water,
- 14 minor construction and renovation, repairs or reconstruction of
- 15 equipment, buildings and facilities, rent of real estate and
- 16 equipment, premiums on workers' compensation, insurance premiums
- 17 on policies of liability insurance, insurance premiums on
- 18 medical payment insurance and surety bonds for volunteer
- 19 workers, premiums on employee group life insurance and employee
- 20 and retired employee group hospital and medical insurance,
- 21 payment of Commonwealth share of Social Security taxes and
- 22 unemployment compensation costs for State employees, the
- 23 purchase of replacement or additional equipment and machinery
- 24 and all other incidental costs and expenses, including payment
- 25 to the Department of General Services of mileage and other
- 26 charges for the use of motor vehicles and rental payments for
- 27 permanently assigned motor vehicles and of expenses or costs of
- 28 services incurred through the Purchasing Fund. The term
- 29 "expenses" also shall include the medical costs for the
- 30 treatment of incarcerated individuals of State institutions when

- 1 the incarcerated individual must be transferred to an outside
- 2 hospital, provided that in no case shall the State institution
- 3 pay more for patient care than that provided under the State
- 4 medical assistance program.

- 6 fiscal year immediately prior to the current fiscal year.

- 28 (a) General Fund.--Except as provided in Part XIX, the sums
- 29 specified in this act, or as much thereof as may be necessary,
- 30 are specifically appropriated from the General Fund to agencies

- 1 of the Executive, Legislative and Judicial Departments of the
- 2 Commonwealth for the payment of salaries, wages or other
- 3 compensation and travel expenses of the duly elected or
- 4 appointed officers and employees of the Commonwealth, for the
- 5 payment of fees for contractual services rendered, for the
- 6 purchase or rental of goods and services, printing, public
- 7 advertising by or through any medium, equipment, land and
- 8 buildings and for payment of any other expenses, as provided by
- 9 law or by this act, necessary for the proper conduct of the
- 10 duties, functions and activities and for the purposes specified
- 11 in this act for the current fiscal year and for the payment of
- 12 bills incurred and remaining unpaid at the close of the prior
- 13 fiscal year.
- 14 (b) Special funds and accounts. -- Except as provided in Part
- 15 XIX, the sums specified in this act, or as much thereof as may
- 16 be necessary, are specifically appropriated from the special
- 17 funds and accounts in the State Treasury to agencies of the
- 18 Executive and Judicial Departments of the Commonwealth for the
- 19 payment of salaries, wages or other compensation and travel
- 20 expenses of the duly appointed officers and employees of the
- 21 Commonwealth, for the payment of fees for contractual services
- 22 rendered, for the purchase or rental of goods and services and
- 23 for payment of any other expenses, as provided by law or by this
- 24 act, necessary for the proper conduct of the duties, functions
- 25 and activities and for the purposes specified in this act for
- 26 the current fiscal year and for the payment of bills incurred
- 27 and remaining unpaid at the close of the prior fiscal year.
- 28 Section 105. Federal appropriations.
- 29 Except as otherwise provided in section 1902, the Federal
- 30 appropriations specified in this act, or as much thereof as may

- 1 be necessary, are specifically appropriated to the agencies of
- 2 the Executive Department of the Commonwealth specified in this
- 3 act for the payment of the expenses of implementing and carrying
- 4 out the programs specified in this act for the current fiscal
- 5 year and for the payment of bills incurred and remaining unpaid
- 6 at the close of the prior fiscal year. Unless otherwise stated,
- 7 the Federal appropriations include any carryovers from the prior
- 8 fiscal year.
- 9 Section 106. Block grants.
- 10 (a) Appropriations. -- The sums specified in this act, or as
- 11 much thereof as may be necessary, are specifically appropriated
- 12 from the block grant (BG) funds to agencies of the Executive
- 13 Department specified in this act for the purposes and under the
- 14 restrictions for which the funds are provided for the current
- 15 fiscal year.
- 16 (b) Small Communities Development Block Grant. -- The Small
- 17 Communities Development Block Grant (SCDBG) is to assist small
- 18 cities and communities that have a high concentration of
- 19 impoverished citizens and substandard housing to expand their
- 20 low-income and moderate-income housing opportunities and to meet
- 21 community development needs.
- 22 (c) Community Services Block Grant. -- The Community Services
- 23 Block Grant (CSBG) is to provide a range of services and
- 24 activities having a measurable and potentially major impact on
- 25 the causes of poverty in the community or those areas of the
- 26 community where poverty is a particularly acute problem. In
- 27 addition, new focus may be placed on the unemployed, both old
- 28 and new. Local agencies may lower their eligibility requirements
- 29 for recipients to three months to allow greater flexibility to
- 30 assure proper consideration of each recipient.

- 1 (d) Preventive Health and Health Services Block Grant. -- The
- 2 Preventive Health and Health Services Block Grant (PHHSBG) is
- 3 for the provision of preventive health and other health services
- 4 related to emergency medical systems, health initiative grants,
- 5 comprehensive public health, hypertension, fluoridation, health
- 6 education, risk reduction, home health, rape crisis and domestic
- 7 violence services.
- 8 (e) Maternal and Child Health Services Block Grant. -- The
- 9 Maternal and Child Health Services Block Grant (MCHSBG) is to
- 10 enable states to maintain and strengthen their leadership in
- 11 planning, promoting, coordinating and evaluating health care for
- 12 pregnant women, mothers, infants and children, and children with
- 13 special health care needs and in providing health services for
- 14 mothers and children who do not have access to adequate health
- 15 care.
- 16 (f) Low-Income Home Energy Assistance Block Grant. -- The Low-
- 17 Income Home Energy Assistance Block Grant (LIHEABG) is to help
- 18 lessen the impact of the high cost of energy on low-income
- 19 families and individuals, including energy efficiency grants for
- 20 low-income dwellings. No less than 15% of the LIHEABG funds
- 21 received shall be used for weatherization. LIHEABG funds
- 22 received pursuant to a Presidential release of contingency funds
- 23 shall be exempt from the 15% requirement.
- 24 (q) Social Services Block Grant. -- The Social Services Block
- 25 Grant (SSBG) is for the provision of social services to eligible
- 26 persons.
- 27 (h) Mental Health Services Block Grant. -- The Mental Health
- 28 Services Block Grant (MHSBG) provides funds for the provision of
- 29 services to adults with serious mental illness or children with
- 30 serious emotional disturbance.

- 1 (i) Substance Abuse Block Grant.--The Substance Abuse Block
- 2 Grant (SABG) provides funds to establish and maintain programs
- 3 to combat alcohol and drug abuse.
- 4 (j) Child Care and Development Fund Block Grant. -- The Child
- 5 Care and Development Fund Block Grant (CCDFBG) is for the
- 6 provision of direct child care or to increase the quality and
- 7 availability of child care for low-income families.
- 8 (k) Temporary Assistance for Needy Families Block Grant.--
- 9 The Temporary Assistance for Needy Families Block Grant (TANFBG)
- 10 provides funds for the provision of cash grants, child care,
- 11 training and support services, child welfare and administration
- 12 for eligible families and individuals.
- 13 Section 107. Appropriations to Pennsylvania Higher Education
- 14 Assistance Agency.
- The appropriations set forth in this act to the Pennsylvania
- 16 Higher Education Assistance Agency, which is an integral part
- 17 and arm of the Commonwealth and which is directly controlled by
- 18 the Commonwealth, shall supplement other Commonwealth funds
- 19 maintained by the Pennsylvania Higher Education Assistance
- 20 Agency in order to fulfill its essential State governmental
- 21 function of providing Commonwealth students with access to
- 22 higher education opportunities and providing essential higher
- 23 education programs for the benefit of Commonwealth students.
