## AN ACT

1 2 3	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in licensing of drivers, further providing for issuance and content of driver's license.

5	hereby enacts as follows:

10	(b.1) Reduced-cost identification card for a homeless
11	individualThe department shall issue an identification card
12	<u>at a reduced cost to an individual who is ten years of age or</u>
13	older, who is homeless and who has made application for the
14	identification card in the manner as the department shall
15	prescribe. The following apply:
16	(1) The reduced cost of the identification card shall be
17	one-half of the full cost of an identification card as

2	applicant has applied for the identification card.
3	(2) The department may require additional documentation
4	to verify the homeless status of an applicant.
5	(3) For the purposes of this subsection, the term
6	"homeless" shall have the meaning given to it in section 103
7	of the McKinney-Vento Homeless Assistance Act (Public Law_
8	<u>100-77, 42 U.S.C. § 11302).</u>
9	(b.2) Reduced-cost identification card for an individual in
10	povertyThe department shall issue an identification card at a
11	reduced cost to an individual who is ten years of age or older,
12	who is a member of a household in poverty and who has made
13	application for the identification card in the manner as the
14	department shall prescribe. The following shall apply:
15	(1) The reduced cost of the identification card shall be
16	one-half of the full cost of an identification card as
17	prescribed by the department in the year in which the
18	applicant has applied for the identification card.
19	(2) The department may require additional documentation
20	to verify an applicant's poverty status.
21	(3) For the purposes of this subsection, the term
22	"poverty" shall mean a household with total income at or
23	below the poverty guideline, adjusted for household size, as
24	published annually by the United States Department of Health
25	and Human Services in the Federal Register.
26	(b.3) Reduced-cost identification card for a disabled
27	individualThe department shall issue an identification card
28	at a reduced cost to an individual who is ten years of age or
29	older, who is considered disabled as described in section
30	1338(a) (relating to person with disability plate and placard)

1	and who has made application for the identification card in the
2	manner as the department shall prescribe. The following shall
3	apply:
4	(1) The reduced cost of the identification card shall be
5	one-half of the full cost of an identification card as
6	prescribed by the department in the year in which the

8	(2) The department may require a health care provider's
9	statement as described in section 1338(c) to verify an
10	applicant's disabled status.
11	(b.4) Reduced-cost identification card for senior
12	citizensThe department shall issue an identification card at
13	a reduced cost to a senior citizen who has made application for
14	the identification card in the manner as the department shall
15	prescribe. The following shall apply:
16	(1) The reduced cost of the identification card shall be
17	one-half of the full cost of an identification card as
18	prescribed by the department in the year in which the
19	applicant has applied for the identification card.
20	(2) The department may require additional documentation
21	to verify an applicant's status as a senior citizen.
22	(3) For the purposes of this subsection, the term
23	"senior citizen" shall have the meaning given to it in 74
24	Pa.C.S. § 1503 (relating to definitions).
25	(b.5) Reduced-cost identification card for veteransThe
26	department shall issue an identification card at a reduced cost
27	to a veteran who has made application for the identification
28	card in the manner as the department shall prescribe. The
29	following shall apply:
30	(1) The reduced cost of the identification card shall be

1	one-half of the full cost of an identification card as
2	prescribed by the department in the year in which the

5	<u>to verify an applicant's status as a veteran.</u>

7	"veteran" shall have the meaning given to it in 51 Pa.C.S. §
8	7202 (relating to definitions).
