AN ACT

Amending the act of April 14, 1972 (P.L.233, No.64), entitled "An act relating to the manufacture, sale and possession of controlled substances, other drugs, devices and cosmetics; conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, Device and Cosmetic Board; establishing schedules of controlled substances; providing penalties; requiring registration of persons engaged in the drug trade and for the revocation or suspension of certain licenses and 9 registrations; and repealing an act," further providing for 10 schedules of controlled substances. 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: Section 1. Section 4(2)(ii) of the act of April 14, 1972 14 15 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, is amended by adding a subclause to 17 read: 18 SECTION 1. SECTION 4(2)(II) OF THE ACT OF APRIL 14, 1972 19 (P.L.233, NO.64), KNOWN AS THE CONTROLLED SUBSTANCE, DRUG, 20 DEVICE AND COSMETIC ACT, IS AMENDED BY ADDING A SUBCLAUSE AND THE SECTION IS AMENDED BY ADDING A PARAGRAPH TO READ:

- 1 Section 4. Schedules of Controlled Substances.--The

- 3 to be listed by whatever official name, common or usual name,
- 4 chemical name, or trade name designated.

- 6 (2) Schedule II--In determining that a substance comes
- 7 within this schedule, the secretary shall find: a high potential
- 8 for abuse, currently accepted medical use in the United States,
- 9 or currently accepted medical use with severe restrictions, and
- 10 abuse may lead to severe psychic or physical dependence. The
- 11 following controlled substances are included in this schedule:

- 13 (ii) Any of the following opiates, including their isomers,
- 14 esters, ethers, salts, and salts of isomers, esters and ethers,
- 15 of any quantity, unless specifically excepted or listed in
- 16 another schedule, whenever the existence of such isomers,
- 17 esters, ethers and salts is possible within the specific
- 18 chemical designation:

- 26 FEDERAL FOOD, DRUG AND COSMETIC ACT PRIOR TO THE DATE OF
- 27 ENACTMENT SHALL NOT BE SUBJECT TO CONTROL UNDER THIS ACT.
- 28 Section 2. This act shall take effect immediately.
