Amending the act of December 19, 1988 (P.L.1262, No.156), entitled "An act providing for the licensing of eligible 2 organizations to conduct games of chance, for the licensing 3 of persons to distribute games of chance, for the registration of manufacturers of games of chance, and for suspensions and revocations of licenses and permits; 6 requiring records; providing for local referendum by 7 electorate; and prescribing penalties," in club licensees, 8 further providing for report and for distribution of proceeds. 10 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: Section 1.
