AN ACT

- 1 Providing for sports raffles for charity; and making related 2 repeals.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Sports Raffle
- 7 Charities Act.
- 8 Section 2. Legislative intent.
- 9 The General Assembly declares that conducting 50/50 drawings
- 10 at athletic events for the purpose of raising funds, by certain
- 11 nonprofit associations, for the promotion of charitable or civic
- 12 purposes, is in the public interest.
- 13 Section 3. Definitions.
- 14 The following words and phrases when used in this act shall
- 15 have the meanings given to them in this section unless the
- 16 context clearly indicates otherwise:

- 1 "Affiliated nonprofit organization." An organization
- 2 established by or affiliated with an athletic team for the
- 3 purpose of raising funds for charity, which is qualified for an
- 4 exemption under section 501(c)(3) of the Internal Revenue Code
- 5 of 1986 (Public Law 99-514, 26 U.S.C. § 501(c)(3)).
- 6 "Athletic event drawing." A 50/50 drawing that is conducted
- 7 by an affiliated nonprofit organization in accordance with this
- 8 act.
- 9 "Athletic team." A sports team or racing facility that is
- 10 any of the following:
- 11 (1) A member of Major League Baseball, the National
- 12 Hockey League, the National Basketball Association, the
- 13 National Football League or Major League Soccer.
- 14 (2) A professional sports team affiliated with a team
- under paragraph (1).
- 16 (3) Any other professional sports team that has a sports
- facility or an agreement with a sports facility to conduct
- 18 home games at the facility.
- 19 (4) A stadium, grandstand, bleacher or contiguous
- 20 parking lot at a closed-course motor facility where
- 21 spectators directly observe motor races with NASCAR, Indy,
- 22 stock or drag racing cars.
- 23 (5) A collegiate team that competes on behalf of an
- institution of higher education.
- 25 "County authority." The county treasurer, or in a home rule
- 26 county or city of the first class where there is no elected
- 27 treasurer, the designee of the governing authority.
- "Department." The Department of Revenue of the Commonwealth.
- 29 "HOME GAME." AS APPLIED TO A UNITED STATES SERVICE ACADEMY, <--
- 30 A GAME PLAYED AT A NEUTRAL SPORTS FACILITY.

- 1 "Institution of higher education." Any of the following:
- 2 (1) A community college operating under Article XIX-A of
- 3 the act of March 10, 1949 (P.L.30, No.14), known as the
- 4 Public School Code of 1949.
- 5 (2) A university within the State System of Higher 6 Education.
 - (3) The Pennsylvania State University.
- 8 (4) The University of Pittsburgh.
- 9 (5) Temple University.

- 10 (6) Lincoln University.
- 11 (7) Any other institution that is designated as "State-12 related" by the Commonwealth.
- 13 (8) An accredited private or independent college or university.
- 15 (9) A UNITED STATES SERVICE ACADEMY.

16 "Public interest purpose." One or more of the following:

- 17 (1) The activities and operations of a nonprofit
 18 organization that provides a benevolent, charitable,
 19 religious, educational, philanthropic, humane, scientific,
 20 patriotic, social welfare, social advocacy, public health,
 21 public safety, emergency response, environmental, historic or
 22 civic objective.
- 23 (2) Initiating, performing or fostering worthy public 24 works or enabling or furthering the erection or maintenance 25 of public structures.
 - (3) Lessening the burdens borne by government or voluntarily supporting, augmenting or supplementing services which government would normally render to the people.
- 29 (4) Improving, expanding, maintaining or repairing real 30 property owned or leased by a nonprofit organization and

- 1 relating operational expenses used for purposes specified in
- 2 paragraphs (1), (2) and (3).
- 3 (5) Nonprofit youth sports activities.
- 4 (6) Activities relating to the provision of volunteer
- 5 fire, ambulance or rescue services.
- 6 (7) Activities conducted by a veterans organization,
- 7 including:
- 8 (i) Scholarships.
- 9 (ii) Services to economically or socially support
- 10 veterans.
- 11 (iii) Activities to honor veterans.
- 12 (iv) Other activities that qualify under paragraphs
- 13 (1), (2), (3), (4), (5) and (6).
- 14 The term does not include the erection or acquisition of real
- 15 property, unless the property will be used exclusively for one
- 16 or more of the purposes specified in this definition.
- 17 "TEAM EVENT." A PRACTICE, SCRIMMAGE OR EXHIBITION OR SIMILAR <--
- 18 EVENT AT THE HOME STADIUM OR TRAINING CAMP FACILITY OF AN
- 19 ATHLETIC TEAM.
- 20 Section 4. Athletic event drawing.
- 21 (a) General rule. -- A person may purchase one or more
- 22 athletic event drawing tickets at a home game OR TEAM EVENT, and <--
- 23 each ticket purchased shall represent one entry in the drawing
- 24 for a winner. A single ticket shall be randomly chosen as the
- 25 winner after a certain number of tickets are sold or a specified
- 26 time period expires as designated by the affiliated nonprofit
- 27 organization. Purchase of athletic event drawing tickets may be
- 28 made by cash, credit card or debit card.
- 29 (b) Frequency. -- An affiliated nonprofit organization may
- 30 conduct no more than one athletic event drawing per home game OR <--

- 1 TEAM EVENT.
- 2 (c) Sales restricted. -- Tickets for an athletic event drawing
- 3 may not be sold in any seating area designated as a family
- 4 section or to an individual under 18 years of age.
- 5 (d) Charitable event. -- An athletic event drawing may be
- 6 conducted by the affiliated nonprofit organization during a
- 7 charitable event held within the same arena, stadium,
- 8 grandstand, bleachers or other facility during a home game, team
- 9 event or car race of the athletic team. Drawings may only be
- 10 held within spectator areas within the arena, stadium,
- 11 grandstand or bleachers where the home game, TEAM EVENT or car <--
- 12 race is being conducted and not at ancillary areas or
- 13 facilities, including parking areas, restaurants and bars or
- 14 areas outside the arena, stadium, grandstand or bleachers or
- 15 areas where the sport is shown on remote electronic equipment.
- 16 (e) Distribution. -- The prize amount of an athletic event
- 17 drawing shall be 50% of the total amount collected from the sale
- 18 of athletic event drawing tickets. Except as provided under
- 19 subsection (f), the other 50% of the total amount collected from
- 20 the sale of athletic event drawing tickets shall be donated
- 21 within seven days from the date of the drawing by the affiliated
- 22 nonprofit organization conducting the athletic event drawing to
- 23 one or more designated charitable organizations for which the
- 24 drawing was conducted and shall be used exclusively for public
- 25 interest purposes.
- 26 (f) Use of funds.--
- 27 (1) The affiliated nonprofit organization may utilize
- 28 nonprize money collected for the following:
- 29 (i) To employ or provide payment to individuals 18
- 30 years of age or older to sell athletic event drawing

- 1 tickets.
- 2 (ii) For administrative expenses directly related to
- 3 the conduct of the athletic event drawing under this
- 4 section.
- 5 (2) Authorized expenses under paragraph (1)(ii) may not
- 6 exceed 2% of the total amount collected from the sale of
- 7 athletic event drawing tickets.
- 8 (g) Designated charitable organization. -- The affiliated
- 9 nonprofit organization conducting the athletic event drawing
- 10 shall disclose to each ticket purchaser the designated
- 11 charitable organization for which the athletic event drawing is
- 12 being conducted.
- 13 (h) Eligibility.--
- 14 (1) In order to receive proceeds from an athletic event
- drawing, a charitable organization must be:
- 16 (i) in existence and fulfilling its purposes for at
- least two years prior to the drawing; and
- 18 (ii) eligible for exemption under section 501(c)(3)
- of the Internal Revenue Code of 1986 (Public Law 99-514,
- 20 26 U.S.C. § 501(c)(3)).
- 21 (2) A political subdivision shall not qualify as a
- 22 charitable organization under this section.
- 23 (3) An institution of higher education that is qualified
- for an exemption under section 501(c)(3) of the Internal
- 25 Revenue Code of 1986 and meets the eligibility requirements
- under paragraph (1)(i) may conduct an athletic event drawing
- as the affiliated nonprofit organization and may receive the
- proceeds therefrom as the designated charitable organization
- at any home game or charitable event of any of its own
- 30 collegiate athletic teams provided that the proceeds are used

- 1 exclusively for public interest purposes or for purposes
- permitted under subsection (f).
- 3 (4) Notwithstanding paragraph (1)(ii), an institution of
- 4 higher education that is qualified for an exemption under
- 5 section 115 of the Internal Revenue Code of 1986 (Public Law
- 6 99-514, 26 U.S.C. § 115) and meets the eligibility
- 7 requirements under paragraph (1)(i) may conduct an athletic
- 8 event drawing as the affiliated nonprofit organization and
- 9 may receive the proceeds therefrom as the designated
- 10 charitable organization at any home game or charitable event
- of any of its own collegiate athletic teams, provided that
- the proceeds are used exclusively for public interest
- purposes or for purposes permitted under subsection (f).
- 14 (i) Unclaimed prizes. -- An athletic event drawing prize
- 15 remaining unclaimed by a winner at the end of the athletic
- 16 team's season shall be donated within 30 days from the end of
- 17 the season by the affiliated nonprofit organization to the
- 18 designated charitable organization for which the athletic event
- 19 drawing was conducted.
- 20 (j) Additional recordkeeping. -- The department may require
- 21 additional recordkeeping or accountability measures for athletic
- 22 event drawings.
- 23 (k) Mechanical or electrical devices. -- An athletic event
- 24 drawing may be played with the assistance of a mechanical or
- 25 electrical device. Nothing under this subsection shall be
- 26 construed to authorize any other form of gambling authorized
- 27 under 4 Pa.C.S. (relating to amusements).
- 28 (1) Prohibitions.--
- 29 (1) no person who has been convicted of a felony or of a
- violation of the act of July 10, 1981 (P.L.214, No.67), known

- as the Bingo Law, or the act of December 19, 1988 (P.L.1262,
- No.156), known as the Local Option Small Games of Chance Act,
- 3 or this act or any comparable Federal or State law shall have
- 4 a pecuniary interest in the operation of or in proceeds from
- 5 an athletic event drawing.
- 6 (2) No person who has been convicted of a felony in a
- 7 Federal or State court within the past five years or has been
- 8 convicted in a Federal or State court within the past 10
- 9 years of a violation of the Bingo Law, the Local Option Small
- Games of Chance Act or this act may manage, set up, supervise
- or participate in the operation of an athletic event drawing.
- 12 (3) No person under 18 years of age may operate or play
- an athletic event drawing.
- 14 (m) Enforcement.--
- 15 (1) The county authority of the county in which an
- 16 athletic event drawing is conducted may enforce the
- 17 provisions of this act and may impose civil penalties under
- 18 subsection (n).
- 19 (2) The district attorney of the county in which the
- 20 athletic event drawing is conducted shall investigate alleged
- 21 violations of this act. If the district attorney finds
- 22 probable cause to believe that a criminal violation has
- occurred, the district attorney may file criminal charges and
- 24 prosecute the complaint against the alleged violator in the
- court of common pleas of the county except in counties of the
- first class where the complaint may be filed in the municipal
- 27 court.
- 28 (3) Nothing in this act may restrict or limit the power
- of a State, county or local law enforcement official to
- 30 conduct investigations and file criminal charges under this

- 1 act.
- 2 (4) The district attorney may require an affiliated
- 3 nonprofit organization to produce its books, accounts and
- 4 records relating to the conduct of athletic event drawings in
- order to determine if a violation of this act has occurred.
- 6 Affiliated nonprofit organizations shall also be required,
- 7 upon request, to provide their books, accounts and records
- 8 relating to the conduct of athletic event drawings to the
- 9 county authority or to a law enforcement agency or official.
- 10 (n) Civil penalties. -- An affiliated nonprofit organization
- 11 that violates the provisions of this act shall be subject to the
- 12 following civil penalties:
- 13 (1) For an initial violation, up to \$500.
- 14 (2) For a second violation, up to \$1,000.
- 15 (3) For a third or subsequent violation, up to \$1,500.
- 16 (o) Criminal penalties.--
- 17 (1) An affiliated nonprofit organization violating the
- provisions of this act shall be guilty of a summary offense
- and, upon conviction thereof, shall be sentenced to pay a
- fine not exceeding \$1,000 for a first offense and \$1,500 for
- 21 a subsequent offense.
- 22 (2) A person who conducts or assists in the conducting
- of an athletic event drawing in violation of the provisions
- of this act is quilty of a summary offense for a first
- violation. A second violation of this act shall be punishable
- as a misdemeanor of the third degree. A third or subsequent
- violation shall be punishable as a misdemeanor of the first
- degree.
- 29 (3) A person commits a misdemeanor of the first degree
- if, with intent to prevent an athletic event drawing from

- 1 being conducted in accordance with the requirements of this
- 2 act or the rules and usages governing the athletic event
- 3 drawing, the person:
- 4 (i) confers or offers or agrees to confer any
- 5 benefit upon or threatens any injury to a participant or
- other person associated with the athletic event drawing;
- 7 (ii) tampers with any person or athletic event
- 8 drawing; or
- 9 (iii) solicits, accepts or agrees to accept any
- 10 benefit.
- 11 Section 5. Repeals.
- 12 (a) Declaration. -- The General Assembly declares that the
- 13 repeal under subsection (b) is necessary to effectuate this act.
- 14 (b) Repeal.--The following provisions of the act of December
- 15 19, 1988 (P.L.1262, No.156), known as the Local Option Small
- 16 Games of Chance Act, are repealed:
- 17 (1) The definition of "major league sports drawing" in
- 18 section 103.
- 19 (2) Section 304.1.
- 20 Section 6. Effective date.
- 21 This act shall take effect in 30 days.
