- Amending the act of February 14, 2008 (P.L.6, No.3), entitled 1 "An act providing for access to public information, for a 2 designated open-records officer in each Commonwealth agency, 3 local agency, judicial agency and legislative agency, for procedure, for appeal of agency determination, for judicial review and for the Office of Open Records; imposing 5 penalties; providing for reporting by State-related 7 institutions; requiring the posting of certain State contract 8 information on the Internet; and making related repeals," in preliminary provisions, further providing for definitions; 10 and, in procedure, further providing for exceptions for 11 public records. 12 13 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 14 Section 1. The definition of "personal financial

- 2 "Personal financial information." An individual's personal

- 4 <u>financial institution</u> account information; bank, credit or

- 7 other than an election to become a member of the State
- 8 <u>Employees' Retirement System, the Public School Employees'</u>
- 9 Retirement System, the Pennsylvania Municipal Retirement System
- 10 or any other retirement plan for employees of the Commonwealth
- 11 or any of its political subdivisions; contributions to
- 12 retirement plans or other investment options; contributions
- 13 toward the cost of health care benefits or other benefits;

- 17 Section 2. Section 708(b)(6) and (c) of the act are amended
- 18 and subsection (b) is amended by adding a paragraph to read:

- 21 (b) Exceptions.--Except as provided in subsections (c) and
- 22 (d), the following are exempt from access by a requester under
- 23 this act:

- 25 (6) (i) The following personal identification

- 27 (A) A record containing all or part of a
- 28 person's Social Security number, driver's license
- 29 number, personal financial information, home,
- 30 cellular or personal telephone numbers, personal e-

3	(B) A spouse's name, marital status or
4	beneficiary or dependent information, including the
5	number, names and ages of an employee's dependents.
6	(C) The home address of a law enforcement
7	officer or judge.
8	(ii) Nothing in this paragraph shall preclude the
9	release of the name, position, salary, actual
10	compensation or other payments or expenses, employment
11	contract, employment-related contract or agreement and
12	length of service of a public official or an agency
13	employee.
14	(iii) An agency may redact the name or other
15	identifying information relating to an individual
16	performing an undercover or covert law enforcement
17	activity from a record.
18	(iv) Nothing in this paragraph shall prevent the
19	disclosure of employer costs or aggregated data of
20	employee costs related to retirement benefits, health
21	care benefits or other benefits, the disclosure of
22	options made available to employees regarding retirement,
23	health care benefits or other benefits or the disclosure
24	of options made available to employees regarding
25	retirement, health care and other benefit plans.

27	(31) An agency's financial institution account number,
28	routing number, credit card number or PIN number. Such
29	numbers may be reasonably redacted to the extent necessary to

- 3 (c) Financial records. -- The exceptions set forth in
- 4 subsection (b) shall not apply to financial records, except that
- 5 an agency may redact that portion of a financial record
- 6 protected under subsection (b) (1), (2), (3), (4), (5), (6), (16)
- 7 [or], (17) or (31). An agency shall not disclose the identity of
- 8 an individual performing an undercover or covert law enforcement
- 9 activity.

- 11 Section 3. This act shall take effect in 60 days.
