AN ACT

- Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An act relating to insurance; amending, revising, and consolidating the law providing for the incorporation of insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds 5 associations, reciprocal and inter-insurance exchanges, and 6 fire insurance rating bureaus, and the regulation and 7 supervision of insurance carried by such companies, associations, and exchanges, including insurance carried by 9 the State Workmen's Insurance Fund; providing penalties; and 10 repealing existing laws," in casualty insurance, further 11 providing for health insurance coverage for certain children 12 of insured parents. 13 The General Assembly of the Commonwealth of Pennsylvania 14 15 hereby enacts as follows: 16 Section 1. Section 617.1(A) of the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, 17 18 is amended to read: 19 Section 617.1. Health Insurance Coverage for Certain 20 Children of Insured Parents. -- (A) An insurer that issues, 21 delivers, executes or renews group health care insurance in this
- 22 Commonwealth under which coverage of a child would otherwise

- 1 terminate at a specified age shall, at the option of the
- 2 [policyholder] policyholder's insured employe, provide coverage
- 3 to a child of an insured employe beyond that specified age, up
- 4 through and including the age of [29] 25, at the insured
- 5 employe's expense, and provided that the child meet all of the
- 6 following requirements:
- 7 (1) Is not married.
- 8 (2) Has no dependents.
- 9 (3) Is a resident of this Commonwealth or is enrolled as a
- 10 full-time student at an institution of higher education.
- 11 (4) Is not provided coverage as a named subscriber, insured,
- 12 enrollee or covered person under any other group or individual
- 13 health insurance policy or enrolled in or entitled to benefits
- 14 under any government health care benefits program, including
- 15 benefits under Title XVIII of the Social Security Act (49 Stat.
- 16 620, 42 U.S.C. § 1395 et seq.).

- 18 Section 2. The amendment of section 617.1(A) of the act
- 19 shall apply to either of the following that occurs 60 days after
- 20 the effective date of this act:
- 21 (1) entering into a contract; or
- 22 (2) renewing a contract.
- 23 Section 3. This act shall take effect in 60 days.
