AN ACT

1 Making appropriations from the General Fund to the Department of
2 Aging for the fiscal year beginning July 1, 2019, and for the
3 payment of bills incurred and remaining unpaid at the close
4 of the fiscal year ending June 30, 2020.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

8 PRELIMINARY PROVISIONS

9 Section 101. Short title.

10 This act shall be known and may be cited as the Appropriation
11 Act of 2019 - Department of Aging.

13 GENERAL FUND APPROPRIATIONS

14 FOR 2019-2020

15 Section 301. Appropriations from General Fund.

16 The following amounts, or as much thereof as may be
17 necessary, are hereby appropriated from the General Fund to the
18 Department of Aging for the purposes specified in this part for
19 the fiscal year beginning July 1, 2019, and for the payment of

1 bills incurred and remaining unpaid at the close of the fiscal
2 year ending June 30, 2020:
