AN ACT

1 Making appropriations from the General Fund to the Department of

9 Section 101. Short title.

10 This act shall be known and may be cited as the Appropriation
11 Act of 2019 - Department of Drug and Alcohol Programs.

15 Section 301. Appropriations from General Fund.
