AN ACT

1 Making appropriations from the General Fund to the Pennsylvania
2 Historical and Museum Commission for the fiscal year
3 beginning July 1, 2019, and for the payment of bills incurred
4 and remaining unpaid at the close of the fiscal year ending
5 June 30, 2020.
