AN ACT

1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
2 act relating to the public school system, including certain
3 provisions applicable as well to private and parochial
4 schools; amending, revising, consolidating and changing the
5 laws relating thereto," making editorial changes.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Sections 502, 925(f), 923.2-A, 1328, 1338,
9 ~~1372(3)~~, 1376(a), 1377, 1377.1, 1378, 1379, 1414, 1502-E(b), ◀
10 2108, 2501(11), 2509(b), ~~2510.17~~, 2517(e) and 2541(b)(3) of the ◀--
11 act of March 10, 1949 (P.L.30, No.14), known as the Public
12 School Code of 1949, are amended to read:

13 Section 502. Additional Schools and Departments.--In
14 addition to the elementary public schools, the board of school
15 directors in any school district may establish, equip, furnish,
16 and maintain the following additional schools or departments for
17 the education and recreation of persons residing in said

1 district, and for the proper operation of its schools, namely:--

2 High schools,

3 Trade schools,

4 Vocational schools,

5 Technical schools,

6 Cafeterias,

7 Agricultural schools,

8 Evening schools,

9 Kindergartens,

10 Libraries,

11 Museums,

12 Reading-rooms,

13 Gymnasiums,

14 Playgrounds,

15 Schools for [physically and mentally handicapped] children

16 with physical and OR mental disabilities,

<--

17 Truant schools,

18 Parental schools,

19 Schools for adults,

20 Public lectures,

21 Such other schools or educational departments as the

22 directors, in their wisdom, may see proper to establish.

23 Said additional schools or departments, when established,

24 shall be an integral part of the public school system in such

25 school district and shall be so administered.

26 No pupil shall be refused admission to the courses in these

27 additional schools or departments, by reason of the fact that

28 his elementary or academic education is being or has been

29 received in a school other than a public school.

30 Section 925. Powers and Duties.--

1 (f) (1) Any county board of school directors may make
2 contracts of insurance with any insurance company, or nonprofit
3 hospitalization corporation, or nonprofit medical service
4 corporation, authorized to transact business within the
5 Commonwealth, insuring its employes, their spouses and
6 dependents and retired employes under a policy or policies of
7 group insurance covering life, health, hospitalization medical
8 service, or accident insurance, and for such purposes may agree
9 to pay part or all of the premiums or charges for carrying such
10 contracts, and may include the cost of such charges in its
11 estimate of the cost of operating and administering classes or
12 schools for [handicapped and institutionalized] children with
13 physical and OR mental disabilities to be operated by the county <--
14 board during the ensuing school year. No contract or contracts
15 of insurance authorized by this section shall be purchased from
16 or through any person employed by the county board in a teaching
17 or administrative capacity.

18 (2) The county board of school directors is hereby
19 authorized to deduct from the employe's pay, salary, or
20 compensation, such part of the premium as is payable by the
21 employe and as may be so authorized by the employe in writing.

22 (3) All contracts procured hereunder shall conform and be
23 subject to all the provisions of any existing or future laws
24 concerning group insurance contracts.

25 Section 923.2-A. Visual Services.--(a) Legislative Finding;
26 Declaration of Policy. [Defects] Impairments in vision are
27 health-related. It is today recognized that the diagnosis and
28 evaluation of those [defects] impairments and the rendering of
29 instruction in skills appropriate for the education, safety and
30 independence of children afflicted by visual impairments are

1 closely related to their physical, mental and emotional health.
2 Such services can best be rendered upon the premises of the
3 school which the child regularly attends and forcing children to
4 go to other premises in order to have such needed services is
5 found by the General Assembly to be both inadequate and harmful.
6 The General Assembly expressly finds and declares diagnostic,
7 evaluative and instructional services for such children to be
8 health services and it is the intention of the General Assembly
9 now to make these available, on a general and even-handed basis
10 to all school children in the Commonwealth.

11 (b) Definitions. As used in this section:

12 "Nonpublic school" means any nonprofit school, other than a
13 public school within the Commonwealth of Pennsylvania, wherein a
14 resident of the Commonwealth may legally fulfill the compulsory
15 school attendance requirements and which meets the requirements
16 of Title VI of the Civil Rights Act of 1964 (Public Law 88-352).

17 "Visual services" means diagnostic, evaluative and
18 instructional visual services for children.

19 (c) Provision of Services. The Secretary of Education,
20 directly or through the intermediate units out of their
21 allocation under section 922.1-A shall have the power and duty
22 to furnish free to nonpublic school students, upon the premises
23 of the nonpublic schools which they regularly attend, services
24 adequate for the diagnosis and evaluation of visual [defects]
25 impairments and instruction and training in skills advisable for
26 the education, independence and safety of such children,
27 including but not limited to mobility training, provided that
28 such services are also afforded to public school students by the
29 public school district in which such nonpublic school is
30 located.

1 Section 1328. Compulsory Education of CHILDREN WITH Physical <--
2 [Defectives] Impairments.--Every parent, guardian, or other
3 person, having control or charge of any child of compulsory
4 school age who is deaf or blind, [or is so crippled,] or whose
5 hearing or vision is so [defective] impaired as to make it
6 impracticable to have such child educated in the public schools
7 of the district in which he is a resident, shall allow such
8 child to be sent to some school where proper provision is made
9 for the education of the deaf, or of the blind, [or of crippled
10 children,] or shall provide for the tuition of such child by a
11 legally certified private tutor.

12 Section 1338. Dependent Children.--In case any child of
13 compulsory school age cannot be kept in school in compliance
14 with the provisions of this act, on account of incorrigibility,
15 truancy, insubordination, or [other {bad}] inappropriate conduct, ◀
16 or if the presence of any child attending school is detrimental
17 to the welfare of such school, on account of incorrigibility,
18 truancy, insubordination, or [other {bad}] inappropriate conduct, ◀
19 the board of school directors may, by its superintendent,
20 secretary, attendance officer or State, municipal, port
21 authority, transit authority or housing authority police
22 officer, under such rules and regulations as the board may
23 adopt, proceed against said child before the juvenile court, or
24 otherwise, as is now or may hereafter be provided by law for
25 incorrigible, truant, insubordinate, or dependent children.

26 ~~Section 1372. Exceptional Children; Education and~~ ◀
27 ~~Training. * * *~~

28 ~~(3) Special Classes or Schools Established and Maintained by~~
29 ~~School Districts. Except as herein otherwise provided, it shall~~
30 ~~be the duty of the board of school directors of every school~~

~~1 district to provide and maintain, or to jointly provide and
2 maintain with neighboring districts, special classes or schools
3 in accordance with the approved plan. The Secretary of Education
4 shall superintend the organization of such special classes and
5 such other arrangements for special education and shall enforce
6 the provisions of this act relating thereto. If the approved
7 plan indicates that it is not feasible to form a special class
8 in any district or to provide such education for any such child
9 in the public schools of the district, the board of school
10 directors of the district shall secure such proper education and
11 training outside the public schools of the district or in
12 special institutions, or by providing for teaching the child in
13 his home, in accordance with rules and regulations prescribed by
14 the Department of Education, on terms and conditions not
15 inconsistent with the terms of this act or of any other act then
16 in force applicable to such children. However, the institution
17 of special classes and programs at the secondary level for
18 exceptional children who are gifted and talented students may be
19 deferred until September 1978 at the discretion of the board of
20 the school directors of any school district.~~

~~21 In addition to the above and in accordance with rules and
22 regulations prescribed by the Department of Education,
23 [homebound] instruction shall be provided for children confined <--
24 in detention homes as provided in section 7, act of June 2, 1933
25 (P.L.1433, No.311), as amended, at the detention home for the
26 period of their confinement, if their confinement exceeds or is
27 expected to exceed ten days, even though such children are not
28 exceptional.~~

30 Section 1376. Cost of Tuition and Maintenance of Certain

1 Exceptional Children in Approved Institutions.--(a) When any
2 child between school entry age and twenty-one (21) years of age
3 and resident in this Commonwealth, who is blind or deaf, or has
4 cerebral palsy and/or neurological impairment and/or muscular
5 dystrophy and/or is [mentally retarded] ~~developmentally~~ <--
6 INTELLECTUALLY disabled and/or has a serious emotional <--
7 [disturbance] disability and/or has autism/pervasive
8 developmental disorder and is enrolled, with the approval of the
9 Department of Education, as a pupil in an approved private
10 school approved by the Department of Education, in accordance
11 with standards and regulations promulgated by the State Board of
12 Education, the school district in which such child is resident
13 or, for students placed by a charter school, the charter school
14 in which the student was enrolled shall pay the greater of
15 either twenty per centum (20%) of the actual audited cost of
16 tuition and maintenance of such child in such school, as
17 determined by the Department of Education, or its "tuition
18 charge per elementary pupil" or its "tuition charge per high
19 school pupil," as calculated pursuant to section 2561, and the
20 Commonwealth shall pay, out of funds appropriated to the
21 department for special education, the balance due for the costs
22 of such child's tuition and maintenance, as determined by the
23 department. For the school years 1989-1990, 1990-1991 and 1991-
24 1992, the school district payment shall be no greater than forty
25 percent (40%) of the actual audited costs of tuition and
26 maintenance of such child in such school. For the 1992-1993
27 school year through the 2003-2004 school year, the school
28 district or charter school payment shall be the greater of forty
29 percent (40%) of the actual audited costs of tuition and
30 maintenance of such child in such school, as determined by the

1 Department of Education, or its "tuition charge per elementary
2 pupil" or its "tuition charge per high school pupil," as
3 calculated pursuant to section 2561, and the Commonwealth shall
4 pay, out of funds appropriated to the department for approved
5 private schools, the balance due for the costs of such child's
6 tuition and maintenance, as determined by the department. For
7 the 2004-2005 school year and each school year thereafter, the
8 school district or charter school payment shall be the greater
9 of forty percent (40%) of the approved tuition rate as
10 established pursuant to subsection (c.3) or (c.5) or the school
11 district or charter school's "tuition charges per elementary
12 pupil" or "tuition charges per secondary pupil" as calculated
13 under section 2561, and the Commonwealth shall pay out of funds
14 appropriated to the department for approved private schools the
15 balance of the approved tuition rate due for the cost of such
16 child's tuition and maintenance. The department will credit the
17 district of residence with average daily membership for such
18 child consistent with the rules of procedure developed in
19 accordance with section 2501. If the residence of such child in
20 a particular school district cannot be determined, the
21 Commonwealth shall pay the whole cost of tuition and maintenance
22 of such child as established under subsection (c.3) or (c.5).

24 Section 1377. Payment of Cost of Tuition and Maintenance of
25 Certain Exceptional Children.--(a) To facilitate payments by
26 the several school districts to the schools or institutions in
27 which children who are deaf or blind, or cerebral palsied and/or
28 brain damaged and/or muscular dystrophied, or socially and
29 emotionally [disturbed] disabled or [mentally retarded children]
30 developmentally INTELLECTUALLY disabled are enrolled, of amounts <--

1 due by such districts for their proportion of the cost of
2 tuition and maintenance of such children, the Secretary of
3 Education shall withhold from any moneys due to such districts
4 out of any State appropriation for the assistance as
5 reimbursement of school districts, the amounts due by such
6 districts to such schools or institutions for the blind or the
7 deaf, or the cerebral palsied and/or brain damaged and/or
8 muscular dystrophied or the socially and emotionally [disturbed]
9 disabled and/or [mentally retarded] ~~developmentally~~ <--
10 INTELLECTUALLY disabled. Amounts so withheld shall be <--
11 specifically appropriated to the Department of Education.

12 (b) Payments of the Commonwealth's proportion of the cost of
13 tuition and maintenance of pupils who are blind or deaf, or
14 cerebral palsied and/or brain damaged and/or muscular
15 dystrophied, or socially and emotionally [disturbed] disabled
16 and/or [mentally retarded pupils] ~~developmentally~~ INTELLECTUALLY <--
17 disabled and are enrolled in schools or institutions for the
18 blind or for the deaf, or for the cerebral palsied and/or brain
19 damaged and/or muscular dystrophied, or for the socially and
20 emotionally [disturbed] disabled and of the cost of instruction
21 of parents of blind pupils less than school entry age, as
22 hereinbefore provided, shall be made quarterly, out of moneys
23 appropriated to the Department of Education for special
24 education. Except for the provisions of section 1376.1 providing
25 for the actual cost of tuition and maintenance of certain
26 exceptional children in the four chartered schools for education
27 of the deaf and of the blind, in no event shall the total
28 payment for the cost of tuition and maintenance of any such
29 child exceed the rates per year allowed under section 1376. The
30 maximum amount payable for the cost of tuition and maintenance

1 of such children shall be subject to review at least once every
2 two years for the purpose of recommending an adjustment thereof.

3 (c) For the purpose of enabling the Department of Education
4 to determine from time to time what amounts are due to schools
5 for the blind or for the deaf or for the cerebral palsied and/or
6 brain damaged and/or muscular dystrophied or for the socially
7 and emotionally [~~disturbed~~] disabled and/or [~~mentally retarded~~]
8 ~~developmentally~~ INTELLECTUALLY disabled hereunder, such schools <--
9 shall forward to the department, at such times and in such form
10 as the department shall prescribe, sworn statements setting
11 forth the names, ages, and residences of all pupils enrolled
12 hereunder, specifying the school districts liable for a part of
13 the cost of tuition and maintenance of any such pupils, the per
14 capita cost of and maintenance of pupils, and such other
15 information as the department shall require.

16 For the purpose of providing adequate administration of the
17 program and to carry out the preaudit functions authorized in
18 section 1376(a), one-half of one percent (.50%) of the total
19 appropriations for approved private schools from all funds shall
20 be allocated to the Department of Education.

21 (d) When, during the course of the 1982-1983 school year,
22 programs for exceptional children are caused to be transferred
23 from schools or institutions for the blind or deaf, or cerebral
24 palsied or brain damaged or muscular dystrophied or [~~mentally~~
25 ~~retarded~~] ~~developmentally~~ INTELLECTUALLY disabled, or socially <--
26 and emotionally [~~disturbed~~] disabled, as provided for in
27 sections 1376 and 1376.1, to school districts or intermediate
28 units, as provided for in sections 2509 and 2509.1, under
29 unanticipated or emergency circumstances, and when such
30 transfers necessitate the transfer of funds from the

1 appropriation to the Department of Education for special
2 education for approved private schools to the appropriation to
3 the Department of Education for payments on account of special
4 education of exceptional children in public schools, the
5 Secretary of Education shall be empowered so to transfer such
6 funds, upon approval of the Secretary of the Budget and written
7 notification to the State Treasurer and the chairmen of the
8 House and Senate Appropriations and Education Committees.

9 Section 1377.1. Transfer of Funds for Transferral Programs.--

10 When, during the course of a school year or after the end of a
11 school year, programs for exceptional children are caused to be
12 transferred from schools or institutions for the blind or deaf,
13 or cerebral palsied or brain damaged or muscular dystrophied or
14 [~~mentally retarded~~] ~~developmentally~~ INTELLECTUALLY disabled, or <--
15 socially and emotionally [~~disturbed~~] disabled, as provided for
16 in sections 1376 and 1376.1, to school districts or intermediate
17 units, as provided for in sections 2509 and 2509.1, and when
18 such transfers necessitate the transfer of funds from the
19 appropriation to the Department of Education for special
20 education for approved private schools to the appropriation to
21 the Department of Education for payments on account of special
22 education of exceptional children in public schools, the
23 Secretary of Education shall be empowered to transfer such
24 funds, upon approval of the Secretary of the Budget and written
25 notification to the State Treasurer and the chairmen of the
26 House and Senate Appropriations and Education Committees.

27 Section 1378. Medical Care for Children Under Six with
28 [~~Defective~~] Impaired Hearing.--Whenever the county medical
29 director of the Department of Health reports to the medical
30 examiner of any school district a case of a minor under six (6)

1 years of age, who is totally deaf or whose hearing is impaired,
2 who is not receiving adequate care and treatment, and whose
3 parent or guardian is financially unable to provide the same,
4 such medical examiner shall provide such care and treatment at
5 the expense of the school district or of the Commonwealth, as
6 the case may be, charged by law with the providing of medical
7 examinations for the schools of the school district. Such care
8 and treatment may be administered by the medical examiner or by
9 some doctor of medicine selected by him.

10 Section 1379. Children Under Six with [Defective] Impaired
11 Hearing; Parent or Guardian Advised of Schools, etc.--Whenever
12 notified by the Department of Health of the case of a minor
13 under six (6) years of age, who is totally deaf or whose hearing
14 is impaired, the Superintendent of Public Instruction, when in
15 his judgment the same is deemed desirable, shall communicate to
16 the parent or guardian the location of any special schools, and
17 also the nearest public school having special classes for the
18 instruction of the hard of hearing, with the information
19 concerning the advantages offered by such school or classes, the
20 benefits to accrue to the child from attending such school or
21 classes, and the manner in which the expenses of such
22 instruction will be provided for.

23 Section 1414. Care and Treatment of Pupils.--Any school
24 district or joint school board may provide for the care and
25 treatment of [defective] impaired eyes, ears and teeth of all
26 children of school age within the district.

27 Section 1502-E. Character education program.

28 * * *

29 (b) Curriculum contents.--The program may include and teach
30 the following basic civil values and character traits:

1 (1) Trustworthiness, including honesty, integrity,
2 reliability and loyalty.

3 (2) Respect, including regard for others, tolerance and
4 courtesy.

5 (3) Responsibility, including hard work, economic self-
6 reliance, accountability, diligence, perseverance and self-
7 control.

8 (4) Fairness, including justice, consequences of [bad]
9 inappropriate behavior, principles of nondiscrimination and
10 freedom from prejudice.

11 (5) Caring, including kindness, empathy, compassion,
12 consideration, generosity and charity.

13 (6) Citizenship, including love of country, concern for
14 the common good, respect for authority and the law and
15 community mindedness.

16 * * *

17 Section 2108. Qualifications of Principals and Teachers.--

18 The board of public education in each school district of the
19 first class shall prescribe the mode or modes of determining the
20 qualifications of applicants for positions as principals or
21 teachers in the schools of the district, and shall designate the
22 kinds or grades of teachers' certificates which may or shall be
23 used in the district, together with the scholastic,
24 professional, and personal qualifications required for each kind
25 or grade of certificate.

26 No certificate shall be granted to any person who is not of
27 good moral character, or to any person who shall not first have
28 presented a certificate, from a physician recognized by the
29 board of public education as competent for the purpose, setting
30 forth that said applicant is neither mentally nor physically

1 disqualified by reason of tuberculosis, or any other chronic or
2 acute physical [defect] impairment, from successfully performing
3 the duties of a teacher.

4 Section 2501. Definitions.--For the purposes of this article
5 the following terms shall have the following meanings:

6 * * *

7 (11) "Actual Instruction Expense Per Elementary Teaching
8 Unit, Actual Instruction Expense Per Elementary Teaching Unit in
9 a Laboratory School of a State-owned College, Actual Instruction
10 Expense Per Secondary Teaching Unit, Actual Instruction Expense
11 Per Secondary Teaching Unit in a Laboratory School of a State-
12 owned College, Actual Instruction Expense Per Joint Elementary
13 Teaching Unit, Actual Instruction Expense Per Joint Secondary
14 Teaching Unit, Actual Instruction Expense Per Area Technical
15 School Teaching Unit." In 1958 in the month of September and
16 thereafter annually in the month of September, the Department of
17 Public Instruction shall calculate for each school district for
18 the immediately preceding school year the actual instruction
19 expense per elementary teaching unit for elementary pupils
20 educated in the district's public schools, the actual
21 instruction expense per secondary teaching unit for secondary
22 pupils educated in the district's public schools, the actual
23 instruction expense per joint elementary teaching unit for
24 elementary pupils educated in elementary schools of jointures of
25 which the district is a member, the actual instruction expense
26 per joint secondary teaching unit for secondary pupils educated
27 in secondary schools of jointures of which the district is a
28 member, the actual instruction expense per area technical school
29 teaching unit for pupils educated in area technical schools in
30 which the district participates, the actual instruction expense

1 per elementary teaching unit for elementary pupils residing in
2 the district and educated in the public schools of other
3 districts within the Commonwealth, and the actual instruction
4 expense per secondary teaching unit for secondary pupils
5 residing in the district and educated in the public schools of
6 other districts within the Commonwealth. In each case, actual
7 instruction expense per teaching unit shall be the sum of (i)
8 and (ii) below but in no case shall include expenses for debt
9 service, capital outlay, rentals of capital facilities and
10 equipment, salaries and expenses for school nurses, for medical
11 and dental services, for driver education courses, for
12 reimbursable transportation of pupils, for tuition paid to other
13 school districts, for reimbursable board and lodging in lieu of
14 transportation, for salaries of directors and supervisors of
15 special education, public school psychologists, principals of
16 special schools and assistants, teachers of approved special
17 classes for [physically and mentally handicapped] children with
18 physical and OR mental disabilities, clerks and assistants <--
19 employed in programs for special education, for school district
20 contributions to the retirement fund on behalf of directors and
21 supervisors of special education, public school psychologists,
22 principals of special schools and assistants, teachers of
23 approved special classes for [physically and mentally
24 handicapped] children with physical and OR mental disabilities, <--
25 clerks and assistants employed in programs for special
26 education, for the cost of textbooks and supplies of the second
27 class used in special education classes or schools, for
28 extension schools and classes, for extension recreation
29 activities, for vocational extension education, or for
30 instruction of †homebound‡ children who are taught at home. (i) <--

1 Expenses of general control per teaching unit. Expenses of
2 general control shall include: salaries, supplies and other
3 expenses of the secretary's office; commission or salary of
4 treasurer, tax collector, auditors and legal service; expenses
5 of census enumeration and other expenses of business
6 administration; salaries of the superintendent of schools and
7 clerks of the superintendent of schools; expenses of supplies
8 and other expenses of the superintendent of schools' office; and
9 other expenses of general control. In the case of computation of
10 actual instruction expense per elementary teaching unit for
11 district pupils educated in the schools of the district and for
12 district pupils educated in the public schools of other
13 districts within the Commonwealth and actual instruction expense
14 per secondary teaching unit for district pupils educated in the
15 schools of the district and for district pupils educated in the
16 public schools of other districts within the Commonwealth,
17 expenses of general control per teaching unit shall be
18 calculated by dividing the foregoing listed expenses of general
19 control of the school district by the number of teaching units
20 based on the number of all pupils who are residents of the
21 school district and are in average daily membership in the
22 public schools of the Commonwealth. In the case of computation
23 of actual instruction expense per joint elementary teaching unit
24 and actual instruction expense per joint secondary teaching
25 unit, expenses of general control per teaching unit shall be
26 calculated by dividing the foregoing listed expenses of general
27 control of the school district by the number of teaching units
28 based on the number of all pupils who are residents of the
29 school district and are in average daily membership in the
30 public schools of the Commonwealth, and adding thereto the

1 quotient obtained by dividing the foregoing listed expenses of
2 general control of the joint school district by the number of
3 joint teaching units based on the number of pupils who are
4 residents of school districts that are members of the joint
5 school district and are in average daily membership in the
6 schools of the joint school district. In the case of computation
7 of actual instruction expense per area technical school teaching
8 unit, expenses of general control per teaching unit shall be
9 computed by dividing the foregoing listed expenses of general
10 control of the school district by the number of teaching units
11 based on the total number of all pupils who are residents of the
12 school district and are in average daily membership in the
13 public schools of the Commonwealth, and adding thereto the
14 quotient obtained by dividing the foregoing listed expenses of
15 general control of the area technical school by the number of
16 area technical school teaching units based on the number of
17 pupils who are residents of districts participating in the area
18 technical school and are in average daily membership in the area
19 technical school. (ii) Expenses of the school district, joint
20 school district, area technical school, or such other school
21 district within the Commonwealth in which the districts' pupils
22 are educated, as the case may be, on account of instruction,
23 auxiliary agencies and coordinate activities, operation of
24 school plant, maintenance of school plant, and fixed charges,
25 and each separately for elementary and for secondary schools,
