AN ACT

1 2	Amending Title 38 (Holidays and Observances) of the Pennsylvania Consolidated Statutes, providing for special observances.

- 9 This chapter recognizes the contributions of veterans of the
- 10 United States Armed Forces from this Commonwealth in major
- 11 conflicts since the Vietnam War.
- 12 § 1302. First Gulf War Veterans Day.
- 13 <u>(a) Legislative findings and declarations.--The General</u>
- 14 <u>Assembly finds and declares as follows:</u>
- 15 (1) On August 2, 1990, Saddam Hussein ordered Iragi
- troops to invade and occupy the sovereign nation of Kuwait.
- 17 (2) The United States led an international coalition
- demanding Saddam Hussein to withdraw Iraqi forces from Kuwait
- 19 by January 15, 1991.
- 20 (3) After Iraq failed to meet the deadline, passed by
- 21 the United Nations Security Council, President George H. W.
- 22 Bush on January 16, 1991, ordered United States Armed Forces
- 23 to begin "Operation Desert Storm."
- 24 (4) On January 17, 750,000 coalition forces from 36
- 25 <u>nations, including 540,000 United States Armed Forces, began</u>
- the battle to liberate Kuwait from occupation.
- 27 <u>(5) After an intensive air campaign, coalition forces</u>
- liberated Kuwait City on February 28, 1991.
- 29 (6) On March 6, after negotiating a cease-fire,
- 30 President Bush announced the end of combat operations.

- 1 (7) By the end of the conflict, 200 United States Armed
- 2 Forces members were killed, including 29 from this
- 3 Commonwealth.
- 4 (8) The bravery of United States Armed Forces and their
- 5 <u>allies should be recognized for the liberation of Kuwait and</u>
- 6 <u>restoration of Kuwait's sovereignty as an independent nation.</u>
- 7 (b) Designation. -- March 6 of each year is designated as
- 8 "First Gulf War Veterans Day."
- 9 (c) Proclamation. -- The Governor shall issue annually a
- 10 proclamation encouraging all public schools and educational
- 11 institutions to observe "First Gulf War Veterans Day" and to
- 12 <u>conduct exercises recognizing the contributions of all those</u>
- 13 <u>involved in the first Gulf War and remembering the sacrifices</u>
- 14 they made for their country. The proclamation may not mandate a
- 15 public school or educational institution to participate in the
- 16 observance.
- 17 § 1303. Afghanistan War Veterans Day.
- 18 (a) Legislative findings and declarations. -- The General
- 19 Assembly finds and declares as follows:
- 20 (1) The war in Afghanistan, which is America's longest
- 21 conflict, began in 2001 and continues to this day.
- 22 (2) Following the terrorist attacks on September 11,
- 23 2001, the United States demanded that the Taliban regime hand
- over Osama bin Laden and stop harboring Al Qaeda.
- 25 (3) President George W. Bush ordered United States Armed
- 26 Forces to begin "Operation Enduring Freedom" to combat
- 27 terrorism in Afghanistan and confront Al Qaeda.
- 28 (4) United States Armed Forces first entered Afghanistan
- and began combat operations on October 7, 2001.
- 30 (5) On May 2, 2011, Osama bin Laden was killed during

- 1 <u>the fighting after President Barack Obama ordered Navy SEALs</u>
- 2 <u>to raid Osama bin Laden's compound.</u>
- 3 (6) On December 28, 2014, the United States and the
- 4 North Atlantic Treaty Organization (NATO) combat operations
- 5 <u>in Afghanistan officially ended.</u>
- 6 (7) Since the beginning of Operation Enduring Freedom,
- 7 over 830,000 Americans, including 18,000 from this
- 8 <u>Commonwealth, have served in Afghanistan.</u>
- 9 <u>(8) More than 2,000 members of the United States Armed</u>
- 10 Forces, including 98 from this Commonwealth, were killed in
- 11 <u>action in Afghanistan since combat began.</u>
- 12 (9) More than 19,000 members of the United States Armed
- Forces were wounded in service to their country in
- 14 Afghanistan.
- 15 (b) Designation. -- October 7 of each year is designated as
- 16 <u>"Afghanistan War Veterans Day."</u>
- 17 (c) Proclamation. -- The Governor shall issue annually a
- 18 proclamation encouraging all public schools and educational
- 19 <u>institutions to observe "Afghanistan War Veterans Day" and to</u>
- 20 conduct exercises recognizing the contributions of all those
- 21 involved in the war in Afghanistan and remembering the
- 22 sacrifices they made for their country. The proclamation may not
- 23 <u>mandate a public school or educational institution to</u>
- 24 participate in the observance.
- 25 § 1304. Second Gulf War Veterans Day.
- 26 (a) Legislative findings and declarations. -- The General
- 27 Assembly finds and declares as follows:
- 28 (1) The second Gulf War was fought from 2003 to 2008.
- 29 (2) On March 19, 2003, President George W. Bush
- announced the beginning of combat operations in Iraq after

- 1 Saddam Hussein failed to meet the deadline for leaving Iraq.
- 2 (3) On December 18, 2011, the last member of the United
- 3 States Armed Forces left Iraq.
- 4 (4) Since the beginning of "Operation Iraqi Freedom,"
- 5 <u>2.5 million Americans have served in Iraq.</u>
- 6 (5) More than 4,000 members of the United States Armed
- 7 Forces lost their lives during the second Gulf War, including
- 8 197 from this Commonwealth, and more than 32,000 were
- 9 <u>wounded.</u>
- 10 (b) Designation. -- December 18 of each year is designated
- 11 <u>as "Second Gulf War Veterans Day."</u>
- 12 <u>(c) Proclamation.--The Governor shall issue annually a</u>
- 13 proclamation encouraging all public schools and educational
- 14 institutions to observe "Second Gulf War Veterans Day" and to
- 15 conduct exercises recognizing the contributions of all those
- 16 <u>involved in the second Gulf War and remembering the sacrifices</u>
- 17 they made for their country. The proclamation may not mandate a
- 18 public school or educational institution to participate in the
- 19 observance.
- 20 Section 2. This act shall take effect immediately.
