Costs and fees. 12 1.3 (a.1) Annual fee. -- The Commonwealth shall impose a fee of 14 [\$25] <u>\$35</u> in each case in which an individual has never received 15 assistance under Title IV-A of the Social Security Act (49 Stat. 16 620, 42 U.S.C. § 301 et seq.) and for whom the Commonwealth has collected at least [\$500] \$550 of support in a Federal fiscal 17

year. [The Commonwealth shall pay the \$25 fee for those cases in

- 1 which the annual collection is between \$500 and \$1,999.99.] The
- 2 [\$25] \$35 fee shall be collected from the custodial parent [in
- 3 cases where annual collections equal \$2,000 or more].
