AN ACT

1 Amending Title 23 (Domestic Relations) of the Pennsylvania
2 Consolidated Statutes, in marriage ceremony, further
3 providing for persons qualified to solemnize marriages.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 1503(a) of Title 23 of the Pennsylvania
7 Consolidated Statutes is amended by adding paragraphs to read:

8 § 1503. Persons qualified to solemnize marriages.

9 (a) General rule.--The following are authorized to solemnize
10 marriages between persons that produce a marriage license issued
11 under this part:

12 * * *

13 (7) A member of the General Assembly.

14 (8) A former member of the General Assembly who:

15 (i) has not been defeated for reelection;

16 (ii) has not been convicted of, pleaded nolo

17 contendere to or agreed to an Accelerated Rehabilitative

1 Disposition or other probation without verdict program
2 relative to a misdemeanor or felony offense under the
3 laws of this Commonwealth or an equivalent offense under
4 the laws of the United States or any one of its
5 possessions, another state, the District of Columbia, the
6 Commonwealth of Puerto Rico or a foreign nation;

7 (iii) has not resigned as a member of the General
8 Assembly to avoid having charges filed or to avoid
9 prosecution by Federal, State or local law enforcement
10 agencies;

11 (iv) has served as a member of the General Assembly
12 by election for an aggregate of a full term in office;

13 (v) is a resident of this Commonwealth; and

14 (vi) registers with the Chief Clerk of the Senate or
15 the Chief Clerk of the House of Representatives, as
16 appropriate.

17 * * *

18 Section 2. This act shall apply as follows:

19 (1) The addition of 23 Pa.C.S. § 1503(a)(7) shall apply
20 only to members of the General Assembly who are elected to
21 office on or after November 6, 2018.

22 (2) The addition of 23 Pa.C.S. § 1503(a)(8) shall apply
23 only to members of the General Assembly who leave office
24 after November 30, 2018.

25 Section 3. This act shall take effect in 60 days.
