- disclosure, further providing for definitions, providing for

- 8 Section 1. The definition of "person" in section 1102 of
- 9 Title 65 of the Pennsylvania Consolidated Statutes is amended
- 10 and the section is amended by adding definitions to read:
- 11 § 1102. Definitions.
- 12 The following words and phrases when used in this chapter
- 13 shall have, unless the context clearly indicates otherwise, the
- 14 meanings given to them in this section:

- 16 "Cash." United States currency and coin and foreign currency
- 17 and coin.

- 2 "Lobbyist." As defined in section 13A03 (relating to
- 3 definitions).

- 5 "Person." A business, governmental body, individual,
- 6 <u>including an individual lobbyist or employee of a lobbyist</u>,
- 7 corporation, union, association, firm, partnership, committee,
- 8 club or other organization or group of persons.

- 10 Section 2. Title 65 is amended by adding sections to read:
- 11 <u>§ 1103.1. Gift ban.</u>
- 12 Except as provided in section 1103.2 (relating to gift ban
- 13 <u>exceptions</u>), no public official, public employee or nominee or
- 14 candidate for public office may receive, accept, take, seek or
- 15 solicit any of the following:
- (1) A gift GIFTS, other than a gift GIFTS of cash, <--
- 17 <u>having either a AN AGGREGATE fair market value or aggregate</u> <-
- 18 <u>actual cost greater than \$50 from any one person in a</u>
- 19 calendar year.
- 20 (2) Hospitality, transportation or lodging having either
- 21 a AN AGGREGATE fair market value or aggregate actual cost
- 22 greater than \$500 from any one person in a calendar year.
- 23 (3) A gift of cash.
- 24 § 1103.2. Gift ban exceptions.
- 25 The prohibitions listed in section 1103.1 (relating to gift
- 26 ban) shall not apply to any of the following:
- 27 (1) A gift or any hospitality, transportation or lodging

20	lobbyist and the circumstances make it clear that the
21	motivation for the gift or hospitality, transportation or
22	lodging is related to the personal romantic relationship.

25	(2) A "contribution," as defined in section 1621 of the
26	act of June 3, 1937 (P.L.1333, No.320), known as the
27	Pennsylvania Election Code, lawfully made under that act.
28	(3) Informational material sent to the office of a
29	public official or public employee in the form of a book,
30	article, periodical, other written material, audiotape,

1	videotape or other forms of communication for
2	nonentertainment purposes.
3	(4) An award or prize given to competitors in a contest
4	or event open to the public, including random drawings.
5	(5) An honorary degree or award and associated travel,
6	food, refreshments and entertainment provided in the
7	presentation of the degree or award.
8	(6) Training provided to a public official or public
9	employee if the training is in the interest of a governmental
10	entity. This paragraph shall include food and refreshments
11	furnished to all attendees as an integral part of the
12	training.
13	(7) Food and beverage for consumption at any of the
14	<pre>following:</pre>
15	(i) A public event, including a public meeting.
16	(ii) An event directly related to the duties and
17	responsibilities of a public official or public employee.
18	(iii) An event where a public official or public
19	employee is a speaker or a member of a panel.
20	(iv) A regularly scheduled event sponsored by a
21	constituent, Statewide organization or nonprofit
22	organization.
23	(8) Gifts exchanged between public officials or public
24	employees and their staffs on a voluntary basis.
25	(9) An educational mission, including a meeting with
26	governmental officials, either foreign or domestic, intended
27	to educate a public official or public employee on matters of
28	public policy, to which the public official or public
29	employee may be invited to participate along with other
30	Federal, State or local public officials or community

2	(10) Anything paid for by a Federal, State or other
3	government or governmental entity under a government
4	<pre>contract.</pre>
5	(11) An honorarium, including an award, plaque, trophy
6	or other item, valued at \$100 or less that is substantially
7	<pre>commemorative in nature.</pre>
8	(12) Tokens having de minimis economic impact, such as a
9	greeting card, pen, cap or t-shirt.
10	(13) Light food or refreshments, such as hors d'oeuvres,
11	in a group setting and intended for mass consumption and not
12	intended for consumption by a specific individual.
13	(14) Complimentary attendance and food or beverage at a
14	bona fide charitable or political event.

16	\$50 OR LESS and the circumstances of each gift. This
17	paragraph shall not apply to a gift [or gifts received from a
18	spouse, parent, parent by marriage, sibling, child,
19	grandchild, other family member or friend when the
20	circumstances make it clear that the motivation for the
21	action was a personal or family relationship. However, for
22	the purposes of this paragraph, the term "friend" shall not
23	include a registered lobbyist or an employee of a registered
24	lobbyist.] under section 1103.2(1) (relating to gift ban
25	exceptions).
26	(7) The name and address of the source and the amount of
27	any payment for or reimbursement of actual expenses for
28	transportation $[and]_{\mathcal{L}}$ lodging or hospitality $[received in]$
