AN ACT

Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," in medical assistance, 2 3 further providing for nonemergency medical transportation 4 services. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: Section 1. Section 443.12 of the act of June 13, 1967 8 (P.L.31, No.21), known as the Human Services Code, amended or 10 added June 22, 2018 (P.L.258, No.40), and June 28, 2019 (P.L.168, No.19), is amended to read: 11 12 Section 443.12. Nonemergency Medical Transportation 13 Services.--[(a) The department shall amend the Commonwealth's State Plan under Title XIX of the Social Security Act (49 Stat. 14 15 620, 42 U.S.C. § 1396 et seq.) to provide nonemergency medical 16 transportation services to eligible and enrolled medical assistance recipients utilizing a Statewide or regional +full-17 risk brokerage+ model. 18 <--

(b) Subject to Federal approval of the amendments to the

- 1 Commonwealth's approved Title XIX State Plan, the department
- 2 shall develop a proposal.
- f(c) The department shall issue the solicitation for a
- 4 Statewide or regional full-risk brokerage model within one
- 5 hundred eighty days after the effective date of this subsection.

- 7 broker under subsection (b) prior to the completion of the
- 8 analysis required under subsection (e).+
- 9 (e) +Prior to the implementation of the full-risk brokerage <--
- 10 model, the] (E) The department, in coordination with the
- 11 Department of Transportation and the Department of Aging, shall
- 12 commission an analysis that provides at a minimum the following:
- 13 (1) An analysis of current Federal and State law,
- 14 regulations and policies controlling the nonemergency medical
- 15 transportation and other human services transportation programs
- 16 administered in the Commonwealth, including the authorized
- 17 methods of delivery and limitations or restrictions imposed on
- 18 the methods of delivery.
- 19 (2) An analysis of the effectiveness and efficiency of the
- 20 current nonemergency transportation service delivery as it
- 21 relates to all human service programs in this Commonwealth.
- 22 (3) A review of other states' models of delivering
- 23 nonemergency medical and other human services transportation,
- 24 including the number of other states that utilize a full-risk
- 25 brokerage model and the effect a brokerage model has had on
- 26 public transit in those states.
- 27 (4) An analysis of the positive and negative impact of
- 28 maintaining the current transportation delivery model versus
- 29 implementing a full-risk brokerage model as it relates to the
- 30 State and local government entities, including financial impact.

- 1 (5) An analysis of the impact on consumers, including an
- 2 increase or decrease in quality and service availability.
- 3 (f) The analysis under subsection (e) shall be completed no
- 4 later than one hundred eighty days from the effective date of
- 5 this subsection. A preliminary report of the analysis under
- 6 subsection (e) shall be completed no later than ninety days from
- 7 the effective date of this subsection. The analysis under
- 8 subsection (e) and the preliminary report under this subsection
- 9 shall be delivered to the following:
- 10 (1) The Secretary of Human Services.
- 11 (2) The Secretary of Aging.
- 12 (3) The Secretary of Transportation.
- 13 (4) The chairperson and minority chairperson of the
- 14 Appropriations Committee of the Senate.
- 15 (5) The chairperson and minority chairperson of the
- 16 Appropriations Committee of the House of Representatives.
- 17 (6) The chairperson and minority chairperson of the Health
- 18 and Human Services Committee of the Senate.
- 19 (7) The chairperson and minority chairperson of the Health
- 20 Committee of the House of Representatives.
- 21 (q) A full-risk brokerage model may not be implemented until <--
- 22 legislation is enacted to do all of the following:
- 23 (1) Authorize a change in the implementation of nonemergency
- 24 <u>medical transportation services.</u>
- 25 <u>(2) Transfer the function of implementing nonemergency</u>
- 26 medical transportation services from the department to the
- 27 Department of Transportation. BY THE DEPARTMENT.
- 28 Section 2. This act shall take effect immediately.
